Dear Director Binkley:

On behalf of the Healthcare and Regulatory Subcommittee, thank you, and your staff for your recent presentation to the subcommittee. As a follow-up to the meeting, please respond to the following:

Amendments to the Sexually Violent Predator Act (2019 S.797)

- 1) What is the timeline to receive input from the criminal defense bar (i.e., attorneys representing the group of inmates affected by S.C. Code Ann. § 44-48-10 et seq.)?

Amendments to Title 44, Chapter 23 Regarding Commitments of Defendants for Treatment Services to Restore Capacity to Stand Trial and Regarding Defendants Found to Lack Capacity to Stand Trial and Further Found to be Unlikely to be Able to be Restored

- 2) Provide proposed strikethrough and underline language.
- 3) Provide citations to the studies referenced in the August 12, 2019, meeting regarding the improvements to the system that could be gained by creating flexibility in the settings (e.g., hospital, detention center, and/or community) where a defendant can be restored and how much time is allowable for restoration.
- 4) Quantify the increase in the agency's evaluative capacity with the addition of each new evaluator.

Amendments to Tort Claims Act

- 5) Provide proposed strikethrough and underline language.

Inpatient Services

- 6) Provide a detailed organizational chart.
- 7) For inpatient medical services, provide the following:
 - Position descriptions for nurse practitioners, primary care physicians and psychiatrists, including scopes of practice, skill set requirements, and the reporting chain.
 - How do South Carolina’s position descriptions, scopes of practice, skill set requirements, and reporting chain compare to public psychiatric hospitals in other states?
- 8) What positions perform the practitioner evaluations described by Representative Ridgeway, beginning at time stamp 1:45 of the August 12, 2019, meeting? What position in the inpatient services organizational chart includes the responsibilities typically performed by a hospital peer-review coordinator?
- 9) For the last three years, what are the annual morbidity and mortality rates for each inpatient facility?
