S. 853 -- Senator Davis: A BILL TO AMEND THE SOUTH CAROLINA CODE OF LAWS SO AS TO ENACT THE "LASER HAIR REMOVAL ACT"; BY ADDING SECTION 40-85-10 SO AS TO PROVIDE DEFINITIONS RELATED TO LASER HAIR REMOVAL; BY ADDING SECTION 40-85-20 SO AS TO PROVIDE THAT ONLY FDA APPROVED LASERS MAY BE USED WHEN PERFORMING LASER HAIR REMOVAL; BY ADDING SECTION 40-85-30 SO AS TO PROVIDE THAT ONLY HEALTH PROFESSIONALS MAY PERFORM LASER HAIR REMOVAL AND TO PROVIDE FOR TRAINING OF NON-PHYSICIAN HEALTH PROFESSIONALS WHO PROVIDE LASER HAIR REMOVAL; BY ADDING SECTION 40-85-40 SO AS TO REGULATE THE PRACTICE OF LASER HAIR REMOVAL; AND BY ADDING SECTION 40-85-50.
