

## Session 106 - (1985-1986)

### **S\*0001 (Rat #0242, Act #0157 of 1985) General Bill, By T.E. Smith**

A Bill to amend Section 20-7-1780, Code of Laws of South Carolina, 1976, relating to release of information by adoption agencies, so as to authorize adoption agencies to release the identity of adopted persons and biological parents of adopted persons under certain conditions; and to amend Section 20-7-2340, relating to the acceptance and use of gifts and donations by the Children's Bureau, so as to allow the Bureau to accept fees and to require the Bureau to use fees for purposes specified by donors or explained by a schedule of fees.
