### **S\*1083 (Rat #0226, Act #0208 of 2018) General Bill, By Grooms, Campbell and Verdin**

**Summary:** Temporary license plates

AN ACT TO AMEND SECTION 56-3-210, CODE OF LAWS OF SOUTH CAROLINA, 1976, RELATING TO THE TIME PERIOD FOR PROCURING REGISTRATION AND LICENSING, TEMPORARY LICENSE PLATES, AND THE TRANSFER OF LICENSE PLATES, SO AS TO PROVIDE THAT THE DEPARTMENT OF MOTOR VEHICLES IS AUTHORIZED TO ADMINISTER A PROGRAM FOR AND REGULATE THE ISSUANCE OF TEMPORARY LICENSE PLATES FOR NEWLY ACQUIRED VEHICLES, TO PROVIDE FOR DESIGN AND OTHER SPECIFICATIONS FOR THE LICENSE PLATES, TO PROVIDE THAT THE DEPARTMENT IS AUTHORIZED TO ADMINISTER AN ELECTRONIC SYSTEM FOR COUNTY AUDITOR'S OFFICES, LICENSED MOTOR VEHICLE DEALERS, LEASING COMPANIES, AND OTHER ENTITIES AUTHORIZED BY THE DEPARTMENT TO USE IN ISSUING TEMPORARY LICENSE PLATES, TO PROVIDE THAT ANY PERSON OR ENTITY AUTHORIZED BY THIS SECTION TO ISSUE A TEMPORARY LICENSE PLATE SHALL MAINTAIN RECORDS AS REQUIRED BY THE DEPARTMENT, TO PROVIDE FOR EXEMPTIONS, TO PROVIDE FOR PENALTIES, AND TO PROVIDE THAT ALL ENTITIES AUTHORIZED TO ISSUE TEMPORARY PLATES MUST COMPLY WITH ALL PROGRAM SPECIFICATIONS WITHIN A CERTAIN TIME PERIOD. - ratified title
