### **S\*1264 (Rat #0391, Act #0434 of 2006) General Bill, By Leventis**

**Summary:** Vocational Education School

AN ACT TO AMEND ACT 470 OF 1971, AS AMENDED, RELATING TO THE VOCATIONAL EDUCATION SCHOOL FOR SUMTER COUNTY AND THE BOARD OF TRUSTEES OF THE CAREER CENTER, SO AS TO PROVIDE THAT BEGINNING JULY 1, 2006, AND ENDING JUNE 30, 2009, THE BOARD OF TRUSTEES OF THE CAREER CENTER SHALL BECOME AN ADVISORY BOARD TO THE BOARDS OF TRUSTEES OF SUMTER SCHOOL DISTRICTS 2 AND 17 AND THE DUTIES, POWERS, AND FUNCTIONS OF THE BOARD OF TRUSTEES OF THE CAREER CENTER ARE DEVOLVED JOINTLY UPON THE BOARD OF TRUSTEES OF SUMTER SCHOOL DISTRICTS 2 AND 17 DURING THIS PERIOD, TO PROVIDE FOR ADDITIONAL MEMBERS OF THE CAREER CENTER BOARD DURING THIS PERIOD, AND TO PROVIDE THAT BEGINNING JULY 1, 2006, THE SUPERINTENDENTS OF SUMTER SCHOOL DISTRICTS 2 AND 17 SHALL TOGETHER EMPLOY A DIRECTOR OF THE CENTER WHO SHALL SERVE UNDER THEIR DIRECTION. - ratified title
