### **S\*0130 (Rat #0343, Act #0366 of 1998) General Bill, By Giese**

A BILL TO AMEND CHAPTER 43, TITLE 40, AS AMENDED, CODE OF LAWS OF SOUTH CAROLINA, 1976, RELATING TO PHARMACISTS, SO AS TO REVISE THE PRACTICE AND REGULATION OF PHARMACY INCLUDING, BUT NOT LIMITED TO FURTHER DEFINING "PHARMACEUTICAL DEVICES" AND FURTHER PROVIDING FOR THEIR REGULATION, REVISING THE ROLE OF PHARMACISTS IN DRUG THERAPY MANAGEMENT, REQUIRING PHARMACISTS TO COUNSEL PATIENTS ON NEW MEDICATION, AUTHORIZING PHARMACISTS TO SUPERVISE TWO, RATHER THAN ONE, PHARMACY TECHNICIAN, FURTHER PROVIDING FOR THE REQUIREMENTS FOR COMPOUNDING PRESCRIPTION DRUGS, PROVIDING FOR THE TRANSFER OF PRESCRIPTIONS BETWEEN PHARMACIES UNDER CERTAIN CONDITIONS, AND REVISING PROCEDURES FOR THE DISCLOSURE OF CONFIDENTIAL PRESCRIPTION INFORMATION.-AMENDED TITLE
