### **S\*0166 (Rat #0113, Act #0050 of 2003) General Bill, By Gregory**

**Summary:** Hunting from a public road, definition of hunting revised

AN ACT TO AMEND SECTION 50-11-760, AS AMENDED, CODE OF LAWS OF SOUTH CAROLINA, 1976, RELATING TO THE OFFENSE OF HUNTING FROM A PUBLIC ROAD OR RAILROAD RIGHT-OF-WAY WITHOUT PERMISSION TO HUNT FROM THE ADJACENT LANDOWNER, SO AS TO REVISE THE DEFINITION OF "HUNTING" FOR PURPOSES OF THE OFFENSE. - ratified title
