A Bill to relieve persons from civil damages when providing assistance or advice to mitigate the threatened or actual discharge of hazardous material and to repeal Item (4) of Section 4 of Act 436 of 1978, relating to prohibiting owners or operators of a treatment, storage, or disposal facility from accepting hazardous waste generated in another state or banned by law in that State.-amended title
