A Bill to amend the Code of Laws of South Carolina, 1976, by adding Section 8-17-60 so as to establish procedures to appraise the performance of employees and faculty members at state funded post-secondary educational institutions and establish a grievance procedure for such employees and faculty members; and to amend Section 8-17-50, as amended, relating to exemptions from the State Employee Grievance Procedure Act, so as to include certain faculty members at state institutions of higher learning in the exemptions.-at
