A Bill to amend the Code of Laws of South Carolina, 1976, by adding Section 11-11-140 so as to limit appropriations in the annual General Appropriations Act to an amount not to exceed the base revenue estimate, to define base revenue estimate, to provide for an increase in the base revenue estimate on the written certification of the Board of Economic Advisors, and to provide when and for what purposes surplus revenues may be appropriated.
