A Bill to amend Section 44-15-60, as amended, Code of Laws of South Carolina, 1976, relating to establishment and appointment of community mental health boards, so as to include parents of emotionally disturbed children and adolescents for consideration as consumer and family representatives on the boards and provide for the number of county members to be proportional to its population instead of its share of the budget.-amended title
