### **H\*3535 (Rat #0551, Act #0483 of 1986) General Bill, By J.E. Lockemy**

A Bill to amend Article 7, Chapter 17, of Title 44, Code of Laws of South Carolina, 1976, relating to the procedures for judicial commitment, by adding Section 44-17-660 so as to provide that monies appropriated to implement the provisions of Article 7, Chapter 17, of Title 44 may be paid to a state employee if the employee is not performing his official duties as a state employee and is not a full-time state employee.-amended title
