### **H\*3669 (Rat #0801, Act #0675 of 1988) General Bill, By Sharpe, T.E. Huff and W.H. Jones**

A Bill to amend Section 15-78-60, as amended, Code of Laws of South Carolina, 1976, relating to exceptions to waiver of immunity of liability by governmental agencies, so as to exempt members of the State and County Athletic Commission and ringside physicians from liability for acts performed in the course of official duties; and to amend the 1976 Code by adding Section 52-7-75 so as to provide for the denial or approval of permits for the holding of events when the applications are late.-amended title
