### **H\*3713 (Rat #0538, Act #0457 of 1984) General Bill, By House Medical, Military, Public and Municipal Affairs**

A Bill to amend Article 1, Chapter 69, Title 40, Code of Laws of South Carolina, 1976, as amended, relating to veterinarians so as to further provide for the regulation and licensing of the practice of veterinary medicine, for the composition of the State Board of Veterinary Medical Examiners, for the powers, duties and functions of the Board, for the fees charged by the Board, for the liability of members of the Board and the agents and employees thereof, and for the authorized penalties for certain violations.
