### **H\*3808 (Rat #0170, Act #0114 of 1995) General Bill, By Law, Dantzler, Kirsh, D. Williams and S.S. Wofford**

A Bill to amend the Code of Laws of South Carolina, 1976, by adding Section 12-21-735 so as to provide for payment of the license tax on cigarettes by the reporting method rather than by tax stamps; and to repeal Sections 12-21-720, 12-21-730, and 12-21-820, relating to cigarette license tax stamps; and to make this change in the payment method effective January 1, 1996.-amended title
