### **H\*4005 (Rat #0318, Act #0292 of 1992) Joint Resolution, By J.J. Bailey, Harvin and D.N. Holt**

A Joint Resolution to require each public school district in the State to implement a nutritional, well-balanced school breakfast program by school year 1993-94, and authorize the State Board of Education to grant a waiver of this requirement under certain conditions.-amended title
