**S\*0648 (Rat #0206, Act #0189 of 2018) General Bill, By Scott, Setzler, McLeod, Jackson and McElveen**

**Summary:** Surplus property of Midlands Tech.

AN ACT TO AMEND SECTION 59-53-1784, CODE OF LAWS OF SOUTH CAROLINA, 1976, RELATING TO THE DISPOSAL OF SURPLUS PROPERTY BY THE MIDLANDS TECHNICAL COLLEGE ENTERPRISE CAMPUS AUTHORITY, SO AS TO PROVIDE THAT THE EXEMPTION OF THE AUTHORITY FROM SURPLUS PROPERTY LAWS APPLIES TO REAL, PERSONAL, AND MIXED PROPERTY IN CERTAIN CIRCUMSTANCES; AND TO PROVIDE THE PROVISIONS OF THIS ACT EXPIRE JUNE 30, 2020. - ratified title
