### **S\*0891 (Rat #0530, Act #0471 of 1994) General Bill, By Short, Mescher, G. Smith and Washington**

A Bill to amend Article 1, Chapter 5, Title 43, Code of Laws of South Carolina, 1976, by adding a new Section 43-5-24, so as to require the Department of Health and Environmental Control to provide the Department of Social Services information on methods of contraception and family planning, excluding abortion information, to be disseminated to individuals needing assistance.-amended title
