### **S\*0975 (Rat #0144, Act #0140 of 2016) General Bill, By L. Martin and Hutto**

**Summary:** Workers' Compensation Commission

AN ACT TO AMEND SECTION 42-3-20, CODE OF LAWS OF SOUTH CAROLINA, 1976, RELATING TO THE MANNER OF APPOINTMENT OF THE CHAIRMAN OF THE WORKERS' COMPENSATION COMMISSION, SO AS TO DELETE A PROHIBITION OF THE SERVING OF CONSECUTIVE TERMS BY THE CHAIRMAN, TO PROVIDE THE GOVERNOR MAY REAPPOINT A CHAIRMAN, AND TO PROVIDE MEMBERS APPOINTED TO THE WORKERS' COMPENSATION COMMISSION ARE SUBJECT TO REMOVAL BY THE GOVERNOR IN CERTAIN CIRCUMSTANCES. - ratified title
