OPERATION OF STATE GOVERNMENT

SECTION 1 - H630 - DEPARTMENT OF EDUCATION

1.1. (SDE: Appropriation Transfer Prohibition) The amounts appropriated herein for aid to subdivisions, allocations to school districts, or special line items shall not be transferred and must be expended in accordance with the intent of the appropriation, except that the department may transfer funds that are deducted and retained from a school district's transportation allocation to reimburse the department for the cost of unauthorized mileage. This transfer must be agreed upon by both the school district and the department. Those funds may be transferred into the department's school bus transportation operating account.

12 1.2. (SDE: DHEC - Comprehensive Health Assessment) All school districts shall participate, to the fullest extent possible, in the
 13 Medicaid program by seeking appropriate reimbursement for services and administration of health and social services.
 14 Reimbursements to the school districts shall not be used to supplant funds currently being spent on health and social services.

15 **1.3.** (SDE: EFA Formula/Base Student Cost Inflation Factor) To the extent possible within available funds, it is the intent of the 16 General Assembly to provide for one hundred percent of full implementation of the Education Finance Act to include an inflation 17 factor projected by the Revenue and Fiscal Affairs Office to match inflation wages of public school employees in the Southeast. The

18 base student cost for the current fiscal year has been determined to be $\frac{2,220}{5,350}$. For the current fiscal year, the total pupil count

19 is projected to be 714,394 <u>723,953</u>. The average per pupil funding is projected to be \$5,536 <u>\$5,827</u> state, \$1,185 <u>\$1,245</u> federal, and

20 $\frac{5,371}{5,542}$ local. This is an average total funding level of $\frac{12,092}{5,371}$ excluding revenues of local bond issues. For the 21 current fiscal year the South Carolina Public Charter School District and any institution of higher education sponsoring a public

22 charter school shall receive and distribute state EFA funds to the charter school as determined by one hundred percent of the current

23 year's base student cost, as funded by the General Assembly multiplied by the weighted students pupils enrolled in the charter school,

24 which must be subject to adjustment for student attendance.

The Revenue and Fiscal Affairs Office, must post in a prominent place on their website for each school district projections, including the per pupil state, federal and local revenues, excluding revenues of local bond

issues, for the current fiscal year. Also, as soon as practicable, upon determining the exact numbers regarding pupil count and funding, the Revenue and Fiscal Affairs Office, shall also post on their website the one hundred thirty-five day average daily membership for each school district and per pupil state, federal and local revenues, excluding revenues of local bond issues, based on the most recent audited financial statement as reported annually pursuant to Section 59-17-100. The Department of Education and the Education Oversight Committee shall provide in a prominent place on their internet websites a link to the information posted by the Revenue and Fiscal Affairs Office, including the projected numbers and the exact numbers.

33 For the current fiscal year, the pupil classification weightings are as follows:

35 Students served in licensed residential treatment facilities (RTFs) for children and adolescents as defined under Section 36 44-7-130 of the 1976 Code shall receive a weighting of 2.10.

adjustments by June 30, 2016 2017. The department must provide districts with technical assistance with regard to student count changes in PowerSchool.

1.4. (SDE: EFA - Formula) The amount appropriated in Part IA, Section 1 for "Education Finance Act" shall be the maximum 3 4 paid under the provisions of Act 163 of 1977 (the South Carolina Education Finance Act of 1977) to the aggregate of all recipients. 5 The South Carolina Education Department shall develop formulas to determine the state and required local funding as stipulated in 6 the South Carolina Education Finance Act of 1977. Such formulas shall require the approval of the State Board of Education and 7 the State Fiscal Accountability Authority. After computing the EFA allocations for all districts, the department shall determine 8 whether any districts' minimum required local revenue exceeds the districts' total EFA Foundation Program. When such instance is found, the department shall adjust the index of taxpaying ability to reflect a local effort equal to the cost of the districts' EFA 9 Foundation Program. The districts' weighted pupil units are to be included in determination of the funds needed for implementation 10 11 of the Education Finance Act statewide. 12 In the event that the formulas as devised by the Department of Education and approved by the State Board of Education and the State Fiscal Accountability Authority should provide for distribution to the various school districts totaling more than the amount 13 appropriated for such purposes, subject to the provisions of this proviso, the Department of Education shall reduce each school district 14 15 entitlement by an equal amount per weighted pupil so as to bring the total disbursements into conformity with the total funds appropriated for this purpose. If a reduction is required in the state's contribution, the required local funding shall be reduced by the 16 proportionate share of local funds per weighted pupil unit. The Department of Education shall continually monitor the distribution 17 of funds under the provisions of the Education Finance Act and shall make periodic adjustments to disbursements to ensure the 18 aggregate of such disbursements do not exceed the appropriated funds. 19 Local districts shall not be mandated or required to inflate the base number in their respective salary schedules by any percentage 20 21 greater than the percentage by which the appropriated base student cost exceeds the appropriated base student cost of the prior fiscal 22 year. 23 **1.5.** (SDE: Employer Contributions/Allocations) It is the intent of the General Assembly that the appropriation contained herein for "Public School Employee Benefits" shall not be utilized to provide employer contributions for any portion of a school district 24 25 employee's salary that is federally funded.

State funds allocated for school district employer contributions must be allocated by the formula and must be used first by each district to cover the cost of fringe benefits for personnel required by the Defined Program, food service personnel and other personnel required by law. Once a district has expended all state allocated funds for fringe benefits, the district may utilize food service revenues to fund a proportionate share of fringe benefits costs for food service personnel.

The Department of Juvenile Justice and the Department of Corrections' school districts must be allocated funds under the fringe benefits program in accordance with criteria established for all school districts.

32 **1.6.** (SDE: Employer Contributions/Obligations) In order to finalize each school district's allocations of Employer Contributions

33 funds for retiree insurance from the prior fiscal year, the Department of Education is authorized to adjust a school district's allocation

in the current fiscal year accordingly to reflect actual payroll and payments to the Retirement System from the prior fiscal year. In

35 the event the Department of Education is notified that an educational subdivision has failed to remit proper payments to cover

1 Employee Fringe Benefit obligations, the Department of Education is directed to withhold the educational subdivision's state funds

2 until such obligations are met.

3 1.7. (SDE: Governor's School for Science & Math) Any unexpended balance on June thirtieth of the prior fiscal year of funds appropriated to or generated by the Governor's School for Science and Mathematics may be carried forward and expended in the current fiscal year pursuant to the direction of the board of trustees of the school.

1.8. (SDE: Educational Responsibility/Foster Care) The responsibility for providing a free and appropriate public education 6 7 program for all children including disabled students is vested in the public school district wherein a child of lawful school age resides 8 in a foster home, group home, orphanage, or a state operated health care facility including a facility for treatment of mental illness 9 or chemical dependence and habilitation centers for persons with intellectual disabilities or persons with related conditions located within the jurisdiction of the school district or alternative residences. The districts concerned may agree upon acceptable local cost 10 11 reimbursement. If no agreement is reached, districts providing education shall receive from the district where the child last resided 12 before placement in a facility an additional amount equivalent to the statewide average of the local base student cost multiplied by the appropriate pupil weighting as set forth in Section 59-20-40 of the Education Finance Act. If a child from out of state is residing 13 in a facility owned and/or operated by a for profit entity, the district providing educational services shall be reimbursed by the for 14 profit entity the local district's local support per weighted pupil above the statewide average base student cost multiplied by the 15 appropriate pupil weighting as set forth in Section 59-20-40 of the Education Finance Act. This also applies to John de la Howe 16 School who also has the authority to seek reimbursement in any situation that the school district has participation in the placement 17 of the student. John de la Howe School shall be reimbursed the local district's local support per weighted pupil above the statewide 18 average base student cost multiplied by the appropriate pupil weighting as set forth in Section 59-20-40 of the Education Finance 19 Act. Participation will be evidenced by a written agreement from the IEP team or 504 team, written referral, or the school district 20 initiating the placement process. School districts providing the education shall notify the nonresident district in writing within forty-21 five calendar days that a student from the nonresident district is receiving education services pursuant to the provisions of the proviso. 22 23 The notice shall also contain the student's name, date of birth, and disabling condition if available. If appropriate financial arrangements cannot be effected between institutions of the state, including independent school districts under the authority of the 24 Department of Disabilities and Special Needs, and school districts, institutions receiving educational appropriations shall pay the 25 26 local base student cost multiplied by the appropriate pupil weighting. Children residing in institutions of state agencies shall be educated with nondisabled children in the public school districts if appropriate to their educational needs. Such institutions shall 27 28 determine, on an individual basis, which children residing in the institution might be eligible to receive appropriate educational 29 services in a public school setting. Once these children are identified, the institution shall convene an IEP meeting with officials of 30 the public school district in which the institution is located. If it is determined by the committee that the least restrictive environment 31 in which to implement the child's IEP is a public school setting, then the school district in which the institution is located must provide the educational services. However, that school district may enter into contractual agreements with any other school district 32 having schools located within a forty-five mile radius of the institution. The cost for educating such children shall be allocated in 33 34 the following manner: the school district where the child last resided before being placed in an institution shall pay to the school 35 district providing the educational services an amount equivalent to the statewide average of the local base student cost multiplied by 36 the appropriate pupil weighting as set forth in Section 59-20-40 of the Education Finance Act; the school district providing the

1 educational services shall be able to count the child for all funding sources, both state and federal. The institution and school district,

through contractual agreements, will address the special education and related services to be provided to students. Should the school

3 district wherein the institution is located determine that the child cannot be appropriately served in a public school setting, then the 4 institution may request a due process hearing pursuant to the procedures provided for in the Individuals with Disabilities Education

institution may request a due process hearing pursuant to the procedures provided for in the individuals with Disabilities Education
 Act.

The agreed upon acceptable local cost reimbursement or the additional amount equivalent to the statewide average of the local base student cost multiplied by the appropriate pupil weighting set forth in Section 59-20-40, for instructional services provided to out-of-district students, shall be paid within sixty days of billing, provided the billing district has provided a copy of the invoice to both the Superintendent and the finance office of the district being invoiced. Should the district not pay within sixty days, the billing district can seek relief from the Department of Education. The department shall withhold EFA funding equal to the billing from the district refusing to pay and submit the funding (equal to the invoice) to the billing school district.

The agency placing a child in any situation that requires changing school districts, must work with the schools to assure that all 12 required school records, including confidential records, are transferred from the sending to the receiving school within three working 13 days. School records to be transferred should include grade transcripts, state birth certificate, certificate of immunization, social 14 security card, attendance records, discipline records, IEP's, psychological reports (or notation in the school records that a 15 psychological report on the child is available at the school district office) and any other records necessary for the appropriate 16 placement of the child in the new school. School districts must release all records upon presentation of a court order or appropriate 17 permission for confidential release. If evaluation or placement is pending, the receiving school district is responsible to secure 18 information and to complete the placement. The receiving school will maintain appropriate confidentiality of all records received 19 20 on a child.

1.9. (SDE: Instruction in Juvenile Detention Centers) It shall be the responsibility of the school district where a local juvenile detention center is located to provide adequate teaching staff and to ensure compliance with the educational requirements of this State. Students housed in local juvenile detention centers are to be included in the average daily membership count of students for that district and reimbursement by the Department of Education made accordingly.

25 **1.10.** (SDE: Revenue Authorization) The State Department of Education is hereby authorized to collect, expend, and carry 26 forward revenues in the following areas to offset the cost of providing such services: the sale of publications, manuals and forms, 27 the sale of Apple Tags, royalties, contributions, donations, foundation funds, special grants and contracts, brochures, photo copies, 28 listings and labels, Directory of South Carolina Schools, student health record cards, items to be recycled, and high school diplomas 29 and certificates; the collection of out-of-state and in-state investigation fees, registration fees for non-SDE employees, recurring facility inspection fees, teacher certification fees; the handling of audio-visual film; the provision of contract computer services to 30 31 school districts and other state agencies, joint broadcast service to school districts, and education-related statistics through agreement with the National Center for Education Statistics; the lease or sale of programs of television, audio or microcomputer software; the 32 lease or sale of virtual courses to other states; the collection of damage fees for instructional materials and the sale of unusable 33 34 instructional materials; sale of fuel; use and repair of transportation equipment; fees for Medicaid reimbursable transportation; the receipt of insurance and warranty payments on Department of Education equipment and the sale of used school buses and support 35 equipment. The Department of Education is authorized to collect revenue for deposit into the State General Fund for testing material 36

1 purchases and test rescoring fees. The Department of Education is authorized to expend revenue collected for lost and damaged

2 instructional materials and the sale of unusable instructional materials for the purpose of contracting for the purchase and maintenance

of a statewide textbook inventory management system, provided that schools' newly-adopted instructional materials needs are met
 first.

1.11. (SDE: School District Bank Accounts) Each school district in this State, upon the approval of the district's governing body, may maintain its own bank account for the purpose of making disbursement of school district funds as necessary to conduct school district business and each county treasurer is hereby authorized to transfer such amount as needed, upon receipt of a written order certified by the district governing body or their designee. Such order shall contain a statement that such amount is for immediate disbursement for the payment of correct and legal obligation of the school district.

10 1.12. (SDE: School Lunch Program Aid) The amount appropriated herein for School Lunch Program Aid shall be divided among 11 the District and/or County Boards of Education of the State upon the basis of the number of schools participating in the School Lunch 12 Program in each district during the prior school year. The travel expenses of the District and/or County School Lunch Supervisor 13 shall be paid from this appropriation at the prevailing rate of mileage allowed by the State. These funds may be used as an aid in 14 improving the School Lunch Program. These funds may not be used to supplement the salaries of school lunch supervisors. In the 15 absence of a County Board of Education in multi-district counties, the funds will be divided among the school districts of the county 16 on the basis of the number of schools participating in the School Lunch Program in each district during the prior school year.

17 1.13. (SDE: Travel/Outside of Continental U.S.) School District allocations from General Funds, lottery, and EIA funds shall 18 not be used for travel outside of the continental United States. The International Baccalaureate Program shall be exempt from this 19 restriction.

1.14. (SDE: Year End Closeout) The State Department of Education is authorized to expend federal and earmarked funds (not including state or EIA funds) in the current fiscal year for expenditures incurred in the prior year; however, state funds appropriated in Part IA, Section 1, X, Aid to School Districts, for the Children's Case Resolution System or private placements for services provided to children with disabilities may be used for those expenditures in prior fiscal years. The department is also authorized to use appropriated funds to pay for textbooks shipped in the fourth quarter of the prior fiscal year.

1.15. (SDE: Transportation Collaboration) The Department of Education School Bus Maintenance Shops shall be permitted, on
 a cost reimbursable-plus basis, to deliver transportation maintenance and services to vehicles owned or operated by public agencies
 in South Carolina.

School buses operated by school districts, other governmental agencies or head start agencies for the purpose of transporting students for school or school related activities shall not be subject to state motor fuel taxes. Further, that school districts, other governmental agencies or head start agencies may purchase this fuel, on a cost reimbursable-plus basis, from the Department of Education School Bus Maintenance Shops.

1.16. (SDE: School Bus Insurance) The Department of Education shall maintain comprehensive and collision insurance or self insure state-owned buses. In no event shall the department charge local school districts for damages to the buses which are commonly
 covered by insurance.

1.17. (SDE: Teacher Data Collection) Of the non-program funds appropriated to the Department of Education, it and the
 Commission on Higher Education shall share data about the teaching profession in South Carolina. The data sharing should ensure

(1) a systematic report on teacher supply and demand information and (2) data to determine classes being taught by public school 1 2 teachers out of field of their preparation. The data collection should include but not be limited to: classes/subjects taught, number of students taught, percentage of teacher education graduates from South Carolina colleges/universities who go into teaching, 3 4 percentage of teacher education graduates who teach in public schools in South Carolina, percentage of new teachers who leave the 5 South Carolina teaching profession in the first three years of public school teaching due to unsuccessful evaluations, percentage of 6 new teachers who leave the profession in the first three years of public school teaching in South Carolina who have successful 7 evaluations, turnover rate of teachers and certification areas with highest vacancies. All database items should be set up so that it 8 can be disaggregated by ethnicity, gender, geographic location, etc. 1.18. (SDE: School Building Aid) Of the funds appropriated in Part IA for School Building Aid, \$500,000 shall be allocated on 9 a K-12 per pupil basis to Multi-District Area Vocational Schools. 10

11 **1.19.** (SDE: School Bus Driver CDL) From funds provided in Part IA, Section 1, VII.B., local school districts shall request a 12 criminal record history from the South Carolina Law Enforcement Division for past conviction of any crime before the initial 13 employment of a school bus driver or school bus aide. The Department of Education and the school districts shall be treated as a 14 charitable organization for purposes of the fee charged for the criminal records search.

15 1.20. (SDE: School Bus Purchase) Any procurement of school buses with funds appropriated in this act or any other appropriation bill must meet specifications developed by the School Bus Specification Committee as established by the State 16 Superintendent of Education. The School Bus Specifications Committee shall allow for input from all school bus chassis and body 17 manufacturers. However, if it is safe, more economical, and in the public interest, the department may use the school bus 18 specifications of another state in the procurement of school buses. If the department uses the specifications of another state, the 19 department must submit a report to the Chairman of the Senate Finance Committee and the Chairman of the House Ways and Means 20 Committee detailing the methodology by which the alternative specifications were determined to be safe, more economical, and in 21 the public interest, when compared to the specifications set forth by the School Bus Specifications Committee. 22

1.21. (SDE: Buses, Parts, and/or Fuel) Funds appropriated for other operating in program VII.B. - Bus Shops and funds appropriated in VII.C. - Buses may be used to purchase buses, fuel, parts, or other school bus related items. All funds appropriated for bus fuel, parts/supplies, maintenance, and bus purchases may be carried forward from the prior fiscal year and expended in the current fiscal year to support bus transportation services.

1.22. (SDE: Mitford Transportation Costs) Transportation costs for the transporting of students from the Mitford area of Fairfield
 County to schools in the Great Falls area of Chester County is not the responsibility of and shall not be borne by the Chester County
 School District. These transportation costs shall continue to be the responsibility of the State Department of Education.

30 **1.23.** (SDE: Status Offenders/John de la Howe) The funds appropriated for the Status Offender Program shall be distributed to 31 John de la Howe School to expand residential programs to include court ordered status offenders. Components of such a program 32 shall include collaboration between the home school district and the residential school and treatment or related services to the families 33 of students in placement.

1.24. (SDE: Governor's School Leave Policy) The South Carolina Governor's School for the Arts and Humanities and the South
 Carolina Governor's School for Science and Mathematics are authorized to promulgate administrative policy governing annual and

sick leave relative to faculty and staff with the approval of their respective board of directors. This policy shall address their
 respective school calendars in order to comply with the instructional needs of students attending both special schools.

1.25. (SDE: School Facilities Management System) School Districts may use capital improvement bond funds, lapsed funds or
 any other unexpended appropriated funds or revenues to access the Department of Education's School Facilities Management System
 database.

6 1.26. (SDE: School Board Meetings) Of the funds appropriated through the Department of Education for technology related
7 expenses, school districts that have a website shall place a notice of a regularly scheduled school board meeting twenty-four hours
8 in advance of such meeting. The notice shall include the date, time, and agenda for the board meeting. The school district shall
9 place the minutes of the board meeting on their website within ten days of the next regularly scheduled board meeting.

10 **1.27.** (SDE: Proviso Allocations) In the event an official General Fund revenue shortfall is declared by the Board of Economic 11 Advisors, the Department of Education may reduce any allocation in Section 1 specifically designated by proviso in accordance with 12 the lower Board of Economic Advisors revenue estimate as directed by the Executive Budget Office, except the additional EFA 13 allocation to the South Carolina Public Charter School District. The reduction may not be greater than the total percentage of 14 reduction of the Section 1 appropriation. Should the department hold back funds in excess of the total percentage reduction those 15 funds must be allocated per the proviso. No allocation for teacher salaries shall be reduced as a result of this proviso.

1.28. (SDE: School Districts and Special Schools Flexibility) All school districts and special schools of this State may transfer 16 and expend funds among appropriated state general fund revenues, Education Improvement Act funds, Education Lottery Act funds, 17 and funds received from the Children's Education Endowment Fund for school facilities and fixed equipment assistance, to ensure 18 the delivery of academic and arts instruction to students. However, a school district may not transfer funds allocated specifically for 19 state level maintenance of effort requirements under IDEA, funds allocated specifically for state level maintenance of effort 20 requirement for federal program, funds provided for the Education and Economic Development Act, funds provided for Career and 21 Technology Education, nor required for debt service or bonded indebtedness. All school districts and special schools of this State 22 23 may suspend professional staffing ratios and expenditure regulations and guidelines at the sub-function and service area level, except 24 for four-year old programs and programs serving students with disabilities who have Individualized Education Programs.

In order for a school district to take advantage of the flexibility provisions, at least seventy-five percent of the school district's per pupil expenditures must be utilized within the In\$ite categories of instruction, instructional support, and <u>only transportation, food</u> *service, and safety within* non-instruction pupil services. No portion of the seventy-five percent may be used for <u>facilities</u>, business services, debt service, capital outlay, program management, and leadership services, as defined by In\$ite. The school district shall report to the Department of Education the actual percentage of its per pupil expenditures used for classroom instruction, instructional support, and *transportation, food service, and safety within* non-instruction pupil services for the current school year ending June

thirtieth. Salaries of on-site principals must be included in the calculation of the district's per pupil expenditures.

32 "In\$ite" means the financial analysis model for education programs utilized by the Department of Education.

33 School districts are encouraged to reduce expenditures by means, including, but not limited to, limiting the number of low 34 enrollment courses, reducing travel for the staff and the school district's board, reducing and limiting activities requiring dues and

35 memberships, reducing transportation costs for extracurricular and academic competitions, restructuring administrative staffing, and

36 expanding virtual instruction.

1 School districts and special schools may carry forward unexpended funds from the prior fiscal year into the current fiscal year.

2 Prior to implementing the flexibility authorized herein, school districts must provide to Public Charter Schools the per pupil 3 allocation due to them for each categorical program.

4 Quarterly throughout the current fiscal year, the chairman of each school district's board and the superintendent of each school

5 district must certify where non-instructional or nonessential programs have been suspended and the specific flexibility actions taken.

6 The certification must be in writing, signed by the chairman and the superintendent, delivered electronically to the State

7 Superintendent of Education, and an electronic copy forwarded to the Chairman of the Senate Finance Committee, the Chairman of

8 the Senate Education Committee, the Chairman of the House Ways and Means Committee, and the Chairman of the House Education

9 and Public Works Committee. Additionally, the certification must be presented publicly at a regularly called school board meeting,

10 and the certification must be conspicuously posted on the internet website maintained by the school district.

For the current fiscal year, Section 59-21-1030 is suspended. Formative assessments for grades one, two, and nine, the foreign language program assessment, and the physical education assessment must be suspended. School districts and the Department of

13 Education are granted permission to purchase the most economical type of bus fuel.

For the current fiscal year, savings generated from the suspension of the assessments enumerated above must be allocated to school districts based on weighted pupil units.

16 School districts must maintain a transaction register that includes a complete record of all funds expended over one hundred dollars, 17 from whatever source, for whatever purpose. The register must be prominently posted on the district's internet website and made 18 available for public viewing and downloading. The register must include for each expenditure:

(i) the transaction amount;

(ii) the name of the payee; and

(iii) a statement providing a detailed description of the expenditure.

The register must not include an entry for salary, wages, or other compensation paid to individual employees. The register must not include any information that can be used to identify an individual employee. The register must be accompanied by a complete explanation of any codes or acronyms used to identify a payee or an expenditure. The register must be searchable and updated at

least once a month.

Each school district must also maintain on its internet website a copy of each monthly statement for all of the credit cards maintained by the entity, including credit cards issued to its officers or employees for official use. The credit card number on each statement must be redacted prior to posting on the internet website. Each credit card statement must be posted not later than the

29 thirtieth day after the first date that any portion of the balance due as shown on the statement is paid.

30 The Comptroller General must establish and maintain a website to contain the information required by this section from a school

31 district that does not maintain its own internet website. The internet website must be organized so that the public can differentiate

32 between the school districts and search for the information they are seeking.

33 School districts that do not maintain an internet website must transmit all information required by this provision to the Comptroller

34 General in a manner and at a time determined by the Comptroller General to be included on the internet website.

The provisions contained herein do not amend, suspend, supersede, replace, revoke, restrict, or otherwise affect Chapter 4, Title 30, the South Carolina Freedom of Information Act. Nothing in this proviso shall be interpreted as prohibiting the State Board of Education to exercise its authority to grant waivers under Regulation 43-261.

1.29. (SDE: Medical Examination and Security Reimbursement/Expenditures) From funds authorized in Part IA, Section 1, VII.B. Other Operating Expenses, the Department of Education may directly pay, or reimburse employees, for the cost of a medical examination as required in Part 391, Subpart E of the Federal Motor Carrier Safety Regulations, for employees that are required to operate a state vehicle transporting hazardous materials and that are required to undergo a national security background check because of the required Hazmat endorsement to their CDL.

9 1.30. (SDE: Budget Reduction) In compensating for any reduction in funding, local districts must give priority to preserving
 10 classroom teachers and operations. Funding reductions should first be applied to administrative and non-classroom expenses before
 11 classroom expenses are affected.

12 **1.31.** (SDE: Governor's School for the Arts and Humanities Carry Forward) Any unexpended balance on June thirtieth of the 13 prior fiscal year of funds appropriated to or generated by the Governor's School for the Arts and Humanities may be carried forward 14 and expended in the current fiscal year pursuant to the discretion of the Board of Trustees of the School.

1.32. (SDE: Governor's Schools' Fees) The South Carolina Governor's School for the Arts and Humanities and the South Carolina Governor's School for Science and Mathematics are authorized to charge, collect, expend, and carry forward student fees as approved by their respective Board of Directors. The purpose and amount of any such fees will be to maintain program quality in both academics and residential support. No student will be denied admittance or participation due to financial inability to pay. The respective Board of Directors shall promulgate administrative policy governing the collection of all student fees. Both schools shall conspicuously publish a fee schedule on their respective websites.

1.33. (SDE: School District Furlough) Should there be a midyear reduction in state funding to the districts, school districts may institute employee furlough programs for district-level and school-level professional staff. Before any of these employees may be furloughed, the chairman of the governing body of the school district must certify that all fund flexibility provided by the General Assembly has been utilized by the district and that the furlough is necessary to avoid a year-end deficit and a reduction in force. The certification must include a detailed report by the superintendent of the specific action taken by the district to avoid a year-end deficit. The certification and report must be in writing and delivered to the State Superintendent of Education and a copy must be forwarded to the Chairman of the Senate Finance Committee and the Chairman of the House Ways and Means Committee.

28 The local school district board of trustees may implement a furlough of personnel once certification to the State Superintendent 29 documents all funding flexibility has been exhausted and continued year-end deficits exist. Local school boards of trustees shall have the authority to authorize furloughs of these employees in the manner in which it sees fit. However, instructional personnel 30 31 may be furloughed for up to five non-instructional days if not prohibited by an applicable employment contract with the district and provided district administrators are furloughed for twice the number of days. District administrators may only be furloughed on non-32 instructional days and may not be furloughed for a period exceeding ten days. District administrators shall be defined by the 33 34 Department of Education using the Professional Certified Staff (PCS) System. For individuals not coded in PCS, the determination shall be made based upon whether the individual performs the functions outlined in position codes identified by the department as 35

administration. Educators who would have received a year's experience credit had a furlough not been implemented, shall not have 1 2 their experience credit negatively impacted because of a furlough implementation. During any furlough, affected employees shall be entitled to participate in the same benefits as otherwise available to them except 3 4 for receiving their salaries. As to those benefits that require employer and employee contributions, including, but not limited to, contributions to the South Carolina Retirement System or the optional retirement program, the district will be responsible for making 5 both employer and employee contributions if coverage would otherwise be interrupted; and as to those benefits which require only 6 7 employee contributions, the employee remains solely responsible for making those contributions. Placement of an employee on furlough under this provision does not constitute a grievance or appeal under any employee grievance procedure. The district may 8 allocate the employee's reduction in pay over the balance of the fiscal year for payroll purposes regardless of the pay period within 9 which the furlough occurs. 10 Each local school district must prominently post on the district's internet website and make available for public viewing and 11 downloading the most recent version of the school district's policy manual and administrative rule manual. 12 This proviso shall not abrogate the terms of any contract between any school district and its employees. 13 1.34. (SDE: School Lunch/Attendance Supervisors) For those counties in which an entity other than the school district 14 administers the school lunch supervisor and/or attendance supervisor programs, the school districts in that county shall transfer to 15 the entity the amount available in the previous fiscal year for administration of the school lunch supervisor and/or attendance 16 supervisor programs. Each district shall transfer a pro rata share of the total cost based upon the percentage of state EFA funds 17 distributed to the districts within the county. 18 1.35. (SDE: SCGSAH Certified Teacher Designation) Because of the unique nature of the South Carolina Governor's School 19 for the Arts and Humanities, the Charleston School of the Arts, and the Greenville County Fine Arts Center, the schools are authorized 20 to employ at its discretion noncertified classroom teachers teaching in the literary, visual and performing arts subject areas who are 21 otherwise considered to be appropriately qualified in a ratio of up to one hundred percent of the entire teacher staff. 22 23 **1.36.** (SDE: No Discrimination Requirement) State funds must not be appropriated to a school that discriminates against or participates with or is a member of an association with policies that discriminate or afford different treatment of students based on 24 25 race or national origin. 26 1.37. (SDE: Medicaid Cash Match Accounting) The department is granted authority to transfer funds between budget lines and object codes to identify, reconcile, reimburse, and remit funds required for Medicaid cash match to the Department of Health and 27 Human Services. 28 1.38. (SDE: Student Report Card-GPA) For each high school student, school districts shall be required to print the student's 29 individual cumulative grade point average for grades nine through twelve on the student's report card. 30 1.39. (SDE: Lost & Damaged Textbook Instructional Materials Fees) Fees for lost and damaged textbooks instructional 31 materials for the prior school year are due no later than December first of the current school year when invoiced by the Department 32 of Education. The department may withhold textbooks instructional materials funding from schools that have not paid their fees by 33 34 the payment deadline. 1.40. (SDE: Education Finance Act Reserve Fund) There is created in the State Treasury a fund separate and distinct from the 35 General Fund of the State and all other funds entitled the Education Finance Act Reserve Fund. All unexpended general funds 36

1 appropriated to the Department of Education for the Education Finance Act in the current fiscal year shall be transferred to the 2 Education Finance Act Reserve Fund. In the event that the amount appropriated for the Education Finance Act is insufficient to fully fund the base student cost as established by this act, revenues from the Education Finance Act Reserve Fund may be used to 3 4 supplement the funds appropriated. The General Assembly may make direct appropriations to this fund. All unexpended funds in 5 the Education Finance Act Reserve Fund and any interest accrued by the fund must remain in the fund and may be carried forward 6 into the current fiscal year. 7 **1.41.** (SDE: Prohibit Advertising on School Buses) The Department of Education and local school districts are prohibited from selling space for or the placement of advertisements on the outside or inside of state-owned school buses. 8 1.42. (SDE: Residential Treatment Facilities Student Enrollment and Funding) Each South Carolina resident of lawful school 9 age residing in licensed residential treatment facilities (RTFs) for children and adolescents as defined under identified on the State 10 Oualified Providers list and meets the requirements of Section 44-7-130 of the 1976 Code, ("students") shall be entitled to receive 11 educational services from the school district in which the RTF is located ("facility school district"). The responsibility for providing 12 appropriate educational programs and services for these students, both with and without disabilities, who are referred, authorized, or 13 placed by the State is vested in the facility school districts. For purposes of this proviso, an authorization must be pursuant to a 14 physician's determination of medical necessity. If clinically appropriate, the facility school district, the RTF, and the parent or 15 guardian of a student referred or placed in a RTF may consider the appropriateness of providing the student's education program 16 virtually through enrollment in either the facility district's virtual program, the South Carolina virtual school program provided 17 through the Department of Education (Virtual SC), or a virtual charter school authorized by the South Carolina Public Charter School 18 District, or a virtual charter school authorized by an approved institute of higher education. This decision should be made jointly 19 with the best interest of the student and what is clinically indicated being considered. 20 A facility school district must provide the necessary educational programs and services directly to the student at the RTF's facility. 21 provided that the RTF facility provides and maintains comparable adequate space for the educational programs and services 22 23 consistent with all federal and state least restrictive environment requirements. Adequate space shall include appropriate electrical support and Internet accessibility. Unless the parent or legal guardian of the student seeks to continue the student's enrollment in 24

the resident school district under a medical homebound instruction program and the district approves, if appropriate, then, under these circumstances, the facility school district shall enroll the student and assume full legal and financial responsibility for the educational services including enrolling the student, approving the student's entry into a medical homebound instructional program, if appropriate, and receiving and expending funds, unless the resident school district undertakes to carry out its educational responsibilities for the student directly. Alternatively, a facility school district may choose to provide the necessary educational programs and services by contracting with the RTF provided that the RTF agrees to provide educational services to the student at the

RTF's facility. Under these circumstances, the facility school district must enroll the student and pay the RTF for the educational services provided. If the facility school district determines the educational program being offered by the RTF does not meet the educational standards outlines in the contract, the facility district shall be justified in terminating the contract.

The facility school districts are entitled to receive the base student cost multiplied by the Education Finance Act pupil weighting for Homebound pupils of 2.10, as set forth in Section 59-20-40 of the 1976 Code and any eligible categorical and federal funds. These funds may be retained by the facility school districts for the purpose of providing the educational programs and services

directly to students referred or placed by the State or the facility school districts may use these funds to reimburse RTFs for the 1 2 educational programs and services provided directly by the RTFs. A facility school district is entitled to reimbursement from a resident school district for the difference between (1) the reasonable costs expended for the educational services provided directly 3 4 by the facility school district or the amount paid to the RTF and (2) the aggregate amount of federal and state funding received by 5 the facility school district for that student. However, the reimbursement rate may not exceed \$45 per student per day. Facility school districts providing the educational services shall notify the resident district in writing within forty-five calendar days that a student 6 7 from the resident district is receiving educational services pursuant to the provisions of the proviso. Reimbursements shall be paid 8 within sixty days of billing, provided the facility district has provided a copy of the invoice to both the District Superintendent and the finance office of the resident district being invoiced. Should the facility school district be unable to reach agreement with the 9 resident school district regarding reasonable costs differences, the facility school district shall notify the Department of Education's 10 Office of General Counsel. The Department of Education shall facilitate a resolution of the dispute between the facility school 11 district and the resident school district within forty-five days of the notice of dispute. If the issue of reasonable cost differences 12 should remain unresolved, a facility school district shall have the right to file a complaint in a Circuit Court. Should a resident school 13 district fail to distribute the entitled funding to the facility school district by the one hundred thirty-five day count, the Department 14 15 of Education is authorized to withhold the equivalent amount of EFA funds and transfer those funds to the facility school district. RTF facilities on the State Qualified Provider List not located within the boundaries of the state shall be reimbursed at a rate that 16 may not exceed \$45 per student per day for education services and school districts shall be eligible to receive a base student cost 17 weighted funding of 2.10 provided that the student remains enrolled in the school district. Facilities providing the educational 18 services shall notify the resident district in writing within forty-five calendar days that a student from the resident district is receiving 19 educational services pursuant to the provisions of the proviso. Reimbursements shall be paid within sixty days of billing, provided 20 the qualified facility has provided a copy of the invoice to both the District Superintendent and the finance office of the resident 21 district being invoiced. Should the facility be unable to reach agreement with the resident school district regarding reasonable costs 22 23 differences, the provider shall notify the Department of Education's Office of General Counsel. The Department of Education shall 24 facilitate a resolution of the dispute between the facility and the resident school district within forty-five days of the notice of dispute. 25 If the issue of reasonable cost differences should remain unresolved, a facility shall have the right to file a complaint in a Circuit 26 Court. Additionally, qualified RTF providers' general education curriculum must be aligned to the South Carolina academic standards in the core content areas. All students with disabilities who are eligible for special education and related services under 27 the Individuals with Disabilities Education Act (IDEA), as amended, and the State Board of Education (SBE) regulations, as 28 amended, shall receive special education and related services in the least restrictive environment by appropriately certified 29 personnel. Students in a qualified RTF will at all times be eligible to receive the educational credits (e.g., Carnegie Units) earned 30 through their educational efforts. The resident school district and the RTF should develop a memorandum of understanding to 31 outline the responsibilities of the RTF in providing the educational services and responsibilities, if any, of the resident school district 32 while the student is housed in the RTF. 33 34 If a child from out of state is placed in a RTF by an out-of-state school district or agency, the child's home state remains responsible

If a child from out of state is placed in a RTF by an out-of-state school district or agency, the child's home state remains responsible for the educational services. The facility school district may choose to provide the educational program to the child and, upon choosing to do so, shall contract with the appropriate entity for payment of educational serviced provided to the child. Out-of-state

students provided educational services by a facility school district shall not be eligible for funding through the Education Finance
 Act.

If a child is placed in a RTF by the child's parent or guardian and is not referred, authorized, or placed by the State, the facility 3 4 school district may choose to provide the educational program to the child, and upon doing so, must negotiate with the resident 5 school district for services through medical homebound procedures. A facility school district is responsible for compliance with all 6 child find requirements under Section 504 of the Rehabilitation Act of 1973 and Individuals with Disabilities Act of 2004 (IDEA). 7 All students enrolled in the facility school districts shall have access to the facility school districts' general education curriculum, 8 which will be tied to the South Carolina academic standards in the core content areas. All students with disabilities who are eligible 9 for special education and related services under the Individuals with IDEA, as amended, and the State Board of Education (SBE) regulations, as amended, shall receive special education and related services in the least restrictive environment by appropriately 10

11 certified personnel. Students in an RTF will at all times be eligible to receive the educational credits (e.g., Carnegie Units) earned

12 through their educational efforts.

With respect to students enrolled in the facility school districts, for accountability purposes, the assessment and accountability measures for students residing in RTFs shall be attributed to a specific school only if the child physically attends the school. The performance of students residing in a RTF who receive their educational program on site at the RTF must be reflected on a separate line on the facility school district's report card and must not be included in the overall performance ratings of the facility school district. The Department of Education shall examine the feasibility of issuing report cards for RTFs. For the current fiscal year, a facility school district shall not have the district's state accreditation rating negatively impacted by deficiencies related to the delivery of an educational program at a RTF.

RTFs shall notify the facility school district as soon as practical, and before admission to the RTF if practical, of a student's admission to the RTF. RTFs, the facility school districts and the Department of Education shall use their best efforts to secure and/or exchange information, including documents and records necessary to provide appropriate educational services and/or related services as necessary to assist the facility school district in determining the resident school district. The Department of Education, in collaboration with state placing agencies, RTFs, facility school districts, and resident school districts, shall implement a system to follow the release of students from a RTF and re-enrollment in public, private, or special schools to ensure these students, when appropriate, are not recorded as dropouts.

1.43. (SDE: Special Schools Flexibility) For the current fiscal year, the special schools are authorized to transfer funds among
 funding categories, including capital funds.

1.44. (SDE: High School Driver Education) For the current fiscal year, the requirement for high schools to provide a course in
 driver education is suspended however, high schools may continue to offer driver education courses if they choose to do so.

1.45. (SDE: Carry Forward Authorization) For the current fiscal year, the Department of Education is authorized to carry forward
 and expend any General Fund balances for school bus transportation.

1.46. (SDE: Administrative Costs Report Posting) School districts must report the amount of funds spent on administrative costs, as defined by In\$ight in the prior fiscal year and post the report on the districts website. School districts shall provide an electronic copy of this report to the Department of Education in conjunction with the financial audit report required by Section 59-17-100, of the 1976 Code. If a district fails to meet these requirements they must be notified in writing by the department that the

(SDE: Governor's Schools Residency Requirement) Of the funds appropriated, the Governor's School for the Arts and the Humanities and the Governor's School for Science and Mathematics are to ensure that a parent(s) or guardian(s) of a student attending either the Governor's School for the Arts and the Humanities or the Governor's School for Science and Mathematics must prove that they are a legal resident of the state of South Carolina at the time of application and must remain so throughout time of attendance. The Governor's School for the Arts and the Humanities and Governor's School for Science and Mathematics may not admit students whose parent(s) or guardian(s) are not legal residents of South Carolina. 1.48. (SDE: Holocaust Funds) Funds appropriated to the Department of Education for the SC Council on Holocaust shall not be used for any other purpose nor transferred to any other program. In addition, in the event the department is required to implement a budget reduction, SC Council on Holocaust funds may not be reduced. 1.49. (SDE: Governor's Schools Capacity) For the current fiscal year, funds appropriated to the Governor's School for the Arts and Humanities and the Governor's School for Science and Mathematics must be used to bring the schools up to full capacity, to the extent possible. Each school must report electronically to the Chairman of the Senate Finance Committee and the Chairman of the House Ways and Means Committee by December first how the funds have been utilized and how many additional students have been served. **1.50.** (SDE: Student Health and Fitness) Funds appropriated for Student Health and Fitness shall be allocated to school districts

district has sixty days to comply with the reporting requirement. If the district does not report within sixty days, the department is

to increase the number of physical education teachers to the extent possible and to provide licensed nurses for elementary public schools. Twenty-seven percent of the funds shall be allocated to the districts based on average daily membership of grades K-5 from the preceding year for physical education teachers. The remaining funds will be made available through a grant program for school nurses and shall be distributed to the school districts on a per school basis. Schools that provide instruction in grades K-5 are eligible to apply for the school nurse grant program funds.

1.51. (SDE: Impute Index Value) For the current fiscal year and for the purposes of calculating the index of taxpaying ability the Department of Revenue shall impute an index value for owner-occupied residential property qualifying for the special four percent assessment ratio by adding the second preceding taxable year total school district reimbursements for Tier 1, 2, and Tier 3(A) and not to include the supplement distribution. The Department of Revenue shall not include sales ratio data in its calculation of the index of taxpaying ability. The methodology for the calculations for the remaining classes of property shall remain as required pursuant to the EFA and other applicable provisions of law.

30 1.52. (SDE: EFA State Share) A school district that does not recognize a State share of the EFA financial requirement shall be
 31 supplemented with an amount equal to seventy percent of the school district with the least State financial requirement.

1.53. (SDE: Health Education) Each school district is required to ensure that all comprehensive health education, reproductive
 health education, and family life education conducted within the district, whether by school district employees or a private entity,
 must utilize curriculum that complies with the provisions contained in Chapter 32, Title 59. *Each district shall publish on its website*

35 the title and publisher of all health education materials it has approved, adopted, and used in the classroom. Any person may

36 complain in a signed, notarized writing to the chairman of the governing board of a school district that matter not in compliance with

the requirements of Chapter 32, Title 59 is being taught in the district. Upon receiving a notarized complaint, the chairman of the 1 2 governing board must ensure that the complaint is immediately investigated and, if the complaint is determined to be founded, that immediate action is taken to correct the violation. If corrective action is not taken, then the district must have its base student cost 3 4 reduced by one percent within 60 days of such a determination, or if no investigation is made within 60 days of the chairman's receipt of the notarized statement, then the complainant may within 60 calendar day, give written notice to the department. The notice must 5 6 include the original notarized complaint. If, upon investigation, the department determines that the district has not taken appropriate immediate action to correct a violation, then the Department of Education is noncompliant with mandated health education, the 7 department shall withhold one percent of the district's funds allocated in Part IA, Section 1, X - Student Health and Fitness Act until 8 the department determines the district is in compliance. If the department determines that a district is non-compliant with mandated 9 health education or if the district fails to publish the title and publisher of materials on its website, then the Department of Education 10 shall withhold one percent of the district's funds allocated in Part IA, Section 1, X - Student Health and Fitness Act until the 11 department determines the district is in compliance. 12 1.54. (SDE: Bus Lease/Purchase) The Department of Education is permitted to purchase or lease school buses in order to 13 continue replacement of the state's school bus fleet. 14 15 1.55. (SDE: Felton Lab Allocation) Of the funds distributed pursuant to the Education Finance Act, the Felton-Laboratory School at South Carolina State University shall receive each year, seventy percent of the funds it would have received for that year 16 under the Education Finance Act and under aid to school districts fringe benefits, as if it were a special school district. The calculation 17 of the amount of funds which the Felton-Laboratory School is entitled to receive each year shall be made by the Department of 18 19 Education. **1.56.** (SDE: Lee County Bus Shop) From the funds appropriated in program VII.B. Bus Shops, in the current fiscal year, the 20 department must fund the Lee County School District Bus Shop and the Kershaw County School District Bus Shop at the same level 21 as they were funded in the previous fiscal year. 22 23 **1.57.** (SDE: School Enrollment Policy) For the current fiscal year, any school district with an open enrollment policy for all schools or certain schools which had previously accepted certain students residing outside of the district to an academic magnet 24 25 school in the district must continue to accept these students and their siblings for enrollment at the academic magnet school under 26 the same terms and conditions these students were previously permitted to attend the school. 1.58. (SDE: District Funding Flexibility) For the current fiscal year, districts must utilize funding flexibility provided herein to 27 28 ensure that district approved safety precautions are in place at every school. 29 1.59. (SDE: Transportation Maintenance Facilities) For the current fiscal year, a school district wishing to include school bus maintenance in a contract with a private vendor may enter into an agreement with the Department of Education whereby the 30 31 department releases the school district to include school bus maintenance in the private vendor contract. **1.60.** (SDE: School District Activity Bus Advertisements) School Districts may sell commercial advertising space on the outside 32 or inside of district owned activity buses. However, as defined and determined by the local school board, a school district may not 33 34 sell such commercial advertising if the advertisement promotes a political candidate, ideology, or cause, a product that could be harmful to children, or a product that appeals to the prurient interest. Revenue generated from the sale of commercial advertising 35 space shall be retained by the school district. 36

1.61. (SDE: School District Property) The requirements of Section 59-19-250 of the 1976 Code, as amended, which requires the consent of a governing board of a county in order for school trustees to sell or lease school property whenever they deem it expedient to do so are suspended for the current fiscal year.

1.62. (SDE: Full-Day 4K) For the current school year, eligible Eligible students residing in a school district with a poverty index 4 5 of seventy percent or greater may participate that met the poverty level for participation in the prior school year are eligible to participate in the South Carolina Early Reading Development and Education Program in the current school year. Public and private 6 7 providers will be reimbursed for instructional costs at a rate of $\frac{4.218}{4.323}$ per student enrolled. Eligible students enrolling during 8 the school year or withdrawing during the school year shall be funded on a pro rata basis determined by the length of their enrollment. Private providers transporting eligible children to and from school shall also be eligible for a reimbursement of \$550 per eligible 9 child transported. All providers who are reimbursed are required to retain records as required by their fiscal agent. New providers 10 participating for the first time in the current fiscal year and enrolling between one and six eligible children shall be eligible to receive 11 up to \$1,000 per child in materials and equipment funding, with providers enrolling seven or more such children eligible for funding 12 not to exceed \$10,000. Providers receiving equipment funding are expected to participate in the program and provide high-quality, 13 center-based programs as defined herein for a minimum of three years. Failure to participate for three years will require the provider 14 to return a portion of the equipment allocation at a level determined by the Department of Education and the Office of First Steps to 15 School Readiness. Funding to providers is contingent upon receipt of data as requested by the Department of Education and the 16 17 Office of First Steps. Of the funds appropriated, \$300,000 shall be allocated to the Education Oversight Committee to conduct an annual evaluation of 18

the South Carolina Child Development Education Pilot Program and to issue findings in a report to the General Assembly by January 19 fifteenth of each year. To aid in this evaluation, the Education Oversight Committee shall determine the data necessary and both 20 public and private providers are required to submit the necessary data as a condition of continued participation in and funding of the 21 program. This data shall include developmentally appropriate measures of student progress. Additionally, the Department of 22 23 Education shall issue a unique student identifier for each child receiving services from a private provider. The Department of Education shall be responsible for the collection and maintenance of data on the public state funded full day and half-day four-year-24 25 old kindergarten programs. The Office of First Steps to School Readiness shall be responsible for the collection and maintenance of data on the state funded programs provided through private providers. The Education Oversight Committee shall use this data and 26 all other collected and maintained data necessary to conduct a research based review of the program's implementation and assessment 27 28 of student success in the early elementary grades.

29 **1.63.** (SDE: Summer Reading Camps) For the current fiscal year, funds appropriated for summer reading camps must be 30 allocated as follows: (1) up to twenty percent to the Department of Education to provide bus transportation for students attending 31 the camps; (2) \$700,000 allocated to the department to provide grants to support community partnerships whereby community organizations would collaborate shall partner with local school districts to provide enrichment activities as part of after school 32 programs or summer reading camps that utilize volunteers, mentors or tutors to provide instructional support to struggling readers in 33 34 elementary schools that have a poverty index of fifty forty percent or greater based on the poverty index utilized the prior fiscal year that was student eligibility for the free or reduced price lunch program and Medicaid. All mentors and tutors that are a part of these 35 after school programs or summer reading camps must have passed a SLED criminal background check. Participant to volunteer or 36

teacher ratio must conform to that of the school district in which the program is located. The Education Oversight Committee will 1 2 document and evaluate the partnerships and the impact of the partnerships on student academic success and make recommendations on the characteristics of effective partnerships and on methods of duplicating effective partnerships throughout the state; and (3) the 3 4 remainder on a per pupil allocation to each school district based on the number of students who substantially failed to demonstrate 5 third-grade reading proficiency as indicated on the prior year's state assessment as defined by Section 59-155-120 (10) of the 1976 6 Code. Summer reading camps must be at least six weeks in duration with a minimum of four days of instruction per week and four 7 hours of instruction per day, or the equivalent minimum hours of instruction in the summer. School transportation shall be provided. 8 The camps must be taught by compensated teachers who have at least an add-on literacy endorsement or who have documented and demonstrated substantial success in helping students comprehend grade-level texts. The Department of Education shall assist districts 9 that cannot find qualified teachers to work in the summer camps. Districts may also choose to contract for the services of qualified 10 instructors or collaborate with one or more districts to provide a summer reading camp. Schools and school districts are encouraged 11 to partner with county or school libraries, institutions of higher learning, community organizations, faith-based institutions, 12 businesses, pediatric and family practice medical personnel, and other groups to provide volunteers, mentors, tutors, space, or other 13 support to assist with the provision of the summer reading camps. In the current school year, any student in third grade who 14 substantially fails to demonstrate third-grade reading proficiency by the end of the school year must be offered the opportunity to 15 attend a summer reading camp at no cost to the parent or guardian. The purpose of the reading camp is to provide students who are 16 significantly below third-grade reading proficiency with the opportunity to receive quality, intensive instructional services and 17 support. A district may also include in the summer reading camps students who are not exhibiting reading proficiency at any grade 18 and may charge fees for these students to attend the summer reading camps based on a sliding scale pursuant to Section 59-19-90, 19 except where a child is found to be reading below grade level in the first, second or third grade. A parent or guardian of a student 20 who does not substantially demonstrate proficiency in comprehending texts appropriate for his grade level must make the final 21 22 decision regarding the student's participation in the summer reading camp.

1.64. (SDE: Interscholastic Athletic Association Dues) A public school district supported by state funds shall not use any funds or permit any school within the district to use any funds to join, affiliate with, pay dues or fees to, or in any way financially support any interscholastic athletic association, body, or entity unless the constitution, rules, or policies of the association, body, or entity contain the following:

(1) a range of sanctions that may be applied to a student, coach, team, or program and that takes into account factors such as
 the seriousness, frequency, and other relevant factors when there is a violation of the constitution, bylaws, rules, or other governing
 provisions of the association, body, or entity;

(2) (a) guarantees that private or charter schools are afforded the same rights and privileges that are enjoyed by all other
members of the association, body, or entity. A private or charter school may not be expelled from or have its membership
unreasonably withheld by the association, body, or entity or restricted in its ability to participate in interscholastic athletics including,
but not limited to, state playoffs or championships based solely on its status as a private school or charter school. The association,
body, or entity shall set reasonable standards for private or charter school admission. A private or charter school denied membership
must be provided, in writing within five business days, the reason or reasons for rejection of its application for membership;

1 (b) guarantees that a South Carolina home school athletic team that is a member of a home school athletic association 2 may not be denied access to preseason and regular season interscholastic athletics including, but not limited to, jamborees and 3 invitational tournaments, based solely on its status as a home school athletic team; other rules or policies of the association, body, or 4 entity would apply;

5 (3) (a) an appeals process in which appeals of the association, body, or entity are made to a disinterested third-body appellate 6 panel which consists of seven members who serve four year terms, with one person appointed by the delegation of each congressional 7 district;

8 (b) a member of the panel serves until his successor is appointed and qualifies. A vacancy on the panel is filled in the 9 manner of the original appointment;

10 (c) members of the appellate panel do not concurrently serve as officers of the association, body, or entity and may not 11 have served as a member of the executive committee within the last three years. Principals and superintendents are able to appeal a 12 ruling of the association, body, or entity to the panel. The appellate panel also must provide the final ruling in any appeal brought 13 against a decision of the association, body, or entity;

14 (4) a procedure in place for emergency appeals to be held and decided upon in an expedited manner if the normal appellate 15 process would prohibit the participation of a student, team, program, or school in an athletic event, to include practices;

16 (5) provisions, implemented within one year after the effective date of this section, that require the composition of the executive 17 committee of the association, body, or entity be geographically representative of this State.

In the event an association, body, or entity fails to include one of the items listed in this proviso, public school districts and schools must end their affiliation with the association, body, or entity prior to the beginning of the upcoming school year and are prohibited from paying dues or fees to the association, body, or entity.

1.65. (SDE: Governor's Schools Informational Access to Students) For the current fiscal year, school districts must permit both 21 the Governor's School for the Arts and Humanities and the Governor's School for Science and Mathematics to collaborate with 22 23 individual schools and their staff to share information with students and families about the educational opportunities offered at the respective Governor's Schools, through avenues including school visits, informational presentations, and posters. By June 30, 2015 24 25 of the current fiscal year, the Governor's School for the Arts and Humanities and the Governor's School for Science and Mathematics must report to the Chairman of the Senate Finance Committee and the Chairman of the House Ways and Means Committee the 26 27 results of these Informational Access efforts. Further, the two Governor's Schools will work with districts, the Department of 28 Education and School Report Card administrators, to ensure that SAT scores of current Governor's Schools' students are included 29 in the School Report Card of those students' resident schools and districts.

30 1.66. (SDE: Reading/*Literacy* Coaches) (A) Funds appropriated for Reading/*Literacy* Coaches must be allocated to school
 31 districts by the Department of Education as follows:

32 (1) for each elementary school in which twenty percent or more of the students scored Not Met <u>below proficient</u> on the reading 33 and research test in the most recent year for which such data are available, the school district shall be eligible to receive the lesser of 34 either up to \$62,730 or the actual cost of salary and benefits for a full-time reading<u>/literacy</u> coach; and

35 (2) for each elementary school in which fewer than twenty percent of the students scored <u>Not Met *below proficient*</u> on the 36 reading and research test during the same period, the school district shall be eligible to receive the lesser of either up to \$31,365 or

fifty percent of the actual cost of salary and benefits for a full-time reading/literacy coach. A school district must provide local 1 2 support for state funds provided under this paragraph. School districts may use existing local funds currently used for reading assistance as the local support. 3 4 (B) By accepting these funds, a school district warrants that they will not be used to supplant existing school district expenditures, 5 except for districts that either are currently, or in the prior fiscal year, were paying for reading/literacy coaches with local funds. A district may, however, assign a reading/literacy coach to a primary school rather than to the elementary school to improve the early 6 7 literacy skills of young children. 8 (C) Funds appropriated for Reading/Literacy Coaches are intended to be used to provide elementary schools with reading/literacy coaches, who shall serve as job-embedded, stable resources for professional development throughout schools in order to generate 9 improvement in reading and literacy instruction and student achievement who shall serve according to the provisions in Chapter 155 10 of Title 59. Reading coaches shall support and provide initial and ongoing professional development to teachers based on an analysis 11 of student assessment and the provision of differentiated instruction and intensive intervention. The reading coach shall: 12 (1) model effective instructional strategies for teachers by working weekly with students in whole, and small groups, or 13 individually; 14 15 (2) facilitate study groups; (3) train teachers in data analysis and using data to differentiated instruction; 16 (4) coaching and mentoring colleagues; 17 (5) work with teachers to ensure that research-based reading programs are implemented with fidelity; 18 (6) work with all teachers (including content area and elective areas) at the school they serve, and help prioritize time for those 19 teachers, activities, and roles that will have the greatest impact on student achievement, namely coaching and mentoring in the 20 21 classrooms; 22 (7) help lead and support reading leadership teams; and-23 (8) The reading coach must not be assigned a regular classroom teaching assignment, must not serve an as administrator, must not perform administrative functions that deter from the flow of improving reading instruction and reading performance of students, 24 25 and must not devote a significant portion of his or her time to administering or coordinating assessments. 26 (D) Schools and districts accepting funding to support a coaching position agree that the reading/literacy coach must not serve as an administrator. If the department finds that school districts are using these funds for administrative costs as defined in statute 27 28 they must withhold that districts remaining balance of funds allocated pursuant to this proviso. (DE) No later than February 1, 2016, the The Department of Education must publish guidelines that define the minimum 29 qualifications for a reading/literacy coach for Fiscal Year 2015-16. These guidelines must deem any licensed/certified teacher 30 qualified if, at a minimum, he or she: 31 (1) holds a bachelor's degree or higher and an add-on endorsement for literacy coach or literacy specialist, or 32 (2) holds a bachelor's degree or higher and is actively pursuing the literacy coach or literacy specialist endorsement; or 33 34 (3) holds a master's degree or higher in reading or a closely-related field. Within these guidelines, the Department of Education must also establish a process for Fiscal Year 2015-16 through which an 35 elementary school may be permitted to use some or all of the allocation granted under subsection (A) in order to obtain in-school 36

reading coaching services from a department approved consultant or vendor, assist districts in identifying a reading/literacy coach 1

2 in the event that the school is not successful in identifying and directly employing a qualified candidate. The provisions of subsection

(A), including the local support requirements, shall also apply to any allocations made pursuant to this paragraph. 3

4 (E F) The Department of Education must develop procedures for monitoring the use of funds appropriated for Reading Coaches 5 reading/literacy coaches to ensure they are applied to their intended uses and are not redirected for other purposes. The Department 6 of Education may receive up to \$100,000 of the funds appropriated for Reading Coaches reading/literacy coaches in order to

7 implement this program, provided that this allocation does not exceed the department's actual costs.

8 (F G) Prior to the close of the current fiscal year, any remaining <u>unspent or unallocated</u> funds for Reading Coaches, reading/literacy coaches but no more than \$5,000,000, shall be distributed by the Department of Education among the school districts 9 containing elementary or primary schools that were eligible for and which elected to receive funding under subsection (A)(1) of this 10 proviso; these funds shall be distributed in proportion to these districts' relative shares of students who scored Not Met on the research 11 and reading test in the most recent year for which such data are available used to fund Summer Reading Camps. Funds distributed 12 under this subsection must be used exclusively to support reading related professional development opportunities for teachers that 13 lead to the literacy add-on endorsement. 14

15 (GH) The Department of Education shall require:

(1) any school district receiving funding under subsection (A) to identify the name and qualifications of the supported 16 reading/literacy coach; as well as the school in which the coach is assigned along with the rationale for how the school selection was 17 18 made: and 19

(2) any school district receiving funding under subsection (F G) to account for the specific amounts and uses of such funds.

(H) With the data reported by the school districts, the department shall report by January fifteenth of the current fiscal year on 20 the hiring of and assignment of reading/ literacy coaches by school and on the expenditure of professional development funds for 21 opportunities for teachers to earn the literacy endorsement. The department shall also report the amount of funds that will be carried 22 23 forward used for Summer Reading Camps.

(IJ) Funds appropriated for Reading Coaches reading/literacy coaches shall be retained and carried forward to be used for the 24 same purpose but may not be flexed. 25

26 (JK) For Fiscal Year 2015-16 2016-17, if increased funding for reading/literacy coaches is not sufficient to provide additional reading/literacy coaches at each elementary school then the funding must be targeted to the areas of greatest need based on the 27 28 number of students substantially failing to demonstrate reading proficiency as indicated on the prior year's state assessment.

29 1.67. (SDE: Charter School Transition Funds) For Fiscal Year 2015-16, charter schools sponsored by a local school district must receive transition funds from the local district or statewide transition funds available in an amount equal to any reduction in 30 funds received by the school due to the changes in the Education Finance Act formula. In order to receive funds from the statewide 31

32 transition funds, the charter school must report the amount of funds required to the department through the authorizing district. The

department shall allocate the transition funds to the district which then shall allocate the funds to the school. If the amount of 33

transition funds for the charter schools exceeds transition funds available, then funds will be reduced pro rata for all parties. 34

1.68. (SDE: Sports Participation) Any school receiving state funds shall be required to allow a military dependent student who 35 has transferred from their resident school district to another school district to participate in a sport that was not offered in the resident 36

school district. Should a school fail to comply with this provision, the Department of Education shall withhold one percent of their
 total state allocation.

1.69. (SDE: Graduation Rates) For the current fiscal year, if a high school has a graduation rate below sixty percent, using appropriated funds a local school district board of trustees must provide a report detailing a plan to increase the graduation rate in accordance with the provisions of the Education Accountability Act to the State Board of Education.

6 1.70. (SDE: South Carolina Community Block Grants for Education Pilot Program) There is created the South Carolina
 7 Community Block Grants for Education Pilot Program. The purpose of this matching grants program is to encourage and sustain
 8 partnerships between a community and its local public school district or school for the implementation of innovative, state-of-the-art
 9 education initiatives and models to improve student learning. The initiatives and models funded by the grant must be well designed,
 10 based on strong evidence of effectiveness, and have a history of improved student performance.

The General Assembly finds that the success offered by these initiatives and programs is assured best when vigorous community support is integral to their development and implementation. It is the intent of this proviso to encourage public school and district communities and their entrepreneurial public educators to undertake state-of-the-art initiatives to improve student learning and to share the results of these efforts with the state's public education community.

15 As used in this proviso:

(1) "Community" is defined as a group of parents, educators, and individuals from business, faith groups, elected officials,
 nonprofit organizations and others who support the public school district or school in its efforts to provide an outstanding education
 for each child. As applied to the schools impacted within a district or an individual school, "community" includes the school faculty
 and the School Improvement Council as established in Section 59-20-60 of the 1976 Code;

20 (2) "Poverty" is defined as the percent of students eligible in the prior year for the free and reduced price lunch program and 21 or Medicaid; and

(3) "Achievement" is as established by the Education Oversight Committee for the report card ratings developed pursuant to
 Section 59-18-900 of the 1976 Code.

The Executive Director of the Education Oversight Committee is directed to appoint an independent grants committee to develop the process for awarding the grants including the application procedure, selection process, and matching grant formula. The grants committee will be comprised of seven members, three members selected from the education community and four members from the business community. The chairman of the committee will be selected by the committee members at the first meeting of the grants committee. The grants committee will review and select the recipients of the Community Block Grants for Education.

29 The criteria for awarding the grants must include, but are not limited to:

30 (1) the establishment and continuation of a robust community advisory committee to leverage funding, expertise, and other 31 resources to assist the district or school throughout the implementation of the initiatives funded through the Block Grant Program;

(2) a demonstrated ability to meet the match throughout the granting period;

(3) a demonstrated ability to implement the initiative or model as set forth in the application; and

(4) an explanation of the manner in which the initiative supports the district's or school's strategic plan required by Section
 59-18-1310 of the 1976 Code.

36 In addition, the district or school, with input from the community advisory committee, must include:

(1) a comprehensive plan to examine delivery implementation and measure impact of the model;

(2) a report on implementation problems and successes and impact of the innovation or model; and

(3) evidence of support for the project from the school district administration when an individual school applies for a grant.

The match required from a grant recipient is based on the poverty of the district or school. No matching amount will exceed more than seventy percent of the grant request or be less than ten percent of the request. The required match may be met by funds or by in-kind donations, such as technology, to be further defined by the grants committee. Public school districts and schools that have high poverty and low achievement will receive priority for grants when their applications are judged to meet the criteria established

8 for the grant program.

9 However, no grant may exceed \$250,000 annually unless the grants committee finds that exceptional circumstances warrant 10 exceeding this amount.

11 The Education Oversight Committee will review the grantee reports and examine the implementation of the initiatives and models

12 to understand the delivery of services and any contextual factors. The Oversight Committee will then highlight the accomplishments

13 and common challenges of the initiatives and models funded by the Community Block Grant for Education Pilot Program to share

14 the lessons learned with the state's public education community.

For the current fiscal year, funds allocated to the Community Block Grant for Education Pilot Program must be used to provide or expand high-quality early childhood programs for a targeted population of at-risk four-year-olds. High-quality is defined as meeting

the minimum program requirements of the Child Early Reading Development and Education Program and providing measurable high-quality child-teacher interactions, curricula and instruction. Priority will be given to applications that involve public-private

high-quality child-teacher interactions, curricula and instruction. Priority will be given to applications that involve public-private partnerships between school districts, schools, Head Start, and private child care providers who collaborate to: (1) provide high-

quality programs to four-year-olds to maximize the return on investment; (2) assist in making the transition to kindergarten; (3)

20 quarty programs to rour-year-olds to maximize the return on investment, (2) assist in making the transition to kindergaten, (3) 21 improve the early literacy, *social and emotional*, and numeracy readiness of children; and (4) engage families in improving their

children's readiness.

1.71. (SDE: Board of Education Funds) For the current fiscal year, the Department of Education is authorized to carry forward
 funds appropriated in Part IA, Section 1, II. Board of Education. The State Board of Education is permitted to utilize these funds for
 innovative educational opportunities and projects. The Board of Education shall develop guidelines and publish them on the board's
 website.

1.72. (SDE: Proceeds from Sale of Bus Shop & Boat) For the current fiscal year the Department of Education is authorized to
 retain any funds received from the sale of any bus shop and the sale of the state- owned boat and expend those funds for transportation
 purposes.

30 **1.73.** (SDE: Transition Funds to Districts) Funds appropriated in Part IA, Section 1, X. Aid to School Districts, A. Aid to School

31 Districts, EFA Transition Payments, are to be distributed to school districts eligible to receive transition funds. The funds will be

32 disbursed in an amount equal to the net aggregate decrease in funding realized by a district as a result of changes to the EFA funding 33 formula

33 formula.

34 (A) Districts eligible for transition payments in the prior fiscal year are eligible to receive one-half of the transition payment
 35 received in Fiscal Year 2014-15, subject to the limitations of item (B) of this section.

(B) School districts are not eligible to receive transition funds for the portion of a net funding decrease resulting from a decrease
 in district ADM from the prior to the current fiscal year.

Funds appropriated for the purchase of textbooks and other instructional materials may be used for reimbursing school districts to offset the costs of refurbishing science kits on the state-adopted 29 textbook inventory, purchasing new kits from the central textbook depository, or a combination of refurbishment and purchase. The 30 31 refurbishing cost of kits may not exceed the cost of the state-adopted refurbishing kits plus a reasonable amount for shipping and handling. (SDE: Health Education Materials) From the funds allocated to each school district, each district shall publish on its 3 4 website the title and publisher of all health education materials it has approved, adopted, and used in the classroom. If the Department 5 of Education determines that a school district is noncompliant with mandated health education, the department shall withhold one 6 percent of the district's funds allocated in Part 1A. Section 1. X. - Student Health and Fitness Act until the department determines the 7 district is in compliance. 8 **1.84.** (SDE: Data Maintenance and Collection) For the current fiscal year and from the funds appropriated to the department for the collection and maintenance of data, personally identifiable information of teacher candidates and teachers collected and 9 maintained by the Department of Education shall be treated as personnel records and shall not be subject to public disclosure. 10 **1.85.** (SDE: Teacher Employment) Of the funds appropriated in the current fiscal year, a local school district superintendent or 11 his designee shall provide a teacher with notice of dismissal and an opportunity for a hearing before the local board or its designee. 12 Further, a local board may authorize a South Carolina licensed, practicing attorney to serve as hearing officer to conduct a hearing 13 on the matter and make a report of its recommendations to the board within forty-five days after receipt of notice of appeal. A 14 15 hearing officer may not be a member of the board or an employee of the district. If the board designates a hearing officer, the report and recommendations of the hearing officer must be presented to the board in the form of a written order. In considering the report 16 and recommendations, the board must have available to it the exhibits presented at the hearing and shall permit limited oral argument 17 on behalf of the district and the teacher, allowing each party thirty minutes to present its respective argument. The board shall uphold 18 the decision of the hearing officer if the evidence shows good and just cause for dismissal. The board shall issue a decision affirming 19 or withdrawing the notice of suspension or dismissal within thirty days. The decision of the board may be appealed to the circuit 20 21 court. **1.86.** (SDE: Educational Credit for Exceptional Needs Children) (A) As used in this proviso: 22 23 (1) "Eligible school" means an independent school including those religious in nature, other than a public school, at which 24 the compulsory attendance requirements of Section 59-65-10 may be met, that: 25 (a) offers a general education to primary or secondary school students; 26 (b) does not discriminate on the basis of race, color, or national origin; 27 (c) is located in this State; 28 (d) has an educational curriculum that includes courses set forth in the state's diploma requirements, graduation 29 certificate requirements (for special needs children), and where the students attending are administered national achievement or state 30 standardized tests, or both, at progressive grade levels to determine student progress; 31 (e) has school facilities that are subject to applicable federal, state, and local laws; and 32 (f) is a member in good standing of the Southern Association of Colleges and Schools, the South Carolina Association of Christian Schools, or the South Carolina Independent Schools Association-; and 33 (g) provides a specially designed program or learning resource center to provide needed accommodations based on 34 the needs of exceptional needs students or provides onsite educational services or supports to meet the needs of exceptional needs 35 students, or is a school specifically existing to meet the needs of only exceptional needs students with documented disabilities. 36

(2) "Exceptional needs child" means a child: 1 2 (a) (i) who has been evaluated in accordance with this state's evaluation criteria, as set forth in S.C. Code Ann. Regs. 3 43-243.1, and determined eligible as a child with a disability who needs special education and related services, in accordance with 4 the requirements of Section 300.8 of the Individuals with Disabilities Education Act: or (b) (ii) who has been diagnosed within the last three years by a licensed speech-language pathologist, psychiatrist, or 5 medical, mental health, psychoeducational, or other comparable licensed health care provider as having a neurodevelopmental 6 disorder, a substantial sensory or physical impairment such as deaf, blind, or orthopedic disability, or some other disability or acute 7 or chronic condition that significantly impedes the student's ability to learn and succeed in school without specialized instructional 8 and associated supports and services tailored to the child's unique needs; and . 9 (b) the child's parents or legal guardian believes that the services provided by the school district of legal residence do 10 not sufficiently meet the needs of the child. 11 (3) "Independent school" means a school, other than a public school, at which the compulsory attendance requirements of 12 Section 59-65-10 may be met and that does not discriminate based on the grounds of race, color, religion, or national origin. 13 (4) "Nonprofit scholarship funding organization" means a charitable organization that: 14 15 (a) is exempt from federal tax pursuant to Section 501(a) of the Internal Revenue Code by being listed as an exempt organization in Section 501(c)(3) of the code; 16 (b) allocates, after its first year of operation, at least ninety-seven percent of its annual contributions and gross revenue 17 received during a particular year to provide grants for tuition to children enrolled in an eligible school meeting the criteria of this 18 proviso, and incurs administrative expenses annually, after its first year of operation, of not more than three percent nor more than 19 \$200,000 in the aggregate, whichever is less, of its annual contributions and revenue for a particular year to cover operational costs; 20 21 (c) allocates all of its funds used for grants on an annual basis to children who are exceptional needs students; (d) does not provide grants solely for the benefit of one school, and if the department determines that the nonprofit 22 scholarship funding organization is providing grants to one particular school, the tax credit allowed by this proviso may be 23 24 disallowed; 25 (e) does not have as a volunteer, contractor, consultant, fundraiser or member of its governing board any parent, legal 26 guardian, or member of their immediate family who has a child or ward who is currently receiving or has received a scholarship grant authorized by this proviso from the organization within one year of the date the parent, legal guardian, or member of their 27 28 immediate family became a board member; 29 (f) does not have as a member of its governing board or an employee, volunteer, contractor, consultant, or fundraiser 30 who has been convicted of a felony; 31 (g) does not release personally identifiable information pertaining to students or donors or use information collected about donors, students or schools for financial gain; and 32 (h) must not place conditions on schools enrolling students receiving scholarships to limit the ability of the schools to 33 34 enroll students accepting grants from other nonprofit scholarship funding organizations. 35 (5) "Parent" means the natural or adoptive parent or legal guardian of a child. (6) "Person" means an individual, partnership, corporation, or other similar entity. 36

1 (7) "Qualifying student" means a student who is an exceptional needs child, a South Carolina resident, and who is eligible 2 to be enrolled in a South Carolina secondary or elementary public school at the kindergarten or later year level for the applicable 3 school year.

- (8) "Resident public school district" means the public school district in which a student resides.
 (9) "Transportation" means transportation to and from school only.
- 6 7

(10) "Tuition" means the total amount of money charged for the cost of a qualifying student to attend an independent school including, but not limited to, fees for attending the school, textbook fees, and school-related transportation.

(11) "Department" means the Department of Revenue.

9 (B) (1) A person is entitled to a tax credit against income taxes imposed pursuant to Chapter 6, Title 12, or bank taxes imposed 10 pursuant to Chapter 11, Title 12 for the amount of cash and the monetary value of any publicly traded securities the person contributes 11 to a nonprofit scholarship funding organization up to the limits of this proviso if:

12 (a) the contribution is used to provide grants for tuition to exceptional needs children enrolled in eligible schools who 13 qualify for these grants under the provisions of this proviso; and

(b) the person does not designate a specific child or school as the beneficiary of the contribution.

12 (E) A corporation or entity entitled to a credit under subsection (B) may not convey, assign, or transfer the credit authorized by 13 this proviso to another entity unless all of the assets of the entity are conveyed, assigned, or transferred in the same transaction.

(F) Except as otherwise provided, neither the Department of Education, the Department of Revenue, <u>the Education Oversight</u>
 <u>Committee</u>, nor any other state agency may regulate the educational program of an independent school that accepts students receiving
 scholarship grants pursuant to this proviso.

(G) (1) By August 1, 2015, each independent school must apply to the Education Oversight Committee to be considered an 17 eligible institution for which it may receive contributions from a nonprofit scholarship funding organization for which the tax credit 18 allowed by this proviso is allowed. The Education Oversight Committee, as established in Chapter 6, Title 59, is responsible for 19 determining *annually* if an eligible school meets the criteria established by subsection (A)(1), and shall publish an approved list of 20 such schools meeting the criteria maintain on its website a list of schools approved for participation in the program. (2) An independent school's application for consideration as an eligible institution must contain: 1 2 (a) the number and total amount of grants received from each nonprofit scholarship funding organization in the 3 preceding fiscal year: 4 (b) student test scores, by category, on national achievement or state standardized tests, or both, for all grades tested 5 and administered by the school receiving or entitled to receive scholarship grants pursuant to this proviso in the previous fiscal year; (c) a copy of a compilation, review, or compliance audit of the organization's financial statements, conducted by a 6 7 certified public accounting firm; and 8 (d) a certification by the independent school that it meets the definition of an eligible school as that term is defined in subsection (A)(1) and that the report is true, accurate, and complete under penalty of perjury in accordance with Section 16-9-10. 9 (3) Any independent school not determined to be an eligible school pursuant to the provisions of this proviso may seek 10 review by filing a request for a contested case hearing with the Administrative Law Court in accordance with the court's rules of 11 procedure. 12 (4) The Education Oversight Committee, after consultation with its nine-member advisory committee, may exempt an 13 independent school having students with exceptional needs who receive scholarship grants pursuant to this proviso from the 14 15 curriculum requirements of subsection (A)(1)(d). (H) (1) By August first of each year, each nonprofit scholarship funding organization must apply to the department to be 16 considered an eligible organization for which its contributors are allowed the tax credit allowed by this proviso. If a nonprofit 17 scholarship funding organization does not apply, the organization may not be published as an approved organization, and 18 contributions to that organization shall not be allowed for purposes of the credit allowed by this proviso. A nonprofit scholarship 19 20 funding organization's application must contain: 21 (a) the number and total amount of grants issued to eligible schools in the preceding fiscal year; (b) for each grant issued to an eligible school in the preceding fiscal year, the identity of the school and the amount of 22 23 the grant; (c) an itemization and detailed explanation of any fees or other revenues obtained from or on behalf of any eligible 24 25 schools; 26 (d) a copy of the organization's Form 990 or other comparable federal submission that indicates the provisions of the Internal Revenue Code under which the organization has been granted exempt status for purposes of federal taxation; 27 28 (e) a copy of a compilation, review, or audit of the organization's financial statements, conducted by a certified public 29 accounting firm; 30 (f) the criteria and eligibility requirements for scholarship awards; and (g) a certification by the organization that it meets the definition of a nonprofit scholarship funding organization as that 31 term is defined in subsection (A)(4) and that the report is true, accurate, and complete under penalty of perjury in accordance with 32 Section 16-9-10. 33 34 (2) By receiving the application materials and approving the organization as an eligible organization pursuant to item (1), the department is not determining that the organization meets all of the requirements of a qualified nonprofit scholarship funding 35 organization and the organization remains subject to examination as provided for pursuant to subsection (I). 36

1 (3) The department has authority to disclose the names of qualifying nonprofit scholarship funding organizations to the 2 Education Oversight Committee. The department also may disclose to the Education Oversight Committee the names of 3 organizations that applied but were not qualified by the department and those organizations whose eligibility has been revoked in 4 accordance with subsection (I)(2), as well as the reason the application of the organization was not accepted or the reason its 5 qualification was revoked.

6 (4) By September first of each year, the Education Oversight Committee must publish on its website a list of all qualifying 7 nonprofit scholarship funding organizations, provided by the department, to include their names, addresses, telephone numbers, and, 8 if available, website addresses. Also, the results of the audit required by item (1)(e) must be published with the list.

9 (I) (1) The department has authority to oversee, audit, and examine the nonprofit scholarship funding organizations, including 10 determining whether the nonprofit scholarship funding organization is being operated in a manner consistent with the requirements 11 for an IRC Section 501(c)(3) organization or is in compliance with any other provision of this proviso.

12 (2) (a) If at any time during the year, the department has evidence, through audit or otherwise, that a nonprofit scholarship 13 funding organization is not being operated in a manner consistent with the requirements for operating an IRC Section 501(c)(3) 14 organization or is not in compliance with any other provision of this proviso, the department immediately may revoke the 15 organization's participation in the program and must notify the organization and the Education Oversight Committee in writing of 16 the revocation.

17 (b) Notice of revocation may be provided to the organization by personal delivery to the organization, by first class 18 mail to the last known address of the organization, or by other means reasonably designed to provide notice to the organization.

(c) Any donations made following the date the notice of revocation is received by the organization or in the case of delivery by mail ten days after the notice of revocation was mailed, will not qualify for the credit and the donated funds must be returned to the donor by the organization. This proviso shall not limit the department's authority to deny any tax credit or other benefit provided by this proviso if the circumstances warrant.

23 (d) (i) Within thirty days after the day on which the organization is notified of the revocation, the organization may 24 request a contested hearing before the Administrative Law Court. Within thirty days after a request for a contested case hearing is 25 received by the Administrative Law Court, an administrative law judge shall hold the contested case hearing and determine whether 26 the revocation was reasonable under the circumstances. The department has the burden of proof of showing that the revocation was reasonable under the circumstances. 1 2 3	(iii) If the administrative law judge determines that immediate revocation is not reasonable, the revocation shall be lifted and the organization may resume accepting donations and award scholarships hereunder. The department may still issue a department determination in accordance with Section $12-60-450(E)(2)$.

10	especially in the event that the organization cannot distribute the funds in a timely manner or if the organization ceases to exist. None
11	of the funds that are transferred by one nonprofit scholarship funding organization to another may be considered by the former
12	organization when calculating its administrative expenses.
13	1.87. (SDE: Moving Cost Study) The department shall report to the Chairman of the Senate Finance Committee, the Chairman
14	of the House Ways and Means Committee, and the Department of Administration no later than September 1, 2016, on the costs
15	associated with relocating the Department of Education from the Rutledge building to a different location.
16	1.88. (SDE: Technology Technical Assistance) Funds appropriated to the Department of Education for Technology Technical
17	Assistance must be used to increase the capacity of districts who are or were the original trial and plaintiff school districts in the
18	Abbeville law suit. Funds shall be used by the department to assist school districts in procuring appropriate technology to include
19	devices and infrastructure in accordance with the recommendations made by the technology review team to begin to build capacity
20	to offer online testing and increased access. For the current fiscal year districts may request a waiver from the State Board of
21	Education from the requirement that all assessments be administered online.
22	<u>1.89. (SDE: College Readiness Assessment)</u> DELETED
23	1.90. (SDE-Highly Qualified Teachers) For the current fiscal year teacher certification requirements for highly qualified
24	educators aligned to No Child Left Behind shall be suspended. The department shall report to the General Assembly by February 1
25	on the updated Federal requirements under the Every Student Succeeds Act.
26	1.91. (SDE: Teacher Salaries Increase) For Fiscal Year 2016-17, the Department of Education is directed to increase the
27	statewide salary schedule by two percent. A local school district board of trustees must provide all certified teachers paid on the
28	teacher salary schedule a two percent salary increase. Districts are to provide this increase using the district salary schedule utilized
29	the prior fiscal year as its base. School districts shall utilize the additional funds made available from the Education Finance Act
30	appropriation to provide one percent of the required two percent increase.
31	Additionally, for the current fiscal year, a local school district board of trustees must increase the salary compensation for all

The Efficiency 8 Studies shall include, at a minimum: (1) overhead; (2) human resources; (3) procurement; (4) financial management; and (5) 9 transportation and must be aligned to any diagnostic review that may be conducted in the district to avoid duplication. The 10 Assessments and Studies shall be first conducted in school districts which are or were the Abbeville Plaintiff District and prioritized 11 according to the prior year poverty index and for districts that have not had an efficiency study or facility assessment completed in 12 the last two years. The completed Assessments and Studies shall be provided to each local school board of trustees and shall inform 13 funding decisions for facilities and potential school or district consolidation. The department shall make the Assessments and the 14 15 Studies available on the department website. 1.93. (SDE: Assistance Funding) For the current fiscal year, any funds appropriated to the Department of Education to assist 16 districts that are or were Plaintiffs in the Abbeville law suit and funding appropriated to the department to provide technical 17 assistance to underperforming districts may not be transferred to any other program, are not subject to flexibility, and may be carried 18 forward and expended for the same purposes. 19 1.94. (SDE: Reporting and Procurement) Any state agency or school for which the department acts as the fiscal agent must 20 comply with any state and federal reporting requirements using agency procedures and shall follow all state procurement laws. 21 **1.95.** (SDE: Abbeville Equity Districts Comprehensive Report) Of the appropriations and provision of services that are provided 22 23 in the current fiscal year's budget for the Abbeville equity districts, the Department of Education must submit a comprehensive report to the General Assembly by January 1, 2017 on the current allocation of funds to the Abbeville equity districts and the provision of 24 25 services to these districts. 26 27 SECTION 1A - H630 - DEPARTMENT OF EDUCATION-EIA 28 1A.1. (SDE-EIA: Prohibition on Appropriation Transfers) The amounts appropriated herein for aid to subdivisions or allocations 29 to school districts shall not be transferred or reduced and must be expended in accordance with the intent of the appropriation. 30

However, transfers are authorized from allocations to school districts or special line items with projected year-end excess 31 32 appropriations above requirements, to allocations to school districts or special line items with projected deficits in appropriations.

1A.2. (SDE-EIA: African-American History) Funds provided for the development of the African-American History curricula 33 34 may be carried forward into the current fiscal year. Funds that are currently a salary line item will be reallocated for the development

of instructional materials and programs and the implementation of professional learning opportunities that promote African 35

American history and culture. For Fiscal Year 2014-15 2016-17 not less than seventy percent of the funds carried forwarded must 36

1 be expended for the development of additional instructional materials by nonprofit organizations selected through a competitive bids

2 grant process by the Department of Education. Priority must be given to organizations that have already produced materials that are

3 currently being used by schools and outreach programs that reflect African American culture and history and that support literacy
 4 efforts.

5 **1A.3.** (SDE-EIA: Teacher Evaluations, Implementation/Education Oversight) The Department of Education is directed to 6 oversee the evaluation of teachers at the School for the Deaf and the Blind, the John de la Howe School and the Department of 7 Juvenile Justice under the ADEPT model.

1A.4. (SDE-EIA: Teacher Salaries/State Agencies) Each state agency which does not contain a school district but has 8 instructional personnel shall receive an allocation from the line item "Alloc. EIA - Teacher/Other Pay" in Part IA, Section 1, VIII.E. 9 appropriation as recommended by the Education Oversight Committee and funded by the General Assembly for teacher salaries 10 based on the following formula: Each state agency shall receive such funds as are necessary to adjust the pay of all instructional 11 personnel to the appropriate salary provided by the salary schedules of the school district in which the agency is located. Instructional 12 personnel may include all positions which would be eligible for EIA supplements in a public school district, and may at the discretion 13 of the state agency, be defined to cover curriculum development specialists, educational testing psychologists, psychological and 14 guidance counselors, and principals. The twelve-month agricultural teachers located at Clemson University are to be included in this 15 allocation of funds for base salary increases. The South Carolina Governor's School for the Arts and Humanities and the South 16 Carolina Governor's School for Science and Mathematics are authorized to increase the salaries of instructional personnel by an 17 amount equal to the percentage increase given by the School District in which they are both located. 18 The funds appropriated herein in the line item "Alloc. EIA-Teacher/Other Pay" must be distributed to the agencies by the Executive 19 Budget Office. Teacher salary increases recommended by the Education Oversight Committee and funded in this Act shall be 20

21 *incorporated into each agency's EIA appropriation contained in Section 1, VIII.E.*

1A.5. (SDE-EIA: Work-Based Learning) Of the funds appropriated in Part IA, Section 1, VIII.A.1. for the Work-Based Learning 22 23 Program, \$75,000 shall be used by the State Department of Education to provide for regional professional development in contextual methodology techniques and integration of curriculum, and professional development in career guidance for teachers and guidance 24 25 counselors and training mentors. Pilot-site delivery of contextual methodology training in mathematics will be supported by technology and hands-on lab activities. In addition, \$500,000 shall be allocated for Regional Career Specialists. Each Regional 26 Career Specialist shall (1) be housed within the regional centers/WIA geographic areas, (2) provide career development activities 27 28 throughout all schools within the region, (3) be under the program supervision of the Office of Career and Technology Education, State Department of Education, and (4) adhere to an accountability and evaluation plan created by the Office of Career and 29 Technology Education, State Department of Education. The Office of Career and Technology Education, State Department of 30 31 Education, shall provide a report, in February of the current fiscal year to the Senate Finance Committee and the House Ways and Means Committee on accomplishments of the Career Counseling Specialists. Of the funds appropriated in the prior fiscal year, 32 unexpended funds may be carried forward to the current fiscal year and expended for the same purposes. 33

34 1A.6. (SDE-EIA: CHE/Teacher Recruitment) Of the funds appropriated in Part IA, Section 1, VIII.E. for the Teacher 35 Recruitment Program, the South Carolina Commission on Higher Education shall distribute a total of ninety-two percent to the Center 36 for Educator Recruitment, Retention, and Advancement (CERRA-South Carolina) for a state teacher recruitment program, of which

at least seventy-eight percent must be used for the Teaching Fellows Program specifically to provide scholarships for future teachers, 1 2 and of which twenty-two percent must be used for other aspects of the state teacher recruitment program, including the Teacher Cadet Program and \$166,302 which must be used for specific programs to recruit minority teachers: and shall distribute eight percent 3 4 to South Carolina State University to be used only for the operation of a minority teacher recruitment program and therefore shall 5 not be used for the operation of their established general education programs. Working with districts with an absolute rating of At-Risk or Below Average, CERRA will provide shared initiatives to recruit and retain teachers to schools in these districts. CERRA 6 7 will report annually by October first to the Education Oversight Committee and the Department of Education on the success of the 8 recruitment and retention efforts in these schools. The South Carolina Commission on Higher Education shall ensure that all funds 9 are used to promote teacher recruitment on a statewide basis, shall ensure the continued coordination of efforts among the three teacher recruitment projects, shall review the use of funds and shall have prior program and budget approval. The South Carolina 10 State University program, in consultation with the Commission on Higher Education, shall extend beyond the geographic area it 11 12 currently serves. Annually, the Commission on Higher Education shall evaluate the effectiveness of each of the teacher recruitment projects and shall report its findings and its program and budget recommendations to the House and Senate Education Committees, 13 the State Board of Education and the Education Oversight Committee by October first annually, in a format agreed upon by the 14 Education Oversight Committee and the Department of Education. 15 With the funds appropriated CERRA shall also appoint and maintain the South Carolina Teacher Loan Advisory Committee. The 16 Committee shall be composed of one member representing each of the following: (1) Commission on Higher Education; (2) State 17 Board of Education; (3) Education Oversight Committee; (4) Center for Educator Recruitment, Retention, and Advancement; (5) 18 South Carolina Student Loan Corporation; (6) South Carolina Association of Student Financial Aid Administrators; (7) a local school 19 district human resources officer; (8) a public higher education institution with an approved teacher education program; and (9) a 20 private higher education institution with an approved teacher education program. The members of the committee representing the 21 public and private higher education institutions shall rotate among those intuitions and shall serve a two-year term on the committee. 22 23 The committee must be staffed by CERRA, and shall meet at least twice annually. The committee's responsibilities are limited to: 24 (1) establishing goals for the Teacher Loan Program; (2) facilitating communication among the cooperating agencies; (3) advocating 25 for program participants; and (4) recommending policies and procedures necessary to promote and maintain the program. 26 1A.7. (SDE-EIA: Disbursements/Other Entities) Notwithstanding the provisions of Sections 2-7-66 and 11-3-50, South 27 Carolina Code of Laws, it is the intent of the General Assembly that funds appropriated in Part IA, Section 1, VIII.E. Other State 28 Agencies and Entities shall be disbursed on a quarterly basis by the Department of Revenue directly to the state agencies and entities 29 referenced except for the Teacher Loan Program, Centers of Excellence, the Education Oversight Committee and School Technology, which shall receive their full appropriation at the start of the fiscal year from available revenue. The Comptroller General's Office 30 31 is authorized to make necessary appropriation reductions in Part IA, Section 1, VIII.E. to prevent duplicate appropriations. If the Education Improvement Act appropriations in the agency and entity respective sections of the General Appropriations Act at the start 32

of the fiscal year do not agree with the appropriations in Part IA, Section 1, VIII.E. Other State Agencies and Entities, the "other funds" appropriations in the respective agency and entity sections of the General Appropriations Act will be adjusted by the

funds" appropriations in the respective agency and entity sections of the General Appropriations Act will be adjusted by the Comptroller General's Office to conform to the appropriations in Part IA, Section 1, VIII.E. Other State Agencies and Entities.

36 Further, the Department of Revenue is directed to provide the full appropriation of the funding appropriated in Part IA, Section 1,

VIII.C.2. Teacher Supplies to the Department of Education at the start of the fiscal year from available revenue. The Department of 1 2 Revenue is also directed to provide the first quarter appropriation of the funding appropriated in Part IA, Section 1, VIII.G. Charter School District to the Department of Education at the start of the fiscal year from available revenue. 3 4 **1A.8.** (SDE-EIA: Arts in Education) Funds appropriated in Part IA, Section 1, VIII.A.1. Arts Curricula shall be used to support 5 innovative practices in arts education curriculum, instruction, and assessment in the visual and performing arts including dance, 6 music, theatre, and visual arts which incorporates strengths from the Arts in Education sites. They shall also be used to support the 7 advancement of the implementation of the visual and performing arts academic standards. These funds shall be distributed to schools 8 and school districts under a competitive grants program; however, up to thirty-three percent of the total amount of the grant fund shall be made available as "Aid to Other Agencies" to facilitate the funding of professional development arts institutes that have been 9 approved by the State Department of Education for South Carolina arts teachers, appropriate classroom teachers, and administrators. 10 Arts Curricular Grants funds may be retained and carried forward into the current fiscal year to be expended in accordance with the 11 12 proposed award. 1A.9. (SDE-EIA: Teacher Supplies) All certified and non-certified public school teachers identified in PCS, certified special 13 school classroom teachers, certified media specialists, and certified guidance counselors, and career specialists who are employed 14 15 by a school district, or a charter school, or lead teachers employed in a publically funded full day 4K classroom approved by the South Carolina First Steps to School Readiness, as of November thirtieth of the current fiscal year, based on the public decision of 16 the school board may receive reimbursement of up to two hundred seventy-five dollars each school year to offset expenses incurred 17 by them for teaching supplies and materials. Funds shall be disbursed by the department to School districts by July fifteenth based 18 on the last reconciled Professional Certified Staff (PCS) listing from the previous year. With remaining funds for this program, any 19 deviation in the PCS and actual teacher count will be reconciled by December thirty-first or as soon as practicable thereafter. Based 20 on the public decision of the school district these funds shall be disbursed to each teacher via check in a manner separate and distinct 21 from their payroll check on the first day teachers, by contract, are required to be in attendance at school for the current contract year. 22 23 Upon request of the teacher, a school district must give the teacher the option of being reimbursed by a debit card. This 24 reimbursement shall not be considered by the state as taxable income. Special schools include the Governor's School for Science 25 and Math, the Governor's School for the Arts and Humanities, Wil Lou Gray Opportunity School, John de la Howe School, School for the Deaf and the Blind, Felton Lab, Department of Juvenile Justice, and Palmetto Unified School District. Funds distributed to 26 school districts or allocated to schools must not supplant existing supply money paid to teachers from other sources. If a school 27 28 district requires receipts for tax purposes the receipts may not be required before December thirty-first. Districts that do not wish to require receipts may have teachers retain the receipts and certify for the district they have received the allocation for purchase of 29 teaching supplies and/or materials and that they have purchased or will purchase supplies and/or materials during the fiscal year for 30 31 the amount of the allocation. Districts shall not have an audit exception related to non-retention of receipts in any instances where a similar instrument is utilized. Any district requiring receipts must notify any teacher from whom receipts have not been submitted 32 between November twenty-fifth and December sixth that receipts must be submitted to the district. Districts may not add any 33 34 additional requirement not listed herein related to this reimbursement. Any classroom teacher, including a classroom teacher at a South Carolina private school, that is not eligible for the reimbursement 35

allowed by this provision, may claim a refundable income tax credit on the teacher's $\frac{2015}{2016}$ tax return, provided that the return

or any amended return claiming the credit is filed prior to the end of the fiscal year. The credit is equal to two hundred seventy-five 1 2 dollars, or the amount the teacher expends on teacher supplies and materials, whichever is less. If any expenditures eligible for a credit are made after December thirty-first, the teacher may include the expenditures on his initial return or may file an amended 3 2015 2016 return claiming the credit, so long as the return or amended return is filed in this fiscal year. The Department of Revenue 4 5 may require whatever proof it deems necessary to implement the credit provided by this part of this provision. Any person receiving 6 the reimbursement provided by this proviso is ineligible to take the income tax credit allowed by this proviso. 7 **1A.10.** (SDE-EIA: Teacher of the Year Awards) Of the funds provided herein for Teacher of the Year Awards, each district 8 Teacher of the Year shall receive an award of \$1,000. In addition, the State Teacher of the Year shall receive an award of \$25,000, and each of the four Honor Roll Teachers of the Year will receive an award of \$10,000. To be eligible, districts must participate in 9 the State Teacher of the Year Program sponsored by the State Department of Education. These awards shall not be subject to South 10 11 Carolina income taxes. 12 1A.11. (SDE-EIA: EOC) The Education Oversight Committee may collect, retain and expend revenue from conference registration and fees; charges for materials supplied to local school districts or other entities not otherwise mandated to be provided 13 by state law; and from other activities or functions sponsored by the committee including public awareness campaign activities. Any 14 15 unexpended revenue from these sources may be carried forward into the current fiscal year and expended for the same purposes. 1A.12. (SDE-EIA: Technical Assistance) In order to best meet the needs of underperforming schools, funds appropriated for 16 technical assistance must be used to provide intensive support to schools and districts with an absolute rating of below average or at-17 risk on the most recent annual school report card or with the lowest percentages of students meeting state standards on state 18 assessments on the most recent state assessments or with the lowest high school graduation rates must be allocated according to the 19 severity of not meeting report card criteria. The department will create a system of tiers of technical assistance for low-performing 20 schools and districts that will receive technical assistance. The tiers will be determined by factors that include, but are not limited 21 to, length of time performance of the school or district has been at-risk/below average, annual achievement ratings, annual growth 22 ratings, school or district accreditation, and/or financial risk status. The tiers of technical assistance may include a per student 23 24 allocation, placement of a principal mentor, transformation coach, instructional leader, replacement of the principal, reconstitution of a school, and declaration of a state of emergency. Low-performing schools and districts shall be placed within the tiered technical 25 26 assistance framework not later than December 15. Schools receiving an absolute rating of below average or at-risk Low-performing schools shall receive a diagnostic review through 27 the department. In addition, newly identified low-performing schools and districts must be reviewed by an External Review Team 28 in the year of designation, and every third year thereafter. These reports shall be made available on the Department of 29 Education's website; any information pertaining to personnel matters or containing personally identifiable information shall be 30 exempted. Based upon the recommendations in the review(s), low-performing schools and districts must develop and submit to the 31 Department of Education a an updated school renewal or district strategic plan outlining goals for improvements. The amended 32 plans must address specific strategies designed to increase student achievement and must include measures to evaluate the success 33 of implementation of the plan. Of the technical assistance funds allocated to below average or at-risk schools each allocation must 34 address specific strategies designed to increase student achievement and must include measures to evaluate success. The school 35 renewal plan may include expenditures for recruitment incentives for faculty and staff, performance incentives for faculty and staff, 36

assistance with curriculum and test score analysis, professional development activities based on curriculum and test score analysis 1 2 that may include daily stipends if delivered on days outside of required contract days. School expenditures of technical assistance shall be monitored by the Department of Education. 3 4 With the funds appropriated to the Department of Education, and any experts placed in the school or district for technical assistance services, the department will assist low-performing schools and districts with an absolute rating of below average or at-risk in 5 designing and implementing technical assistance school renewal the strategies and measurement identified in the amended plans and 6 7 in brokering for technical assistance personnel as needed and as stipulated in the plan. In addition, the department must monitor 8 student academic achievement and progress on implementation the expenditure of technical assistance funds in schools receiving these funds and report their findings to the General Assembly and the Education Oversight Committee by January first of each fiscal 9 year as the General Assembly may direct Chairman of the Senate Finance Committee, the Chairman of the House Ways and Means 10 Committee, the Chairman of the Senate Education Committee, the Chairman of the House Education and Public Works Committee, 11 the local legislative delegation, and the Governor in the fall following the school or district designation as low-performing. If the 12 Education Oversight Committee or the department requests information from schools or school districts regarding the expenditure 13 of technical assistance funds pursuant to evaluations, the school or school district must provide the evaluation information necessary 14 15 to determine effective use. If the school or school district does not provide the evaluation information necessary to determine effective use, the principal of the school or the district superintendent may be subject to receiving a public reprimand by the State 16 Board of Education if it is determined that those individuals are responsible for the failure to provide the required information. 17 No more than five percent of the total amount appropriated for technical assistance services to schools with an absolute rating of 18 below average or at-risk may be retained and expended Funds must be used by the department for implementation and delivery of 19 20 technical assistance services. Using previous report card data and monitoring reports on the status of implementation of the school 21 renewal plan, the department shall identify priority schools. Up to \$6,000,000 of the total funds Funds appropriated for technical assistance shall be used by the department to work with those schools identified as *low-performing and to support* priority schools 22 23 under the tiered system. These funds shall not be transferred to any other funding category by the school district without prior 24 approval of the State Superintendent of Education and funds are not subject to agency flexibility provisions. The department will create a system of levels of technical assistance for schools that will receive technical assistance funds. The 25 levels will be determined by the severity of not meeting report card criteria. The levels of technical assistance may include a per 26 27 student allocation, placement of a principal mentor, replacement of the principal, and/or reconstitution of a school. 28 Reconstitution means the redesign or reorganization of the school, which includes may include the declaration that all positions in 29 the school are considered vacant. Certified staff currently employed in priority schools must undergo a formal an evaluation in the spring following the school's identification as a priority school and must meet determined goals to be rehired and continue their 30 employment at that school. Student achievement will be considered as a significant factor when determining whether to rehire 31 existing staff. Educators who were employed at a school that is being reconstituted prior to the effective date of this proviso July 32 2009 and to whom the employment and dismissal laws apply will not lose their rights in the reconstitution. If they are not rehired or 33 34 are not assigned to another school in the school district they have the opportunity for a hearing. However, employment and dismissal laws shall not apply to educators who are employed in the district and assigned to the priority schools after the effective date of this 35

36 proviso July 1, 2009, in the event of a reconstitution of the school in which the educator is employed. Those rights are only suspended

in the event of a reconstitution of the entire school staff. Additionally, the rights and requirements of the employment and dismissal 1 2 laws do not apply to educators who are currently on July 1, 2009 were on an induction or annual contract, that subsequently are were offered continuing contract status after the effective date of this proviso, and are employed at a school that is subject to reconstitution 3 4 under this proviso. 5 The reconstitution of a school could take place if the school has been identified as a priority school that has failed to improve 6 satisfactorily. The decision to reconstitute a school shall be made by the State Superintendent of Education in consultation with the 7 principal and/or principal mentor, the school board of trustees, and the district superintendent. The decision to reconstitute a school 8 shall be made by April first, at which time notice shall be given to all employees of the school. The department, in consultation with the principal and district superintendent, shall develop a staffing plan, recruitment and performance bonuses, and a budget for each 9 10 reconstituted school. The State Superintendent of Education may declare a state of emergency in a district if the accreditation status is probation or 11 denied, if a majority of the schools fail to show improvement, if the district is classified as being in "high risk" status financially, or 12 for financial mismanagement resulting in a deficit. The State Superintendent of Education may declare a state of emergency in a 13 school if the accreditation status is probation or denied, or if the school fails to show improvement. Upon declaration of a state of 14 15 emergency, the Superintendent may take over management of the school or district. Management of the school or district may include direct management, consolidation with another district, charter management, public/private management, or contracting 16 with an educational management organization or another school district. 17 Upon approval of the school renewal plans by the department and the State Board of Education, a newly identified school or a 18 currently identified school with an absolute rating of below average or at-risk on the report card will receive a base amount and a per 19 pupil allocation based on the previous year's average daily membership as determined by the annual budget appropriation. No more 20 than fifteen percent of funds not expended in the prior fiscal year may be carried forward and expended in the current fiscal year for 21 strategies outlined in the school's renewal plan. Schools must use technical assistance funds to augment or increase, not to replace 22 23 or supplant local or state revenues that would have been used if the technical assistance funds had not been available. Schools must 24 use technical assistance funds only to supplement, and to the extent practical, increase the level of funds available from other revenue 25 sources. 26 **1A.13.** (SDE-EIA: Proviso Allocations) In the event an official EIA revenue shortfall is declared by the Board of Economic Advisors, the Department of Education may reduce any allocation in Section 1A specifically designated by proviso in accordance 27 28 with the lower Board of Economic Advisors revenue estimate as directed by the Executive Budget Office. No allocation for teacher 29 salaries shall be reduced as a result of this proviso. 1A.14. (SDE-EIA: School Districts and Special Schools Flexibility) All school districts and special schools of this State may 30 transfer and expend funds among appropriated state general fund revenues, Education Improvement Act funds, Education Lottery 31 Act funds, and funds received from the Children's Education Endowment Fund for school facilities and fixed equipment assistance, 32 to ensure the delivery of academic and arts instruction to students. However, a school district may not transfer funds allocated 33 34 specifically for state level maintenance of effort requirements under IDEA, funds allocated specifically for state level maintenance of effort requirement for federal program, funds provided for the Education and Economic Development Act, funds provided for 35 Career and Technology Education, nor required for debt service or bonded indebtedness. All school districts and special schools of 36

this State may suspend professional staffing ratios and expenditure regulations and guidelines at the sub-function and service area 1

2 level, except for four-year old programs and programs serving students with disabilities who have Individualized Education Programs. 3

In order for a school district to take advantage of the flexibility provisions, at least seventy-five percent of the school district's per 4

5 pupil expenditures must be utilized within the Insite categories of instruction, instructional support, and *only transportation, food*

service, and safety within non-instruction pupil services. No portion of the seventy-five percent may be used for *facilities*, business 6

7 services, debt service, capital outlay, program management, and leadership services, as defined by In\$ite. The school district shall

report to the Department of Education the actual percentage of its per pupil expenditures used for classroom instruction, instructional 8 support, and only transportation, food service, and safety within non-instruction pupil services for the current school year ending 9

June thirtieth. Salaries of on-site principals must be included in the calculation of the district's per pupil expenditures. 10

"In\$ite" means the financial analysis model for education programs utilized by the Department of Education. 11

School districts are encouraged to reduce expenditures by means, including, but not limited to, limiting the number of low 12 enrollment courses, reducing travel for the staff and the school district's board, reducing and limiting activities requiring dues and 13

memberships, reducing transportation costs for extracurricular and academic competitions, restructuring administrative staffing, and 14 15 expanding virtual instruction.

School districts and special schools may carry forward unexpended funds from the prior fiscal year into the current fiscal year. 16

Prior to implementing the flexibility authorized herein, school districts must provide to Public Charter Schools the per pupil 17 allocation due to them for each categorical program. 18

Quarterly throughout the current fiscal year, the chairman of each school district's board and the superintendent of each school 19 district must certify where non-instructional or nonessential programs have been suspended and the specific flexibility actions taken. 20 The certification must be in writing, signed by the chairman and the superintendent, delivered electronically to the State 21 Superintendent of Education, and an electronic copy forwarded to the Chairman of the Senate Finance Committee, the Chairman of 22

23 the Senate Education Committee, the Chairman of the House Ways and Means Committee, and the Chairman of the House Education

and Public Works Committee. Additionally, the certification must be presented publicly at a regularly called school board meeting, 24

25 and the certification must be conspicuously posted on the internet website maintained by the school district.

26 For the current fiscal year, Section 59-21-1030 is suspended. Formative assessments for grades one, two, and nine, the foreign language program assessment, and the physical education assessment must be suspended. School districts and the Department of 27 Education are granted permission to purchase the most economical type of bus fuel. 28

29

For the current fiscal year, savings generated from the suspension of the assessments enumerated above must be allocated to school districts based on weighted pupil units. 30

31 School districts must maintain a transaction register that includes a complete record of all funds expended over one hundred dollars, from whatever source, for whatever purpose. The register must be prominently posted on the district's internet website and made 32 available for public viewing and downloading. The register must include for each expenditure: 33 34

- (i) the transaction amount;
- 35 (ii) the name of the payee; and

(iii) a statement providing a detailed description of the expenditure. 36

The register must not include an entry for salary, wages, or other compensation paid to individual employees. The register must 1 2 not include any information that can be used to identify an individual employee. The register must be accompanied by a complete explanation of any codes or acronyms used to identify a payee or an expenditure. The register must be searchable and updated at 3 4 least once a month. 5 Each school district must also maintain on its internet website a copy of each monthly statement for all of the credit cards 6 maintained by the entity, including credit cards issued to its officers or employees for official use. The credit card number on each statement must be redacted prior to posting on the internet website. Each credit card statement must be posted not later than the 7 8 thirtieth day after the first date that any portion of the balance due as shown on the statement is paid. The Comptroller General must establish and maintain a website to contain the information required by this section from a school 9 district that does not maintain its own internet website. The internet website must be organized so that the public can differentiate 10 between the school districts and search for the information they are seeking. 11 School districts that do not maintain an internet website must transmit all information required by this provision to the Comptroller 12 General in a manner and at a time determined by the Comptroller General to be included on the internet website. 13 The provisions contained herein do not amend, suspend, supersede, replace, revoke, restrict, or otherwise affect Chapter 4, Title 14 30, the South Carolina Freedom of Information Act. Nothing in this proviso shall be interpreted as prohibiting the State Board of 15 Education to exercise its authority to grant waivers under Regulation 43-261. 16 **1A.15.** (SDE-EIA: Teacher Salary Supplement) The department is directed to carry forward prior year unobligated teacher salary 17 supplement and related employer contribution funds into the current fiscal year to be used for the same purpose. Any unexpended 18 funds in teacher salary supplement may be used to fund shortfalls in the associated employer contribution funding in the current 19 20 fiscal year. 1A.16. (SDE-EIA: Dropout Prevention and High Schools That Work Programs) The Department of Education must report 21 annually by December first, to the Governor, the Chairman of the Senate Finance Committee, the Chairman of the House Ways and 22 23 Means Committee, the Chairman of the Senate Education Committee, and the Chairman of the House Education and Public Works 24 Committee on the effectiveness of dropout prevention programs funded by the Education and Economic Development Act and on 25 the High Schools that Work Programs' progress and effectiveness in providing a better prepared workforce and student success in 26 post-secondary education. The department, school districts, and special schools may carry forward unexpended funds from the prior fiscal year into the current fiscal that were allocated for High Schools That Work. 27 28 1A.17. (SDE-EIA: Assessment) The department is authorized to carry forward into the current fiscal year, prior year state 29 assessment funds for the same purpose. Reimbursements shall resume in the current fiscal year for PSAT pre-ACT or 10th grade 30 Aspire. 31 1A.18. (SDE-EIA: Report Card Information) The percentage each school district expended on classroom instruction as defined by the Department of Education's In\$ite classification for "Instruction" must be printed on the Annual School and District Report 32 33 Card.

1A.19. (SDE-EIA: Core Curriculum Materials) The funds appropriated in Part IA, Section 1, VIII.A.3 for instructional materials for core curriculum shall be expended consistent with the requirements of Section 59-31-600 of the 1976 Code requiring the development of higher order thinking skills and critical thinking which should be integrated throughout the core curriculum

instructional materials. Furthermore, the evaluation criteria used to select instructional materials with funds appropriated in Part IA, 1 2 Section 1, VIII.A.3 shall include a weight of up to ten percent of the overall criteria to the development of higher order thinking skills 3 and critical thinking. 4 **1A.20.** (SDE-EIA: Certified Staff Technology Proficiency) To ensure the effective and efficient use of the funding provided by 5 the General Assembly in Part IA, Section 1 VIII.D. for school technology in the classroom and internet access, the State Department 6 of Education shall approve district technology plans that specifically address and incorporate certified staff technology competency 7 standards and local school districts must require certified staff to demonstrate proficiency in these standards as part of each certified 8 staff's Professional Development plan. The Department of Education's professional development tracking, prescriptive and electronic portfolio system for certified staff is the preferred method for demonstrating technology proficiency as this system is 9 District adopted technology proficiency standards and plans should be, at minimum, aligned to the International Society for 10 Technology in Education (ISTE) teacher standards. Evidence that districts are meeting the requirement is a prerequisite to 11 expenditure of a district's technology funds. 12 1A.21. (SDE-EIA: Accountability Program Implementation) To support implementation of the accountability program, the 13 Education Oversight Committee may carry forward unexpended Education Accountability Act funds authorized specifically for the 14 administration of the Education Oversight Committee. For the current fiscal year the Education Oversight Committee may carry 15 forward prior year EIA South Carolina Community Block Grants for Education Pilot Program funds not awarded by the grant 16 committee. These funds must be used for an independent common evaluation of each awarded grant to ensure high quality programs 17 that maximize a return on the state's investment. 18 1A.22. (SDE-EIA: 4K Targeting) EIA funds allocated for the provision of four-year-old kindergarten shall be utilized for the 19 provision of services to age-eligible children qualifying for free or reduced-price lunch or Medicaid. Children with developmental 20 delays documented through state approved screening assessments or children with medically documented disabilities who do not 21 already qualify for special need services should also be considered for enrollment. In the event that more students seek to enroll than 22 23 available space permits, districts shall prioritize students (at the time of acceptance) on the basis of family income expressed as a 24 percentage of the federal poverty guidelines, with the lowest family incomes given the highest enrollment priority. 25 **1A.23.** (SDE-EIA: Reading) Of the funds appropriated for reading/literacy, the Department of Education, schools, and districts shall ensure that resources are utilized to improve student achievement in reading/literacy. To focus on the importance of early 26 reading and writing skills and to ensure that all students acquire reading/literacy skills by the end of grade three, fifty percent of the 27 28 appropriation shall be directed toward acquisition of reading proficiency to include, but not be limited to, strategies in phonemic awareness, phonics, fluency, vocabulary, and comprehension. Forty percent of the appropriation shall be directed toward classroom 29 instruction and intervention to focus on struggling readers and writers in grades four through eight. Ten percent of the appropriation 30 31 should be directed toward acceleration to provide additional opportunities for deepening and refinement of literacy skills. Fifty percent of the funds shall be allocated to school districts based on the number of weighted pupil units in each school district 32 in proportion to the statewide weighted pupil units using the one hundred thirty-five day count of the prior school year. Fifty percent 33 34 of the funds shall be allocated to the Department of Education to provide districts with research-based strategies and professional development and to work directly with schools and districts to assist with implementation of research-based strategies. When 35

36 providing professional development the department and school districts must use the most cost effective method and when able

utilize ETV to provide such services throughout the state. The department shall provide for an evaluation to review first year 1 2 implementation activities and to establish measurements for monitoring impact on student achievement. 1A.24. (SDE-EIA: Students at Risk of School Failure) For the current fiscal year, EIA funds appropriated for students at academic 3 4 risk of school failure, which include funds for Act 135 Academic Assistance, summer school, reduce class size, alternative schools, 5 parent support and family literacy, must be allocated to school districts based two factors; (1) the poverty index of the district as 6 documented on the most recent district report card, which measures student eligibility for the free or reduced price lunch program 7 and Medicaid as determined for the poverty add on weight in Proviso 1.3; and (2) the number of students not in poverty or eligible 8 for Medicaid but who fail to meet state standards on state standards based assessments in either reading or mathematics weighted pupil units identified in the prior fiscal year as in need of academic assistance. At least eighty-five percent of the funds allocated for 9 students classified as at academic risk must be spent on instruction and instructional support for these students who generated the 10 funds. Instructional support may include family literacy and parenting programs to students at-risk for school failure and their 11 families. Students at academic risk are defined as students who are at risk of not graduating from high school because they failed 12 either the English language arts or mathematics portion of the High School Assessment Program on first attempt and who score not 13 met on grades three through eight in reading and mathematics state assessments. Public charter schools, the Palmetto Unified School 14 District, and the Department of Juvenile Justice must also receive a proportionate per pupil allocation based on the number of students 15 at academic risk of school failure served. 16 **1A.25.** (SDE-EIA: Professional Development) Of the funds appropriated for professional development, up to \$500,000 may be 17 expended for gifted and talented teacher endorsement and certification activities. The balance of EIA funds appropriated for 18 professional development must be allocated to districts based on the number of weighted pupil units in each school district in 19 proportion to the statewide weighted pupil units using the one hundred thirty-five day count of the prior school year. The funds must 20 be expended on professional development for certificated instructional and instructional leadership personnel in grades kindergarten 21 through twelve across all content areas, including teaching in and through the arts. No more than twenty-five percent of the funds 22 23 appropriated for professional development may be retained by the Department of Education for the administration and provision of 24 other professional development services which must be targeted to districts who are or were the original trial and plaintiff school 25 districts in the Abbeville law suit to increase the capacity of educators and leaders in those districts. The Department of Education must provide professional development on assessing student mastery of the content standards through classroom, formative and end-26 of-year assessments. The Department of Education also must post on the agency's website the South Carolina Professional 27 28 Development Standards and provide training through telecommunication methods to school leadership on the professional development standards. The department is authorized to carry forward and expend professional development funds for the same 29 30 purpose. 31 1A.26. (SDE-EIA: Assessments-Gifted & Talented, Advanced Placement, & International Baccalaureate Exams) Of the funds appropriated and/or authorized for assessment, up to \$4,600,000 \$5,400,000 shall be used for assessments to determine eligibility of 32 students for gifted and talented programs and for the cost of Advanced Placement and International Baccalaureate exams. 33 34 1A.27. (SDE-EIA: Adult Education) A minimum of thirty percent of the funds appropriated for adult education must be allocated

in A.27. (SDE-EIA: Adult Education) A minimum of unity percent of the funds appropriated for adult education must be anocated
 to school districts to serve adult education students between the ages of seventeen and twenty-one who are enrolled in programs
 leading to a state high school diploma, state high school equivalency diploma (GED), or career readiness certificate (WorkKeys).

The remaining funds will be allocated to districts based on a formula which includes factors such as target populations without a 1 2 high school credential, program enrollment the previous school year, number of students making an educational gain the previous school year, and performance factors such as number of high school credentials and career readiness certificates awarded the previous 3 4 school year. Overall levels of state funding must meet the federal requirement of state maintenance of effort. Each school district 5 must collect information from both the student and the school including why the student has enrolled in Adult Education and whether 6 or not the student is pursuing a GED or Diploma. The school district must then provide a quarterly report to the Department of 7 Education and must include the unique student identifier. The department, in turn, will provide summary information to the House 8 Ways and Means Committee, the House Education and Public Works Committee, the Senate Finance Committee and the Senate Education Committee on the information. Up to a maximum of \$300,000, of funds may be used to establish an initiative by which 9 qualifying adult education students may qualify for a free high school equivalency test. The Department of Education shall establish 10 guidelines for the free high school equivalency testing initiative. 11 1A.28. (SDE-EIA: Clemson Agriculture Education Teachers) The funds appropriated in Part IA, Section VIII.E. for Clemson 12 Agriculture Education Teachers must be transferred to Clemson University PSA to fund summer employment of agriculture teachers 13 and to cover state-mandated salary increases on that portion of the agriculture teachers' salaries attributable to summer employment. 14 15 If sufficient funds remain, Clemson University PSA may utilize such funds for a Regional Coordinator. 1A.29. (SDE-EIA: Incentive for National Board Certification After June 30, 2010) Public school classroom teachers to include 16 teachers employed at the special schools or classroom teachers who work with classroom teachers to include teachers employed at 17 the special schools who are certified by the State Board of Education and who complete the application process on or after July 1, 18 2010 shall be paid a \$5,000 salary supplement in the year of achieving certification. The special schools include the Governor's 19 School for Science and Math, Governor's School for the Arts and Humanities, Wil Lou Gray Opportunity School, John de la Howe 20 School, School for the Deaf and the Blind, Felton Lab, Department of Juvenile Justice and Palmetto Unified School District 1. The 21 \$5,000 salary supplement shall be added to the annual pay of the teacher, not to exceed ten years of the national certificate. However, 22 23 the \$5,000 supplement shall be adjusted on a pro rata basis for the teacher's FTE and paid to the teacher in accordance with the 24 district's payroll procedure. The Center for Educator Recruitment, Retention, and Advancement (CERRA-South Carolina) shall 25 administer whereby teachers who are United States citizens or permanent resident aliens apply to the National Board for Professional Teaching Standards for certification on or after July 1, 2010. Should the program not be suspended, up to nine hundred applications 26 27 shall be processed annually. Of the funds appropriated in Part IA, Section 1, VIII.C.2. for National Board Certification, the 28 Department of Education shall transfer to the Center for Educator Recruitment, Retention, and Advancement (CERRA-South Carolina) the funds necessary for the administration of teachers applying to the National Board for Professional Teaching Standards 29 30 for certification. 31 **1A.30.** (SDE-EIA: Full-Day 4K) For the current school year, eligible *Eligible* students residing in a school district with a poverty index of seventy percent or greater may participate that met the poverty level for participation in the prior school year are eligible 32 to participate in the South Carolina Early Reading Development and Education Program in the current school year. Public and 33 34 private providers will be reimbursed for instructional costs at a rate of \$4,218 \$4,323 per student enrolled. Eligible students enrolling

35 during the school year or withdrawing during the school year shall be funded on a pro rata basis determined by the length of their

36 enrollment. Private providers transporting eligible children to and from school shall also be eligible for a reimbursement of \$550

per eligible child transported. All providers who are reimbursed are required to retain records as required by their fiscal agent. New 1 2 providers participating for the first time in the current fiscal year and enrolling between one and six eligible children shall be eligible to receive up to \$1,000 per child in materials and equipment funding, with providers enrolling seven or more such children eligible 3 4 for funding not to exceed \$10,000. Providers receiving equipment funding are expected to participate in the program and provide 5 high-quality, center-based programs as defined herein for a minimum of three years. Failure to participate for three years will require 6 the provider to return a portion of the equipment allocation at a level determined by the Department of Education and the Office of 7 First Steps to School Readiness. Funding to providers is contingent upon receipt of data as requested by the Department of Education 8 and the Office of First Steps. Of the funds appropriated, \$300,000 shall be allocated to the Education Oversight Committee to conduct an annual evaluation of 9 the South Carolina Child Development Education Pilot Program and to issue findings in a report to the General Assembly by January 10 fifteenth of each year. To aid in this evaluation, the Education Oversight Committee shall determine the data necessary and both 11 public and private providers are required to submit the necessary data as a condition of continued participation in and funding of the 12 program. This data shall include developmentally appropriate measures of student progress. Additionally, the Department of 13 Education shall issue a unique student identifier for each child receiving services from a private provider. The Department of 14 Education shall be responsible for the collection and maintenance of data on the public state funded full day and half-day four-year-15 old kindergarten programs. The Office of First Steps to School Readiness shall be responsible for the collection and maintenance of 16 data on the state funded programs provided through private providers. The Education Oversight Committee shall use this data and 17 all other collected and maintained data necessary to conduct a research based review of the program's implementation and assessment 18 of student success in the early elementary grades. 19 1A.31. (SDE-EIA: Aid to Districts) Funds appropriated in Part IA, Section 1, VIII.A.1. Aid to Districts shall be dispersed to 20 school districts based on the number of weighted pupil units. 21 1A.32. (SDE-EIA: Centers of Excellence) Of the funds appropriated for Centers of Excellence, \$350,000 must be allocated to the 22 23 Francis Marion University Center of Excellence to Prepare Teachers of Children of Poverty to expand statewide training for individuals who teach children of poverty through weekend college, nontraditional or alternative learning opportunities. 24 25 1A.33. (SDE-EIA: IDEA Maintenance of Effort) Prior to the dispersal of funds appropriated in Section VIII.A.1. Aid to Districts according to Proviso 1A.31 for the current fiscal year, the department shall direct funds appropriated in Section VIII.A.1. Aid To 26 27 Districts to school districts and special schools for supplemental support of programs and services for students with disabilities, to 28 meet the estimated maintenance of effort for IDEA or to resolve pending litigation concerning the IDEA maintenance of effort. Funds provided for the maintenance of effort for IDEA these purposes may not be transferred to any other purpose and therefore are 29 not subject to flexibility. The department shall distribute these funds using the current fiscal year one hundred thirty-five day Average 30 Daily Membership or as directed in any litigation settlement agreement. For continued compliance with the federal maintenance of 31 efforts requirements of the IDEA, funding for children with disabilities must, to the extent practicable, be held harmless to budget 32 cuts or reductions to the extent those funds are required to meet federal maintenance of effort requirements under the IDEA. In the 33 34 event cuts to funds that are needed to maintain fiscal effort are necessary, when administering such cuts, the department must not 35 reduce funding to support children with disabilities who qualify for services under the IDEA in a manner that is disproportionate to

the level of overall reduction to state programs in general. By December 1, 2015 2016, the department must submit an estimate of the IDEA MOE requirement to the General Assembly and the Governor.

1A.34. (SDE-EIA: Career Cluster Industry Partnerships) From the funds appropriated to the Department of Education, \$800,000 3 4 must be provided as direct grants to the private sector statewide trade association or educational foundation providing nationally 5 certified programs in career and technology education representing the automotive, construction, engineering, healthcare, mechanical contracting/construction, and hospitality tourism career clusters. Organizations applying for a grant must do so by July first 31st and 6 7 the Department of Education must award a minimum of one grant of at least \$150,000 in at least four of these specified career clusters 8 to be used exclusively for career and technology education. The recipient industry organization must conduct end-of-course exams graded by a national industry organization and must include in their grant request how the money will be spent in direct support of 9 students to further industry-specific career technology education; a description and history of their program nationally and within 10 South Carolina; estimates of future employment growth in their industry; and the national scope of their program. By August first 11 of the following year, the organization must submit to the department a report detailing how the grant increased industry/employer 12 awareness; the number of increased schools using the industry-based curriculum and partnered with the industry organization; the 13 increased number of students in the program; and an overview and analysis of the organization's statewide student competition. The 14 grant must be used for career awareness programs for that industry cluster; statewide student competitions leading to national 15 competitions; teacher development and training; post-secondary scholarships in industry-specific degree programs; student 16 recruitment into that career cluster programs; programs to educate middle and high school Career or Guidance Counselors about the 17 industry; service to disadvantaged youth; and administering business/employer awareness and partnerships which help lead to 18 experience-based, career-oriented experiences including internships, apprenticeships, mentoring, co-op education and service 19 learning. The Office of Career and Technology Education of the department will develop goals with each career cluster on the 20 number of new schools using the industry-based curriculum and partnered with that career cluster organization. These funds may 21 not be used to supplant or replace, in whole or in part, other existing resources/assets sourced outside the present grant being used to 22 23 provide the same services or programs. Organizations may carry-over grants for up to three years when a large project is identified 24 in the grant application to be used at a future date; otherwise excess funds must be returned to the state. Organizations awarded must 25 submit a semi-annual programmatic and financial report on the last day of December in addition to the final report due August first 26 that has been audited by a third party accounting firm.

1A.35. (SDE-EIA: Partnerships/Other Agencies & Entities) For the current fiscal year, agencies and other entities receiving funds appropriated in Part IA, Section 1, VIII.E. will continue to report annually to the Education Oversight Committee (EOC). Any entity receiving funds that must flow through a state agency will receive those funds through the EOC. The EOC will make funding recommendations to the Governor and General Assembly as part of the agency's annual budget request.

31 **1A.36.** (SDE-EIA: ETV Teacher Training/Support) Of the funds appropriated in Part IA, Section 1, VIII.E. South Carolina 32 Educational Television must provide training and technical support on the educational resources available to teachers and school 33 districts.

A maximum of twenty-five percent of the funds appropriated
 for Modernize Vocational Equipment, Career and Technology Education may be utilized to purchase textbooks, instructional

materials and other consumables used in classroom instruction. The department may carry forward unexpended Modernize 1 2 Vocational Equipment and Tech Prep funds to be used for the same purpose. **1A.38.** (SDE-EIA: Teacher Salaries/SE Average) The projected Southeastern average teacher salary shall be the average of the 3 4 average teachers' salaries of the southeastern states as projected by the Revenue and Fiscal Affairs Office. For the current school 5 year the Southeastern average teacher salary is projected to be $\frac{49,796}{51,495}$. The General Assembly remains desirous of raising the average teacher salary in South Carolina through incremental increases over the next few years so as to make such equivalent to 6 7 the national average teacher salary. 8 The statewide minimum teacher salary schedule used in Fiscal Year 2012-13 will continue to be used in Fiscal Year 2015-16 2016-9 17 and be increased by 2%. Additionally, for the current fiscal year, a local school district board of trustees must increase the salary compensation for all 10 eligible certified teachers employed by the district by no less than one year of experience credit using the district salary schedule 11 utilized the prior fiscal year as the basis for providing the step. Application of this provision must be applied uniformly for all eligible 12 certified teachers. 13 Funds appropriated in Part IA, Section 1, VIII.C.2. for Teacher Salaries must be used to increase salaries of those teachers eligible 14 pursuant to Section 59-20-50(b), to include classroom teachers, librarians, guidance counselors, psychologists, social workers, 15 occupational and physical therapists, school nurses, orientation/mobility instructors, and audiologists in the school districts of the 16 17 state. For purposes of this provision teachers shall be defined by the Department of Education using the Professional Certified Staff 18 19 (PCS) System. 1A.39. (SDE-EIA: PowerSchool Dropout Recovery Data) With the funds appropriated to the Department of Education for 20 PowerSchool and data collection, the department will begin in the current fiscal year to collect data from schools and school districts 21 22 on the number of students who had previously dropped out of school and who reenrolled in a public school or adult education to 23 pursue a high school diploma. The Education Oversight Committee working with the Department of Education will determine how 24 to calculate a dropout recovery rate that will be reflected on the annual school and district report cards. 25 **1A.40.** (SDE-EIA: Assisting, Developing and Evaluating Professional Teaching -ADEPT) With funds appropriated in the current fiscal year, the Department of Education, school districts, the Department of Juvenile Justice and special schools of the state may 26 continue implementation of the ADEPT program. Governing boards of public institutions of higher education may provide by policy 27 28 or regulation for a tuition waiver for the tuition for one three-hour course at that institution for those public school teachers who serve 29 as supervisors for full-time students completing education degree requirements. Unexpended funds appropriated for this purpose may be carried forward from the prior fiscal year into the current fiscal year and expended for the same purposes. 30 1A.41. (SDE-EIA: Assessment Preparation) From the funds appropriated in Part IA for Assessment Preparation, the Department 31 of Education shall institute a plan reviewing the strengths and weaknesses of students on national assessments such as, but not limited 32 to, the SAT, ACT, WorkKeys, GED, Advanced Placement exams, and International Baccalaureate exams. The department shall use 33 34 reports that analyze student strengths and weaknesses to provide guidance to local school districts. 1A.42. (SDE-EIA: National Board Certification Incentive) Public school classroom teachers to include teachers employed at the 35 special schools or classroom teachers who work with classroom teachers to include teachers employed at the special schools who are 36

certified by the State Board of Education and who have been certified by the National Board for Professional Teaching Standards or 1 2 completed the application process prior to July 1, 2010 shall be paid a \$7,500 salary supplement beginning July first in the year following the year of achieving certification, beginning with 2009 applicants. The special schools include the Governor's School 3 4 for Science and Math, Governor's School for the Arts and Humanities, Wil Lou Gray Opportunity School, John de la Howe School, 5 School for the Deaf and the Blind, Felton Lab, Department of Juvenile Justice and Palmetto Unified School District 1. The \$7,500 6 salary supplement shall be added to the annual pay of the teacher for the length of the national certificate. However, the \$7,500 7 supplement shall be adjusted on a pro rata basis for the teacher's FTE and paid to the teacher in accordance with the district's payroll 8 procedure. The Center for Educator Recruitment, Retention, and Advancement (CERRA-South Carolina) shall administer the 9 programs whereby teachers who are United States citizens or permanent resident aliens, and who applied to the National Board for Professional Teaching Standards for certification prior to July 1, 2010, may receive a loan equal to the amount of the application fee. 10 Teachers who applied to the National Board for Professional Teaching Standards for certification prior to July 1, 2010 shall have 11 12 one-half of the loan principal amount and interest forgiven when the required portfolio is submitted to the national board. Teachers who applied to the National Board for Professional Teaching Standards for certification prior to July 1, 2010 who attain certification 13 within three years of receiving the loan will have the full loan principal amount and interest forgiven. Teachers who previously 14 submitted a portfolio to the National Board for Professional Teaching Standards for certification under previous appropriation acts, 15 shall receive reimbursement of their certification fee as prescribed under the provisions of the previous appropriation act. Funds 16 collected from educators who are in default of the National Board loan shall be retained and carried forward by the department. The 17 department may retain up to ten percent of the funds collected to offset the administrative costs of loan collection. All other funds 18 19 shall be retained by the department and used for National Board loan purposes. Of the funds appropriated in Part IA, Section 1, 20 VIII.C.2. for National Board Certification, the Department of Education shall transfer to the Center for Educator Recruitment, Retention, and Advancement (CERRA-South Carolina) the funds necessary for the administration of the loan program for teachers 21 who applied to the National Board for Professional Teaching Standards for certification prior to July 1, 2010. In addition, teachers 22 23 who have applied prior to July 1, 2010 and are certified by the National Board for Professional Teaching Standards shall enter a recertification cycle for their South Carolina certificate consistent with the recertification cycle for national board certification. 24 25 National board certified teachers who have been certified by the National Board for Professional Teaching Standards or completed 26 the application process prior to July 1, 2010 moving to this State who hold a valid standard certificate from their sending state are 27 exempted from initial certification requirements and are eligible for a professional teaching certificate and continuing contract status. 28 Their recertification cycle will be consistent with national board certification.

29 Provided, further, that in calculating the compensation for teacher specialists, the Department of Education shall include state and 30 local compensation as defined in Section 59-18-1530 to include local supplements except local supplements for National Board 31 certification. Teacher specialists remain eligible for state supplement for National Board certification.

1A.43. (SDE-EIA: Educational Partnerships) The funds provided to the Center for Educational Partnerships at the College of Education at the University of South Carolina will be used to create a consortium of educational initiatives and services to schools and communities. These initiatives will include, but are not limited to, professional development in writing, geography and other content areas; training; research; advocacy; and practical consultancy. The Center will establish collaborative educational enterprises with schools, school districts, parents, communities, and businesses while fulfilling the responsibilities of the School Improvement

1 Council Assistance. The Center will focus on connecting the educational needs and goals of communities to improve efficiency and 2 effectiveness.

1A.44. (SDE-EIA: STEM Centers SC) All EIA-funded entities that provide professional development and science programming 3 4 to teachers and students should be included in the state's science, technology, engineering and mathematics education strategic plan. 5 **1A.45.** (SDE-EIA: EOC Partnerships for Innovation) Of the funds appropriated or carried forward from the prior fiscal year, the Education Oversight Committee is directed to participate in public-private partnerships to promote innovative ways to transform the 6 7 assessment of public education in South Carolina that support increased student achievement in reading and college and career 8 readiness. The Education Oversight Committee may provide financial support to districts and to public-private partnerships for planning and support to implement, sustain and evaluate the innovation and to develop a matrix and measurements of student 9 academic success based on evidence-based models. These funds may also focus on creating public-private literacy partnerships 10 utilizing a 2:1 matching funds provision when the initiative employs research-based methods, has demonstrated success in increasing 11 reading proficiency of struggling readers, and works directly with high poverty schools and districts. CERRA shall develop a set of incentives including, but not limited to, salary supplements, education 3 4 subsidies, loan forgiveness, professional development, and mentorship to be provided to classroom educators that offer instructional 5 services in eligible districts. The incentives and implementation shall be developed in consultation with the State Department of Education and the Education Oversight Committee, and shall provide incentive options for eligible individuals at all stages of their 6 7 careers, including high-school and college or university students interested in entering the teaching profession and including 8 individuals entering the field through an alternative certification pathway to include, but not limited to, PACE, ABCTE, Teach for American and CATE Work-Based Certification. 9 At a minimum, the incentives shall include: 10 (1) South Carolina Teachers Loan forgiveness at a rate of one year for every two years of service as a teacher in an eligible 11 district, unless otherwise eligible for a greater forgiveness rate under the guidelines of the South Carolina Teachers Loan Program. 12 (2) Development of a program for forgiveness of undergraduate student loans, not to exceed \$5,000 per year, for up to 7 years, 13 for teachers participating in this incentive that achieve certification through an alternative pathway or who have a loan from an 14 institution other than the South Carolina Student Loan Corporation or program other than the South Carolina Teachers Loan 15 16 Program. (3) Development of a forgivable loan program for individuals pursuing graduate coursework in furtherance of a teaching 17 career, including enrollment in graduate-level coursework necessary to seek additional credentialing or certification relevant to the 18 participant's teaching practice, or individuals seeking an alternative pathway to certification as a teacher. 19 (4) Support for the establishment and maintenance of a teaching mentorship program, including salary supplements for 20 21 teaching mentors not to exceed \$2,500 per vear. 22 (5) Other technical support and recruiting incentives as developed by CERRA in conjunction with the Department of Education 23 and the Education Oversight Committee consistent with the objectives of this section. 24 (D) In addition to eligibility and application requirements, CERRA shall develop a process for recovering an amount equal to the incentives given to individual participants who fail to comply with the obligations associated with a relevant incentive in which 25 26 they participate including, but not limited to, failure to complete a prescribed course of study, failure to obtain a relevant certification or licensure upon completion of a course of study, or failure to provide instructional services in an eligible district for a prescribed 27 period of time. 28 (DE) CERRA shall report by January 15, 2016 July 31 of the current fiscal year to the Governor, President pro Tempore of the 29 Senate, and Speaker of the House on the incentives developed pursuant to item (C) of this section and make recommendations for 30 attracting and retaining high quality teachers in rural and underserved districts. (8) The reading coach must not be assigned a regular classroom teaching assignment, must not serve an as administrator, must 33 34 not perform administrative functions that deter from the flow of improving reading instruction and reading performance of students, and must not devote a significant portion of his or her time to administering or coordinating assessments. 35

(D) Schools and districts accepting funding to support a coaching position agree that the reading/literacy coach must not serve 1 2 as an administrator. If the department finds that school districts are using these funds for administrative costs as defined in statute they must withhold that districts remaining balance of funds allocated pursuant to this proviso. 3 (DE) No later than February 1, 2016, the The Department of Education must publish guidelines that define the minimum 4 qualifications for a reading/literacy coach for Fiscal Year 2015-16. Funds appropriated for the purchase of 8 textbooks and other instructional materials may be used for reimbursing school districts to offset the costs of refurbishing science 9 kits on the state-adopted textbook inventory, purchasing new kits from the central textbook depository, or a combination of refurbishment and purchase. The refurbishing cost of kits may not exceed the cost of the state-adopted refurbishing kits plus a 10 reasonable amount for shipping and handling. Costs for staff development, personnel costs, equipment, or other costs associated 11 with refurbishing kits on state inventory are not allowable costs. Funds provided for Instructional Materials may be carried forward 12 from the prior fiscal year into the current fiscal year to be expended for the same purposes by the department, school districts, and 13 special schools. These funds are not subject to flexibility. Digital Instructional Materials shall include the digital equivalent of 14 15 materials and devices.

1A.68. (SDE-EIA: 4K Early Literacy Competencies Assessments) Of the funds carried forward from the full-day 4K program 16 from the previous fiscal year, the Department of Education is authorized to expend up to \$800,000 on assessments and professional 17 development to analyze the early literacy competencies of children in publicly funded prekindergarten. The assessment may not be used to deny a student to 30 31 admission to prekindergarten. Furthermore, \$2,000,000 of the funds appropriated for half-day programs for four-year-olds and funds carried forward from 32

assessment must be expended by the Department of Education to administer the Developmental Reading Assessment® 2nd Edition

PLUS to implement the progress monitoring system required by the Read to Succeed Act of 2014 and to evaluate the early literacy

35 and language competencies of each child entering kindergarten in the public schools. The assessment of kindergarten students must

36 be administered at a minimum of once during the first forty-five days of the school year and once during the last forty-five days of

the school year with the results collected by the department. The results of the assessments and the developmental intervention 1 2 strategies recommended or services needed to address each child's identified needs must also be provided, in writing, to the parent or guardian. The assessment may not be used to deny a student admission to kindergarten. Accommodations that do not invalidate 3 4 the results of these assessments must be provided in the manner set forth by the student's Individualized Education Program or 504 Accommodations Plan. Districts are given the option of designating up to two days of the one hundred eighty day school calendar 5 6 to administer the assessment to kindergarten students. The department will also provide the results of the assessment of kindergarten 7 students to the Education Oversight Committee. With available funds, the department will also provide or secure training for 8 appropriate educators in how to administer the assessment. In addition the department may pilot in kindergarten classes one or more comprehensive readiness assessments that address the other domains in numeracy, approaches to learning, social and emotional 9 development, and physical well-being in the current school year. 10 1A.69. (SDE-EIA: Teacher Supply Study) With funds appropriated to the Center for Educator Recruitment, Retention, and 11 Advancement (CERRA), in concert with the Commission on Higher Education, the Department of Education, and the Education 12 Oversight Committee, CERRA shall initiate and conduct a study to identify and project the number of additional teachers needed 13 annually in public school classrooms for grades K5 through 12, for school years beginning 2017 through 2027. (SDE-EIA: Statewide Assessment Procurement) With the funds appropriated and carried forward for assessment, the 21 Department of Education, in consultation with the State Board of Education and the Education Oversight Committee pursuant to 22 23 Section 59-18-320 of the 1976 Code, is directed to issue a procurement for a statewide assessment to students in grades 3 through 8 24 in English/language arts and mathematics that meet the requirements of the Education Accountability Act as amended by Act 200 of 25 2014. The assessment must be a rigorous, achievement assessment that measures student mastery of the SC College and Career-26 Ready Standards, that provides timely reporting of results to educators, parents, and students, and that measures each student's 27 progress toward college and career readiness.

In addition, the Department of Education, in consultation with the State Board of Education and the Education Oversight Committee pursuant to Section 59-18-320, is directed to issue a procurement for a statewide assessment of students in grade 11 that meets the requirements of the Education Accountability Act as amended by Act 155 of 2014. The procured assessments are to be administered in school year 2015-16.

32 **1A.71.** (SDE-EIA: CDEPP Unexpended Funds) For Fiscal Year 2015-16 2016-17, the Office of First Steps to School Readiness 33 is directed <u>permitted</u> to retain the first \$2,000,000 \$1,000,000 of any unexpended CDEPP funds from <u>of</u> the prior fiscal year and 34 expend these funds to enhance the quality of the full-day 4K program in private centers and provide professional development 35 opportunities.

(WLG: Lease Revenue) Wil Lou Gray Opportunity School is authorized to retain revenues derived from the lease of school properties titled to or utilized by the school and may use revenues retained for general school operations, including, but not limited to, maintenance of such properties. Unexpended funds may be carried forward into the current fiscal year and used for the same purposes. 5.7. (WLG: USDA Federal Grants) All revenues generated from USDA federal grants may be retained and expended by the school in accordance with Federal regulations for the purpose of covering actual expenses in the cafeteria/food service operations of the school. 5.8. (WLG: By-Products Revenue Carry Forward) The Wil Lou Gray Opportunity School is authorized to sell goods that are by-products of the school's programs and operations, charge user fees and fees for services to the general public, individuals, organizations, agencies and school districts, and such revenue may be retained and carried forward into the current fiscal year and expended for the purpose of covering expenses of the school's programs and operations. 5.9. (WLG: Capacity) For Fiscal Year 2015-16, funds appropriated to Wil Lou Gray Opportunity School must be used to bring the school up to full capacity, to the extent possible, and the school must report electronically to the Chairman of the Senate Finance Committee and the Chairman of the House Ways and Means Committee by December first, on how the funds have been utilized and how many additional students have been served. SECTION 6 - H750 - SCHOOL FOR THE DEAF AND THE BLIND 6.1. (SDB: Student Activity Fee) The School for the Deaf and the Blind is authorized to charge to the parents of students at the

Such fees will be determined by the School 13 Board of Commissioners, and such revenue shall be retained and carried forward into the current fiscal year and expended by the 14 School for the purpose of covering expenses in the Adult Vocational Program. 15 6.5. (SDB: By-Products Revenue Carry Forward) The School for the Deaf and the Blind is authorized to sell goods that are by-28 products of the school's programs and operations, charge user fees and fees for services to the general public: individuals, organizations, agencies and school districts, and such revenue may be retained and carried forward into the current fiscal year and 29 expended for the purpose of covering expenses of the school's programs and operations. 30 31 6.10. (SDB: Deferred Salaries Carry Forward) South Carolina School for the Deaf and the Blind is authorized to carry forward in the current fiscal year the amount of the deferred salaries and employer contributions earned in the prior fiscal year for non-twelve 32 month employees. SECTION 7 - L120 - JOHN DE LA HOWE SCHOOL

1	In consultation with the advisory group and as set forth herein, by November 30, the John de la Howe Board of Trustees will
2	procure a contract with a non-profit child-service provider to operate the program. The non-profit child-service provider must be a
3	nationally accredited (AdvancED) educational organization experienced in both child protection and juvenile justice programs and
4	must be able to demonstrate a history of success in the operation of educational and vocational residential training programs for
5	youth. The Department of Administration and the Executive Budget Office will assist John de la Howe as needed in the transition.
6	With funds appropriated and with technical assistance from Clemson University, the Department of Administration and the
7	Executive Budget Office, the John de la Howe School Board of Trustees will continue to provide wilderness camp programs to
8	students in the current fiscal year; and identify initiatives to provide agricultural education opportunities on campus for students.
9	John de la Howe will work with the Department of Social Services and the Department of Juvenile Justice to provide for the safe
10	transition of the existing residents from John de la Howe School into such placements, programs and services as determined
11	appropriate based on an assessment of their individual needs.
12	In the development of the program and in the qualifications and selection of the non-profit child-service provider, considerations
13	by the John de la Howe Board of Trustees in consultation with the advisory group will include the following:
14	(1) the overlap of needs of children who crossover for services between the Department of Social Services and the Department
15	<u>of Juvenile Justice;</u>
16	(2) educational, school drop-out recovery, GED, vocational programs, life skills training programs, career and employment
17	opportunities, and independent living programs for these older youth clients that can be provided using the John de la Howe School
18	facilities, resources, and funding to assist these youth who are at risk and aging out of state services to prepare for success as adults;
19	(3) aftercare programs that will follow these youths into the community and help them to become established in viable
20	employment and living situations that encourage a future free of homelessness, unemployment, poverty, alcohol and other substance
21	abuse, criminal behavior, and dependence on public assistance;
22	(4) provide the existing child clients at John de la Howe School with a proper, safe transition to family reunification or other
23	appropriate placements and services:
24	(5) provide consideration of current John de la Howe School employees, where appropriate, for employment pursuant to the
25	<u>new non-profit provider contract for program services; and,</u>
26	(6) how the existing funds and youth vocational training programs can be applied to provide repairs and maintenance to the

28	The John de la Howe Board of Trustees, with technical assistance from the Department of Education will provide procurement
29	for the contract, fiscal administration of the funds, contract accountability, compliance, and reporting and will submit reports by

SECTION 8 - H670 - EDUCATIONAL TELEVISION COMMISSION

8.1. (ETV: Grants/Contributions Carry Forward) The Educational Television Commission shall be permitted to carry forward any funds derived from grant awards or designated contributions and any state funds necessary to match such funds, provided that these funds be expended for the programs which they were originally designated.

8.2. (ETV: Spectrum Auction) During the current fiscal year, if If the Educational Television Commission opts to enter the 6 7 Federal Communications Commission TV Spectrum Auction and subsequently receives any proceeds from the auction Federal Communication Commission TV Auction, the commission is authorized to receive and retain the proceeds for the development of a 8 capital reserve declining balance fund. Up to \$40,000,000 of the proceeds shall be used to fund several critical capital needs at ETV, 9 including an expected broadcast industry standards change. Proceeds shall also be deployed for existing equipment repair, 10 maintenance and replacement needs and operational costs. Any proceeds received above \$40,000,000 must be placed into a 11 segregated account and shall require General Assembly approval prior to the expenditure of these funds. Unexpended funds shall be 12 carried forward from the prior fiscal year into the current fiscal year and used for the same purpose. The Subject to the FCC 13 requirements for a specified quiet period, the commission shall report to the Governor, the Chairman of the Senate Finance 14 15 Committee and the Chairman of the House Ways and Means Committee on the intent to enter the auction; dates of the auction; potential revenue estimates; and actual received revenue. 16 8.3. (ETV: Antenna and Tower Placement) All leases for antenna and tower operations within institutions of higher learning 17 campuses must conform to master plans for such property, as determined solely by the institution of higher learning. 18 8.4. (ETV: Wireless Communications Tower) The Educational Television Commission is directed to coordinate tower and 19 antenna operations within South Carolina state government. The commission shall (1) approve all leases regarding antenna 20 placement on state-owned towers and buildings, (2) coordinate all new tower construction on state-owned property, (3) promote 21 and market excess capacity on the State's wireless communications infrastructure, (4) generate revenue by leasing, licensing, or 22 selling excess capacity on the State's wireless communications infrastructure, and (5) construct new communications assets on 23

24 appropriate state-owned property for the purpose of generating revenue pursuant to this proviso. The commission shall retain and

25 expend such funds for agency operations. The commission shall be authorized to carry forward unexpended funds from the prior

11.1. (CHE: Contract for Services Program Fees) The amounts appropriated in this section for "Southern Regional Education Board Contract Programs" and "Southern Regional Education Board Dues" are to be used by the commission to pay to the Southern Regional Education Board the required contract fees for South Carolina students enrolled under the Contract for Services program of the Southern Regional Education Board, in specific degree programs in specified institutions and the Southern Regional Education Board membership dues. The funds appropriated may not be reduced to cover any budget reductions or be transferred for other purposes.

11.2. (CHE: African-American Loan Program) Of the funds appropriated to the Commission on Higher Education for the 1 2 African-American Loan Program, 73.7 percent shall be distributed to South Carolina State University and 26.3 percent shall be distributed to Benedict College, and must be used for a loan program with the major focus of attracting African-American males to 3 4 the teaching profession. The Commission of Higher Education shall act as the monitoring and reporting agency for the African-5 American Loan Program. Of the funds allocated according to this proviso, no more than ten percent shall be used for administrative 6 purposes. 7 11.3. (CHE: GEAR-UP) Funds appropriated for GEAR-UP shall be used for state grants programs to reach disadvantaged 8 middle school students to improve their preparation for college. Eligible South Carolina public schools and public institutions of higher education shall cooperate with the Commission on Higher Education in the provision of services under the Gaining Early 9 Awareness and Readiness for Undergraduate Programs (GEAR-UP) grant. 10 **11.4.** (CHE: EPSCoR Committee Representation) With the intent that the four-year teaching institutions receive a portion of 11 EPSCoR funding, the State EPSCoR Committee shall have an executive committee consisting of one representative from each of the 12 research institutions and one representative from the four-year teaching university sector. 13 11.5. (CHE: SREB Funds Exempt From Budget Cut) In the calculation of any across the board cut mandated by the Executive 14 Budget Office or General Assembly, the amount which the Commission on Higher Education is appropriated for Southern Regional 15 Education Board (SREB) Professional Scholarship Programs and Fees, Dues and Assessments shall be excluded from the 16 Commission on Higher Education's base budget. Funds appropriated for SREB programs may be carried forward into the current 17 fiscal year and expended for the same purpose by the Commission on Higher Education. 18 11.6. (CHE: Performance Improvement Pool Allocation) Of the funds appropriated to the Commission on Higher Education 19 under Section II. Other Agencies & Entities: Special Items: Performance Funding, eighty percent will be allocated to the EPSCoR 20 program under the Commission on Higher Education to improve South Carolina's research capabilities and twenty percent will be 21 allocated to support the management education programs of the School of Business at South Carolina State University. 22 23 **11.7.** (CHE: Troop-to-Teachers) Members of the Armed Forces either active-duty, retired, or separated who are admitted to and enrolled in the South Carolina Troop-to-Teachers Alternative Route to Certification program are entitled to pay in-state rates at 24 participating state institutions for requisite program work. 25 26 **11.8.** (CHE: Need-Based Grants for Foster Youth) For the current academic year, youth in the custody of the Department of Social Services and attending a higher education institution in South Carolina are eligible for additional need-based grants funding 27 28 of up to \$2,000 above the \$2,500 maximum. Foster youth must apply for these funds no later than May first, of the preceding year. All other grants, both state and federal, for which these foster youth are eligible must be applied first to the cost of attendance prior 29 to using the additional need-based grant funding. If the cost of attendance for a foster youth is met with other grants and scholarships, 30 31 then no additional need-based grant may be used. The Department of Social Services, in cooperation with the Commission on Higher Education will track the numbers of recipients of this additional need-based grant to determine its effectiveness in encouraging more 32 foster youth to pursue a secondary education. No more than \$100,000 may be expended from currently appropriated need-based 33

34 grants funding for this additional assistance.

11.9. (CHE: Tuition Age) For the current fiscal year, the age limitation for those children of certain war veterans who may be 1 2 admitted to any state-supported college, university, or post high school technical education institution free of tuition is suspended for eligible children that successfully appeal the Division of Veterans Affairs on the grounds of a serious extenuating health condition. 3 4 11.10. (CHE: LIFE and Palmetto Fellows Enhancement Stipends) In the current fiscal year before fall awards are made, to 5 continue eligibility for LIFE and Palmetto Fellows Enhancement Stipends, students shall certify and the institutions shall verify that 6 the student is meeting all requirements as stipulated by the policies established by the institution and the academic department to be 7 enrolled as a declared major in an eligible program and is making academic progress toward completion of the student's declared 8 eligible major. These determinations are subject to the verification and audit of the Commission on Higher Education. Institutions shall return funds determined to have been awarded to ineligible students. 9 11.11. (CHE: SmartState) The Commission on Higher Education is prohibited from expending any source of funds on the 10 11 marketing of the SmartState Program. 11.12. (CHE: College Transition Need-Based Grants) Of the currently appropriated need-based grants funding, no more than 12 \$179,178 \$350,000 shall be used to provide need-based grants to South Carolina resident students enrolled at a public institution of 13 higher education in an established college transition program that serves students with intellectual disabilities. The Commission on 14 Higher Education shall allocate the available funds to eligible institutions on the basis of student need and enrollment in the 15 established college transition programs. All other grants and gift aid for which these students are eligible must be applied first to the 16 cost of attendance prior to using the need-based grant funding. If the cost of attendance for an eligible student is met with all other 17 grants and gift aid, the need-based grant shall not be used. The participating institutions, in cooperation with the Commission on 18 Higher Education, shall track the number of grant recipients and other information determined necessary to evaluate the effectiveness 19 of these grants in assisting students with intellectual disabilities in college transition programs. 20 11.13. (CHE: Scholarship Awards) A student may receive a Palmetto Fellows or LIFE scholarship award during the summer, in 21 addition to fall and spring semesters of an academic year, provided continued eligibility requirements are met as of the end of the 22 23 spring semester. Students must enroll full-time, which for purposes of the summer award will require enrollment in at least twelve 24 hours over the course of the summer. The summer is defined as the period between the end of the spring term and prior to the 25 opening of the fall term. The total summer award per student may not exceed half of the allowable academic year award up to the cost of attendance and must be reimbursed if less than twelve hours for academic credit are not attempted by the student during 26 summer sessions. If awarded in the summer, a student's total award during his or her enrollment may not exceed the amount that 27 28 would otherwise be provided under current semester limits applied for the scholarship awards. (LIB: Consortium Purchasing) The State Library shall be authorized to accept funds to be used for consortium purchasing 16 between libraries (public, academic, special) that serve South Carolina residents. Funds received by the State Library for consortium 17 purchasing agreements shall be placed in a designated account and shall only be used to pay for items related to specific consortium 18 purchasing agreements. These funds may be retained, expended, and carried forward from the prior fiscal year into the current fiscal 19 year and used for the same purpose. 20 21 27.9. (LIB: Content Licensing) **DELETED**

23 SECTION 28 - H910 - ARTS COMMISSION

24

28.1. (ARTS: Professional Artists Contract) Where practicable, all professional artists employed by the Arts Commission in the
 fields of music, theater, dance, literature, musical arts, craft, media arts and environmental arts shall be hired on a contractual basis
 as independent contractors. Where such a contractual arrangement is not feasible employees in these fields may be unclassified,
 however, the approval of their salaries shall be in accord with the provisions of Section 8-11-35 of the 1976 Code.

29 **28.2.** (ARTS: Special Revolving Account) Any income derived from Arts Commission sponsored arts events or by gift, 30 contributions, or bequest now in possession of the Arts Commission including any federal or other funds balance remaining at the 31 end of the prior fiscal year, shall be retained by the commission and placed in a special revolving account for the commission to use 32 solely for the purpose of supporting the programs provided herein. Any such funds shall be subject to the review procedures as set 33 forth in Act 651 of 1978.

(ARTS: Distribution to Subdivisions) Of the funds appropriated and/or authorized to the Arts Commission for Distribution to Subdivisions, the following amounts shall be distributed in the same manner as the funds were distributed in the prior fiscal year, subject to requests received and availability of funds: \$65,000 for Alloc Mun-Restricted; \$10,000 \$34,012 for Alloc Cnty-Restricted;
\$226,280 \$928,569 for Alloc School Dist; \$10,000 \$40,000 for Alloc Other State Agencies; \$368,148 \$459,026 for Alloc-Private Sector; \$25,750 \$42,750 for Alloc Private Sector; \$69,992 \$75,449 for Aid Mun-Restricted; \$25,889 \$41,155 for Aid Cnty-Restricted; \$305,306 \$243,241 for Aid School Districts; \$328,839 \$389,171 for Aid Other State Agencies; \$1,527,874 \$1,580,603 for Aid To Private Sector; \$54,014 \$45,221 for Aid To Private Sector-Reportable; and \$5,855 \$3,750 for Aid to County Libraries.

29.1. (MUSM: Removal From Collections) The commission may remove accessioned objects from its museum collections by 14 gift to another public or nonprofit institution, by trade with another public or nonprofit institution, by public sale, by transfer to the 15 commission's education, exhibit, or study collections or to its operating property inventory; or as a last resort, by intentional 16 destruction on the condition that the objects so removed meet with one or more of the following criteria: (1) they fall outside the 17 scope of the South Carolina Museum Commission's collections as defined in the Collection Policy; (2) they are unsuitable for 18 exhibition or research; (3) they are inferior duplicates of other objects in the collection; or (4) they are forgeries or were acquired on 19 20 the basis of false information; funds from the sale of such objects will be placed in a special revolving account for the commission to use solely for the purpose of purchasing objects for the collections of the State Museum. 21

22 29.2. (MUSM: Museum Store) The Museum Commission shall establish and administer a museum store in the State Museum. 23 This store may produce, acquire, and sell merchandise relating to historical, scientific, and cultural sources. All profits received from 24 the sale of such merchandise shall be retained by the Museum Commission in a restricted fund to be carried forward into the following 25 fiscal year. These funds may be used for store operations, publications, acquisitions, educational programs, exhibit production and 26 general operating expenses provided that the expenditures for such expenses are approved by the General Assembly in the annual 27 Appropriation Act.

28 29.3. (MUSM: Retention of Revenue) The Museum Commission may retain revenue received from admissions, program fees, 29 facility rentals, professional services, donations, food service, exhibits and exhibit components, and other miscellaneous operating 30 income generated by or for the museum and may expend such revenue for general operating expenses provided that such expenditures 31 are approved by the General Assembly in the annual Appropriation Act. Any unexpended revenue from these sources may be carried 32 forward into the current fiscal year to be expended for the same purposes.

29.4. (MUSM: School Tour Fee Prohibition) The commission may not charge admission fees to groups of children from South
 Carolina who have made reservations that are touring the museum as part of a school function.

29.5. (MUSM: Dining Area Rent) Of the space currently vacant in the Columbia Mills Building, space large enough for the
 museum to have dining space for school-aged children shall be provided to the State Museum at no cost.

SECTION 29 - H950 - STATE MUSEUM COMMISSION

1 29.6. (MUSM: Remittance to General Services) The State Museum is directed to remit not less than \$1,800,000 to the 2 Department of Administration as compensation for expenses associated with the premises it leases in the Columbia Mills Building. 3 In the event the General Assembly or the Executive Budget Office implements a mid-year across-the-board budget reduction, the 4 rent that the State Museum remits to the Department of Administration shall be reduced by the same percentage as the assessed 5 budget reduction.

SECTION 30 - H960 - CONFEDERATE RELIC ROOM AND MILITARY MUSEUM COMMISSION

30.1. (CRR: Southern Maritime Collection) The Confederate Relic Room and Military Museum Commission, on behalf of the Hunley Commission is authorized to expend funds appropriated for such purpose to pay the outstanding note entered into to finance the purchase of the Southern Maritime Collection and the Hunley Commission will assume custody and management of the Collection for the State. The commission is authorized to use up to \$500,000 of the funds transferred for implementation of this proviso. The balance of the funds transferred may be used by the commission for costs associated with other Museum operations. The General Assembly will provide for funds in future fiscal years to cover the costs of the financing of the Southern Maritime Collection.

17 SECTION 32 - H730 - DEPARTMENT OF VOCATIONAL REHABILITATION

32.1. (VR: Production Contracts Revenue) All revenues derived from production contracts earned by people with disabilities
 receiving job readiness training at the agency's Work Training Centers may be retained by the State Agency of Vocational
 Rehabilitation and used in the facilities for Client Wages and any other production costs; and further, any excess funds derived from
 these production contracts may be used for other operating expenses and/or permanent improvements of these facilities.

32.2. (VR: Reallotment Funds) To maximize utilization of federal funding and prevent the loss of such funding to other states
 in the Basic Service Program, the State Agency of Vocational Rehabilitation be allowed to budget reallotment and other funds
 received in excess of original projections in following State fiscal years.

32.3. (VR: User/Service Fees) Any revenues generated from user fees or service fees charged to the general public or other parties ineligible for the department's services may be retained to offset costs associated with the related activities so as to not affect the level of service for regular agency clients.

32.4. (VR: Meal Ticket Revenue) All revenues generated from sale of meal tickets may be retained by the agency and expended
 for supplies to operate the agency's food service programs or cafeteria.

31 32.5. (VR: Basic Services Program - Educational Scholarships) For those persons with disabilities who are eligible for and are 32 receiving services under an approved plan of the South Carolina Vocational Rehabilitation Department (consistent with the 1973 33 Rehabilitation Act, as amended) tuition costs at state supported institutions (four year, technical, or trade schools) will not increase 34 beyond the 1998 tuition rate, will be provided, or will be waived by the respective institution after the utilization of any other federal 35 or state student aid for which the student is eligible. Persons eligible for this tuition reduction or sponsorship must meet all academic

33.1. (DHHS: Recoupment/Restricted Fund) The Department of Health and Human Services shall recoup all refunds and
 identified program overpayments and all such overpayments shall be recouped in accordance with established collection policy.
 Further, the Department of Health and Human Services is authorized to maintain a restricted fund, on deposit with the State Treasurer,
 to be used to pay for liabilities and improvements related to enhancing accountability for future audits. The restricted fund will
 derive from prior year program refunds. The restricted fund shall not exceed one percent of the total appropriation authorization for
 the current year. Amounts in excess of one percent will be remitted to the general fund.

33.2. (DHHS: Long Term Care Facility Reimbursement Rate) The department, in calculating a reimbursement rate for long term 12 care facility providers, shall obtain for each contract period an inflation factor, developed by the Revenue and Fiscal Affairs Office. 13 Data obtained from Medicaid cost reporting records applicable to long term care providers will be supplied to the Revenue and Fiscal 14 Affairs Office. A composite index, developed by the Revenue and Fiscal Affairs Office will be used to reflect the respective costs 15 of the components of the Medicaid program expenditures in computing the maximum inflation factor to be used in long term care 16 contractual arrangements involving reimbursement of providers. The Revenue and Fiscal Affairs Office shall update the composite 17 index so as to have the index available for each contract renewal. 18 The department may apply the inflation factor in calculating the reimbursement rate for the new contract period from zero percent 19

19 The department may apply the inflation factor in calculating the reimbursement rate for the new contract period from zero percent 20 up to the inflation factor developed by the Revenue and Fiscal Affairs Office.

33.3. (DHHS: Medical Assistance Audit Program Remittance) The Department of Health and Human Services shall remit to the State Auditor's Office an amount representing fifty percent (allowable Federal Financial Participation) of the cost of the Medical Assistance Audit Program as established in the State Auditor's Office of the State Fiscal Accountability Authority, Section 105. Such amount shall also include appropriated salary adjustments and employer contributions allocable to the Medical Assistance Audit Program. Such remittance to the State Auditor's Office shall be made monthly and based on invoices as provided by the State Auditor's Office of the State Fiscal Accountability Authority.

33.4. (DHHS: Third Party Liability Collection) The Department of Health and Human Services is allowed to fund the net costs
 of any Third Party Liability and Drug Rebate collection efforts from the monies collected in that effort.

33.5. (DHHS: Medicaid State Plan) Where the Medicaid State Plan has been altered to cover services that previously were provided by one hundred percent state funds, or that have been requested to be added by other state agencies, the department can bill other agencies for the state share of services provided through Medicaid. In order to comply with Federal regulations regarding allowable sources of matching funds, state agencies are authorized to make appropriation transfers to the Department of Health and Human Services to be used as the state share when certified public expenditures are not allowed for those state agency Medicaid services. The department will keep a record of all services affected and submit periodic reports to the Senate Finance and House Ways and Means Committees.

33.6. (DHHS: Medically Indigent Assistance Fund) The department is authorized to expend disproportionate share funds to all 1 2 eligible hospitals with the condition that all audit exceptions through the receipt and expenditures of these funds are the liability of the hospital receiving the funds. 3 33.7. (DHHS: Registration Fees) The department is authorized to receive and expend registration fees for educational, training, 4 5 and certification programs. 6 **33.8.** (DHHS: Fraud and Abuse Collections) The Department of Health and Human Services may offset the administrative costs 7 associated with controlling fraud and abuse. 8 **33.9.** (DHHS: Medicaid Eligibility Transfer) The South Carolina Department of Health and Human Services (DHHS) is hereby authorized to determine the eligibility of applicants for the South Carolina Medicaid Program in accordance with the State Plan 9 Under Title XIX of The Social Security Act Medical Assistance Program. The governing authority of each county shall provide 10 office space and facility service for this function as they do for DSS functions under Section 43-3-65. 11 33.10. (DHHS: Franchise Fees Suspension) Franchise fees imposed on nursing home beds and enacted by the General Assembly 12 during the 2002 session are suspended. 13 33.11. (DHHS: Program Integrity Efforts) The Department of Health and Human Services is instructed to expand its program 14 integrity efforts by utilizing resources both within and external to the agency including, but not limited to, the ability to contract with 15 other entities for the purpose of maximizing the department's ability to detect and eliminate provider fraud. 16 **33.12.** (DHHS: Post Payment Review) The department is directed to perform post payment reviews as permitted under Medicaid 17 regulations to ensure compliance with the Hyde Amendment provisions as it relates to the performance of medically necessary 18 services under the Medicaid program. The results of such reviews shall be available to the General Assembly upon request in a 19 format that meets the requirements of the Health Insurance Accountability and Portability Act (HIPAA) and Medicaid confidentiality 20 regulations. 21 33.13. (DHHS: Long Term Care Facility Reimbursement Rates) The department shall direct staff to complete and submit its 22 23 Medicaid State Plan Amendment for long term care facility reimbursement rates to the Director of the Department of Health and Human Services by August first of each year. The director shall review the plan and submit to the Federal Government on or before 24 25 August fifteenth of each year provided the State Appropriations Act has been enacted by that date. All additional requests for 26 information from CMS concerning the plan shall be promptly submitted to CMS by the Department of Health and Human Services. 27 33.14. (DHHS: Nursing Services to High Risk/High Tech Children) The Department of Health and Human Services shall continue 28 a separate classification and compensation plan for Registered Nurses (RN) and Licensed Practical Nurses (LPN) who provide services to Medically Fragile Children, who are Ventilator dependent, Respirator dependent, Intubated, and Parenteral feeding or 29 any combination of the above. The classification plan shall recognize the skill level that these nurses caring for these Medically 30 31 Fragile Children must have over and above normal home-care or school-based nurses.

32 33.15. (DHHS: <u>SCHIP</u> <u>CHIP</u> Enrollment and Recertification) The Department of Health and Human Services shall enroll and 33 recertify eligible children to the <u>State</u> Children's Health Insurance Program (<u>SCHIP</u> <u>CHIP</u>) and must use available state agency 34 program data <u>including</u>, <u>but not limited to</u>, <u>that</u> housed in the Revenue and Fiscal Affairs Office, to include the Department of Social 35 Social 25 Social

35 Services' Food Stamp program Supplemental Nutritional Assistance Program (SNAP) and the department may use the poverty-

related information from the Department of Education's Free and Reduced Meal eligibility data Education. Use of this data and 1 2 cooperative efforts between state agencies reduces the cost of outreach and maintenance of eligibility for SCHIP CHIP. **33.16.** (DHHS: Carry Forward) The Department of Health and Human Services is authorized to carry forward cash balances from 3 4 the prior fiscal year into the current fiscal year for any earmarked or restricted trust and agency, or special revenue account or subfund. 5 The department shall submit a comprehensive reporting of all cash balances brought forward from the prior fiscal year. The report 6 shall, at a minimum, for each account or subfund include the following: the statutory authority that allows the funds to be carried forward, the maximum authorized amount that can be carried forward, the general purpose or need for the carry forward, the specific 7 source(s) of funding or revenue that generated the carry forward, and a detailed description of any pending obligations against the 8 carry forward. The report must be submitted to the President Pro Tempore of the Senate, Chairman of the Senate Finance Committee, 9 Speaker of the House of Representatives, and Chairman of the House Ways and Means Committee, within fifteen days after the 10 Comptroller General closes the fiscal year. 11 12 **33.17.** (DHHS: Medicaid Provider Fraud) The department shall expand and increase its effort to identify, report, and combat Medicaid provider fraud. The department shall publish on its' agency homepage by April first, of the current fiscal year, the results 13 of these efforts, the funds recovered, and information pertaining to prosecutions of such cases, including pleas agreements entered 14 15 into. **33.18.** (DHHS: GAPS) The requirements of Article 5, Chapter 6, Title 44 shall be suspended for the current state fiscal year. 16 33.19. (DHHS: Disproportionate Share - DMH) For the current fiscal year, the department is directed to transfer funds to the 17 Department of Mental Health to make up any shortfall in disproportionate share funding due to rule changes from the Center for 18 Medicare and Medicaid Services from the latest federal fiscal year amount. The department must also take any necessary action, 19 including the submission of an amendment to the State Medicaid Plan, to minimize the impact of disproportionate share funding 20 redistribution to the Department of Mental Health in future years. 21 **33.20.** (DHHS: Contract Authority) The Department of Health and Human Services is authorized to contract with community-22 23 based not-for-profit organizations for local projects that further the objectives of department programs. The department shall develop policies and procedures and may promulgate regulations to assure compliance with state and federal requirements associated with 24 25 the funds used for the contracts and to assure fairness and accountability in the award and administration of these contracts. The department may require a match from contract recipients. The department shall report to the Chairman of the Senate Finance 26 Committee and the Chairman of the House Ways and Means Committees on the contracts administered. 27 28 **33.21.** (DHHS: Medicaid Accountability and Quality Improvement Initiative) From the funds appropriated and authorized to the 29 Department of Health and Human Services, the department is authorized to implement the following accountability and quality 30 improvement initiatives: 31 (A) Healthy Outcomes Initiative - The Department of Health and Human Services may tie Disproportionate Share Hospital (DSH) payments to participation in the Healthy Outcomes Initiative and may expand the program as DSH funding is available. 32 (B) To improve community health, the department may explore various health outreach, education, patient wellness and 33 34 incentive programs. The department may pilot health interventions targeting diabetes, smoking cessation, weight management, heart disease, and other health conditions. These programs may be expanded as their potential to improve health and lower costs are 35 identified by the department. 36

1 (C) Rural Hospital DSH Payment - Medicaid-designated rural hospitals in South Carolina may be eligible to receive up to one 2 hundred percent of costs associated with uncompensated care as part of the DSH program. Funds shall be allocated from the existing 3 DSH program and shall not exceed \$25,000,000 total funds. To be eligible, rural hospitals must participate in reporting and quality 4 guidelines published by the department and outlined in the Healthy Outcomes Initiative. In addition to the requirements placed upon 5 them by the department, rural hospitals must actively participate with the department and any other stakeholder identified by the 6 department, in efforts to design an alternative health care delivery system in these regions.

7 (D) Primary Care Safety Net - The department shall implement a methodology to reimburse safety net providers participating 8 in a hospital Healthy Outcomes Initiative program to provide primary care, behavioral health services, and pharmacy services for chronically ill individuals that do not have access to affordable insurance. Qualifying safety net providers are approved, licensed, 9 and duly organized Federally Qualified Health Centers (FQHCs, and other entities receiving funding under Section 330 of the Public 10 Health Services Act, and FOHC Look A Likes), Rural Health Clinics (RHCs), local alcohol and drug abuse authorities established 11 12 by Act 301 of 1973, Free Clinics, other clinics serving the uninsured, and Welvista. The department shall formulate a methodology and allocate at least \$5,000,000 \$4,000,000 for innovative care strategies for qualifying safety net providers. The department shall 13 formulate a separate methodology and allocate \$8,000,000 \$6,400,000 of funding to FQHCs at least \$4,000,000 for documented 14 capital needs for FQHCs, at least \$2,000,000 \$1,600,000 for of funding for Free Clinics, and at least \$2,000,000 \$1,600,000 of 15 funding for local alcohol and drug abuse authorities created under Act 301 of 1973. The department shall develop a process for 16 obtaining encounter-level data that may be used to access assess the cost and impact of services provided through this proviso. The 17 18 department shall also explore a transition to a prospective payment system for FOHCs to provide greater predictability and stability for FOHC budgets. 19

20 (E) Rural and Underserved Area Provider Capacity - The department shall incentivize the development of primary care access 21 in rural and underserved areas through the following mechanisms:

(1) the department shall leverage Medicaid spending on Graduate Medical Education (GME) by implementing
 methodologies that support recommendations contained in the January 2014 report of the South Carolina GME Advisory Group;

(2) the department shall develop <u>or continue</u> a program to leverage the use of teaching hospitals to provide rural physician
 coverage, expand the use of Telemedicine, and ensure targeted placement and support of OB/GYN services in at least four counties
 with a demonstrated lack of adequate OB/GYN resources by June 30, <u>2016</u> <u>2017</u>; and

(3) during the current fiscal year the department shall contract with the MUSC Hospital Authority in the amount of 27 28 \$10,000,000 to lead the development and operation of an open access South Carolina Telemedicine Network. Working with the 29 department, the MUSC Hospital Authority shall collaborate with Palmetto Care Connections to pursue this goal. No less than \$1,000,000 of these funds shall be allocated toward support of Palmetto Care Connections and other hospitals in South Carolina. 30 31 MUSC Hospital Authority must provide the department with quarterly reports regarding the funds allocation and progress of telemedicine transformation efforts and networks. MUSC Hospital Authority shall publish a summary report to the General 32 Assembly indicating the overall progress of the state's telemedicine transformation by March 1, 2015 2017. In addition, the 33 34 department shall also contract with the MUSC Hospital Authority in the amount of \$1,000,000, and the USC School of Medicine in 35 the amount of \$2,000,000 to further develop statewide teaching partnerships.

1 (4) the department shall partner with the University of South Carolina School of Medicine to develop a statewide Rural 2 Health Initiative to identify strategies for significantly improving health care access, supporting physicians, and reducing health 3 inequities in rural communities. *Any funding supplied by the department in support of the Rural Health Initiative may be deducted* 4 *from the allocation made to the USC School of Medicine in section (E)(3) of this proviso.*

5 (F) The department shall allocate funds to be used for obesity education for patients, reimbursement payments for providers, 6 and continuing education for all providers through partnerships with the Department.

(G) To be eligible for funds in this proviso, providers must provide the department with patient, service and financial data to
assist in the operation and ongoing evaluation of both the initiatives resulting from this proviso, and other price, quality, transparency
and DSH accountability efforts currently underway or initiated by the department. The Revenue and Fiscal Affairs Office shall
provide the department with any information required by the department in order to implement this proviso in accordance with state
law and regulations.

12 (H) The department shall <u>may</u> pilot an all-inclusive health intervention program for wrap-around care to vulnerable mental 13 health patients who frequent the emergency room in hotspots and underserved areas within the state. The pilot program must provide 14 reports detailing progress on the target population and health outcomes achieved. These programs may be expanded as their potential 15 to improve health and lower costs are identified by the department.

16 (I) The department shall publish quarterly reports on the agency's website regarding the department's progress in meeting the 17 goals established by this provision.

33.22. (DHHS: Medicaid Healthcare Initiatives Outcomes) Prior to February fifteenth of the current fiscal year, the Director of
 the Department of Health and Human Services shall make a presentation to the House Ways and Means Healthcare Budget
 Subcommittee on the outcomes of Medicaid healthcare initiatives enacted during the current fiscal year to improve the well-being of
 persons enrolled in the Medicaid program and receiving services from Medicaid providers.

33.23. (DHHS: Carry Forward Authorization) For the current fiscal year, the Department of Health and Human Services is authorized to carry forward and expend any General Fund balances for the Medicaid program. Within thirty days after the close of the fiscal year, the department shall report the balance carried forward to the Chairman of the Senate Finance Committee and the Chairman of the House Ways and Means Committee.

26 **33.24.** (DHHS: Hospital Transformation Plans) The Department of Health and Human Services shall continue a program to help qualifying hospitals transition to more sustainable models of service delivery that meet the needs of their community and reduce 27 reliance on inpatient admissions, surgery or high tech diagnostics. This includes encouraging new long term partnerships between 28 rural hospitals and community, tertiary and teaching facilities to ensure seamless, timely and high quality clinical care for patients in 29 30 rural areas of the state. Notwithstanding the provisions in its existing regulations, for the current fiscal year, the Department of Health and Environmental Control, may in its discretion, make exceptions to applicable licensing standards and regulations where it 31 is determined that the exception will assist in the successful implementation and operation of the plans developed by the Department 32 of Health and Human Services pursuant to this provision; the health, safety, and well-being of the community will not be 33 compromised by the exception; and provided that the standard is not specifically required by statute. The program shall provide 34 funding that fully or partially offsets the one-time costs of these transitions. The department shall develop the methodology for 35

36 funding award amounts and distribution and may prioritize funding to target hotspots of poor health and/or limited health care access.

Total state funds available statewide for transition funding shall not exceed \$15,000,000, less funds allocated during the prior fiscal 1 2 year, and the department may leverage federal funds or other funding mechanisms to maximize resources as appropriate and approved by CMS. Plans must be submitted to the department on or before April 1, 2016. No partnership may receive an allocation in the 3 4 current fiscal year that would result in it having received more than \$4,000,000 in cumulative support through the hospital 5 transformation program. The department shall provide reports detailing progress on transformation efforts to the Chairman of the Senate Finance Committee and the Chairman of the House Ways and Means Committee by January 1, 2016 and by June 1, 2016. 6 7 33.25. (DHHS: Healthcare Workforce Analysis) Of the funds appropriated to the Department of Health and Human Services, the 8 department shall transfer \$200,000 to the Area Health Education Consortium (AHEC) for the Office of Healthcare Workforce 9 Analysis. **33.26.** (DHHS: Healthy Connections Prime Participation) In the current fiscal year participation in Healthy Connections Prime 10 shall be limited to individuals who affirmatively elect to participate until April 1, 2016, at which time the department may begin 11 passively enrolling participants. 12 33.27. (DHHS: Rural Health Initiative) From the funds appropriated to the Department of Health and Human Services for the 13 Rural Health Initiative, the department shall partner with the following state agencies, institutions, and other key stakeholders to 14 15 implement these components of a Rural Health Initiative to better meet the needs of medically underserved communities throughout the state. The department may leverage any and all available federal funds to implement this initiative. 16 (A) The Department of Health and Human Services shall take appropriate action to facilitate the following provisions: 17 (1) Rural Healthcare and Education - The USC School of Medicine shall consult with the South Carolina Office of Rural 18 Health in preparing a proposal for a Center of Excellence to support and develop rural medical education and delivery infrastructure 19 with a statewide focus through clinical practice, training and research as well as collaboration with other state agencies and 20 institutions. The department may grant funds to support Center staffing as well as the programs and collaborations delivering rural 21 22 health research, the ICARED program, workforce development scholarships and recruitment, rural fellowships, health education 23 development, and/or rural practice support and education. Funding released by the department pursuant to this section must not be 24 used by the recipient(s) to supplant existing resources already used for the same or comparable purposes. 25 (2) Rural Medicine Workforce Development - The department, in consultation with the Medical Education Advisory 26 Committee, shall support the development of additional residency and/or fellowship slots or programs in rural medicine, family 27 medicine, and any other appropriate primary care specialties that have been identified by the department as not being adequately served by existing Graduate Medical Education programs. New training sites and/or residency positions are subject to approval as 28 specified by the Accreditation Council for Graduate Medical Education (ACGME). Applications to the ACGME must be developed 29 no later than June 30, 2017. The department may also accept proposals and award grants for programs designed to expose resident 30 physicians to rural practice and enhance the opportunity to recruit these residents for long term practice in these rural and/or 31 underserved communities. Up to \$500,000 of the recurring funds appropriated to the department for the Rural Health Initiative may 32 be used for this purpose. 33 34 (B) The department shall investigate the potential use of DSH and/or any other allowable and appropriate source of funds in order to improve access to emergency medical services in one or more communities identified by the department in which such 35 access has been degraded due to a hospital's closure during the past five years. In the current fiscal year, the department is 36

13	34.1. (DHEC: County Health Departments Funding) Out of the appropriation provided in this section for "Access to Care", the
14	sum of \$25,000 shall be distributed to the county health departments by the commissioner, with the approval of the Board of
15	Department of Health and Environmental Control, for the following purposes:
16	(1) To insure the provision of a reasonably adequate public health program in each county.
17	(2) To provide funds to combat special health problems that may exist in certain counties.

20	(4) To encourage and promote local participation in financial support of the county health departments.
21	(5) To meet emergency situations which may arise in local areas.
22	(6) To fit funds available to amounts budgeted when small differences occur.
23	The provisions of this proviso shall not supersede or suspend the provisions of Section 13-7-30 of the 1976 Code.
24	34.2. (DHEC: County Health Units) General funds made available to the Department of Health and Environmental Control for
25	the allocation to the counties of the State for operation of county health units be allotted on a basis approved by the Board of the
26	Department of Health and Environmental Control. The amount of general funds appropriated herein for Access to Care shall be
27	allocated on a basis such that no county budget shall receive less than the amount received in the prior fiscal year, except when
28	instructed by the Executive Budget Office or the General Assembly to reduce funds within the department by a certain percentage,
29	the department may unilaterally reduce the county health units up to the stipulated percentage.
30	34.3. (DHEC: Camp Burnt Gin) Private donations or contributions for the operation of Camp Burnt Gin shall be deposited in a
31	restricted account. These funds may be carried forward and shall be made available as needed to fund the operation of the camp.
32	Withdrawals from this restricted account must be in accordance with approved procedures.
33 34	34.4. (DHEC: Children's Rehabilitative Services) The Children's Rehabilitative Services shall be required to utilize any available financial resources including insurance benefits and/or governmental assistance programs, to which the child may otherwise
34 35	be entitled in providing and/or arranging for medical care and related services to physically handicapped children eligible for such
36	services, as a prerequisite to the child receiving such services.

34.5. (DHEC: Cancer/Hemophilia) Notwithstanding any other provisions of this act, the funds appropriated herein for prevention, detection and surveillance of cancer as well as providing for cancer treatment services, \$545,449 and the hemophilia assistance program, \$1,186,928 shall not be transferred to other programs within the agency and when instructed by the Executive Budget Office or the General Assembly to reduce funds within the department by a certain percentage, the department may not act unilaterally to reduce the funds for any cancer treatment program and hemophilia assistance program provided for herein greater than such stipulated percentage.

7 **34.6.** (DHEC: Local Health Departments) Counties of the state will be relieved of contribution requirements for salary, fringe 8 benefits and travel reimbursement to local health departments. The amount of \$5,430,697 is appropriated for county health department salaries, fringe benefits and travel. These funds and other state funds appropriated for county health units may, based 9 upon need, be utilized in either salary or travel categories. The monies allocated to the Counties are for the 18 purpose of improving or upgrading the local EMS system through the licensed ambulance services, the monies allocated to the EMS 19 Regional Councils are for the administration of training programs and technical assistance to local EMS organizations and county 20 systems. All additional funds are to be allocated as follows: to the counties at the ratio of eighty-one percent of the additional funds 21 appropriated herein, to the EMS Regions at a ratio of twelve percent of the additional funds appropriated herein and to the state EMS 22 23 Office at the ratio of seven percent of the additional funds appropriated herein. The Department of Health and Environmental Control shall develop criteria and guidelines and administer the system to make allocations to each region and county within the state, based 24 25 on demonstrated need and local match. Funds appropriated to Emergency Medical Services shall not be transferred to other programs 26 within the department's budget. Unexpended funds appropriated to the program may be carried forward to succeeding fiscal years and expended for administrative and operational support and for temporary and contract employees to assist with duties related to 27 improving and upgrading the EMS system throughout the state, including training of EMS personnel and administration of grants to 28 local EMS providers. In addition, when instructed by the Executive Budget Office or the General Assembly to reduce funds by a 29 certain percentage, the department may not reduce the funds appropriated for EMS Regional Councils or Aid to Counties greater 30 31 than such stipulated percentage.

32 **34.9.** (DHEC: Rape Violence Prevention Contract) Of the amounts appropriated in Rape Violence Prevention, \$1,103,956 shall 33 be used to support programmatic efforts of the state's rape crisis centers with distribution of these funds based on the Standards and 34 Outcomes for Rape Crisis Centers and each center's accomplishment of a preapproved annual action plan. For the current fiscal 35 year, the department shall not reduce these contracts below the current funding level.

(DHEC: Sickle Cell Blood Sample Analysis) \$16,000 is appropriated in Independent Living for the Sickle Cell Program 1 2 for Blood Sample Analysis and shall be used by the department to analyze blood samples submitted by the four existing regional programs - Region I, Barksdale Sickle Cell Anemia Foundation in Spartanburg; Region II, Clark Sickle Cell Anemia Foundation in 3 4 Columbia; Region III, Committee on Better Racial Assurance Hemoglobinopathy Program in Charleston; and the Orangeburg Area 5 Sickle Cell Anemia Foundation. **34.11.** (DHEC: Sickle Cell Programs) \$761,233 is appropriated for Sickle Cell program services and shall be apportioned as 6 7 follows: (1) sixty-seven percent is to be divided equitably between the existing Community Based Sickle Cell Programs located in 8 Spartanburg, Columbia, Orangeburg, and Charleston; and 9 (2) thirty-three percent is for the Community Based Sickle Cell Program at DHEC. 10 The funds shall be used for providing prevention programs, educational programs, testing, counseling and newborn screening. 11 The existing Community Based Sickle Cell Programs will provide counseling for families of newborns who test positive for sickle 12 cell trait or other similar blood traits upon referral from DHEC. The balance of the total appropriation must be used for Sickle Cell 13 Services operated by the Independent Living program of DHEC. The funds appropriated to the community based sickle cell centers 14 shall be reduced to reflect any percent reduction assigned to the Department of Health and Environmental Control by the Executive 15 Budget Office; provided, however, that the department may not act unilaterally to reduce the funds for the Sickle Cell program 16 greater than such stipulated percentage. The department shall not be required to undertake any treatment, medical management or 17 health care follow-up for any person with sickle cell disease identified through any neonatal testing program, beyond the level of 18 services supported by funds now or subsequently appropriated for such services. No funds appropriated for ongoing or newly 19 established sickle cell services may be diverted to other budget categories within the DHEC budget. For the current fiscal year, the 20 21 department shall not reduce these funds below the current funding level. **34.12.** (DHEC: Genetic Services) The sum of \$104,086 appearing under the Independent Living program of this act shall be 22 appropriated to and administered by the Department of Health and Environmental Control for the purpose of providing appropriate 23 genetic services to medically needy and underserved persons. Such funds shall be used by the department to administer the program 24 25 and to contract with appropriate providers of genetic services. Such services will include genetic screening, laboratory testing, counseling, and other services as may be deemed beneficial by the department, and these funds shall be divided equally among the 26 three Regional Genetic Centers of South Carolina, composed of units from the Medical University of South Carolina, the University 27 28 of South Carolina School of Medicine, and the Greenwood Genetic Center. 29 34.13. (DHEC: Revenue Carry Forward Authorization) The Department of Health and Environmental Control is hereby authorized to collect, expend, and carry forward revenues in the following programs: Sale of Goods (confiscated goods, arm patches, 30 31 etc.), sale of meals at Camp Burnt Gin, sale of publications, brochures, Spoil Easement Areas revenue, performance bond forfeiture revenue for restoring damaged critical areas, beach renourishment appropriations, photo copies and certificate forms, including but 32 not limited to, pet rabies vaccination certificate books, sale of listings and labels, sale of State Code and Supplements, sale of films 33 34 and slides, sale of maps, sale of items to be recycled, including, but not limited to, used motor oil and batteries, sale and/or licensing of software products developed and owned by the Department, and collection of registration fees for non-DHEC employees. Any 35

36 unexpended balance carried forward must be used for the same purpose.

(DHEC: Medicaid Nursing Home Bed Days) Pursuant to Section 44-7-84(A) of the 1976 Code, the maximum number of 1 2 Medicaid patient days for which the Department of Health and Environmental Control is authorized to issue Medicaid nursing home permits is 4.452.015. 3 4 34.15. (DHEC: Health Licensing Fee) Funds resulting from an increase in the Health Licensing Fee Schedule shall be retained 5 by the department to fund increased responsibilities of the health licensing programs. Failure to submit a license renewal application or fee to the department by the license expiration date shall result in a late fee of \$75 or twenty-five percent of the licensing fee 6 7 amount, whichever is greater, in addition to the licensing fee. Continual failure to submit completed and accurate renewal 8 applications and/or fees by the time period specified by the department shall result in enforcement actions. The department may waive any or all of the assessed late fees in extenuating circumstances, as long as it is with public knowledge. 9 34.16. (DHEC: Infectious Waste Contingency Fund) The Department of Health and Environmental Control is authorized to use 10 not more than \$75,000 from the Infectious Waste Contingency Fund per year for personnel and operating expenses to implement the 11 Infectious Waste Act. 12 34.17. (DHEC: Nursing Home Medicaid Bed Day Permit) When transfer of a Medicaid patient from a nursing home is necessary 13 due to violations of state or federal law or Medicaid certification requirements, the Medicaid patient day permit shall be transferred 14 with the patient to the receiving nursing home. The receiving facility shall apply to permanently retain the Medicaid patient day 15 permit within sixty days of receipt of the patient. 16 34.18. (DHEC: Mineral Sets Revenue) The department is authorized to charge a reasonable fee for mineral sets. Funds generated 17 from the sale of mineral sets may be retained by the department in a revolving account with a maximum carry forward of \$2,000 and 18 must be expended for mineral set supplies and related mining and reclamation educational products. 19 34.19. (DHEC: Spoil Easement Areas Revenue) The department is authorized to collect, retain and expend funds received from 20 the sale of and/or third party use of spoil easement areas, for the purpose of meeting the State of South Carolina's responsibility for 21 providing adequate spoil easement areas for the Atlantic Intracoastal Waterway in South Carolina. 22 23 **34.20.** (DHEC: Per Visit Rate) The SC DHEC is authorized to compensate nonpermanent, part-time employees on a fixed rate per visit basis. Compensation on a fixed rate per visit may be paid to employees for whom the department receives per visit 24 reimbursement from other sources. These individuals will provide direct patient care in a home environment. The per visit rate may 25 26 vary based on the discipline providing the care and the geographical location of services rendered. Management may pay exempt or nonexempt employees as defined by the Fair Labor Standards Act only when they are needed to work. Individuals employed in this 27 category may exceed twelve months, but are not eligible for State benefits except for the option of contributing to the State Retirement 28 29 System. 34.21. (DHEC: Allocation of Indirect Cost and Recoveries) The department shall continue to deposit in the general fund all 30 indirect cost recoveries derived from state general funds participating in the calculation of the approved indirect cost rate. Further 31 administration cost funded with other funds used in the indirect cost calculation may, based on their percentage, be retained by the 32

33 agency to support the remaining administrative costs of the agency.

34 34.22. (DHEC: Permitted Site Fund) The South Carolina Department of Health and Environmental Control may expend funds as
 35 necessary from the permitted site fund established pursuant to Section 44-56-160(B)(1), for legal services related to environmental
 36 response, regulatory, and enforcement matters, including administrative proceedings and actions in state and all federal courts.

BHFL shall retain up to the 5 first \$50,000 of civil monetary penalties collected each fiscal year and these funds shall be utilized solely to carry out and enforce 6 the provisions of regulations applicable to that division. These funds shall be separately accounted for in the department's fiscal 7 records.

8 **34.25.** (DHEC: Health Facility Facilities Licensing Monetary Penalties) In the course of regulating health care facilities/ and services, the Division of Construction/Fire & Life Safety (DCFLS) Bureau of Health Facilities Licensing (BHFL) assesses civil 9 monetary penalties against nonconforming providers. DCFLS BHFL shall retain up to the first \$100,000 of civil monetary penalties 10 collected each fiscal year and these funds shall be utilized solely to carry out and enforce the provisions of regulations applicable to 11 that division. These funds shall be separately accounted for in the department's fiscal records. Regulations for nursing home staffing 12 for Fiscal Year 2015-16 the current fiscal year must (1) provide a minimum of one and sixty-three hundredths (1.63) hours of direct 13 care per resident per day from the non-licensed nursing staff; and (2) maintain at least one licensed nurse per shift for each staff work 14 area. All other staffing standards and non-staffing standards established in Standards for Licensing Nursing Homes: R61-17, Code 15 of State Regulations, must be enforced. 16 34.26. (DHEC: Radiological Health Monetary Penalties) In the course of regulating health care facilities/services, the Bureau of 17 Radiological Health (BRH) assesses civil monetary penalties against nonconforming providers. BRH shall retain up to the first 18

\$30,000 of civil monetary penalties collected each fiscal year and these funds shall be utilized solely to carry out and enforce the
 provisions of regulations applicable to that Bureau. These funds shall be separately accounted for in the department's fiscal records.
 34.27. (DHEC: Prohibit Use of Funds) The Department of Health and Environmental Control must not use any state appropriated

22 funds to terminate a pregnancy or induce a miscarriage by chemical means.

34.28. (DHEC: Meals in Emergency Operations) The cost of meals may be provided to state employees who are required to work
 during actual emergencies and emergency simulation exercises when they are not permitted to leave their stations.

34.29. (DHEC: Compensatory Payment) In the event the President of the United States has declared a state of emergency or the
 Governor has declared a state of emergency in a county in the State, Fair Labor Standards Act exempt employees of the department
 may be paid for actual hours worked in lieu of accruing compensatory time, at the discretion of the agency Director, and providing
 funds are available.

34.30. (DHEC: Beach Renourishment and Monitoring and Coastal Access Improvement) If state funds are made available or carried forward from any general revenue, capital, surplus or bond funding appropriated to the department for beach renourishment and maintenance, the department shall be able to expend not more than \$100,000 of these funds annually to support annual beach profile monitoring. Additional funds made available or carried forward for beach renourishment projects that are certified by the department as excess may be spent for beach renourishment and departmental activities that advance the policy goals contained in the State Beachfront Management Plan, R.30-21.

35 34.31. (DHEC: South Carolina State Trauma Care Fund) Of the funds appropriated to the South Carolina State Trauma Care
 36 Fund, \$2,268,885 shall be utilized for increasing the reimbursement rates for trauma hospitals, for trauma specialists' professional

fee, for increasing the capability of EMS trauma care providers from counties with a high rate of traumatic injury deaths to care for 1 2 injury patients, and for support of the trauma system, based on a methodology as determined by the department with guidance and input from the Trauma Council as established in Section 44-61-530 of the South Carolina Code of Laws. The methodology to be 3 4 developed will include a breakdown of disbursement of funds by percentage, with a proposed seventy-six and one half percent 5 disbursed to hospitals and trauma physician fees, sixteen percent of the twenty-one percent must be disbursed to EMS providers for 6 training EMTs, Advanced EMTs and paramedics by the four regional councils of this state and the remaining five percent must be 7 disbursed to EMS providers in counties with high trauma mortality rates, and two and one half percent allocated to the department for administration of the fund and support of the trauma system. 12 to cope with a major influenza outbreak or pandemic influenza and maintain an emergency plan and stockpile of medicines and supplies to improve the state's readiness condition. The department shall report on preparedness measures to the Speaker of the 13 House of Representatives, the President Pro Tempore of the Senate, and the Governor by November first, each year. The department, 14 in conjunction with the Department of Health and Human Services, is authorized to establish a fund for the purpose of developing 15 an emergency supply, stockpile, and distribution system of appropriate antiviral, antibiotic, and vaccine medicines and medical 16 supplies. In the event the United States Department of Health and Human Services makes available medicines or vaccines for 17 purchase by states via federal contract or federally subsidized contract or other mechanism, the department, with Executive Budget 18 Office approval, may access appropriated or earmarked funds as necessary to purchase an emergency supply of these medicines for 19 the State of South Carolina. 20

34.33. (DHEC: Pharmacist Services) For the current fiscal year, provisions requiring that all department facilities distributing or 21 dispensing prescription drugs be permitted by the Board of Pharmacy and that each pharmacy have a pharmacist-in-charge are 22 23 suspended. Each Department of Health and Environmental Control Public Health Region shall be required to have a permit to 24 distribute or dispense prescription drugs. A department pharmacist may serve as the pharmacist-in-charge without being physically 25 present in the pharmacy. The department is authorized to designate one pharmacist-in-charge to serve more than one department 26 facility. Only pharmacists, nurses, or physicians are allowed to dispense and provide prescription drugs/products/vaccines for conditions or diseases that the department treats, monitors, or investigates. In the event of a public health emergency or upon 27 28 activation of the strategic national stockpile, other medications may be dispensed as necessary.

34.34. (DHEC: Coastal Zone Appellate Panel) The Coastal Zone Appellate Panel as delineated in Section 48-39-40 of the 1976
 Code under the Department of Health and Environmental Control shall be suspended for the current fiscal year.

31 34.35. (DHEC: Rural Hospital Grants) Rural Hospital Grants funds shall be allocated to public hospitals in very rural or rural 32 areas whose largest town is less than 25,000 and whose licensed bed capacity does not exceed two hundred beds. Hospitals qualifying 33 for the grants shall utilize such funds for any of the following purposes: (a) the development of preventive health programs, medical 34 homes, and primary care diversion from emergency departments; (b) expanded health services, including physician recruitment and 35 retention;(c) to improve hospital facilities; (d) activities involving electronic medical records or claims processing systems; (e) to

34.38. (DHEC: Fetal Pain Awareness) (A) The department must utilize at least one hundred dollars to prepare printed materials concerning information that unborn children at twenty weeks gestation and beyond are fully capable of feeling pain and the right of a woman seeking an abortion to ask for and receive anesthesia to alleviate or eliminate pain to the fetus during an abortion procedure. The materials must be provided to each abortion provider in the State and must be placed in a conspicuous place in each examination

14 room at the doctor's office. The materials must contain only the following information:

15

"Fetal Pain Awareness

An unborn child who is twenty weeks old or more is fully capable of experiencing pain. Anesthesia provided to a woman for an abortion typically offers little pain prevention for the unborn child. If you choose to end your pregnancy, you have a right to have anesthesia or analgesic administered to alleviate the pain to your unborn child during the abortion."

19 (B) The materials must be easily comprehendible and must be printed in a typeface large and bold enough to be clearly legible.

34.39. (DHEC: SCHIDS) From funds appropriated for Chronic Disease Prevention, the department shall establish a South Carolina Health Integrated Data Services (SCHIDS) program to disseminate data about prevalence, treatment and cost of disease from the South Carolina Health and Human Services Data Warehouse and in particular the Medicaid System. The purpose of the program is to educate communities statewide about improving health and wellness through lifestyle changes.

(DDSN: Greenwood Genetic Center Autism Research) The department is authorized to transfer up to \$500,000 of 10 unencumbered funds from the PDD autism waiver to the Greenwood Genetic Center for autism research. 11 12 **36.13.** (DDSN: Medicaid Direct Billing) The department shall facilitate Medicaid direct billing for all providers, including local disabilities and special needs boards, who choose to initiate the direct billing process regardless of the receipt of capital grant funds 13 from the department for the specific facility involved. All entities receiving capital grant funds must use the funds as originally 14 specified in the award. If the purpose or use of a facility constructed or purchased with departmental grant funds is altered without 15

(DAODAS: Medicaid Match Transfer) At the beginning of the fiscal year, the Department of Alcohol and Other Drug 12 Abuse Services will transfer \$1,915,902 to the Department of Health and Human Services to meet federal Medicaid Match 13 participation requirements for the delivery of alcohol and other drug abuse services to the Medicaid beneficiary population.

37.4. (DAODAS: Health Information Technology) The Department of Alcohol and Other Drug Abuse Services shall work with 14 15 Department of Health and Human Services and each county's designated alcohol and drug abuse authorities to pursue funding to aid in purchasing the appropriate Certification Commission for Health Information Technology (CCHIT) behavioral health Electronic 16 Health Records (EHR) system for the authorities. The new system shall streamline the 301 system and shall contain CCHIT certified 17 programming that will have the capability of interoperability with other state agencies such as the Department of Health and Human 18 Services and Federally Qualified Health Centers. All state funds above \$800,000 shall be retained by the department to fund Self-Sufficiency and Family Preservation and Support initiatives.

31 **38.2.** (DSS: Recovered State Funds) The department shall withhold a portion of the State Funds recovered, under the Title IV-32 D Program, for credit to the general fund in order to allow full participation in the federal "set off" program offered through the 33 Internal Revenue Service, the withholding of unemployment insurance benefits through the Department of Employment and 34 Workforce and reimbursement for expenditures related to blood testing. (DSS: Court Examiner Service Exemption) In order to prevent the loss of federal funds to the State, employees of the 13 Department of Social Services whose salaries are paid in full or in part from federal funds will be exempt from serving as court 14 15 examiners. **38.6.** (DSS: TANF Advance Funds) The Department of Social Services is authorized to advance sufficient funds during each 16 fiscal year from the Temporary Assistance for Needy Families Assistance Payments general fund appropriations to the Temporary 17 Assistance for Needy Families Assistance Payments federal account only for the purpose of allowing a sufficient cash flow in the 18 federal account. The advance must be refunded no later than April of the same fiscal year. Upon the advance of funds as provided 19 herein, the Comptroller General is authorized to process the July voucher for the funding of benefit checks. 20 **38.7.** (DSS: Fee Schedule) The Department of Social Services shall be allowed to charge fees and accept donations, grants, and 21 bequests for social services provided under their direct responsibility on the basis of a fee schedule. The fees collected shall be 22 utilized by the Department of Social Services to further develop and administer these program efforts. 21 38.8. (DSS: Food Stamp Fraud) The state portion of funds recouped from the collection of recipient claims in the TANF and 22 Food Stamp programs shall be retained by the department. A portion of these funds shall be distributed to local county offices for 23 emergency and program operations.

38.9. (DSS: TANF - Immunizations Certificates) The department shall require all TANF applicants and/or recipients to provide
 proof of age appropriate immunizations for children. If such immunizations have not been administered, the department shall assist
 in referring applicants to appropriate county health departments to obtain the immunizations.

38.10. (DSS: County Directors' Pay) With respect to the amounts allocated to the Department of Social Services for Employee Pay Increase in this act, the Department of Social Services is authorized to allot funds for pay increases to individual county directors and regional directors in classified positions without uniformity. Pay increases for DSS county directors and regional directors shall be administered in accordance with the guidelines established by the Department of Administration for Executive Compensation System and other nonacademic unclassified employees. Any employees subject to the provisions of this paragraph shall not be eligible for any other compensation increases provided in this act.

38.11. (DSS: Use of Funds Authorization) Department investigative units shall be authorized to receive and expend funds awarded to these units as a result of a donation, contribution, prize, grant, and/or court order. These funds shall be retained by the department on behalf of the investigative units and deposited in a separate, special account and shall be carried forward from year to year and withdrawn and expended as needed to fulfill the purposes and conditions of the donation, contribution, prize, grant, and/or

court order, if specified, and if not specified, as may be directed by the Director of the Department of Social Services. These accounts 1 2 shall not be used to supplant operating funds in the current or future budgets. The report shall include, but not be limited to, actions currently being undertaken to become compliant with federal government requirements; the cost required to meet minimum federal guidelines; total funds spent so far on the system; the amount of fines assessed by the federal government associated with noncompliance; how much has been spent to satisfy actions taken by the state judicial system; and how much has been spent related to actions taken by any other entity which may have altered the amount required for meeting minimum federal guidelines. The report shall be submitted to the General Assembly by August thirty-first of the current fiscal year.

12 38.18. (DSS: Child Care Voucher) State funds allocated to the Department of Social Services and used for child care vouchers 13 must be used to enroll eligible recipients within provider settings exceeding the state's minimum child care licensing standards. The 14 department may waive this requirement on a case by case basis.

15 38.19. (DSS: Meals in Emergency Operations) The cost of meals may be provided to state employees who are not permitted to 16 leave their stations and are required to work during actual emergencies, emergency situation exercises, and when the Governor 17 declares a state of emergency.

38.20. (DSS: Day Care Facilities Supervision Ratios) For the current fiscal year, staff-child ratios contained in Regulations
 114-504(B), 114-504(C), 114-524(B), and 114-524(C) shall remain at the June 24, 2008 levels.

38.21. (DSS: Foster Care Goals) To comply with the requirements of 42 U.S.C. Section 671(a)(14) and 45 C.F.R. Section 1356.21(n), it shall be the goal of the state that the maximum number of Title IV-E funded children who will remain in foster care for more than twenty-four months will not exceed a total of 2,617 during the fiscal year. The Department of Social Services shall develop appropriate plans for timely permanency and use appropriate data benchmarks and targets that will achieve this goal.

38.22. (DSS: Comprehensive Teen Pregnancy Prevention Funding) (A) From the monies appropriated for the Continuation of Teen Pregnancy Prevention, the department must award the dollars allocated to a nonprofit 501(c)(3) entity to provide abstinence first, age appropriate comprehensive approach to health and sexuality education with a goal of preventing adolescent pregnancy throughout South Carolina.

28 (B) Contracts must be awarded utilizing a competitive approach in accordance with the South Carolina Procurement Code.

(C) The monies appropriated must be paid over a twelve month basis for services rendered. Unexpended funds shall be carried
 forward for the purpose of fulfilling the department's contractual agreement.

(D) The programs implemented by the entity awarded a contract pursuant to this proviso may not violate any portion of the South
 Carolina Comprehensive Health Education Act when implemented in a school setting. An entity that violates any portion of the
 South Carolina Comprehensive Health Education Act must reimburse the State for all funds disbursed.

34 **38.23.** (DSS: SNÅP Coupons) The Department of Social Services shall continue the "Healthy Bucks" program established to 35 provide coupons that allow Supplemental Nutrition Assistance Program (SNAP) recipients to obtain additional fresh fruits and 36 vegetables when purchasing fresh produce at grocery stores or farmers markets with SNAP benefits through their EBT cards. Each

coupon shall allow the beneficiary to double the amount of produce purchased, up to ten dollars per month. The agency shall utilize 1 2 all funds received in the prior and current fiscal years from the U.S. Department of Agriculture as a bonus for reducing the error rate in processing SNAP applications to fund the program. The report shall include, at a minimum, the number of recipients, counties served, and cumulative expenditure data for the 6 program. 7 **38.24.** (DSS: Local Internal Child Fatality Review Committees) For Fiscal Year 2015-16 2016-17, the Director of the Department of Social Services shall create and fund Local Internal Child Fatality Review Committees (local internal committees) pursuant to 8 the authority granted in Sections 43-1-60(3), 43-1-80, and 63-7-910(E) of the 1976 Code to allow for the rapid and expeditious 9 review of reported child fatalities which come within the investigative authority of the department that are reported to the Department 10 of Social Services on suspicion of abandonment, child abuse, neglect or harm as defined in Section 63-7-20. This review process 11 will enable the department to respond to the safety needs of any surviving siblings and will lead to improvement in the department's 12 efforts to prevent child fatalities caused by abandonment, child abuse, neglect or harm. Local Internal committees shall have access to information and records 19 maintained by a provider of medical care regarding a child whose death is being reviewed by the local internal committee, including 20 information on prenatal care; all information and records maintained by any state, county, or local government agency, including, 21 but not limited to, birth certificates, law enforcement investigation data, county coroner or medical examiner investigation data, 22 23 parole and probation information and records, and information and records of health agencies that provided services to the child or 24 family; and unfounded reports of abuse or neglect made strictly confidential and whose disclosure is otherwise prohibited by statute. Further, local committees shall have the same authority as the State Child Fatality Advisory Committee to obtain information as set 25 26 forth in Section 63-11-1970. The meetings, information obtained by, reports prepared by, and testimony statements made before the local internal committees are confidential and protected from disclosure pursuant to the Freedom of Information Act, criminal and 27 civil proceedings, and subpoenas to the same extent as the State Child Fatality Advisory Committee as set forth in Sections 63-11-28 1980 and 63-11-1990 63-7-940 and 63-7-1990. 29 38.25. (DSS: Tuition Reimbursement/Student Loan Repayment) The Department of Social Services is allowed to spend state, 30 federal, and other sources of revenue to provide tuition reimbursement and/or student loan repayment to aid in retaining caseworkers 31 and critical needs department jobs based on objective guidelines established by the State Director of the Department of Social 32 33 Services. 34 The department may also provide paid educational leave for any employees in an FTE position to attend class while enrolled in

35 programs that are related to the agency's mission. All such leave is at the agency head's discretion.

The department may enter into an agreement with staff employed in critical need departments to repay them for their outstanding 1 2 student loans and/or reimburse tuition expenses. The employee must be employed in a critical needs area, which would be identified at the agency head's discretion, be in a covered FTE, and not have any disciplinary actions. Participants in this program must agree 3 4 to remain at the department for a period of five years. The department may pay these employees up to \$7,500 each year over a fiveyear period in accordance with a program developed by the department. Payments will be made directly to the employee at the end 5 of each year of employment. Payments cannot exceed the balance of the student loan or the cost of tuition. 6 38.26. To the extent the Transfer System operating processes deviate from, or are incompatible with, current South Carolina 10 practice, the department is authorized to determine the most effective and efficient practice to comply with federal requirements. 11 The department shall work with Clerks of Court to identify the changes involved in the implementation of the Transfer System which 12 may impact their current operating practices with regards to performance of required child support functions in order to facilitate 13 the integration of those practices into the Transfer System. Pursuant to the Social Security Act and S.C. Code Section 63-17-610, 14 Clerks of Court shall utilize the federally certifiable child support system and the state disbursement unit developed by the department 15 to perform required child support functions. 16 38.27. The Department of Social Services shall maintain all 23 24 *Employment and Training program responsibilities in those regions.* 25 26 **SECTION 39 - L240 - COMMISSION FOR THE BLIND** 27 28 **39.1.** (BLIND: Matching Federal Funds) For the current fiscal year the amount appropriated in this section under Program II for 29 Rehabilitative Services is conditioned upon matching by federal funds to the maximum amount available under the Federal 30 Vocational Rehabilitation Program. 31 32 SECTION 42 - L320 - HOUSING FINANCE AND DEVELOPMENT AUTHORITY 33 34 42.1. (HFDA: Federal Rental Assistance Administrative Fee Carry Forward) All federal rental assistance administrative fees shall be carried forward to the current fiscal year for use by the authority in the administration of the federal programs under contract 35

44.4. (AGRI: Weights & Measures Registration) All servicepersons required to be registered with the Department of Agriculture pursuant to the provisions of Section 39-9-65 of the 1976 Code shall pay to the department a registration fee of \$25.00. Revenues generated by this provision shall be for use by the Department of Agriculture to offset expenses incurred in administering this registration program.

44.5. (AGRI: Sale of Property Revenue) The department may retain revenues associated with the sale of the property titled to

45.5. (CU-PSA: Pesticide Registration) All revenues collected from pesticide registration fees and revenue collected from
 structural pest control businesses for business licensing must be retained by Clemson University PSA Regulatory and Public Service
 Programs to support general regulatory, enforcement, and education programs and to carry out provisions of the South Carolina
 Pesticide Control Act and regulations related to it.

5 **45.6.** (CU-PSA: Lime Inspection Fee) The Public Service Activities of Clemson University are hereby authorized to charge an 6 inspection fee of \$0.50 per ton on Agricultural Liming Materials sold or distributed in this state. Clemson University-PSA may 7 retain, expend, and carry forward these funds to maintain its programs.

45.7. (CU-PSA: Livestock-Poultry Health Programs) For the current fiscal year Clemson University Public Service Activities shall maintain operation of the state Meat Inspection Program. All revenues and recoveries from USDA Food Safety Inspection Services and from USDA Animal and Plant Health Inspection Services for Clemson University PSA's Livestock-Poultry Health Programs and its departments shall be retained by Clemson University-PSA's Livestock-Poultry Health Program for purposes of carrying out the operation of its programs.

13 45.8. (CU-PSA: Boll Weevil Eradication) For the current fiscal year Clemson University Public Services Activities shall 14 maintain operation of the Boll Weevil Eradication Program. In the calculation of any across-the-board budget reduction mandated 15 by the Executive Budget Office or the General Assembly, the amount appropriated for the Boll Weevil Eradication Program shall be 16 excluded from Clemson PSA's base budget. In addition, the department is authorized to sell advertising in the magazine and to increase the magazine's subscription rate, if necessary, to be self-sustaining. No general funds may be used for the operation and support of the "South Carolina Wildlife" magazine.

(DNR: Casual Sales Tax Collection) The Department of Natural Resources shall continue to collect the casual sales tax as contained in the contractual agreement between the Department of Revenue and the Department of Natural Resources and the State Treasurer is authorized to reimburse the department on a quarterly basis for the actual cost of collecting the casual sales tax and such reimbursement shall be paid from revenues generated by the casual sales tax.

SECTION 47 - P240 - DEPARTMENT OF NATURAL RESOURCES

47.3. (DNR: Proportionate Funding) Each of South Carolina's forty-six soil and water conservation districts shall receive a 1 2 proportionate share of funding set aside for Aid to Conservation Districts at \$15,000 per district for general assistance to the district's program. Available funding above \$15,000 for each district will be apportioned by the Department of Natural Resources based upon 3 4 local needs and priorities as determined by the board. During the fiscal year, the districts' funding may only be reduced in an amount 5 not to exceed the percentage of each agency budget reduction. No district shall receive any funds under this provision unless the 6 county or counties wherein the district is located shall have appropriated no less than three hundred dollars to the district from county 7 funds for the same purposes. 8 47.4. (DNR: Carry Forward - Contract for Goods & Services) If any funds accumulated by the Department of Natural Resources Geology Program, under contract for the provision of goods and services not covered by the department's appropriated funds, are 9 not expended during the preceding fiscal years, such funds may be carried forward and expended for the costs associated with the 10 provision of such goods and services. 11 47.5. (DNR: Revenue Carry Forward) The department may collect, expend, and carry forward revenues derived from the sale 12 of goods and services in order to support aerial photography, map services, climatology data, and geological services. The department 13 shall annually report to the Senate Finance Committee and the House Ways and Means Committee the amount of revenue generated 14 15 from the sale of these goods and services. 47.6. (DNR: Clothing Allowance) The Department of Natural Resources is hereby authorized to provide Natural Resource 16 Enforcement Officers on special assignment with an annual clothing allowance (on a prorata basis) not to exceed \$600 per officer 17 for required clothing used in the line of duty. 18 47.7. (DNR: Commissioned Officers' Physicals) The department is authorized to pay for the cost of physical examinations for 19

department personnel who are required to receive such physical examinations prior to receiving a law enforcement commission.

47.8. (DNR: Cormorant Control) The Department of Natural Resources shall continue to coordinate a public Cormorant control 21 program with the US Fish and Wildlife Service for Lake Marion and Moultrie. The department shall try to coordinate with the Army 22 Corp of Engineers, Santee Cooper, and the USFWS to include waters above and below each spillway, Wildlife Management Areas, 23 and national refuges. The department shall assess the need to expand the program to other public waters and implement a plan if 24 warranted. If the USFWS allows continuation of the control program, the department shall establish an online method of permitting. 25 47.9. (DNR: Web Services and Technology Development) The department may carry forward any unexpended general fund 26 balance remaining on the Other Operating Expenses line, identified in the "Web Services and Technology Development" program 27 of the department appropriations from Part IA in this Act. Balances carried forward from the prior fiscal year are only authorized to 28 be expended to support technology operating expenses within the department. 29

48.1. (SGC: Publications Revenue) Funds generated by the sale of pamphlets, books, and other promotional materials, the
 production of which has been paid for by non-state funding, may be deposited in a special account by the consortium and utilized as
 other funds for the purchase of additional pamphlets, books, and other promotional materials for distribution to the public.

SECTION 49 - P280 - DEPARTMENT OF PARKS, RECREATION AND TOURISM

49.1. (PRT: Tourism and Promotion) The funds appropriated in this act for Regional Promotions shall be distributed equally to the eleven Regional Tourism groups, except that the Grandstrand Tourism Region's funds shall be divided, with \$50,000 distributed to the Myrtle Beach Chamber of Commerce, \$115,000 distributed to the Georgetown Chamber of Commerce, \$30,000 distributed to the City of Georgetown, and \$30,000 distributed to the Williamsburg Chamber of Commerce for tourism related activities. The Myrtle Beach Chamber of Commerce and the Georgetown Chamber of Commerce shall submit a report to the Senate Finance Committee and the House Ways and Means Committee by December first each year describing how these funds were expended in the prior fiscal year.

10 **49.2.** (PRT: Destination Specific Tourism Marketing) The minimum grant awarded by the Destination Specific Tourism Program shall be \$250,000. Each state dollar must be matched with two dollars of private funds. An organization receiving a state 11 grant must certify that, as of the date of the application: (i) the private funds are new dollars specifically designated for the purpose 12 of matching state funds; (ii) the private funds have not been previously allocated or designated for tourism-related destination 13 marketing; (iii) the organization has on hand or has an approved line of credit of not less than the amount of private funds needed to 14 provide the required match. Organizations applying for a grant must include in the grant application, information on how the 15 organization proposes to measure the success of the marketing and public relations program, including the estimated return on 16 investment to the state. Promotional programs proposed by an applicant must be based on research-based outcomes. Grants must 17 be made only to organizations that have a proven record of success in creating and sustaining new and repeat visitation to its area 18 and must have sufficient resources to create, plan, implement, and measure the marketing and promotional efforts undertaken as a 19 part of the program. The department must award a grant only to one qualified destination marketing organization within their tourism 20 region where the organization's private funds are raised. An organization receiving a grant must use the public and private funds 21 22 only for the purpose of destination specific marketing and public relations designed to target international and/or domestic travelers 23 outside the state to destinations within the state. All grants that qualify under the program must be funded if funds are available. 24 Funding of all qualified grants will be on a first come first served basis with such basis retained throughout the term of this proviso. No organization shall receive in the first quarter more than fifty percent of the state dollars allocated to the program. If by the end 25 of the third quarter matching funds are still available with no other organizations meeting the criteria for funding, the funds will be 26 27 distributed to the organization or organizations that have and can meet all of the requirements of this proviso. Grant recipients shall 28 provide an annual report by November first, to the Chairmen of the Senate Finance Committee and the House Ways and Means 29 Committee and the director of the Department of Parks, Recreation and Tourism on the expenditure of the grants funds and on the 30 proposed outcome measures.

49.3. (PRT: Advertising Funds Use and Carry Forward) The Department of Parks, Recreation and Tourism may carry forward
 any unexpended funds appropriated on the Advertising line within Program II. A. Tourism Sales and Marketing from the prior fiscal
 year into the current fiscal year to be used for the same purposes which include the Tourism Partnership Fund, Destination Specific
 Marketing Grants and the agency advertising fund. \$250,000 of the funds appropriated for the Advertising line within Program II.
 A. Tourism Sales and Marketing shall be provided to the Charleston Area Convention & Visitors Bureau for special event promotion.

49.4. While holding court or on other official business at a 28 location fifty miles or more from his residence, an Administrative Law Judge is entitled to a subsistence allowance in the amount as 29 provided in this act for members of the General Assembly plus such mileage allowance for travel as is provided for other employees 30 31 of the State. However, notwithstanding any other provision of law, the allowance as provided shall not exceed \$8,000 per judge in a fiscal year. 32

(AG: Securities Fee Revenue) After the provisions of Section 35-1-702(b) of the 1976 Code have been satisfied, and upon 12 notification to the Chairman of the Senate Finance Committee and the Chairman of the House Ways and Means Committee that such 13 provisions have been satisfied, the next \$20,500,000 of Securities Fee revenues collected during the current fiscal year by the Office 14 of the Attorney General shall be remitted to the General Fund of the State. (INDEF: Defense of Indigents Formula) The amount appropriated in this act for "Defense of Indigents" shall be apportioned among counties in accord with Section 17-3-330 of the 1976 Code, but on a per capita basis and based upon the most current official decennial census of the United States; provided that no county shall receive funding in an amount less than the amount apportioned to it as of July 1, 2005. The level of contribution of each county as of July 1, 2001, must be maintained. No county shall be permitted to contribute less money than the amount the county contributed in the prior fiscal year. Within the amount of money established for indigent defense services, the State shall set aside \$3,000,000 (Death Penalty Trial Fund) annually exclusively

4 counsel appointed in noncapital cases pursuant to Section 17-3-50 (Conflict Fund). Of the funds generated from the fees imposed 5 under Sections 14-1-206(C)(4), 14-1-207(C)(6) and 14-1-208(C)(6) and the application fee provided in Section 17-3-30(B), on a

6 monthly basis, fifty percent must be deposited into the Death Penalty Trial Fund, fifteen percent must be deposited into the Conflict

Fund, and the remaining funds each month must be apportioned among the counties' public defender offices pursuant to Section 17-

8 3-330. At the end of each fiscal year any leftover funds shall carryover to the next fiscal year. All applications for the payment of

9 fees and expenses in capital cases shall be applied for from the Death Penalty Trial Fund which shall be administered by the

10 Commission on Indigent Defense. All applications for the payment of fees and expenses of private counsel or expenses of public

11 defenders pursuant to Section 17-3-50 shall be applied for from the Conflict Fund administered by the Commission on Indigent

12 Defense. Reimbursement in excess of the hourly rate and limit set forth in Section 17-3-50 is authorized only if the court certifies,

14 necessary to provide reimbursement adequate to ensure effective assistance of counsel and reimbursement in excess of the limit is

appropriate because the services to be provided are reasonable and necessary. If prior approval by written order of the court is not

16 obtained, no additional fees shall be paid under any circumstances.

Upon a finding in ex parte proceedings that investigative, expert, or other services are reasonable and necessary for the 17 representation of the defendant, the court shall authorize the defendant's attorney to obtain such services on behalf of the defendant 18 and shall authorize the payment, from funds available to the Commission on Indigent Defense, of fees and expenses not to exceed 19 five hundred dollars as the court considers appropriate. Payment in excess of the five hundred dollar limit is authorized only if the 20 court certifies, in a written order with specific findings of fact, prior to the expense being incurred, that payment in excess of the 21 limit is appropriate because the services to be provided are reasonable and necessary to provide adequate defense. Payments shall 22 23 be made from funds appropriated for this purpose from the Commission of Indigent Defense. If prior approval by written order of 24 the court is not obtained, no additional expenses shall be paid under any circumstances.

Indigent defense vouchers authorized in this provision must be reviewed and paid pursuant to procedures and policies established by the Commission on Indigent Defense. The commission shall provide a copy of the established procedures and policies to the Senate Finance Committee and the House Ways and Means Committee.

61.2. (INDEF: State Employee Compensation Prohibited) Except as otherwise provided in Section 117.5, no money

 guardians ad litem or attorneys nor shall such funds be used in payment to any state agency for providing such services by their

61.3. (INDEF: Appellate Conflict Fund) The purpose of the Appellate Conflict Fund is to provide money to pay attorneys for representing indigent defendants on appellate review when the Office of Appellate Defense is unable to do so. The method of payment and amount of set (flat) fee will be determined by the Commission on Indigent Defense. Attorney fees shall not exceed one thousand dollars in any single case.

A portion of the funds appropriated under "SC Appellate Court Rule 608 Appointments" shall be used for noncapital criminal cases pursuant to Section 17-3-50 (Conflict Fund). Any attorney appointed shall be compensated at a rate not to exceed forty dollars per hour for time expended out of court and sixty dollars per hour for time expended in court, or on the basis of a set (flat) fee. The method of payment and amount of set (flat) fee will be determined by the Commission on Indigent Defense. Attorney fees shall not exceed three thousand five hundred dollars in any single felony case or one thousand dollars in any single misdemeanor case.

Reimbursement in excess of the hourly rate and limit set forth herein is authorized only if the court certifies, in a written order with specific findings of fact, prior to the fees being incurred, that reimbursement in excess of the rates or limit is necessary to provide reimbursement adequate to ensure effective assistance of counsel and reimbursement in excess of the limit is appropriate because

34 the services to be provided are reasonable and necessary. If prior approval by written order of the court is not obtained, no additional

35 fees shall be paid under any circumstances.

Upon a finding in ex parte proceedings that investigative, expert, or other services are reasonable and necessary for the 1 2 representation of the defendant, the court shall authorize the defendant's attorney to obtain such services on behalf of the defendant and shall authorize the payment, from funds available to the Commission on Indigent Defense, of fees and expenses not to exceed 3 five hundred dollars as the court considers appropriate. Payment in excess of the five hundred dollar limit is authorized only if the 4 5 court certifies, in a written order with specific findings of fact, prior to the expense being incurred, that payment in excess of the 6 limit is appropriate because the services to be provided are reasonable and necessary to provide adequate defense. Payments shall 7 be made from funds appropriated for this purpose from the Commission of Indigent Defense. If prior approval by written order of 8 the court is not obtained, no additional expenses shall be paid under any circumstances. The commission shall provide a copy of the established procedures and policies to the 10 Senate Finance Committee and the House Ways and Means Committee. 11 A portion of the funds appropriated under "SC Appellate Court Rule 608 Appointments" may be used by the Commission on 12 Indigent Defense to retain, on a contractual basis, the services of attorneys qualified to handle civil and criminal court appointments, 13 to be reimbursed in accordance with applicable provisos and statutes. 14 15 61.5. (INDEF: Carry Forward) To offset budget reductions, the Commission on Indigent Defense may carry forward and utilize any unencumbered balances available in the Appellate Conflict Fund and the SC Appellate Court Rule 608 Appointment Fund at the 16 end of the prior fiscal year. 17 **61.6.** (INDEF: Public Defender Fee) Every person placed on probation on or after July 1, 2003, who was represented by a public 18 defender or appointed counsel, shall be assessed a fee of five hundred dollars. The revenue generated from this fee must be collected 19 by the clerk of court and sent on a monthly basis to the Commission on Indigent Defense. However, if a defendant fails to pay this 20 fee, this failure alone is not sufficient basis for incarceration for a probation violation. (D) Nothing contained above shall restrict or hinder a court from appointing counsel in any emergency proceedings or where 8 existing statutes do not provide sufficient time for an individual to complete the application process. 9 (E) The appointment of counsel, as herein before provided, creates a claim against the assets and estate of the person who is 10 provided counsel or the parents or legal guardians of a juvenile in an amount equal to the costs of representation as determined by a 11 voucher submitted by the appointed counsel and approved by the court, less that amount that the person pays to the appointed counsel. 12 (F) Such claim shall be filed in the office of the clerk of court in the county where the person is assigned counsel, but the filing 13 of a claim shall not constitute a lien against real or personal property of the person unless, in the discretion of the court, part or all of 14 such claim is reduced to judgment by appropriate order of the court, after serving the person with at least thirty days' notice that 15 judgment will be entered. When a claim is reduced to judgment, it shall have the same effect as judgments, except as modified by 16 this provision. 17 61.8. (INDEF: Exemption for Pass Through Funding) The funds distributed by the Commission on Indigent Defense to the 18 Legal Services Corporation in accordance with Section 14-1-204 of the 1976 Code shall not be considered part of the commission's 19 budget for purposes of calculating budget reductions. 20 61.9. (INDEF: Reporting Requirement) Circuit Public Defenders shall provide, in a manner and form as the agency head 21 requires, information and data concerning caseloads, dispositions, and other information as required by the agency head or General 22 Assembly. The agency shall withhold payments and transfers to Circuit Public Defenders who are not in compliance with the agency 23 24 reporting requirements. 25 61.10. (INDEF: Donation Carry Forward) The Commission on Indigent Defense may accept donations for the publication of 26 "The South Carolina Juvenile Collateral Consequences Checklist." All revenue derived from donations received at the Commission on Indigent Defense shall be retained, carried forward and expended according to agreement reached between the donor, or donors, 27 and the Commission on Indigent Defense. 28

61.11. (INDEF: Capital Case Contract Attorneys) Funds appropriated from the Death Penalty Trial Fund may be used by the commission to retain, on a contractual basis, the service of attorneys qualified to provide representation in capital proceedings to include: capital trials, post-conviction relief actions, re-sentencing, appeals or any other capital litigation proceeding.

The commission shall establish all policies, procedures and contract provisions as it deems appropriate for the implementation of the system, including but not limited to the selection and compensation of contract awardees.

61.12. (INDEF: Optional Courts and Indigent Representation) If a municipality has or elects to have an optional municipal court
 system, it must provide adequate funds for representation of indigents. No public defender shall be appointed in any such court

unless the municipality and the office of the circuit public defender have reached an agreement for indigent representation and no
 funds allocated to the commission shall be used to provide compensation for appointed counsel in municipal courts.

3 61.13. (INDEF: Indigent Verification) The Commission on Indigent Defense is directed to review the Affidavit for Indigency

4 and Application for Counsel and make recommendations to the General Assembly by January 5, 2016, on any additional requirements

(SLED: Special Account Carry Forward) Funds awarded to the State Law Enforcement Division by either court order or from donations or contributions shall be deposited in a special account with the State Treasurer, and shall be carried forward from year to year, and withdrawn from the Treasurer as needed to fulfill the purposes and conditions of the said order, donations or contributions, if specified, and if not specified, as may be directed by the Chief of the State Law Enforcement Division. Funds expended from the special account must be annually reported by October first to the Senate Finance Committee and the Ways and Means Committee.

62.2. (SLED: Computer/Communications Center Carry Forward) Revenue generated from the operation of the division's
 criminal justice computer/communications center and not expended during the prior fiscal year may be carried forward and expended
 for the same purpose during the current fiscal year.

62.3. (SLED: Agents Operations Carry Forward) Any unexpended balance on June thirtieth, of the prior fiscal year, in Part IA,
 subsection 62 of the section "Agents Operations" may be carried forward and expended for the same purpose in the current fiscal
 year.

62.4. (SLED: Match for Federal Grants Carry Forward) State appropriations to SLED that are required to provide match for federal grant programs in the prior fiscal year may be carried forward into the current fiscal year and expended for the same purpose as originally appropriated.

62.5. (SLED: Clothing Allowance) The State Law Enforcement Division is hereby authorized to provide agents and criminalists
 with an annual clothing allowance (on a pro rata basis) not to exceed \$600 per agent/criminalist for required clothing used in the line
 of duty.

62.6. (SLED: Witness Fee) The State Law Enforcement Division is hereby authorized to charge a witness fee of \$130.00 per
 hour up to \$1,000 per day for each employee testifying in civil matters which do not involve the State as a part in interest. This fee
 shall be charged in addition to any court prescribed payment due as compensation or reimbursement for judicial appearances and
 deposited into a designated revenue account.

62.7. (SLED: Commissioned Officers' Physicals) The department is authorized to pay for the cost of physical examinations for
 department personnel who are required to receive such physical examinations prior to receiving a law enforcement commission.

SECTION 62 - D100 - STATE LAW ENFORCEMENT DIVISION

62.8. (SLED: Meals in Emergency Operations) The State Law Enforcement Division may provide meals to employees of SLED
 who are not permitted to leave assigned duty stations and are required to work during deployment, emergency simulation exercises
 and when the Governor declares a state of emergency.

62.9. (SLED: Hazardous Materials Security Detail) The State Law Enforcement Division (SLED) is authorized to be reimbursed for security related law enforcement services provided to entities authorized to transport sensitive materials within the borders of South Carolina. SLED shall determine all costs associated with security details and is authorized to coordinate the collection, retention, and distribution to any assisting agency. SLED and each assisting agency shall expend any funds associated with minimizing risks related to the transportation of these hazardous materials for the implementation of homeland security initiatives.

62.10. (SLED: Sex Offender Registry Fee) Each Sheriff is authorized to charge and collect an annual amount of one hundred fifty dollars from each sex offender required to register by law. If such sex offender has been declared indigent by the Sheriff of the county in which the offender must register and provides proof of the declaration at the time of registration, the fee will automatically be waived. If an offender is not declared indigent and fails to pay the fee, he is officially declared unregistered. This fee shall be divided between the Sheriffs and the State Law Enforcement Division with one hundred dollars of the fee retained by the Sheriffs and the remaining fifty dollars remitted by the Sheriffs to SLED on a quarterly basis. These funds must be used to support the Statewide See Offonder Pagintry.

15 Statewide Sex Offender Registry.

62.11. (SLED: Private Detective Fees Criminal History Checks) The State Law Enforcement Division is authorized to charge private detective companies, individual private detectives, private security companies, armed security guards, and proprietary security companies a fee of twenty-five dollars to process state criminal history checks and fifty dollars for federal fingerprint based criminal history checks. These funds shall be collected, retained, expended and carried forward by the State Law Enforcement Division.

62.12. (SLED: CWP Instructors Certification) The State Law Enforcement Division is authorized to charge one hundred dollars
 for the issuance of a Certified Concealable Weapons Permit Instructor certificate, and one hundred dollars every three years for each
 renewal. These funds shall be collected, retained, expended and carried forward by the State Law Enforcement Division.

62.13. (SLED: Expungement Requests) The State Law Enforcement Division is authorized to collect a twenty-five dollar expungement fee for each request to expunge criminal records. These funds shall be used to offset the operational and research expenses associated with processing these expungement requests. SLED is authorized to collect, retain, expend, and carry forward these funds. Persons found not guilty by a court of competent jurisdiction or where charges have been dismissed or nolle prossed shall be excluded from the fee requirement.

62.14. (SLED: Retention of Funds Reimbursed by State or Federal Agencies) The State Law Enforcement Division is authorized to
 collect, expend, retain, and carry forward all funds received from other state or federal agencies in the current fiscal year as
 reimbursement of expenditures incurred in the current or prior fiscal year.

62.15. (SLED: Monies Associated with Illegal Gaming Devices) The State Law Enforcement Division is authorized to retain,
 expend, and carry forward all monies associated with illegal gaming devices seized by the division, once orders of destruction and
 awarding of these monies have been received from a court of competent jurisdiction.

62.16. (SLED: Private Detective/Security Fee) The license and registration fees set by the State Law Enforcement Division for
 private detective businesses, private security businesses, including employees of these businesses, and companies which provide

1 private security on their own premises must not exceed those fees set by regulation as of January 1, 2011, unless otherwise approved

2 by the General Assembly. From the funds collected from these fees, the State Law Enforcement Division must transfer \$480,000 to

3 the Department of Public Safety which shall be used for the purpose of providing security in the Capitol Complex area.

62.17. (SLED: Criminal Record Search Fees) The State Law Enforcement Division is authorized to charge and collect a fee of eight dollars for a criminal record search for local park and recreation volunteers through a commission, municipality, county, or the South Carolina Department of Parks, Recreation, and Tourism. Any organization that is authorized to receive the reduced fee must not charge the volunteer, mentor, member, or employee more than the eight dollars or any additional fee that is not required by the State Law Enforcement Division. All criminal record searches conducted under this provision must be for a volunteer, mentor, member or employee performing in an official capacity of the organization and must not be resold.

62.18. (SLED: Compensatory Payment) In the event a State of Emergency is declared by the Governor, exempt employees of the
 State Law Enforcement Division may be paid for actual hours worked in lieu of accruing compensatory time, at the discretion of the
 Chief, and providing funds are available.

62.19. (SLED: Meth Lab Clean Up Carry Forward) Any unexpended balance on June thirtieth of the prior fiscal year, in the
 special line "Meth Lab Clean Up" may be carried forward and expended for the same purpose <u>agency law enforcement operations</u>
 in the current fiscal year.

62.20. (SLED: CWP Renewal and Replacement) A concealed weapons permit may not be suspended by a state official, agent, or employee supported by state funds if the permit holder has initiated a renewal or replacement application and the processing and issuance of a renewal or replacement permit is delayed for administrative reasons. A concealed weapons permit remains valid during the pendency of the renewal or replacement process so long as the application for replacement renewal is submitted prior to the expiration of the permit.

62.21. (SLED: Drug Lab Electronic Mandatory Reporting System) Of the funds appropriated for Meth Lab Clean Up, the State
 Law Enforcement Division is authorized to expend such funds for the development and implementation of a statewide electronic
 mandatory reporting system for municipal, county and state governmental entities to report information, as directed by the State Law
 Enforcement Division, pertaining to the discovery or seizure of methamphetamine laboratories and dumpsites.

62.22. (SLED: Mandatory Meth Lab Reporting) If a municipal, county, or state governmental entity locates, finds, or seizes a
 methamphetamine laboratory or dumpsite within the State, the governmental entity shall report the incident within three business
 days to the State Law Enforcement Division.

The State Law Enforcement Division shall determine the reporting mechanism and is authorized to request, receive, catalogue, classify, and maintain all information it determines necessary pertaining to the laboratory or dumpsite including, but not limited to, the location, the type of manufacturing method used, and suspect information. The State Law Enforcement Division shall maintain

information related to these governmental reports on its website, which must be made available to the public, and is authorized to

32 use funds appropriated for Meth Lab Clean Up towards the prudent maintenance of information reported.

A governmental entity that fails to report information to the State Law Enforcement Division pursuant to this proviso is ineligible to receive public safety grants that are funded through the South Carolina Public Safety Coordinating Council pursuant to Section

35 23-6-520(2) of the 1976 Code.

62.23. (SLED: First Responder PTSD Treatment) From the funds provided for First Responder PTSD Treatment, the State Law 1 2 Enforcement Division shall distribute 50% percent to the South Carolina Law Enforcement Assistance Program to reimburse law enforcement officers who incur mental injury as a result of a critical incident during the scope of employment for actual out-of-3 pocket expenses not covered through worker's compensation claims and/or other insurance and can also be utilized to provide 4 services through the South Carolina Law Enforcement Assistance Program. The State Law Enforcement Division shall distribute 5 50% percent to the South Carolina State Firefighters Association for the South Carolina Firefighter Assistance Support Team to 6 7 reimburse firefighters and emergency medical technicians who incur mental injury as a result of a critical incident during the scope of employment for actual out-of-pocket expenses not covered through worker's compensation claims and/or other insurance and can 8 also be utilized to provide services through the South Carolina Firefighter Assistance Support Team. The State Law Enforcement 9 Division shall promulgate any administrative regulations necessary to carry out the provisions of this section. 10 11 12 **SECTION 63 - K050 - DEPARTMENT OF PUBLIC SAFETY** 13 63.1. (DPS: Special Events Traffic Control) The highway patrol must not charge any fee associated with special events for 14 maintaining traffic control and ensuring safety on South Carolina public roads and highways unless approved by the General 15 Assembly. Nothing shall prohibit the Treasury of the State from accepting voluntary payment of fees from private or public entities 16 to defray the actual expenses incurred for services provided by the Department of Public Safety. 17 63.2. (DPS: Retention of Private Detective Fees) The Department of Public Safety is hereby authorized to receive, expend, 18 retain, and carry forward all funds transmitted from SLED related to fees charged and collected by SLED from license and registration 19 fees for private detective businesses, private security businesses, including employees of these businesses, and companies which 20 provide private security on their own premises. The funds transferred are to be used in the Bureau of Protective Services Program 21 to provide security for state agencies and the Capitol Complex. 22 23 63.3. (DPS: Motor Carrier Advisory Committee) From the funds appropriated and/or authorized to the Department of Public 24 Safety and the Department of Motor Vehicles, the departments are directed to jointly establish a Motor Carrier Advisory Committee 25 to solicit input from the Trucking Industry and other interested parties in developing policies and procedures for the regulation of this industry. The members of the advisory committee shall serve without compensation. 26 63.4. (DPS: Sale of Real Property) At such time as any portion of the Laurens Road property in Greenville is declared to be 27 surplus by the agency or agencies which occupy said portion, and after receiving approval from the Department of Administration 28 or State Fiscal Accountability Authority, for the sale of the property, the Department of Public Safety, the Department of 29 Transportation, and the Department of Motor Vehicles are authorized to receive, retain, expend, and carry forward funds derived 30 31 from the sale of the real property in which each agency holds an interest or title. No portion of the property may be declared as surplus by one agency if another agency is occupying said property. The Department of Public Safety is directed to use these funds 32 to defray the operating expenses of the Highway Patrol and the Department of Transportation and the Department of Motor Vehicles 33 34 are directed to use their portion of these funds for department operating expenses.

63.5. (DPS: CMV Driver Rest Areas) A joint working group is to be established between the Department of Transportation,
 Department of Public Safety, State Transport Police and the South Carolina Trucking Association to review and evaluate where

critical rest areas may be made available for commercial motor vehicle drivers to park and obtain their federally mandated required

63.6. (DPS: SC Law Enforcement Officers Hall of Fame Scholarships) The Department of Public Safety is hereby authorized to accept donations from the public in order to provide scholarships to the children of law enforcement officers killed in the line of duty. The South Carolina Law Enforcement Officers Hall of Fame Advisory Committee is authorized to set the criteria for awarding such scholarships. All revenue received for this purpose shall be used to provide scholarships and shall be retained, carried forward, and expended for the same purpose.

- **63.7.** (DPS: Hours of Service Rest Requirements) Of the funds directed to the Department of Public Safety, the department shall expend the necessary funds to establish a policy to allow drivers of commercial motor vehicles engaged in intrastate commerce to use time waiting in their trucks while on the job to satisfy any hours of service thirty minute rest requirements. The policy shall then be printed and distributed to the Senate Transportation Committee and the House of Representatives Education and Public Works Committee. In addition, the policy shall be provided to any motor carrier who requests a copy. The department is further instructed to allow the Motor Carrier Advisory Committee to review options that may facilitate adoption of allowable variances from state and federal statutes, rules, and regulations, as well as specific relief for interstate border-zone operations.
- 15 <u>63.8.</u> (DPS: Body Cameras) The Department of Public Safety is authorized to retain and carry forward unexpended funds 16 associated with body cameras from the prior fiscal year into the current fiscal year and expend those funds for the same purpose.

64.1. (LETC: CJA-Federal, Other Flow Through Funds) In order to complete projects begun in a prior fiscal year, the Law
 Enforcement Training Council, Criminal Justice Academy is authorized to expend federal and earmarked funds in the current fiscal
 year for expenditures incurred in the prior fiscal year.

64.2. (LETC: CJA-Retention of Emergency Expenditure Refunds) The Law Enforcement Training Council, Criminal Justice Academy is authorized to collect, expend, retain, and carry forward all funds received from other state or federal agencies in the current fiscal year as reimbursement of expenditures incurred in the current or prior fiscal year when personnel and equipment are mobilized and expenses incurred due to an emergency.

SECTION 65 - N040 - DEPARTMENT OF CORRECTIONS

30 65.1. (CORR: Canteen Operations) Revenue derived wholly from the canteen operations within the Department of Corrections 31 on behalf of the inmate population, may be retained and expended by the department for the continuation of the operation of said 32 canteens and the welfare of the inmate population or, at the discretion of the Director, used to supplement costs of operations. The 33 canteen operation is to be treated as an enterprise fund within the Department of Corrections and is not to be subsidized by state 34 appropriated funds.

65.2. (CORR: E.H. Cooper Trust Fund) Any unclaimed funds remaining in any inmate account, after appropriate and necessary
 steps are taken to determine and contact a rightful owner of such funds, shall be deposited into the Inmate Welfare Fund.

65.3. (CORR: Instructional Salaries) The certified instructional personnel of the Department of Corrections shall receive a percentage increase in their annual salary for the current fiscal year equal to the percentage allocated to the instructional personnel throughout the State.

65.4. (CORR: Funding Through State Criminal Assistance Program) All funds received by the State from the United States
 Department of Justice, State Criminal Alien Assistance Program, for care and custody of illegal aliens housed in the state correctional
 facilities shall be retained by the South Carolina Department of Corrections to offset incurred expenses.

65.5. (CORR: Remedial Education Funding) A criminal offender committed to the custody of the Department of Corrections, who has been evaluated to function at less than an eighth grade educational level, or less than the equivalent of an eighth grade educational level, may be required by department officials to enroll and actively participate in academic education programs. Funds appropriated to the Department of Corrections for educational programs shall be prioritized to assure such remedial services are provided.

12 **65.6.** (CORR: Tire Retreading Program Restriction) The tire retreading program at the Lieber Correctional Institution shall be 13 limited to the marketing and sale of retreads to state governmental entities.

65.7. (CORR: Social Security Administration Funding) All funds received by the South Carolina Department of Corrections from the Social Security Administration under Section 1611 (e)(1)(I) of the Social Security Act, which provides payment for information regarding incarcerated Social Security Insurance recipients, shall be retained by the South Carolina Department of Corrections and credited to a fund entitled "Special Social Security" for the care and custody of inmates housed in the state correctional facilities.

65.8. (CORR: Medical Expenses) The Department of Corrections shall be authorized to charge inmates a nominal fee for any
 medical treatment or consultation provided at the request of or initiated by the inmate. A nominal co-pay shall be charged for
 prescribed medications. Inmates shall not be charged for psychological or mental health visits.

65.9. (CORR: Prison Industry Funds) The Director of the Department of Corrections, at his discretion, is hereby authorized to utilize prison industry funds for projects or services benefiting the general welfare of the inmate population or to supplement costs of operations. These funds may be carried forward from the prior fiscal year into the current fiscal year to be used for the same purpose.

65.10. (CORR: Reimbursement for Expenditures) The Department of Corrections may retain for general operating purposes any
 reimbursement of funds for expenses incurred in a prior fiscal year.

65.11. (CORR: Sale of Real Property) Funds generated from the sale of real property owned by the Department of Corrections
 shall be retained by the department to offset renovation and maintenance capital expenditures.

65.12. (CORR: Funds From Vehicle Cleaning) Monies generated by inmates engaged in the cleaning and waxing of private
 vehicles, or any other adult work activity center, shall be placed in a special account and utilized for the welfare of the inmate
 population.

65.13. (CORR: Release of Inmates) The Director of the Department of Corrections and other persons having charge of prisoners
 who are required to serve a period of six months or more, may release all such prisoners, including prisoners to whom Section 24 12.150(A) of the 1076 Code applies on the first day of the month in which their contaneous appires and if the first day of the month

35 13-150(A) of the 1976 Code applies, on the first day of the month in which their sentences expire, and if the first day of the month

falls on a Saturday, Sunday, or a legal holiday, such prisoners may be released on the last weekday prior to the first of the month 1 2 which is not a holiday.

65.14. (CORR: Western Union Funding) All funds received by the South Carolina Department of Corrections from the Western 3 4 Union Quick Collect Revenue Sharing Program or similar private sector entities, which provides payment for processing electronic

5 transfers into the E.H. Cooper Trust Fund, shall be retained by the South Carolina Department of Corrections and credited to a fund

6 entitled "Inmate Welfare Fund" to be expended for the benefit of the inmate population.

7 65.15. (CORR: Monitoring Fees) The Department of Corrections is authorized to charge an inmate who participates in community programs a reasonable fee for the cost of supplying electronic and telephonic monitoring. The fees charged may not exceed the 8 actual cost of the monitoring. 9

65.16. (CORR: Inmate Insurance Policies) The Department of Corrections may collect and record private health insurance 10 information from incarcerated individuals. The department may file against any private insurance policy covering an inmate to 11 recoup any health care expenditures covered by the policy. Health care will be provided in accordance with law and standards 12

regardless of whether or not an inmate is covered by insurance. 13

65.17. (CORR: Work Release Transportation Fee) The South Carolina Department of Corrections is authorized to charge a \$4.00 14

per day transportation fee to participants in the work release program only when such transportation is provided by the department. 15

Monies collected shall be credited to the South Carolina Department of Corrections, and utilized solely to fund transportation of 16 work release participants and vehicle replacement for the work release program. 17

18

65.18. (CORR: Special Assignment Pay Level 2 & 3 Facilities) Funds appropriated for special assignment pay at the Department of Corrections are for the purpose of addressing vacancies and turnover of staff by providing a pay differential for certain employees 19

assigned to institutions with a Level II or Level III security designation. The funds are to be used for special assignment pay only 20

and may not be transferred to any other program. If the employee leaves one of the qualifying job classes or leaves a Level II or 21

Level III institution for a non-Level II or non-Level III facility, they shall no longer be eligible for this special assignment pay. Only 22

23 employees in full-time equivalent positions are eligible for this special assignment pay.

The special assignment pay is not a part of the employee's base salary, but is a percentage thereof, and is to be paid as follows so 24 as not to exceed the percentages specified below and as determined by the Director of the Department of Corrections: 25

65.19. (CORR: Quota Elimination) Pursuant to Section 24-3-60 of the 1976 Code, upon notification by the county, the 4 5 Department of Corrections shall accept newly sentenced inmates from each local jail and detention center.

6 For sentenced inmates who the county is willing to transport, the department may limit the acceptance at the Kirkland Correctional 7 Institution to the hours of 8:00 a.m. to 1:00 p.m., Monday through Friday, excluding holidays, and at the Perry and Lieber Correctional

8 Institutions to the hours of 8:00 a.m. to 10:30 a.m., Monday through Friday, excluding holidays.

By mutual agreement between the Department of Corrections and a local jail or detention center, the department may establish an 9 alternate admissions schedule for receiving inmates at the Reception and Evaluation Center. 10

At the time of transfer of the inmate to the department, the county shall provide the sentencing order, and if available copies of 11 medical screening records, booking reports, and other documents to assist the department in its intake processing. Counties that have 12

not completed medical screenings at the time of transfer shall not be required to do so. 13

In the event there are inadequate beds within the Reception and Evaluation Center, the Department of Corrections may create a 14

"jail" within the Kirkland Correctional Institution using one or more of the available 192-bed housing units to accept newly sentenced 15

state inmates who are awaiting R & E processing. The department may operate such "jail," to the extent feasible, in accordance with 16 17 standards applicable to the local jails.

The department shall use the funds appropriated in this act for "Quota Elimination" to accomplish this initiative and to open a 96-18 bed unit at the MacDougall Correctional Institution and the 192-bed housing units at Kirkland Correctional Institution. The funds 19 may not be transferred to any other program or used for any other purpose. 20

65.20. (CORR: Public/Private Partnerships for Construction) Funds appropriated in Act 407 of 2006, item 23, shall be used to 21 construct as many multi-purpose buildings at Department of Corrections institutions as possible. For such facilities at Lieber, 22 23 McCormick, Leath, Perry, or Allendale Correctional Institution, at least \$150,000 in matching funds and/or construction materials or services must be donated before construction of the facility may begin. At other Department of Corrections locations, the Director 24

25 may require that donated funds and/or materials or services equal one-half of the cost of construction, including design and engineering costs. 26

27 65.21. (CORR: Inmate Barbering Program) Inmate barbers in the Inmate Barbering Program at the Department of Corrections, 28 shall not be subject to the licensing requirement of Section 40-7-30 of the 1976 Code.

65.22. (CORR: Executed Inmate Autopsy) For the current fiscal year, the autopsy requirements of Section 17-7-10 of the 1976 29 Code are suspended when an inmate is executed by the Department of Corrections pursuant to a valid order of the Supreme Court of 30 South Carolina. 31

65.23. (CORR: Recoupment of Expenses Associated with Inmate Cremation) If the Department of Corrections incurs expenses 32 for cremating and disposing of an unclaimed deceased inmate, the department may recoup all associated costs of cremation, including 33 34 transportation, through the deceased inmate's E.H. Cooper account, providing funds are available.

65.24. (CORR: Credited Jail Time; DNA Sample Collection) Inmates committed to the Department of Corrections for sentences 35 greater than ninety days, but who have credit for jail time in excess of their sentence to incarceration are not required to be transported 36

1 to the Reception and Evaluation Center of the Department of Corrections. Cities and counties housing inmates who have credit for

2 jail time in excess of their sentence may, through written agreement with the Department of Corrections, transfer required 3 commitment records to the department electronically or by other means. The Department of Corrections must establish reasonable

4 documentation requirements to facilitate the implementation of this cost savings measure. Employees of the Department of

5 Probation, Parole and Pardon Services assigned to the court or employees of the Department of Corrections, as applicable, shall

6 obtain DNA samples from the offenders who are required to submit DNA samples. This provision does not exempt the above

7 referenced inmates from the \$250 DNA fee as required by Section 23-3-670 of the 1976 Code. The \$250 fee shall be collected in

65.25. (CORR: Cell Phone Interdiction) The Director of the Department of Corrections is granted the right to add a surcharge to 9 all inmate pay phone calls to offset the cost of equipment and operations of cell phone interdiction measures. The surcharge will be 10 added to the cost per call, collected by chosen telephone vendor and paid to the department on a monthly basis. When the equipment has been paid in full, the surcharge amount will be reviewed and adjusted to cover the 13 cost of ongoing operational expenses of the interdiction equipment. Any unexpended balance may be carried forward from the prior 14 fiscal year into the current fiscal year and be used for the same purpose. 15 65.26. (CORR: Correctional Institution Maintenance and Construction) For maintenance and construction activities funded in the 16

65.26. (CORR: Correctional Institution Maintenance and Construction) For maintenance and construction activities funded in the
 current fiscal year, the Department of Corrections may utilize inmate labor to perform any portion of the work on its own grounds
 and facilities. The provisions of Section 40-11-360(A)(9) of the 1976 Code shall apply to any such project, including new
 construction.

65.27. (CORR: Meals in Emergency Operations) The Department of Corrections may provide meals to public employees who
 are not permitted to leave their stations and are required to work during actual emergencies, emergency simulation exercises, or when
 the Governor declares a state of emergency.

65.28. (CORR: Prohibition on Funding Certain Surgery) (A) The Department of Corrections is prohibited from using state funds or state resources to provide a prisoner in the state prison system sexual reassignment surgery; however, if a person is taking hormonal therapy at the time the person is committed to the Department of Corrections, the department shall continue to provide this therapy to the person as long as medically necessary for the health of the person.

27 (B) As used in this provision:

(1) 'Hormonal therapy' means the use of hormones to stimulate the development or alteration of a person's sexual
 characteristics in order to alter the person's physical appearance so that the person appears more like the opposite gender;

30 (2) 'Sexual reassignment surgery' means a surgical procedure to alter a person's physical appearance so that the person

66.1. (DPPP: Sale of Equipment) All revenue generated by the Department of Probation, Parole and Pardon Services from the sale of various equipment in excess of \$575, less the cost of disposition incurred by the Department of Administration, may be retained and carried forward into the current fiscal year and expended for the purpose of purchasing like items.

6 **66.2.** (DPPP: Interstate Compact Application Fee) The department may charge offenders an application fee set by the 7 department, not to exceed the department's actual costs, to offenders applying for transfers out of or into the state under the Interstate 8 Compact Act. The application fee shall be retained by the department to offset the cost of the Interstate Compact Act. All unexpended 9 funds at year-end may be retained and carried forward by the department to be expended for the same purpose.

66.3. (DPPP: GED Learn and Earn Program) From the funds appropriated in Part IA, the department may enter into agreements with statewide colleges, technical colleges, and school districts for the purpose of providing GED and GED Prep education to offenders. Offenders of the department enrolled in the program must repay the department the cost of the course and materials within six months of obtaining their GED.

66.4. (DPPP: Sex Offender Monitoring Carry Forward) The Department of Probation, Parole and Pardon Services is authorized to carry forward any unexpended funds in the Sex Offender Monitoring program. These funds must be used for the sex offender monitoring program. For the purpose of calculating the amount of funds which may be carried forward by the department, Sex Offender Monitoring program funds carried forward by this provision shall be excluded from the calculation of the carry forward authorized by provision elsewhere in this act.

66.5. (DPPP: Offender Drug Testing Fee) The department may charge offenders a fee set by the department, not to exceed \$50, for the purpose of drug testing. If it is determined that the offender is indigent, this fee must be waived. The fee shall be retained by the department to offset the cost of drug testing. All unexpended funds at year-end may be retained and carried forward by the department to be expended for the same purpose.

66.6. (DPPP: Public Service Employment Set-Up Fee) In addition to any other fee, the department may charge an adult offender
 placed under the jurisdiction of the department, who is ordered to public service employment by the court, a twenty-five dollar Public

67.1. (DJJ: Meal Ticket Revenue) The revenue generated from sale of meal tickets by the Department of Juvenile Justice shall
 be retained and carried forward into the current fiscal year by the agency and expended for the operation of the agency's cafeterias
 and food service programs.

67.2. (DJJ: Interstate Compact Revenue) The revenue returned to the Interstate Compact Program shall be retained and carried
 forward into the current fiscal year by the agency and expended for the operation of the program.

SECTION 67 - N120 - DEPARTMENT OF JUVENILE JUSTICE

67.3. (DJJ: Children's Projects Revenue) Funds generated from the projects undertaken by children under the supervision of the Department of Juvenile Justice may be retained by the department and utilized for the benefit of those children. Such funds may be carried forward into the following fiscal year.

67.4. (DJJ: Instructional Salaries) The certified instructional personnel of the Department of Juvenile Justice shall receive a
 percentage increase in their annual salary for the current fiscal year equal to the percentage allocated to the instructional personnel
 throughout the State.

67.5. (DJJ: Reimbursements for Expenditures) The Department of Juvenile Justice may retain for general operating purposes
 any reimbursement of funds for expenses incurred in a prior fiscal year.

67.6. (DJJ: Juvenile Arbitration/Community Advocacy Program) The amount appropriated and authorized in this section for the Juvenile Arbitration Program shall be retained and expended by the Department of Juvenile Justice for the purpose of providing juvenile arbitration services through the sixteen Judicial Circuit Solicitors' offices in the state and used to fund necessary administrative and personnel costs for the programs.

The Department of Juvenile Justice shall contract with Solicitors to administer the Juvenile Arbitration Program and disburse up to \$60,000 per Judicial Circuit based on services rendered. The amount payable to Solicitors may vary based on consistent adherence to established statewide program guidelines to assess program performance.

The \$250,000 appropriated for the Community Advocacy Program in the first Judicial Circuit, will be used to fund necessary administrative and personnel costs for this status offender diversion program. The Department of Juvenile Justice shall monitor and provide support to this program.

19 All unexpended funds may be retained and carried forward from the prior fiscal year to be used for the same purposes.

67.7. (DJJ: Sale of Real Property) After receiving approval from the Department of Administration or State Fiscal Accountability
 Authority, for the sale of property, the department is authorized to retain revenues associated with the sale of department-owned real

67.8. (DJJ: Sale of Timber) The Department of Juvenile Justice is hereby authorized to sell mature trees and other timber suitable for commercial purposes from lands owned by the department. Prior to such sales, the director shall consult with the State Forester to determine economic and environmental feasibility and to obtain approval for such sales. Funds derived from timber sales shall be retained and utilized for family support services after setting aside a reasonable amount, as determined by the State Forester, for reforestation of the lands from which the trees and timber are sold.

67.9. (DJJ: Drug Free Workplace) The critical mission of the Department of Juvenile Justice requires a safe and drug free work
 environment. In order to accomplish this, the department may conduct and pay for the cost of pre-employment drug testing and
 random employee drug testing. The department is authorized to expend funds in order to provide or procure these services.

67.10. (DJJ: Definition of Juveniles) The Department of Juvenile Justice is authorized to place juveniles in marine and wilderness programs or other community residence programs operated by nongovernmental entities. Juveniles receiving services in these community residence programs must either be referred to such a program by the Family Court as a condition of probation, released to such a program by the Board of Juvenile Parole, or voluntarily agree to be assigned and released to such a program by the Department of Juvenile Justice.

SECTION 67 - N120 - DEPARTMENT OF JUVENILE JUSTICE

67.11. (DJJ: Adult Education - GED) Juveniles committed to the Department of Juvenile Justice who have been enrolled in, but not yet completed, a GED educational program while at the department, at the discretion of the local school district, upon release from the department shall be allowed to enroll in either the juvenile's local school district's regular education program, in their appropriate grade placement, or allowed to enroll in that district's or county's adult education program. If enrolled in an adult education program, the juvenile's eligibility for taking the GED shall be based upon the regulations promulgated by the Department of Education for youth who are confined in, or under the custody of, the Department of Juvenile Justice.

7 67.12. (DJJ: Local District Effort) Upon commitment or confinement to a Department of Juvenile Justice facility, the school district in which that child resides shall pay an amount equivalent to the statewide average of the local base student cost (thirty 8 percent), multiplied by the appropriate pupil weighting set forth in Section 59-20-40, for instructional services provided to out-of-9 district students to the Department of Juvenile Justice for the time period in which the child is committed or confined to a department 10 facility. EFA funding for school districts is provided for a one hundred eighty day school year. The billing provided by the 11 12 department shall be calculated by dividing the local base student cost by two hundred twenty-five days to determine the daily rate. The department shall notify the school district in writing within forty-five calendar days that a student from the nonresident district 13 is receiving education services pursuant to this provision. (DJJ: Early Release Authorization) In order to avoid unconstitutional levels of overcrowding and other unconstitutional 22 23 conditions from occurring in facilities operated by the department and in residential programs operated for the department, the number of children housed in residential placements (either committed to the custody of the Department of Juvenile Justice or who 24 25 are under the department's supervision) shall not exceed the number of beds available to the department to house them. Should 26 appropriation reductions necessitate that the department close any additional facility, program, or housing unit it operates, or to be unable to fund any additional residential program operated for its benefit, the department is authorized and empowered to release 27 28 from its residential placements sufficient numbers of children committed to its custody or supervision for a status offense, a 29 misdemeanor offense, other than Assault and Battery of a High and Aggravated Nature and Assault with Intent to Kill, or for violation of probation/contempt of a status offense or a misdemeanor offense, other than Assault and Battery of a High and Aggravated Nature 30 31 and Assault with Intent to Kill, so that the number of children in its custody or under its supervision and placed in these residential placements does not exceed the number of housing units/beds available to properly house those children. No child adjudicated 32 delinquent for a violent crime as defined in Section 16-1-60 of the 1976 Code, a felony offense as defined in Section 16-1-90 of the 33 34 1976 Code, or a sexual offense shall be released pursuant to this proviso.

(LLR: Illegal Immigration Hotline Assistance) Upon the request of the Commission on Minority Affairs, the Department 13 of Labor, Licensing, and Regulation shall provide assistance to establish and maintain a twenty-four hour toll free telephone number 14 and electronic website to receive, record, collect, and report allegations of violations of federal immigration laws or related provisions 15 of South Carolina law by any non-United States citizen or immigrant, and allegations of violations of any federal immigration laws 16 or related provisions in South Carolina law against any non-United States citizen or immigrant. 17 Such violations shall include, but are not limited to, E-Verify or other federal work authorization program violations, violations of 18 Chapter 83, Title 40 of the 1976 Code relating to immigration assistance services, or any regulations enacted governing the operation 19 of immigration assistance services, false or fraudulent statements made or documents filed in relation to an immigration matter, as 20 defined by Section 40-83-20, violation of human trafficking laws, as defined in Section 16-3-930, landlord tenant law violations, or 21 violations of any law pertaining to the provision or receipt of public assistance benefits or public services. 22 23 **81.11.** (LLR: Board of Pharmacy) The Board of Pharmacy must accept affidavits of practical experience from interns whose practical experience internships occurred in this State. The affidavit must be accompanied by a ten dollar fee to cover administrative costs associated with compliance with this 27 proviso.

81.12. (LLR: Office of State Fire Marshal - Clothing) The Department of Labor, Licensing, and Regulation is authorized to

All funds not expended 15 in the prior fiscal year may be carried forward for use in the current fiscal year. 16 83.3. (DEW: Federal and Earmarked Prior Year Payments) The Department of Employment and Workforce shall be allowed to 17 pay federal and earmarked prior year obligations with current year funds. 18 83.4. (DEW: Transparency of Funding Appropriation) In order to promote accountability and transparency, the Department of 19 Employment and Workforce must provide and release to the public via the agency's website, a report of all aggregate amounts of 20 taxes, fees and payments that were charged, collected and paid by that state agency in the prior fiscal year. For the purpose of 21 efficiency and conservation of resources, this report shall be incorporated into the Trust Fund Report due by October first as required 22 23 by Section 41-33-45 of the 1976 Code. 17 84.10. (DOT: Hanahan Permit Application) With the funds authorized for the Department of Transportation, the department shall
 18 coordinate and facilitate negotiations between the City of Hanahan, the United States Army Corps of Engineers, CSX Railroad, and

19 other applicable entities for the necessary permit required to complete the Railroad Avenue Extension project in the City of Hanahan.

20 The department shall submit any and all necessary applications for the required permit on behalf of the applicable entities no later 21 than June 30, 2016.

22 **84.11.** (DOT: Bridge Replacement in McCormick County) Planning and construction on a new U.S. 378 bridge crossing Lake J.

(DOT: Project Priority List) From the funds appropriated to the department, the Department of Transportation Commission project priority lists, as required under Act 114 of 2007, shall be published in a conspicuous place on the department's website in a manner easily accessible to the public. The priority lists shall be accompanied by the associated engineering directives explaining the ranking process and methodology for applying the commission approved criteria.

29 **84.13.** (DOT: Sunset Suspended) The provisions of Section 6 of Act 114 of 2007 are suspended for the current fiscal year.

18 19	appropriations based on enplanements in South Carolina. This policy may be waived to provide matching state funds for critical FAA safety or capacity projects at air carrier airports.
20	87.4. (AERO: Hangar/Parking Facilities) The Division of Aeronautics will provide hangar/parking facilities for government
20 21	owned and/or operated aircraft on a first come basis. Funds shall be retained by the division for the purpose of hangar and parking

These funds shall be carried forward from the prior 24 fiscal year into the current fiscal year and must be used for the same purpose. 25 88.4. (SPA: Georgetown Port Maintenance Dredging Fund) The State Ports Authority shall maintain the Georgetown Port Maintenance Dredging Fund and any funds appropriated in this act for this purpose shall be deposited into this account. This fund 26 shall be separate and distinct from the General Fund and the Harbor Deepening Reserve Fund and interest accrued by the fund must 27 remain in the fund. This fund must be used exclusively by the South Carolina Ports Authority for the activities associated with the 28 29 maintenance dredging of the Port of Georgetown. Prior to expending any amount from the fund, the State Ports Authority must present a comprehensive plan for the use of the fund for maintenance dredging to the Joint Bond Review Committee for review and 30 comment. These funds shall be carried forward from the prior fiscal year into the current fiscal year and must be used for the same 31 32 purpose. 88.5. (SPA: Jasper Ocean Terminal Permitting) Of the funds allocated to the Ports Authority for the Jasper Ocean Terminal 33 34 Permitting, \$1,000,000 is designated for a contract for the permitting process that was previously scheduled to be handled by the Corps of Engineers. This funding may not be expended by the Ports Authority until a contract is executed. Additionally, any funds 35 not committed by this contract must be returned to the General Fund at the end of Fiscal Year 2016-17. 36

SECTION 91 - A990 - LEGISLATIVE DEPARTMENT

91.1. (LEG: Legislative Employee Designations) The positions included in this section designated (P) shall denote a permanent employee and the salary is an annual rate. The positions designated (T) shall denote a temporary employee and the salary is for a period of six months to be paid at that rate only while the General Assembly is in session. The positions designated as (Interim) shall denote a temporary employee and the salary is for a period of six months to be paid at that rate while the General Assembly is not in session. The positions designated (PTT) shall denote part-time temporary employees on a twelve-months basis. The positions designated (PPT) shall denote permanent part-time employees retained for full-time work for a period of months or the duration of the legislative session.

(LEG: Legislative Employee BPI/Merit) Legislative employees designated (P) or (PPT) shall receive base pay and average 11 merit pay in the same manner as such pay is granted to classified state employees, but for purposes of this paragraph, the term 12 "legislative employees" does not include employees of the House of Representatives. From the funds appropriated for Employee 13 Pay Increases, the Speaker of the House and the President Pro Tempore of the Senate shall determine the amount necessary for 14 compensation of the employees of the House and Senate.

15 91.3. (LEG: Interim Expenses Allowance) The Chairman of the Standing House and Senate Committees shall each be allowed 16 the sum of six hundred and fifty dollars for expenses during the interim, between sessions of the General Assembly, to be paid from 17 the House or Senate approved accounts, with each body paying the expense allowance of the chairman in its membership. The 18 Speaker of the House is authorized to approve not more than six hundred and fifty dollars for expenses during the interim for 19 Chairmen of the Standing Committees of the House.

91.4. (LEG: Subsistence/Travel Regulations) (A) Members of the General Assembly shall receive subsistence for each
 legislative day that the respective body is in session and in any other instance in which a member is allowed subsistence expense.
 No member of the General Assembly except those present are eligible for subsistence on that day. Legislative day is defined as those
 days commencing on the regular annual convening day of the General Assembly and continuing through the day of adjournment sine
 die, excluding Friday, Saturday, Sunday, and Monday.

25 (B) Standing Committees of the Senate and House of Representatives are authorized to continue work during the interim; however, House members must receive advanced approval by the Speaker of the House and Senate members must receive advanced 26 approval by the President Pro Tempore of the Senate or Standing Committee Chairman to meet. If such advanced approval is not 27 received, the members of the General Assembly shall not be paid the per diem authorized in this provision. When certified by the 28 Speaker of the House, President Pro Tempore of the Senate, or Standing Committee Chairman, the members serving on such 29 committees shall receive a subsistence and mileage at the rate provided for by law, and the regular per diem established in this act 30 for members of boards, commissions, and committees while attending scheduled meetings. Members may elect to receive actual 31 expenses incurred for lodging and meals in lieu of the allowable subsistence expense. The funds for allowances specified in this 32 proviso shall be paid to the members of the Senate or House of Representatives from the Approved Accounts of the respective body 33 34 except as otherwise may be provided.

35 (C) Joint Study Committees created pursuant to Acts and Resolutions of the General Assembly are authorized to continue work 36 during the interim to secure such information and complete such investigations as may be assigned to the respective committees;

however, House members must receive advanced approval by the Speaker of the House and Senate members must receive advanced 1 2 approval by the President Pro Tempore of the Senate or Standing Committee Chairman to meet. If such advanced approval is not received, the House and Senate members of the Joint Study Committee shall not be paid the per diem authorized in this provision. 3 4 When certified by the appropriate authority, the members appointed to such committees shall receive a subsistence and mileage at 5 the rate provided for by law, and the regular per diem established in this act for members of boards, commissions, and committees 6 while attending scheduled meetings. Members may elect to receive actual expenses incurred for lodging and meals in lieu of the 7 allowable subsistence expense. The allowances specified in this proviso shall be paid from funds appropriated to the respective 8 committees for such purposes, or from Approved Accounts of the respective body of the General Assembly if no funds have been appropriated to such a committee for these purposes. 9 (D) Members of the Senate and the House of Representatives when traveling on official State business shall be allowed a 10 subsistence and transportation expenses as provided for by law, and the regular per diem established in this act for members of 11 boards, commissions, and committees upon approval of the appropriate chairman. When traveling on official business of the Senate 12 or the House of Representatives not directly associated with a committee of the General Assembly, members shall be paid the same 13 allowance upon approval of the President Pro Tempore of the Senate or the Speaker of the House of Representatives. In either 14 instance, the members may elect to receive actual expenses incurred for lodging and meals in lieu of the allowable subsistence 15 expense. The funds for the allowances specified in this proviso shall be paid from the Approved Accounts of the Senate or the House 16 of Representatives or from the appropriate account of the agency, board, commission, task force or committee upon which the 17 18 member serves. (E) Members of the House of Representatives shall not be reimbursed for per diem, subsistence, or travel in connection with any 19 function held outside of the regular session of the General Assembly unless prior approval has been received from the Speaker of the 20 21 House. (F) Notwithstanding any other provision of law, subsistence and mileage reimbursement for members of the General Assembly 22

shall be the level authorized by the Internal Revenue Service for the Columbia area. Provided, in calculating the subsistence reimbursement for members of the General Assembly the reimbursement rate for the lodging component shall be the average daily rate for hotels in the Columbia Downtown area as defined by the Columbia Metro Convention and Visitor's Bureau for the preceding fiscal year.

91.5. (LEG: Senate Voucher Approval) All payroll vouchers, disbursement vouchers, and interdepartmental transfers of the
 Senate shall only require the approval of the Clerk of the Senate.

91.6. (LEG: Supplies Approval) All supplies for the Senate shall be purchased only upon the authority of the Clerk of the Senate
 and all supplies for the House of Representatives shall be purchased only upon the authority of the Clerk of the House.

91.7. (LEG: House Pages) Up to one hundred forty-four Pages may be appointed pursuant to House policies and procedures and
 they shall be available for any necessary service to the House of Representatives.

91.8. (LEG: Senate Research Personnel Compensation) Senate Research personnel other than Directors of Research and the
 committee research staff shall be paid from funds appropriated for Senate Research at the direction of the Clerk of the Senate.

91.9. (LEG: Contract for Services) The Standing Committees of the Senate may, upon approval of the President Pro Tempore, 1 2 contract with state agencies and other entities for such projects, programs, and services as may be necessary to the work of the respective committees. Any such projects, programs, or services shall be paid from funds appropriated for contractual services. 3 4 91.10. (LEG: Jt. Leg. Committee Operational Authorization) Only the Joint Legislative Committees for which funding is provided 5 herein are authorized to continue operating during the current fiscal year under the same laws, resolutions, rules or regulations which provided for their operations during the prior fiscal year. 6 91.11. (LEG: Legislative Carry Forward) In addition to the funds appropriated in this section, the funds appropriated under Part 7 IA. Sections 91A, 91B, 91C, 91D, and 91E for the prior fiscal year which are not expended during that fiscal year may be carried 8 forward to be expended for the same purposes in the current fiscal year. 9 91.12. (LEG: Senate Expenditures/O&M Committee) Notwithstanding any limitation or other provisions of law to the contrary, 10 funds expended by the Senate for salary adjustments, professional fees and dues, and necessary expenses, supplies, and equipment 11 for Senate employees, must be paid from funds appropriated to the Senate Operations and Management Committee and funds 12 available in approved accounts of the Senate, and shall be authorized and allocated in such manner as determined by the Senate 13 Operations and Management Committee. From the funds annually allocated to each Senator and Representative for postage and 14 telephone, \$250 may be used to purchase American and State flags. 15 91.13. (LEG: In-District Compensation) All members of the General Assembly shall receive an in-district compensation of \$1,000 16 17 per month. 91.14. (LEG: Additional House Support Personnel) The House Operations and Management Committee shall determine 18 procedures and policies for the administration and operation of the Legislative Aide program and the House Operations and 19 Management Committee shall manage the program. Appropriations to the House of Representatives in Part IA shall fund the 20 program. 21 22 91.15. (LEG: House Postage) The Speaker of the House is authorized to approve no more than \$700 per member per fiscal year 23 for postage. 91.16. (LEG: Legislative Dual Employment) Each committee and joint legislative committee provide a list to the members of the 24 25 General Assembly of all employees who hold dual positions of state employment. 26 91.17. (LEG: Code of Law Reimbursement) The Legislative Council may require reimbursement from public sector recipients except for the General Assembly of its cost of acquiring codes of law, supplements, or replacement volumes distributed to them. 27 91.18. (LEG: Statewide Acts Availability) From the funds appropriated in Part IA, Section 91D of this act, for the current fiscal 28

29 year the clerks of the House of Representatives and the Senate are to make all statewide Acts available to the public electronically.

30 The provisions of this section are in lieu of the House and Senate Clerks' duties related to the printing and mailing of acts as set forth

31 in Sections 2-13-190, 2-13-210, and 11-25-640 through 11-25-680 of the 1976 Code.

32 **91.19.** (LEG: LAC Matching Federal Funds) The Legislative Audit Council is authorized to use funds appropriated in this act as

33 state matching funds for federal funds available for audits and reviews. The council is also authorized to charge state agencies for

34 federal funds, if available, for the costs associated with audits and reviews. Agencies shall remit the federal funds to the Legislative

35 Audit Council as reimbursement for the costs of audits and reviews.

91.20. (LEG: Other Funds Oversight Committee) There is created a joint committee of the Senate and of the House of 1 2 Representatives entitled the Other Funds Oversight Committee. The committee shall consist of eight members as follows: the Chairman of the Senate Finance Committee, or his designee; one member of the Senate Finance Committee appointed by the 3 4 Chairman of the Senate Finance Committee: the Chairman of the House of Representatives Ways and Means Committee, or his 5 designee; one member of the House Ways and Means Committee appointed by the Chairman of the House Ways and Means 6 Committee; the Senate Majority Leader, or his designee; the Senate Minority Leader, or his designee; the House Majority Leader, or 7 his designee; and the House Minority Leader, or his designee. Members of the committee shall serve without compensation, but are allowed the usual per diem and mileage as provided by law 16 for members of boards, commissions, and committees while on official business. 17 For purposes of the proviso, 'other funds' means any revenues received by an agency which are not federal funds and are not 18 general funds appropriated by the General Assembly in the appropriations act. 19 91.21. (LEG: DMV Audit Review) For Fiscal Year 2015-16 the current fiscal year, the provisions of Section 56-1-5(F) are 20 suspended. Any savings generated by not conducting the review shall be used to conduct audits required by Section 2-15-60 of the 21 1976 Code. 22 23 91.22. (LEG: Electronic Correspondence) For Fiscal Year 2015-16 the current fiscal year, the House of Representatives may not expend any funds for the printing or mailing of bills, summaries, committee agendas, etc. to committee members. The House of 24 25 Representatives shall send all relevant information concerning committee meetings to committee members via electronic means. 91.23. (LEG: Technology Panel) Of the funds appropriated in XII.E.2. for Technology the K-12 Technology Initiative partnership 26 shall provide a report to the House Education and Public Works Committee, the House Ways and Means Committee, the Senate 27 28 Education Committee and the Senate Finance Committee, describing the state's efforts to facilitate the cost effective provision of 29 connectivity and internet bandwidth to schools and libraries on a statewide basis, regardless of location, activities to assist schools and libraries in minimizing and detecting internet security threats, the development and utilization of technological and online 30 31 resources to support student development and achievement, the development and utilization of curriculum and professional training to support the use of instructional technology in schools and libraries, and other educational technology related activities engaged in 32 by the partnership. Further, the report must detail information on the expenditure of the K-12 Technology funds by each district as 33 34 well as a list of the districts requesting flexibility in the use of those funds. The report shall be submitted no later than June 1, 2016 35 2017.

1	91.24. (LEG: Legislative Department Applicability) For purposes of this act and any other provision of law that would have any

18	91.27. (LEG: Voting System Research Committee) There is created a joint legislative committee, entitled the "Joint Voting
19	System Research Committee." This committee shall be comprised of ten members of the General Assembly, as follows:
20	(1) the President Pro Tempore of the Senate, or his designee;
21	(2) the Speaker of the House of Representatives, or his designee;

12	Governor is not a party in interest. Upon being served with the lawsuit, the Lieutenant Governor shall immediately notify the

34 92.2. (GOV: Mansion and Grounds Budget) The Governor's Office of Mansion and Grounds shall not exceed ten percent of its 35 quarterly allocation of funds so as to provide for agency operations on a uniform basis throughout the fiscal year.

SECTION 92 - D210 - OFFICE OF THE GOVERNOR

92.3. (GOV: Mansion and Grounds Maintenance and Complex Facilities) Revenue collected from rental of Mansion Complex 1 2 facilities and grounds must be retained and expended by the Governor's Office, Mansion and Grounds to support its operations. Unexpended funds shall be carried forward from the prior fiscal year into the current fiscal year and be utilized for the same purposes. 3 4 92.4. (GOV: Use of Funds Report) In order to ensure transparency and accountability, the Governor's Office of Executive 5 Control of State shall report quarterly to the Senate Finance Committee and House Ways and Means Committee on financial transactions that have taken place between Executive Control of State and Mansion and Grounds. These transactions shall include, 6 but are not limited to, any transfer of funds or payments or reimbursements for services rendered. For each transfer, payment, or 7 8 reimbursement the report must specify the amount, the reason for, or circumstance that necessitated the transaction, and the source of funds used. In the event federal or other funds were utilized, the source from which the revenue was generated must also be 9 included. The report must be submitted as soon after the end of each quarter as practicable. 10

12 SECTION 93 - D500 - DEPARTMENT OF ADMINISTRATION

93.1. (DOA: Development Disabilities Case Coordination System) Of the funds appropriated to the Department of Administration, Office of Executive Policy and Programs, \$50,000 must be used as state match for the Developmental Disabilities Council federal grant. These funds shall be excluded from the Department of Administration's base budget calculation of any acrossthe-board agency base reductions mandated by the Executive Budget Office or General Assembly.

93.2. (DOA: CCRS Evaluations & Placements) The amount appropriated in this section under Special Items Children's Case 18 Resolution System for Private Placement of Handicapped School-Age Children must be used for expenses incurred in the evaluation 19 of children referred to the CCRS to facilitate appropriate placement and to pay up to forty percent when placement is made in-state 20 and up to thirty percent when placement must be made out-of-state of the excess cost of private placement over and above one-per-21 22 pupil share of state and local funds generated by the Education Finance Act, and the one-per-pupil share of applicable federal funds; 23 provided it has been established that all other possible public placements are exhausted or inappropriate. The balance of funding 24 responsibility necessary to provide the child with services must be determined by the Children's Case Resolution System (CCRS) and apportioned among the appropriate public agencies on the basis of the reasons for the private placement. When the amount 25 26 appropriated in this section is exhausted, the funding responsibility must be apportioned according to the procedures of the CCRS. 93.3. (DOA: CCRS Significant Fiscal Impact) In accordance with Section 20-7-5240(e) of the 1976 Code, "significant fiscal 27 28

impact" in the current fiscal year shall be defined for each designated agency as the greater of (1) funds appropriated by the General
 Assembly for the current fiscal year on cases referred to, decided or placed through the Children's Case Resolution System or (2)
 that agency's assigned shares in the current fiscal year of five cases decided by the Children's Case Resolution System.

93.4. (DOA: Victim/Witness Program Formula Distribution) If funds in the South Carolina Victims' Compensation Fund exceed the amount required to operate the State Office of Victims Assistance and pay claims of crime victims the first \$650,000 of such excess must be used for Victim/Witness programs by distribution to Judicial Circuits based on a formula and criteria developed by the policy committee, and otherwise subject to requirements of Section 60.8.

93.5. (DOA: Physical Abuse Examinations) Of the funds appropriated in this section for Victims' Rights, up to \$120,000 may
 be expended for physical abuse examinations.

93.6. (DOA: Foster Care-Private Foster Care Reviews) The Department of Administration, Office of Executive Policy and Programs, Division of Foster Care is authorized to restructure its programs, including but not limited to, suspending reviews of children privately placed in private foster care and/or changing the location of reviews of children in public foster care, to maintain continuous operations within existing resources as dictated by recent budget reductions. These decisions must be based upon the availability of existing funds. This provision supersedes any previous statutory or regulatory mandate.

93.7. (DOA: Guardian Ad Litem Program) Both the program and the funds appropriated to the Department of Administration,
 Office of Executive Policy and Programs, Division of Children's Services, Guardian ad Litem Program must be administered
 separately from other programs within the Division of Children's Services and must be expended for the exclusive use of the Guardian
 ad Litem Program.

For the current fiscal year, the Department of Revenue is directed to reduce the rate of interest paid on eligible refunds by two percentage points. The revenue resulting from this reduction must be used exclusively for operations of the Guardian ad Litem program and be deposited in the State Treasury in a separate and distinct fund known as the "South Carolina Guardian ad Litem Trust Fund." Unexpended revenues in this fund carry forward to succeeding fiscal years, and earnings in this fund must be credited to it. The Guardian ad Litem program may carry forward the other funds authorized herein for its operations from the prior fiscal year into the current fiscal year.

93.8. (DOA: Continuum of Care Carry Forward) The Department of Administration, Office of Executive Policy and Programs,
 Division of Continuum of Care may carry forward funds appropriated herein to continue services.

93.9. (DOA: Procuring Services) In order to maximize services for victims of crime, if the fulfilling of requirements pursuant 18 to Section 16-3-1410 of the 1976 Code, necessitates hiring any outside entities, the State Office of Victims' Assistance must follow 19 procedures established by the SC Consolidated Procurement Code. Any entity contracting with the agency will submit an annual 20 report by August first to the Governor's Office and to the Chairmen of the Senate Finance Committee and House Ways and Means 21 Committee detailing expenditures from the prior fiscal year in accordance with the State Office of Victims' Assistance. The 22 23 Governor's Office of Executive Policy and Programs is directed to transfer \$122,032 of the funds carried forward from the prior 24 fiscal year in the Victims' Compensation Fund, and up to \$41,892 from general funds from Program III.C.1 to pay for any contracts 25 or services procured. 26

93.10. (DOA: M.J. "Dolly" Cooper Veterans Cemetery Carry Forward) The Department of Administration, Office of Executive Policy and Programs, Veterans' Affairs Program may carry forward unexpended funds appropriated and/or authorized for the M.J. "Dolly" Cooper Veterans Cemetery from the prior fiscal year and shall use such funds for the same purpose. In addition, any unexpended funds in the Veterans' Affairs Program, including Special Line Items, shall be carried forward from the prior fiscal year into the current fiscal year and used for operation of the M.J. "Dolly" Cooper Veterans Cemetery. Funds carried forward in excess of the amount needed for the operation of the Cemetery may be used for other expenses of the Veterans' Affairs Program. Funds carried forward may not be transferred to any other Department of Administration programs.

93.11. (DOA: Crime Victims Ombudsman) For the current fiscal year, the State Office of Victims Assistance shall transfer
 \$85,000 to the Crime Victims Ombudsman's Office to be used for administrative and operational support.

93.12. (DOA: Veterans' Affairs Budget Reduction Exemption) Funds appropriated for the Department of Administration, Office 1 2 of Executive Policy and Program, Veterans' Affairs Program shall be excluded from the Department of Administration's base budget in the calculation of any across-the-board agency base reductions mandated by the Executive Budget Office or General Assembly. 3 4 93.13. (DOA: Outside Legal Counsel) In the event circumstances necessitate that the Department of Administration, Office of 5 Executive Policy and Programs acquire the services of outside legal counsel, the Department of Administration must follow procedures established by the SC Consolidated Procurement Code. 6 7 93.14. (DOA: Carillon Tower) The Department of Administration, Office of Executive Policy and Programs, Veterans' Affairs 8 Program shall use any carry forward funds authorized for the M.J. "Dolly" Cooper Veterans Cemetery to construct the Carillon Tower to house the sound system used to provide bell tower music for the cemetery. 9 93.15. (DOA: State House Operation & Maintenance Account) Funds appropriated to the Department of Administration - for 10 State House Maintenance & Operations & Renovations must be set aside in a separate account for the operation and maintenance of 11 the State House. The department shall report annually to the State House Committee on the amount expended from this fund. 12 93.16. (DOA: Wireless Communications Tower) The Department of Administration is directed to coordinate tower and antenna 13 operations within South Carolina state government. The department shall (1) approve all leases regarding antenna placement on 14 15 state-owned towers and buildings, (2) coordinate all new tower construction on state-owned property, (3) promote and market excess capacity on the State's wireless communications infrastructure, (4) generate revenue by leasing, licensing, or selling excess capacity 16 on the State's wireless communications infrastructure, and (5) construct new communications assets on appropriate state-owned 17 property for the purpose of generating revenue pursuant to this proviso. All revenue from tower and antenna leases and contracts 18 after July 1, 2001 must be remitted to a separate fund established by the department and shall be transferred to the Educational 19 Television Commission which shall retain and expend such funds for agency operations. The commission shall be authorized to 20 21 carry forward unexpended funds from the prior fiscal year into the current fiscal year. Agencies owning tower and antenna assets will be allowed to recover expenses associated with implementing this proviso from this fund. The department shall annually report 22 to the Chairmen of the Senate Finance and House Ways and Means Committees by October first of each year all revenue collected 23 24 and disbursed. This report shall also include a summary of each agency's overall revenues, whether retained by the agency or 25 remitted to the separate fund. 93.17. (DOA: Compensation - Reporting of Supplemental Salaries) No supplement shall be paid to an agency's employee unless 26 the agency head or designated official of the employing agency, or in the case of supplements paid to college and university 27 28 presidents, their board of trustees, has approved the conditions and amount of salary supplement. Any compensation, excluding travel reimbursement, from an affiliated public charity, foundation, clinical faculty practice plan, or other public source or any 29 supplement from a private source to the salary appropriated for a state employee and fixed by the State must be reported by the 30 31 employing agency to the Department of Administration. The report must include the employee's base salary, amount of the supplement, source of the supplement, and any condition of the supplement. The employing agency must report this information on 32 or before August thirty-first of each year and must include the total amount and source of the salary supplement received by the 33 34 employee during the preceding fiscal year (July first through June thirtieth). The Department of Administration shall formulate

35 policies and procedures to ensure compliance with the reporting provisions of this proviso. Copies of the reports shall be made

available to the Chairman of the Senate Finance Committee and the Chairman of the House Ways and Means Committee, upon
 request.

93.18. (DOA: Compensation Increase - Appropriated Funds Ratio) Appropriated funds may be used for compensation increases for classified and unclassified employees and agency heads only in the same ratio that the employee's base salary is paid from appropriated sources.

93.19. (DOA: Local Provider Health Insurance) The local health care providers of the Department of Disabilities and Special
 Needs shall be awarded funding increases as prescribed for state agencies to cover the employer's share for the cost of providing
 health and dental insurance to their employees.

9 93.20. (DOA: Military Service) Notwithstanding the provisions of Section 8-11-610 of the 1976 Code, a permanent full-time state employee who serves on active duty as a result of an emergency or conflict declared by the President of the United States, and performs such duty, may use up to forty-five days of accumulated annual leave and may use up to ninety days of accumulated sick leave in a calendar year as if it were annual leave.

13 93.21. (DOA: Antenna and Tower Placement) All leases for antenna and tower operations within institutions of higher learning 14 campuses must conform to master plans for such property, as determined solely by the institution of higher learning.

15 93.22. (DOA: First Responder Interoperability) The Department of Administration is directed to administer and coordinate First Responder Interoperability operations for the statewide Palmetto 800 radio system to better coordinate public safety disaster 16 responses and communications. First Responder Interoperability administration and coordination shall be funded as provided in this 17 act. The cost-proportional funds shall be utilized for radio user fees of state agencies and public safety first responders (Fire, EMS 18 and Law Enforcement) that participate in the statewide Palmetto 800 radio system (Palmetto 800 participants). The Department of 19 Administration, in consultation with the State Law Enforcement Division, the Department of Public Safety, and the State Emergency 20 Management Division, and a representative of the South Carolina Sheriff's Association, shall set a baseline number of radios used 21 by each Palmetto 800 participant based on the technical aspects of the Palmetto 800 radio system and the jurisdictional requirements 22 23 of the participant. If a Palmetto 800 participant reduces the baseline number of radios in use, the amount of funds allocated for the participant's radio user fees shall be reduced in a proportional amount. The funds shall also be utilized to provide private county and 24 25 city radio systems with grant funds to be used for purchases of equipment that support interoperability with the statewide Palmetto 800 radio system and its users. Grant funds shall be allocated to private county and city radio systems based on the criteria used for 26 Palmetto 800 Participants and in amounts proportional to the amounts allocated to support the per-site radio user fees of Palmetto 27 28 800 participants. A matching share is required by a Palmetto 800 participant or by a private county or city radio system in order to qualify for receipt of funds pursuant to this proviso. Each fiscal year the Department of Administration shall establish the level of 29 match required based upon funding provided by this act. These entities shall be required to furnish such documentation as may be 30 31 required by the department to verify that the matching funds requirement is met. Upon funding state agency and public safety first responder user fees and private county and city equipment purchases, any remaining funds may be used to enhance and expand the 32 statewide Palmetto 800 radio system. All funds shall be held in a separate account established by the department for the purposes 33 34 set forth herein. Any unexpended portion of these funds may be carried forward and used for the same purpose. In the calculation of any across-the-board budget reduction mandated by the Executive Budget Office or General Assembly, the amount appropriated 35 to the Department of Administration for First Responder Interoperability must be excluded from the department's base budget. 36

1 The Department of Administration shall provide a report on the status of the integration of the statewide Palmetto 800 radio system 2 which shall include, but not be limited to, a list of entities who are not integrated into the system as of the end of the immediately

3 preceding fiscal year and the reason why they are not integrated. The report shall be submitted by October first, of the current fiscal

4 year to the Chairman of the Senate Finance Committee and the Chairman of the House Ways and Means Committee.

93.23. (DOA: Sale of Surplus Real Property) Up to fifty percent of the proceeds, net of selling expenses, from the sale of surplus real properties shall be retained by the Department of Administration and used for the deferred maintenance of state-owned buildings. The remaining fifty percent of the net proceeds shall be returned to the agency that the property is owned by, under the control of, or assigned to and shall be used by that agency for nonrecurring purposes. This provision applies to all state agencies and departments except: institutions of higher learning; the Public Service Authority; the Ports Authority; the MUSC Hospital Authority; the Myrtle

10 Beach Air Force Redevelopment Authority; the Department of Transportation; the Columbia State Farmers Market; the Department 11 of Agriculture's Columbia Metrology Lab building and property; the Charleston Naval Complex Redevelopment Authority; the

Department of Commerce's Division of Public Railways; the Midlands Technical College Enterprise Campus Authority; the Trident

13 Technical College Enterprise Campus Authority; the Commissioners residence at the Department of Corrections and the Educational

14 Television Commission's Key Road property.

The Educational Television Commission shall be authorized to retain the net proceeds from the sale of its property on Key Road, and such proceeds may be used for the renovation of the ETV Telecommunications Center and other maintenance and operating

17 expenses. If it is determined that sufficient net proceeds are not to be derived from the sale of its property on Key Road to cover the

18 cost of all renovations of the Telecommunications Center, the property on Key Road shall not be sold. Any proposed sale hereunder

- 19 shall, prior to said sale, be submitted to the Department of Administration for approval as being in compliance with the requirements
- 20 of this subsection.

The Department of Corrections shall be authorized to retain the net proceeds from the sale of the residence provided for the Commissioner of the Department of Corrections and use such proceeds for deferred maintenance needs at the Department of

23 Corrections.

The Forestry Commission shall be authorized to retain the net proceeds from the sale of surplus land for use in firefighting operations and replacement of firefighting equipment.

26 The Department of Natural Resources shall be authorized to retain the net proceeds from the sale of existing offices originally

27 purchased with a federal grant or with restricted revenue from hunting and fishing license sales for the improvement, consolidation,

and/or establishment of regional offices and related facilities.

The Department of Vocational Rehabilitation shall be authorized to retain the net proceeds from the sale of 3.205 acres located at 22861 Highway 76 East in Clinton, South Carolina to be used for capital projects and deferred maintenance.

31 The Department of Agriculture, the Educational Television Commission, the Department of Corrections, the Department of

32 Natural Resources, the Forestry Commission, and the Department of Vocational Rehabilitation shall annually submit a report, within

33 sixty days after the close of the fiscal year, to the Senate Finance Committee and the House Ways and Means Committee on the

34 status of the sale of the identified property and a detailed accounting on the expenditure of funds resulting from such sale.

35 This provision is comprehensive and supersedes any conflicting provisions concerning disposition of state-owned real property

36 whether in permanent law, temporary law or by provision elsewhere in this act.

1 Any unused portion of these funds may be carried forward into succeeding fiscal years and used for the same purposes.

2 93.24. (DOA: Compensation - Agency Head Salary) In the event of an agency head or technical college president vacancy, the governing board of the agency or the Governor, or the appointing authority of a technical college president, must have the prior 3 4 favorable recommendation of the Agency Head Salary Commission to set, discuss, offer, or pay a salary for the agency head or technical college president at a rate that exceeds the minimum of the range established by the Agency Head Salary Commission. No 5 agency head or technical college president shall be paid a salary higher than that recommended by the commission. Boards and 6 7 commissions, or the Governor if he is the appointing authority, of newly created agencies or technical colleges shall not offer or pay 8 a salary to a prospective agency head until a salary range has been established and the salary approved by the Agency Head Salary Commission. The funding of the salaries of any agency head or technical college president should come from resources within the 9 agency. The Department of Administration shall contract every four years for a study of agency head and technical college president 10 compensation. The cost of the study must be shared by the participating agencies. The staff of the State Fiscal Accountability 11 Authority shall serve as the support staff to the Agency Head Salary Commission. Limited only by the maximum of the respective 12 salary range, the General Assembly authorizes the respective appointing authority for an agency head or technical college president 13 to provide salary increases for an agency head or technical college president not to exceed that recommended by the Agency Head 14 Salary Commission. No agency head or technical college president shall be paid less than the minimum of the pay range nor receive 15 an increase that would have the effect of raising the salary above the maximum of the pay range. 16

93.25. (DOA: Cyber Security) All state agencies must adopt and implement cyber security policies, guidelines and standards 17 developed by the Department of Administration. The department may conduct audits on state agencies except public institutions of 18 higher learning, technical colleges, political subdivisions, and quasi-governmental bodies as necessary to monitor compliance with 19 established cyber security policies, guidelines and standards. Upon request, public institutions of higher learning, technical colleges, 20 21 political subdivisions, and quasi-governmental bodies shall submit sufficient evidence that their cyber security policies, guidelines and standards meet or exceed those adopted and implemented by the department. In addition, while agencies retain the primary 22 23 responsibility and accountability for ensuring responses to breach incidents comply with federal and state laws, the department shall 24 be informed of all agency cyber security breaches, and is authorized to oversee incident responses in a manner determined by the 25 department to be the most prudent. Upon request of the Department of Administration for information or data, all agencies must fully cooperate with and furnish the department with all documents, reports, assessments, and any other data and documentary 26 27 information needed by the department to perform its mission and to exercise its functions, powers and duties. The Judicial and 28 Legislative Branches are specifically exempt from the requirements set forth herein.

29 93.26. (DOA: Holidays) When a legal holiday specified in Section 53-5-10 of the 1976 Code falls on Sunday, the following Monday and when a holiday specified in that section falls on Saturday, the preceding Friday next preceding is deemed a public 30 31 holiday for all of the purposes. If either the following Monday or the preceding Friday is also a legal holiday, then the State Human Resources Director will designate the day upon which the legal holiday will be observed by state employees. To insure that no more 32 than the legal holidays specified in Section 53-5-10 are observed in the calendar year, a New Year's Day that falls on Saturday must 33 34 be observed on the following Monday. All bills of exchange, checks, and promissory notes which would otherwise be presentable for acceptance or payment on a Monday or Friday observed as a holiday pursuant to this section are deemed presentable for 35 acceptance or payment on the secular or business day succeeding the holiday. 36

1	93.27. (DOA: Nuclear Advisory Council) The Office of Regulatory Staff shall reimburse the Department of Administration for
2	travel expenses associated with the Governor's Nuclear Advisory Council from the SC Energy Office's radioactive waste funds.
3	93.28. (DOA: Classification and Compensation System Study) (A) The Department of Administration, Human Resources
4	Division shall enter into a contract to conduct an in-depth study of the state's classification and compensation system. For purposes
5	of the study, compensation shall include comprehensive employee benefits. The vendor must have experience with a state's
6	compensation system. The study shall include, but not be limited to:
7	(1) methods used to develop and determine position classifications;
8	(2) methods used to set pay grade minimum, midpoint, and maximum;
9	(3) appropriate market comparisons including, but not limited to, the private sector and local governments;
10	(4) methods to minimize salary disparities within an agency and within state government;
11	(5) methods of developing and sustaining a consistent long-term salary increase administrative policy for state government;
12	(6) recruitment and retention tools including, but not limited to, the impact of the Teacher and Employee Retirement
13	Incentive program;
14	(7) a process to address longevity pay deficits that currently exist;
15	(8) a state compensation philosophy statement;
16	(9) an analysis of merit-based compensation for employees and
17	(10) an analysis of unnecessary, underutilized, and duplicative positions in order to use that pay to increase salaries of existing
18	employees.
19	The study should also include interviews with agency heads and human resource staff from state agencies of various sizes. The
20	cost of the study shall not exceed \$300,000.
21	The findings of the study along with an implementation plan outlining the steps, sequences, and costs for implementing study
22	recommendations and findings shall be submitted by January 4, 2016 to the Classification and Compensation System Study
23	Committee as defined herein.
24	(B) There is created the Classification and Compensation System Study Committee which shall examine the findings and
25	recommendations submitted by the Department of Administration, Human Resources Division on the state's classification and
26	compensation system.
27	The committee shall be composed of eleven members, which shall be appointed as follows: two members appointed by the
28	Governor; two members appointed by the President Pro Temporary of the Senate; two members appointed by the Speaker of the
29	House of Representatives; two members appointed by the Chairman of the Senate Finance Committee; two members appointed by
30	the Chairman of the House Ways and Means Committee; and one member appointed by the SC State Employees Association. The
31	members shall elect a chairman at the first meeting of the committee.
32	No later than six months after the date from which a vendor contract has been signed, the committee shall prepare and deliver a
33	report and recommendation to the Chairman of the Senate Finance Committee and the Chairman of the House Ways and Means
34	Committee.
35	Staff for the committee shall be provided by the Senate Finance Committee and the House Ways and Means Committee. Members
36	of the study committee shall serve without compensation for per diem, mileage, and subsistence.

93.29. (DOA: Office of Victim Assistance) For the current fiscal year, The State Office of Victim Assistance may enter into
 memoranda of agreement with third-party victim service providers to secure emergency medical, transportation, or other crisis
 stabilization services on a reimbursable basis. Such agreements shall not allow for more than eight percent of the total reimbursement
 to cover a provider's administrative, marketing, and advocacy costs. Annually, and no later than October first of each year, the State
 Office of Victim Assistance shall report to the Governor, the Chairman of Senate Finance Committee, and the Chairman of House
 Ways and Means Committee on the performance of third-party providers and the use of funds authorized pursuant to this provision
 in the prior fiscal year.
 93.30. (DOA: Emerging Leaders Program) (A) With the funds appropriated to the Office of Human Resources, the Department

93.30. (DOA: Emerging Leaders Program) (A) With the funds appropriated to the Office of Human Resources, the Department of Administration shall establish an Emerging Leaders Program (ELP) that is designed to identify and develop the next generation 9 of South Carolina state government's leaders by attracting and/or retaining imminent or recent graduates of relevant post-10 baccalaureate programs to careers in public service. In order to cultivate effective and innovative leaders with demonstrated problem-11 solving capabilities, the program shall be cohort-based and require participants to complete rotations in a variety of functional roles 12 that focus on budgeting, policymaking, operations/service delivery, and other appropriate/elective fields. These rotations shall be 13 augmented by and interspersed with classroom-based modules on organizational behavior, decision-making processes, principles of 14 leadership, and other appropriate topics. 93.32. (DOA: Sale of Port Royal) (A) Within thirty days of the transfer of the real and personal property at Port Royal to the Department of Administration pursuant to Section 54-3-700 of the 1976 Code, from the funds appropriated to the department, the department must order a new appraisal for the property, which shall be the appraisal to which Section 54-3-700(C)(3) applies. For purposes of this section, a qualifying bid is a bid that meets the requirements of Section 54-3-700(C)(3).

(C) Upon the transfer of the real and personal property at Port Royal to the Department of Administration pursuant to Section 54 3-700, the State Ports Authority, and any of its representatives, are divested of any authority, control, jurisdiction, or legal standing
 in regards to the property.

17	(12) The Director of the Public Employee Benefit Authority, or their designee; and
18	(13) The state's 529 plan Administrator, or their designee;
19	Appointees two through seven may be members of the South Carolina Legislature or private citizens.
20	The Governor must designate a private entity to staff the task force. The entity shall be responsible for convening the first task
21	force meeting for the purposes of organizing and electing a chairperson. Thereafter the private entity shall serve as a coordinator
22	and staff for the work of the task force.
23	The Scope of the Task Force shall include, but is not limited to:

(LTG: Home and Community-Based Services Carry Forward) Unexpended funds from appropriations to the Lieutenant 6 Governor's Office on Aging for Home and Community-Based Services shall be carried forward from the prior fiscal year and used 7 for the same purpose. State funds appropriated for Home and Community-Based Services shall be used to fund those services that most directly meet the goal of allowing seniors to live independently at home. Allowable services include: group dining, home 8 delivered meals, transportation to group dining sites, transportation for essential trips, Home Care Level I and II, Home Chore, 9 Home Modification, Legal Assistance, Assessments, and Area Agencies on Aging (AAAs) may expend no more than ten percent for 10 administrative services. All state funds appropriated for Home and Community-Based Services are to be allocated to the AAAs 11 based on the methodology of the Intrastate Funding Formula. However, up to five percent of the annual state appropriation for 12 Home and Community Based Services may be retained at the state office to be allocated to the affected regions in cases of a 13 recognized emergency and/or natural disaster. A national security background check must be performed on the individual prior to a job offer being tendered. 3 4 100.16. (ADJ: National Guard State Active Duty) In the event of the activation of the South Carolina National Guard to State 5 Active Duty by the Governor in a Declaration of State Emergency (including Emergency Management Assistance Compact 6 (EMAC)), the State Treasurer and the Comptroller General are hereby authorized and directed to pay from the general fund of the 7 State such funds as necessary, not to exceed \$500,000, to cover the actual costs incurred for personnel, travel, and per diem costs, 8 and the Operational Tempo costs for equipment from the U.S. Property and Fiscal Office. EMAC and any Federal monies from a Declared Federal Emergency reimbursed to the state shall be deposited in the state general fund, up to the amount of funds advanced 9 to the South Carolina National Guard for the Declared State of Emergency. 10 100.17. (ADJ: National Guard Association and Foundation Support) From the funds authorized or appropriated for State Military 11 Department operations, the Adjutant General may authorize National Guard personnel to support and assist the National Guard 12 Association of South Carolina and the South Carolina National Guard Foundation in their missions to promote the health, safety, 13 education, and welfare of South Carolina National Guard personnel and their families. 14 15 100.18. (ADJ: State Guard Activation) In the event of activation of the State Guard of the South Carolina National Guard to State Active Duty, the Office of the Adjutant General is authorized to compensate State Guard personnel at a rate of \$150 per day 16 and to also compensate such personnel for meal per diem as authorized by National Guard and State policy. 17 18 **SECTION 101 - E280 - ELECTION COMMISSION** 19 20 21 101.1. (ELECT: County Boards of Voter Registration and Elections Compensation) The amounts appropriated in this section for "County Boards of Voter Registration and Elections Commissioners Members," shall be disbursed annually to the County Treasurer 22 23 at the rate of \$1,500 \$2,500 for each member. not to exceed \$12,500 per county. The County Treasurer shall use these funds only 24 for the compensation of County Boards of Voter Registration and Elections Commissioners Members. of the Board of State Canvassers up to a total of fifteen days that may be required for hearings held by the members of the Board of

6 **101.4.** (ELECT: Sale of Lists Revenue Carry Forward) Any revenue generated from the sale of election lists may be retained and 7 expended by the South Carolina Election Commission to reimburse the Department of Administration, for the printing of such lists 8 and to pay expenses of postage and shipment of these lists to electors who purchase them. After such reimbursement has been made 9 an amount, not to exceed \$400,000, shall be used for nonrecurring expenses in conjunction with extraordinary special election and 10 legal costs and costs for upgrading the Statewide Voter Registration System. Any balance in the Sale of Lists Account on June 11 thirtieth, of the prior fiscal year may be carried forward and expended for the same purposes during the current fiscal year.

12 **101.5.** (ELECT: Budget Reduction Exemption) Funds appropriated for recurring and nonrecurring general and primary election 13 expenses are exempted from mandated across the board reductions. In addition, in the calculation of any across the board agency 14 base reductions mandated by the Executive Budget Office or the General Assembly, the amount of funds appropriated for recurring 15 and nonrecurring primary and general election expenses shall be excluded from the agency's base budget.

(ELECT: Primary and General Election Carry Forward) Filing fees received from candidates filing to run in statewide or 17 special primary elections may be retained and expended by the State Election Commission to pay for the conduct of primary elections. 18 Any balance in the filing fee accounts on June thirtieth, of the prior fiscal year may be carried forward and expended for the same 19 purposes during the current fiscal year. In addition, any balance in the Primary and General Election Accounts on June thirtieth, of 20 the prior fiscal year may be carried forward and expended for the same purposes during the current fiscal year. In addition, the 21 aforementioned funds may also be utilized to conduct the Presidential Preference Primary elections.

101.7. (ELECT: Training & Certification Program) All members and staff of County Boards of Voter Registration and Elections will receive a common curriculum to include core courses on the duties and responsibilities of county boards of voter registration and elections and electives to promote quality service and professional development. The State Election Commission shall make these courses available in various locations, including but not be limited to, the upstate, coastal, and midlands areas of the state. Up to \$35,000 of revenue generated by charging a fee to attend these courses may be retained and expended by the South Carolina Election Commission to help cover the cost of providing the training. Any balance in the training and certification account on June thirtieth, of the prior fiscal year may be carried forward and expended for the same purpose during the current fiscal year.

The State Election Commission is required to withhold the stipend of members who do not complete the training and certification program as required in Section 7-5-10 of the 1976 Code. Additionally, funds will also be withheld if a board or commission member completes the training and certification program, but fails to complete at least one training course per year. The board or commission member and members of that county's legislative delegation will be notified of the withholding of the stipend and the requirements needed to bring the member into compliance with the law. (ELECT: Penalty for Late Submission of Reimbursable Expenses) In the event that a county submits reimbursable election 3 4 expenses to the Commission for payment more than thirty days after the election is held, the Commission may deduct a penalty of 5 ten percent of the late-submitted amount. The county is responsible for payment of this amount. If the Commission finds good 6 reason for such late submission, the penalty may be waived. The Election Commission shall be authorized to expend funds 7 appropriated/ authorized in the current fiscal year to pay election expenses incurred by a county in the prior fiscal year. If a county 8 submits a request for reimbursement of election expenses through any means other than the Voter Registration and Election Management System (VREMS), the Commission may deduct a penalty of ten percent of the amount submitted. 9 101.9. (ELECT: Help America Vote Act) Of funds appropriated to the commission for primary and general elections, the 10

commission shall utilize any excess funds to match the Help America Vote Act program to the greatest extent possible, and also ensure compliance with the Uniformed and Overseas Citizens Absentee Voting Act of 1986.

13 101.10. (ELECT: HAVA Carry Forward) The Election Commission shall be authorized to carry forward unexpended Help
 14 America Vote Act funds into the current fiscal year and to use these funds for the same purpose.

101.11. (ELECT: HAVA Match Funds) Funds appropriated through the General Fund for the purpose of providing a match for
 federal funds received through the Help America Vote Act (HAVA) shall be moved to a restricted account in order that the funds
 may accrue interest as per Section 254 (b) (1) of the Help America Vote Act.

18 **101.12.** (ELECT: Use of Election Funds) Funds appropriated to the Election Commission for the purpose of conducting elections 19 shall not be used for any other purpose unless specifically authorized in this act. However, up to \$200,000 may be transferred to 20 other operating accounts from General Election accounts upon approval from the Executive Budget Office, which shall then notify 21 the Chairman of the Senate Finance Committee, the Chairman of the House Ways and Means Committee, and the Governor of such 22 transfer of funds.

The merged systems will allow the Revenue and Fiscal Affairs 3 4 Office to provide the respective county officials with a list of potential voters who are possibly assigned to the wrong election district. 5 File merger is required only for those districts in which elections are scheduled. Counties and municipalities shall release GIS to the 6 Revenue and Fiscal Affairs Office upon the office's written request. Written request must be sent to the chief administrative officer 7 of the county or municipality and advise the county or municipality that failure to comply within thirty days of request may result in 8 the withholding of ten percent of the county's or municipality's state aid. The Executive Director of the Revenue and Fiscal Affairs Office may grant additional time for good cause and must waive release if the county or municipality does not possess GIS data. For 9 counties and municipalities that possess GIS data but do not release it, the Executive Director of the Revenue and Fiscal Affairs 10 Office shall notify the State Treasurer of the failure to comply with this provision after the required notice. Notification shall result 11 12 in the withholding of ten percent of subsequent payments of state aid to the entity until the GIS data is provided. Municipal and county data acquired by the Revenue and Fiscal Affairs Office in the course of performing its responsibilities may be used for other 13 functions of the office as well as shared with other state agencies. For this provision GIS data includes, but is not limited to, road 14 15 centerlines; orthophotography; parcel boundaries; address points; political boundaries; and administrative boundaries. 102.3. The purpose of the Warehouse is to ensure that the operation 29 of health and human services agencies may be enhanced by coordination and integration of client information. Client data is defined as person-level data that is created, received, and/or maintained by state agencies and other entities required to report client 30 31 information to the Revenue and Fiscal Affairs Office under this provision. To integrate client information, client data from health and human services state agencies will be linked to improve client outcome measures, enabling state agencies to analyze coordination 32 and continuity of care issues. (SFAA: Procurement of Art Objects) Before any governmental body, with the exception of the South Carolina Museum Commission, the Confederate Relic Room and Military Museum Commission, and the South Carolina Hunley Commission as defined under the South Carolina Consolidated Procurement Code, procures any art objects such as paintings, antiques, sculptures, or similar objects above \$1,000, the head of the Purchasing Agency shall prepare a written determination specifying the need for such objects and benefits to the State. The South Carolina Arts Commission shall review such determination for approval prior to any acquisition.

9 **104.2.** (SFAA: Vacant Positions) In the event that any permanent position in an agency remains vacant for more than twelve 10 months the position may be deleted by the State Fiscal Accountability Authority.

104.3. (SFAA: Lawsuit Funding) The Executive Director shall pay from the Insurance Reserve Fund the defense costs of the 12 State, which are incurred in the current fiscal year, in the Abbeville school funding litigation and the prisoner mental health care 13 litigation. The appropriate official from the House of Representatives and the Senate must certify to the Executive Director on a 14 monthly basis the costs incurred in defense of this litigation. Upon receipt of the certification, the Executive Director shall pay the 15 provider of these services the amount certified.

16 **104.4.** (SFAA: Public Procurement Unit) For purposes of participation in the Minnesota Multi State Contracting Alliance for 17 Pharmacy (MMCAP), a private, nonprofit corporation that provides only free medical care may be allowed to participate as a local 18 public procurement unit in the MMCAP cooperative purchase. The participation of nonprofit corporations in the program is 19 contingent upon approval of the Minnesota Multi-State Contracting Alliance for Pharmacy. Participating nonprofit corporations 20 must comply with all applicable federal laws or regulations for participation in the MMCAP cooperative purchase. The state shall 21 not be liable for any action or inaction of such a nonprofit corporation.

104.5. (SFAA: Insurance Coverage for Aging Entity Authorized) The State Fiscal Accountability Authority, through the Insurance Reserve Fund, for Fiscal Year 2015-16 the current fiscal year is also authorized to offer insurance coverage to an aging entity and its employees serving clients countywide which previously obtained its tort liability insurance coverage through the board. The Insurance Reserve Fund and the State of South Carolina shall not be liable to any person or entity, including an insured, for any

26 insufficiencies of coverage provided hereunder.

104.6. (SFAA: IRF Report) The State Fiscal Accountability Authority shall prepare a report on prior fiscal year utilization of the Insurance Reserve Fund to include for each transaction the amount, the recipient of the funds, the date of the transfer or payment, and the action or reason that necessitated the transfer. The report shall be submitted to the President Pro Tempore of the Senate, the Chairman of the Senate Finance Committee, the Speaker of the House of Representatives, and the Chairman of the House Ways and Means Committee by October fifteenth, of the current fiscal year.

(SFAA: Attorneys) For the current fiscal year, during the transition of the Insurance Reserve Fund from the Budget and 5 Control Board to the State Fiscal Accountability Authority, the Insurance Reserve Fund shall continue to approve the attorneys-at-6 law retained to defend those it insures. 7 104.10. (SFAA: Compensation - Agency Head Salary) In the event of an agency head or technical college president vacancy, the governing board of the agency or the Governor, or the appointing authority of a technical college president, must have the prior 8 favorable recommendation of the Agency Head Salary Commission to set, discuss, offer, or pay a salary for the agency head or 9 technical college president at a rate that exceeds the minimum of the range established by the Agency Head Salary Commission. No 10 agency head or technical college president shall be paid a salary higher than that recommended by the commission. Boards and 11 commissions, or the Governor if he is the appointing authority, of newly created agencies or technical colleges shall not offer or pay 12 a salary to a prospective agency head until a salary range has been established and the salary approved by the Agency Head Salary 13 Commission. The funding of the salaries of any agency head or technical college president should come from resources within the 14 agency. The State Fiscal Accountability Authority shall contract every four years for a study of agency head and technical college 15 president compensation. The cost of the study must be shared by the participating agencies. The staff of the State Fiscal 16 Accountability Authority shall serve as the support staff to the Agency Head Salary Commission. Any procurement of school buses by the Department of Education prior to the completion of the study 35 committee's report of its findings and recommendations shall be made utilizing the traditional sealed bid procurement process.

SECTION 105 - F270 - SFAA, STATE AUDITOR'S OFFICE

105.1. (SFAA-AUD: Annual Audit of Federal Programs) Each state agency receiving federal funds subject to the audit requirements of the Single Audit Act Amendments of 1996 and OMB Circular A-133, Audits of States, Local Governments and Nonprofit Organizations shall remit to the State Auditor an amount representing an equitable portion of the expense of contracting with a nationally recognized CPA firm to conduct a portion of the audit of the State's federal financial assistance.

Each state agency's equitable portion of the expense will be determined by a schedule developed by the State Auditor. Such remittance will be based upon invoices provided by the State Auditor. The audit shall be re-bid every five years. The State Auditor shall retain and expend the funds received and shall carry forward any unexpended funds from the prior fiscal year into the current fiscal year for the same purpose.

105.2. (SFAA-AUD: Medical Assistance Audit Carry Forward) The State Auditor's Office shall retain and expend the funds 12 received from the Department of Health and Human Services for the Medical Assistance Audit Program pursuant to Proviso 33.3 of 13 this act and shall carry forward any unexpended funds from the prior fiscal year into the current fiscal year for the same purpose.

14 **105.3.** (SFAA-AUD: Coordination with Inspector General) In the event the State Auditor's Office identifies instances of fraud, 15 waste, and abuse during any state agency audit, the State Auditor shall refer such instances to the State Inspector General for 16 examination. The State Auditor shall prepare and submit an annual report to the Chairmen of the House Ways and Means Committee 17 and the Senate Finance Committee and the Governor detailing all written referrals of fraud, waste, and abuse submitted to the State 18 Inspector General.

105.4. (SFAA-AUD: Annual Audit of Court Fees and Fines Reports) The State Auditor shall conduct a minimum of fifteen audits 19 annually of county treasurers, municipal treasurers, county clerks of court, magistrates and/or municipal courts as required by Section 20 14-1-210 of the 1976 Code and allowed by Section 14-1-240; however, the State Auditor shall not be required to spend more than 21 the annual amount of \$250,000, received from the State Treasurer to conduct the said audits pursuant to Section 14-1-210 of the 1976 22 23 Code. The State Auditor may contract with one or more CPA/accounting firms to conduct the required audits. Any unexpended balance on June thirtieth of the prior fiscal year shall be carried forward and must be expended for the same purpose during the current fiscal 29 year. The State Auditor shall annually report by October first, its findings of the jurisdictions audited to the Senate Finance 30 Committee and the House Ways and Means Committee. 31

(PEBA: Funding Abortions Prohibited) No funds appropriated for employer contributions to the State Health Insurance 3 4 Plan may be expended to reimburse the expenses of an abortion, except in cases of rape, incest or where the mother's medical 5 condition is one which, on the basis of the physician's good faith judgment, so complicates the pregnancy as to necessitate an 6 immediate abortion to avert the risk of her death or for which a delay will create serious risk of substantial and irreversible impairment 7 of major bodily function, and the State Health Plan may not offer coverage for abortion services, including ancillary services provided 8 contemporaneously with abortion services. The Public Employee Benefit Authority must determine the amount of the total premium paid for health coverage necessary to cover the risks associated with reimbursing participants in the plan for obtaining an abortion in 9 the circumstances covered by this provision. The determination must be based on actuarial data and empirical study in the same 10 manner and by the same method that other risks are adjusted for in similar circumstances. (PEBA: Inactive SCRS Account Transfer) A current employee or teacher who is an active participant in the State Optional Retirement Program but who has an inactive account in the South Carolina Retirement Program due to previous service in that system, shall be allowed to transfer previous contributions to the employee's or teacher's active State Optional Retirement Program

108.9. (PEBA: Network Pharmacy Publications) All pharmacy publications or lists must include independent retail pharmacies.
 Abridged pharmacy lists are prohibited.

31 **108.10.** (PEBA: Covered Contraceptives) In its Plan of Benefits effective January 1, 2016 <u>2017</u>, the State Health Plan shall not

32 apply patient cost sharing provisions to covered contraceptives. This provision does not alter the current approved list of

(DOR: Subpoenaed Employee Expense Reimbursement) If any employee of the Department of Revenue is subpoenaed to testify during litigation not involving the Department of Revenue, the party subpoenaing the employee(s) to testify shall reimburse the State for expenses incurred by the employee(s) requested to testify. Expenses shall include but are not limited to the cost of materials and the average daily salary of the employee or employees.
- 109.2. (DOR: Court Order Funds Carry Forward) Funds awarded to the Department of Revenue by court order shall be retained
 in a special account and shall be carried forward from year to year, and expended as needed to accomplish the purposes and conditions
 of said order if specified, and if not specified, as may be directed by the Director of the Department of Revenue.
- 10 **109.3.** (DOR: Rural Infrastructure Fund Transfer) Notwithstanding Section 12-10-85, the Department of Revenue is authorized 11 to deposit revenues from the Rural Infrastructure Fund in excess of \$12 million dollars to the Rural Infrastructure Fund under the 12 Rural Infrastructure Authority. Any revenues in excess of \$17 million shall be deposited in the Rural Infrastructure Fund under the

- 14 **109.4.** (DOR: SCBOS Funds) The Department of Revenue shall share equally the collection assistance fees imposed on overdue 15 tax debt with the South Carolina Business One Stop program. 6 **109.7.** (DOR: Admissions Tax Exemption) Any amount that an accredited college or university requires a season ticket holder to 7 pay to a nonprofit athletic booster organization that is exempt from federal income taxation in order to receive the right to purchase 8 athletic event tickets is exempt from admissions tax.

111.1. (PRP: Filing Fee) Requests for administrative review before the South Carolina Procurement Review Panel shall be 14 accompanied by a filing fee of two hundred and fifty dollars (\$250.00), payable to the SC Procurement Review Panel. The panel is 15 authorized to charge the party requesting an administrative review under the S.C. Code Sections 11-35-4210(6), 11-35-4220(5), 11-16 35-4230(6), 11-35-4330, and/or 11-35-4410. The funds generated by the filing fee shall be retained by the panel and carried forward 17 to be used for the operation of the panel. Withdrawal of an appeal will result in the filing fee being forfeited to the panel. If the filing 21 fee is not waived, the party must pay the filing fee within fifteen days of the date of receipt of the order denying waiver of the filing 22 23 fee. Requests for administrative review will not be accepted unless accompanied by the filing fee or a completed Request for Filing 24 Fee Waiver form at the time of filing.

113.4. (AS-TREAS: Legislative Delegations) In the current fiscal year, a county government must fund its legislative delegation budget pursuant to Section 3, Act No. 283 of 1975. If a county council does not meet that funding level, the amount of the shortfall must be deducted from the responsible county's Aid to Subdivisions allocation and forwarded to the legislation delegation of the county. Additionally, the responsible county's remaining Aid to Subdivisions allotment must be reduced by twenty-five percent of the shortfall amount, which sum must be forwarded to the legislative delegation to be used for its administrative costs.

(AS-TREAS: Withholding Funds) DELETED 113.9. (AS-DOR: Homestead Exemption Fund Reduction and CTC Road Program) The Fiscal Year 2015-16 appropriation to 33 34 Aid to Subdivisions Department of Revenue for Distribution to Subdivisions: Aid to Counties-Homestead Exemption Fund (X440) is reduced by \$20,425,000. 35

SECTION 114 - X440 - AID TO SUBDIVISIONS-DEPARTMENT OF REVENUE

The first \$10,000,000 carried forward from Fiscal Year 2014-15 annual appropriations to Aid to Subdivisions Department of Revenue for Distribution to Subdivisions: Aid to Counties Homestead Exemption Fund (X440) shall be credited to the Department of Transportation for distribution pursuant to Section 12-28-2740 of the 1976 Code. County Transportation Committees shall utilize the funds distributed pursuant to this proviso solely for use on the state-owned secondary road system for paving, rehabilitation, resurfacing, and/or reconstruction, and bridge repair, replacement, or reconstruction. No funds from this allocation shall be used for any road, bridge, or highway that is not part of the state-owned system.
SECTION 117 - X900 - GENERAL PROVISIONS

117.1. (GP: Revenues, Deposits Credited to General Fund) For the current fiscal year, except as hereinafter specifically provided, 10 all general state revenues derived from taxation, licenses, fees, or from any other source whatsoever, and all institutional and 11 departmental revenues or collections, including income from taxes, licenses, fees, the sale of commodities and services, and income 12 derived from any other departmental or institutional source of activity, must be remitted to the State Treasurer at least once each 13 week, when practical, and must be credited, unless otherwise directed by law, to the General Fund of the State. Each institution, 14 department or agency, in remitting such income to the State Treasurer, shall attach with each such remittance a report or statement, 15 showing in detail the sources itemized according to standard budget classification from which such income was derived, and shall, 16 at the same time, forward a copy of such report or statement to the Comptroller General and the Executive Budget Office. In order 17 to facilitate the immediate deposit of collections, refunds of such collections by state institutions where properly approved by the 18 authorities of same, may be made in accordance with directions from the State Comptroller General and State Treasurer. General 19 fund appropriations herein made for the support of the public school system of the State must be greater than or equal to the revenues 20 derived from the General Retail Sales Tax, the Soft Drinks Tax, and the state's portion of the Alcoholic Liquors Tax and Cable 21 22 Television Fees as forecasted in the general fund revenue estimate of the Board of Economic Advisors as accounted for in Section 23 116 of this act. Appropriations in this act for the support of the public school system shall include the following: 24 Department of Education; 25 State Board for Technical and Comprehensive Education; 26 Educational Television Commission;

- 27 Wil Lou Gray Opportunity School;
- 28 School for the Deaf and the Blind;
- 29 John de la Howe School;
- 30 Debt Service on Capital Improvement Bonds Applicable to
- 31 Above Agencies;
- 32 Debt Service on School Bonds;
- 33 Other School Purposes.
- 34 Nothing contained herein shall be construed as diminishing the educational funding requirements of this section.
- 35 **117.2.** (GP: Appropriations From Funds) Subject to the terms and conditions of this act, the sums of money set forth in this part,

36 if so much is necessary, are appropriated from the General Fund of the State, the Education Improvement Act Fund, the Highways

and Public Transportation Fund, and other applicable funds, to meet the ordinary expenses of the state government for Fiscal Year
 2015-16 <u>2016-17</u>, and for other purposes specifically designated.

3 **117.3.** (GP: Fiscal Year Definitions) For purposes of the appropriations made by this part, "current fiscal year" means the fiscal

4 year beginning July 1, 2015 2016, and ending June 30, 2016 2017, and "prior fiscal year" means the fiscal year beginning July 1,

5 <u>2014</u> <u>2015</u>, and ending June 30, <u>2015</u> <u>2016</u>.

6 **117.4.** (GP: Descriptive Proviso Titles) Descriptive proviso titles listed in this act are for purposes of identification only and are 7 not to be considered part of the official text.

8 **117.5.** (GP: Judicial & Involuntary Commitment, Defense of Indigents) It is the responsibility of all agencies, departments and 9 institutions of state government, to provide at no cost and as a part of the regular services of the agency, department or institutions

such services as are necessary to carry out the provisions of Chapter 52, Title 44 (Involuntary Commitment), Article 7, Chapter 17,

11 Title 44 of the 1976 Code (Judicial Commitment), Chapter 3, Title 17 of the 1976 Code (Defense of Indigents), and Article 1, Chapter 12 3, Title 16 of the 1976 Code (Death Penalty), as amended, upon request of the Judicial Department and/or the appropriate court. To

13 this end, state agencies are directed to furnish to the Judicial Department a list of their employees who are competent to serve as

14 court examiners. The Judicial Department shall forward a copy of this list to the appropriate courts, and the courts shall utilize the

services of such state employees whenever feasible. State employees shall receive no additional compensation for performing such

16 services. For the purpose of interpreting this section, employees of the Medical University of South Carolina and individuals serving

- 17 an internship or residency as an academic requirement or employees who are not full-time state employees and who are not
- 18 performing duties as state employees are not considered state employees.

19 **117.6.** (GP: Case Service Billing Payments Prior Year) Agencies appropriated case services funds who routinely receive prior 20 year case service billings after the old fiscal year has been officially closed are authorized to pay these case service obligations with 21 current funds. This authorization does not apply to billings on hand that have been through a timely agency payment approval 22 process when the old fiscal year closes.

117.7. (GP: Fee Increases) (A) No state agency, department, board, committee, commission, or authority, may increase an
 existing fee for performing any duty, responsibility, or function unless the fee for performing the particular duty, responsibility, or
 function is authorized by statutory law and set by regulation except as provided in this paragraph.

26 (B) This paragraph does not apply to:

- (1) state-supported governmental health care facilities;
- (2) state-supported schools, colleges, and universities;
- 29 (3) educational, entertainment, recreational, cultural, and training programs;
- 30 (4) the State Board of Financial Institutions;
- 31 (5) sales by state agencies of goods or tangible products produced for or by these agencies;
- 32 (6) charges by state agencies for room and board provided on state-owned property;

1 (C) This paragraph does not prohibit a state agency, department, board, committee, or commission from increasing fees for 2 services provided to other state agencies, departments, boards, committees, commissions, political subdivisions, or fees for health 3 care and laboratory services regardless of whether the fee is set by statute.

4 (D) Statutory law for purposes of this paragraph does not include regulations promulgated pursuant to the State Administrative 5 Procedures Act.

117.8. (GP: State Institutions - Revenues & Income) The University of South Carolina, Clemson University, the Medical 6 7 University of South Carolina (including the Medical University Hospital), The Citadel, Winthrop University, South Carolina State 8 University, Francis Marion University, University of Charleston, Lander University, Coastal Carolina University, and the Wil Lou Gray Opportunity School shall remit all revenues and income, collected at the respective institutions, to the State Treasurer according 9 to the terms of Section 117.1 of this act, but all such revenues or income so collected, except fees received as regular term tuition, 10 matriculation, and registration, shall be carried in a special continuing account by the State Treasurer, to the credit of the respective 11 institutions, and may be requisitioned by said institutions, in the manner prescribed in Section 11-3-185 of the 1976 Code, and 12 expended to fulfill the purpose for which such fees or income were levied, but no part of such income shall be used for permanent 13 improvements without the express written approval of the State Fiscal Accountability Authority and the Joint Legislative Capital 14 Bond Review Committee; and it is further required that no such fee or income shall be charged in excess of the amount that is 15 necessary to supply the service, or fulfill the purpose for which such fee or income was charged. Notwithstanding other provisions 16 of this act, funds at state institutions of higher learning derived wholly from athletic or other student contests, from the activities of 17 student organizations, and from the operations of canteens and bookstores, and from approved Private Practice plans at institutions 18 and affiliated agencies may be retained at the institution and expended by the respective institutions only in accord with policies 19 established by the institution's Board of Trustees. Such funds shall be audited annually by the State but the provisions of this act 20 concerning unclassified personnel compensation, travel, equipment purchases and other purchasing regulations shall not apply to the 21 22 use of these funds. 23 **117.9.** (GP: Transfers of Appropriations) Agencies and institutions shall be authorized to transfer appropriations within programs and within the agency with notification to the Executive Budget Office and Comptroller General. No such transfer may exceed 24 25 twenty percent of the program budget. Upon request, details of such transfers may be provided to members of the General Assembly 26 on an agency by agency basis. Transfers of appropriations from personal service accounts to other operating accounts or from other

operating accounts to personal service accounts may be restricted to any established standard level set by the State Fiscal
 Accountability Authority upon formal approval by a majority of the members of the State Fiscal Accountability Authority.

117.10. (GP: Federal Funds - DHEC, DSS, DHHS - Disallowances) Amounts appropriated to the Department of Health and Environmental Control, Department of Social Services and Department of Health and Human Services may be expended to cover program operations of prior fiscal years where adjustment of such prior years are necessary under federal regulations or audit exceptions. All disallowances or notices of disallowances by any federal agency of any costs claimed by these agencies shall be submitted to the State Auditor, the Senate Finance Committee and the House Ways and Means Committee, within five days of receipt of such actions.

117.11. (GP: Fixed Student Fees) During the current fiscal year, student fees at the state institutions of higher learning shall be
 fixed by the respective Boards of Trustees as follows:

1 (1) Fees applicable to student housing, dining halls, student health service, parking facility, laundries and all other personal 2 subsistence expenses shall be sufficient to fully cover the total direct operating and capital expenses of providing such facilities and 3 services over their expected useful life except those operating or capital expenses related to the removal of asbestos.

(2) Student activity fees may be fixed at such rates as the respective Boards shall deem reasonable and necessary.

5 **117.12.** (GP: Tech Educ. Colleges Student Activity Fees) Notwithstanding any other provisions of this act, funds at technical 6 education colleges derived wholly from the activities of student organizations and from the operations of canteens and bookstores 7 may be retained by the college and expended only in accord with policies established by the respective college's area commission 8 and approved by the State Board for Technical and Comprehensive Education.

9 117.13. (GP: Discrimination Policy) It is the policy of the State of South Carolina to recruit, hire, train, and promote employees 10 without discrimination because of race, color, sex, national origin, age, religion or physical disability. This policy is to apply to all 11 levels and phases of personnel within state government, including but not limited to recruiting, hiring, compensation, benefits, 12 promotions, transfers, layoffs, recalls from layoffs, and educational, social, or recreational programs. It is the policy of the State to 13 take affirmative action to remove the disparate effects of past discrimination, if any, because of race, color, sex, national origin, age, 14 religion or physical disability.

Each state agency shall submit to the State Human Affairs Commission employment and filled vacancy data by race and sex by October thirty-first, of each year.

In accordance with Section 1-13-110 of the 1976 Code, as amended, the Human Affairs Commission shall submit a report on the 17 status of state agencies' Affirmative Action Plans and Programs to the General Assembly by February first each year. This report 18 shall contain the total number of persons employed in each job group, by race and sex, at the end of the preceding reporting period, 19 a breakdown by race and sex of those hired or promoted from within the agency during the reporting period, and an indication of 20 whether affirmative action goals were achieved. For each job group referenced in the Human Affairs report, where the hiring of 21 personnel does not reflect the percentage goals established in the agency's affirmative action plan for the year in question, the state 22 agency shall submit a detailed explanation to the Human Affairs Commission by February fifteenth, explaining why goals were not 23 24 achieved. 25 The Human Affairs Commission shall review the explanations and notify the Department of Administration of any agency not in

25 The Human Affairs Commission shall review the explanations and notify the Department of Administration of a 26 satisfactory compliance with meeting its stated goals.

The Department of Administration shall notify any agency not in compliance that their request for additional appropriations for the current appropriation cycle, may not be processed until such time as the Department of Administration, after consultation with the Human Affairs Commission, is satisfied that the agency is making a good faith effort to comply with its affirmative action plan, and that the compliance must be accomplished within a reasonable length of time to be determined by the mission and circumstances of the agency. This requirement shall not affect additional appropriation requests for public assistance payments or aid to entities. This section does not apply to those agencies that have been exempted from the reporting requirements of the Human Affairs

33 Commission.

34 **117.14.** (GP: Personal Service Reconciliation, FTEs) In order to provide the necessary control over the number of employees,

35 the Executive Budget Office is hereby directed to maintain close supervision over the number of state employees, and to require

36 specifically the following:

(1) That no state agency exceed the total authorized number of full-time equivalent positions and those funded from state 1 2 sources as provided in each section of this act except by majority vote of the State Fiscal Accountability Authority.

- (2) That the Executive Budget Office shall maintain and make, as necessary, periodic adjustments thereto, an official record 3 4 of the total number of authorized full-time equivalent positions by agency for state and total funding sources.
- 5 (a) That within thirty days of the passage of the Appropriation Act or by August first, whichever comes later, each agency of the State must have established on the Executive Budget Office records all positions authorized in the Act. After that date, the 6 7 office shall delete any non-established positions immediately from the official record of authorized full-time equivalent positions. No positions shall be established by the office in excess of the total number of authorized full-time equivalent positions. Each agency 8 may, upon notification to the Executive Budget Office, change the funding source of state FTE positions established on the Executive 9 Budget Office records as necessary to expend federal and other sources of personal service funds to conserve or stay within the state 10 appropriated personal service funds. No agency shall change funding sources that will cause the agency to exceed the authorized 11 number of state or total full-time equivalent positions. Each agency may transfer FTE's between programs as needed to accomplish 12 the agency mission. 13
- (b) That by September thirtieth, the office shall prepare a personal service analysis, by agency, which shows the number 14 15 of established positions for the fiscal year and the amount of funds required, by source of funds, to support the FTE's for the fiscal year at a funding level of one hundred percent. The office shall then reconcile each agency's personal service detail with the agency's 16 personal service appropriation as contained in the Act adjusted for any pay increases and any other factors necessary to reflect the 17 agency's personal service funding level. The office shall provide a copy of each agency's personal service reconciliation to the 18 Senate Finance and House Ways and Means Committees. 19
- 20 (c) That any position which is shown by the reconciliation to be unfunded or significantly underfunded may be deleted at the direction of the State Fiscal Accountability Authority. 21

- (3) That full-time equivalent (FTE) positions shall be determined under the following guidelines:
 - (a) The annual work hours for each FTE shall be the agency's full-time standard annual work hours.
- 24 (b) The state FTE shall be derived by multiplying the state percentage of budgeted funds for each position by the FTE for 25 that position.
- 26 (c) All institutions of higher education shall use a value of 0.75 FTE for each position determined to be full-time faculty with a duration of nine months. 27
- 28 The FTE method of accounting shall be utilized for all authorized positions. 29
 - (4) That the number of positions authorized in this act shall be reduced in the following circumstances:
 - (a) Upon request by an agency.
 - (b) When anticipated federal funds are not made available.
- (c) When the Executive Budget Office, through study or analysis, becomes aware of any unjustifiable excess of positions 32 33 in any state agency.
- 34 (5) That the Executive Budget Office shall annually reconcile personal service funds with full-time employee count. Unfunded 35 positions will be eliminated no later than January fifteenth of the current fiscal year unless specifically exempted elsewhere in this

act or by the Executive Budget Office. The Executive Budget Office must report the full-time employee count and unfunded position
 status to the Senate Finance Committee and the Ways and Means Committee by February first of the current fiscal year.

3 (6) That no new permanent positions in state government shall be funded by appropriations in acts supplemental to this act but 4 temporary positions may be so funded.

5 (7) That the provisions of this section shall not apply to personnel exempt from the State Classification and Compensation 6 Plan under item I of Section 8-11-260 of the 1976 Code.

The Governor, in making his appropriation recommendations to the Ways and Means Committee, must provide that the level of personal service appropriation recommended for each agency is at least ninety-seven percent of the funds required to meet one hundred percent of the funds needed for the full-time equivalents positions recommended by the Governor (exclusive of new positions).

117.15. (GP: Allowance for Residences & Compensation Restrictions) That salaries paid to officers and employees of the State, 11 12 including its several boards, commissions, and institutions shall be in full for all services rendered, and no perquisites of office or of employment shall be allowed in addition thereto, but such perquisites, commodities, services or other benefits shall be charged for 13 at the prevailing local value and without the purpose or effect of increasing the compensation of said officer or employee. The charge 14 for these items may be payroll deducted at the discretion of the Comptroller General or the chief financial officer at each agency 15 maintaining its own payroll system. This shall not apply to the Governor's Mansion, nor to guards at any of the state's penal 16 institutions and nurses and attendants at the Department of Disabilities and Special Needs, and registered nurses providing clinical 17 care at the MUSC Medical Center, nor to the Superintendent and staff of John de la Howe School, nor to the cottage parents and staff 18 of Wil Lou Gray Opportunity School, nor to full-time or part-time staff who work after regular working hours in the SLED 19 Communications Center or Maintenance Area, nor to adult staff at the Governor's School for Science and Mathematics and the 20 Governor's School for Arts and Humanities who are required to stay on campus by the institution because of job requirements or 21 program participation. Any state institution of higher learning may provide complimentary membership privileges to employees 22 23 who work at their wellness centers. The presidents of those state institutions of higher learning authorized to provide on-campus 24 residential facilities for students may be permitted to occupy residences on the grounds of such institutions without charge.

Any state institution of higher learning may provide a housing allowance to the president in lieu of a residential facility, the amount to be approved by the State Fiscal Accountability Authority.

That the following may be permitted to occupy residences owned by the respective departments without charge: the Farm Director, 27 Farm Managers, and Specialists employed at the Wateree River Correctional Institution; the South Carolina State Commission of 28 Forestry fire tower operators, forestry aides, and caretaker at central headquarters; the Department of Natural Resources' Game 29 Management Personnel, Fish Hatchery Personnel, and Fort Johnson Superintendent; the Department of Parks, Recreation and 30 Tourism field personnel in the State Parks Division; Director of Wil Lou Gray Opportunity School; President of the School for the 31 Deaf and the Blind; houseparents for the Commission for the Blind; South Carolina Department of Health and Environmental Control 32 personnel at the State Park Health Facility and Camp Burnt Gin; Residence Life Coordinators at Lander University; Residence Life 33 34 Directors, temporary and transition employees, student interns, and emergency personnel at Winthrop University; Farm Superintendent at Winthrop University; Residence Hall Directors at the College of Charleston; the Department of Disabilities and 35 Special Needs' physicians and other professionals at Whitten Center, Clemson University Off-Campus Agricultural Staff and 36

1 Housing Area Coordinators; and TriCounty Technical College's Bridge to Clemson Resident and Area Directors; and housing

2 maintenance night supervisors, residence life directors, temporary and transition employees, and emergency medical personnel 3 occupying residences owned by the University of South Carolina. Except in the case of elected officials, the fair market rental value

4 of any residence furnished to a state employee shall be reported by the state agency furnishing the residence to the Agency Head

5 Salary Commission, and the Department of Administration by October first of each fiscal year.

6 All salaries paid by departments and institutions shall be in accord with a uniform classification and compensation plan, approved 7 by the Department of Administration, applicable to all personnel of the State Government whose compensation is not specifically 8 fixed in this act. Such plan shall include all employees regardless of the source of funds from which payment for personal service is drawn. The Department of Administration is authorized to approve temporary salary adjustments for classified and unclassified 9 employees who perform temporary duties which are limited by time and/or funds. When approved, a temporary salary adjustment 10 shall not be added to an employee's base salary and shall end when the duties are completed and/or the funds expire. Academic 11 12 personnel of the institutions of higher learning and other individual or group of positions that cannot practically be covered by the plan may be excluded therefrom but their compensations as approved by the Department of Administration shall, nevertheless, be 13 subject to review by the State Fiscal Accountability Authority. Salary appropriations for employees fixed in this act shall be in full 14 for all services rendered, and no supplements from other sources shall be permitted or approved by the State Fiscal Accountability 15 Authority. With the exception of travel and subsistence, legislative study committees shall not compensate any person who is 16 otherwise employed as a full-time state employee. Salaries of the heads of all agencies of the State Government shall be specifically 17 fixed in this act and no salary shall be paid any agency head whose salary is not so fixed. As long as there is no impact on appropriated 18 funds, state agencies and institutions shall be allowed to spend public funds and/or other funds for designated employee award 19 programs which shall have written criteria approved by the agency governing board or commission. For purposes of this section, 20 monetary awards, if any, shall not be considered a part of an employee's base salary, a salary supplement, or a perquisite of 21 22 employment. The names of all employees receiving monetary awards and the amounts received shall be reported annually to the 23 Department of Administration.

24 In the case of lodging furnished by certain higher education institutions to employees, the prevailing local rate does not apply if 25 the institution meets the exceptions for inadequate rent described in the current Internal Revenue Code Section 119(d)(2). To meet 26 the exception, rental rates must equal the lesser of five percent of the appraised value of the qualified campus lodging, or the average of the rentals paid by individuals (other than employees or students of the educational institution) during the calendar year for lodging 27 provided by the educational institution which is comparable to the qualified campus lodging provided to the employee, over the rent 28 paid by the employee for the qualified campus lodging during the calendar year. The appraised value shall be determined as of the 29 close of the calendar year in which the taxable year begins, or, in the case of a rental period not greater than one year, at any time 30 during the calendar year in which the period begins. 31

117.16. (GP: Universities & Colleges - Allowance for Presidents) Presidents of the University of South Carolina, Clemson University, the Medical University of South Carolina, The Citadel, Winthrop University, South Carolina State University, Francis Marion University, University of Charleston, Coastal Carolina University and Lander University must not be paid a fixed allowance for personal expenses incurred in connection with the performance of their official duties. Reimbursements may be made to the presidents from funds available to their respective institutions for any personal expenses incurred provided that all requests for

1 reimbursement are supported by properly documented vouchers processed through the normal accounting procedures of the 2 institutions.

117.17. (GP: Replacement of Personal Property) The Department of Juvenile Justice, Department of Corrections, Department 3 4 of Probation, Parole and Pardon Services, Department of Mental Health, Department of Disabilities and Special Needs, Continuum 5 of Care, Department of Social Services and School for the Deaf and the Blind may replace the personal property of an employee which has been damaged or destroyed by a client while in custody of the agency. The replacement of personal property may be 6 7 made only if the loss has resulted from actions by the employee deemed to be appropriate and in the line of duty by the agency head 8 and if the damaged or destroyed item is found by the agency head to be reasonable in value, and necessary for the employee to carry out the functions and duties of his employment. Replacement of damaged or destroyed items shall not exceed \$250 per item, per 9 incident. Each agency must have guidelines to insure the reasonableness of the replacement payments. 10 **117.18.** (GP: Business Expense Reimbursement) Agency heads and deputy commissioners or deputy directors designated by 11 agency heads may receive reimbursements for business expenses incurred while performing their official duties, provided that 12 receipts are presented when seeking reimbursement and justification is submitted to document the time, place, and purpose of the 13 expense as well as the names of the individuals involved. The Department of Administration shall promulgate regulations governing 14

15 these expenses.

16 117.19. (GP: Per Diem) The per diem allowance of all boards, commissions and committees shall be at the rate of \$35 per day.
 17 No full-time officer or employee of the State shall draw any per diem allowance for service on such boards, commissions or
 18 committees.

19 117.20. (GP: Travel - Subsistence Expenses & Mileage) Travel and subsistence expenses, whether paid from state appropriated,
 20 federal, local or other funds, shall be allowed in accordance with the following provisions:

(A) Unless otherwise provided in paragraphs B through H of this section, all employees of the State of South Carolina or any 21 agency thereof including employees and members of the governing bodies of each technical college while traveling on the business 22 23 of the State shall, upon presentation of a paid receipt, be allowed reimbursement for actual expenses incurred for lodging, not to exceed the current maximum lodging rates, excluding taxes, established by the U.S. General Services Administration. The lodging 24 25 reimbursement for employees of a school district must also conform to these rates when that employee's travel reimbursement is 26 paid by state funds that are transferred to the school district. Agencies may contract with lodging facilities to pay on behalf of an employee. Failure to maintain proper control of direct payments for lodging may result in the revocation of the agency's authority 27 by the Comptroller General or the State Auditor. The employee shall also be reimbursed for the actual expenses incurred in the 28 obtaining of meals except that such costs shall not exceed \$25 per day within the State of South Carolina. For travel outside of South 29 Carolina the maximum daily reimbursement for meals shall not exceed \$32. Agencies may contract with food or dining facilities to 30 31 pay for meals on behalf of employees in accordance with rules and regulations established by the Office of Comptroller General. It shall be the responsibility of the agency head to monitor the charges for lodging which might be claimed by his employees in order 32 to determine that such charges are following maximum lodging rates as established by the U.S. General Services Administration. 33 34 Any exceptions must have the written approval of the agency head, taking into consideration location, purpose of travel or other extenuating circumstances. The provisions of this item shall not apply to Section 42-3-40 of the 1976 Code, and when pertaining to 35 institutions of higher learning, for travel paid with funds other than General Funds. 36

1 (B) That employees of the State, when traveling outside the United States, Canada, and Puerto Rico upon promotional business 2 for the State of South Carolina shall be entitled to actual expenses for both food and lodging.

3 (C) The Governor, Lieutenant Governor, Secretary of State, Comptroller General, Attorney General, State Treasurer, Adjutant
 4 General, Superintendent of Education and the Commissioner of Agriculture shall be reimbursed actual expenses for subsistence.

5 (D) Non-legislative members of committees appointed pursuant to Acts and Resolutions of the General Assembly whose 6 membership consists solely of members of the General Assembly or members of the General Assembly and other personnel who are 7 not employees of the State of South Carolina shall be allowed subsistence expenses of \$35 per day while traveling on official business, 8 unless otherwise designated by law. Members of such committees may opt to receive actual expenses incurred for lodging and actual 9 expenses incurred in the obtaining of meals in lieu of the allowable subsistence expense.

10 (E) Members of the state boards, commissions, or committees whose duties are not full-time and who are paid on a per diem 11 basis, shall be allowed reimbursement for actual expenses incurred at the rates provided in paragraph A and I of this section while 12 away from their places of residence on official business of the State. One person accompanying a handicapped member of a state 13 board, commission, or committee on official business of the State shall be allowed the same reimbursement for actual expenses 14 incurred at the rates provided in paragraph A through I of this section.

15 (F) No subsistence reimbursement shall be allowed to a Justice of the Supreme Court or Judge of the Court of Appeals while traveling in the county of his official residence. When traveling on official business of said court within fifty miles outside the county 16 of his official residence, a Supreme Court Justice and a Judge of the Court of Appeals shall be allowed subsistence expenses in the 17 amount of \$35 per day plus such mileage allowance for travel as is provided for other employees of the State. When traveling on 18 official business of said court fifty or more miles outside the county of his official residence, each Justice and Judge of the Court of 19 Appeals shall be allowed subsistence expenses in the amount as provided in this act for members of the General Assembly plus such 20 mileage allowance for travel as is provided for other employees of the State. The Chief Justice, or such other person as the Chief 21 Justice designates, while attending the Conference of Chief Justices and one member of the Supreme Court while attending the 22 23 National Convention of Appellate Court Judges, and three Circuit Judges while attending the National Convention of State Trial 24 Judges shall be allowed actual subsistence and travel expenses.

Upon approval of the Chief Justice, Supreme Court Justices, Judges of the Court of Appeals, Circuit Judges, and Family Court Judges shall be reimbursed for actual expenses incurred for all other official business requiring out-of-state expenses at the rate provided in paragraph A of this section.

(G) No subsistence reimbursements are allowed to a Circuit Judge, a Family Court Judge, or an Administrative Law Judge while holding court within the county in which he resides. While holding court or on other official business outside the county, within fifty miles of his residence, a Circuit Court Judge, Family Court Judge, or an Administrative Law Judge is entitled to a subsistence allowance in the amount of \$35 per day plus such mileage allowance for travel as is provided for other employees of the State. While holding court or on other official business at a location fifty miles or more from his residence, a Circuit Court, Family Court or Administrative Law Judge is entitled to a subsistence allowance in the amount as provided in this act for members of the General Assembly plus such mileage allowance for travel as is provided for other employees of the State.

(H) Any retired Justice, Circuit Court Judge or Family Court Judge or Master-in-Equity appointed by the Supreme Court to serve
 as a Special Circuit Judge, Family Court Judge, Appeals Court Judge, or Acting Associate Justice shall serve without pay but shall
 receive the same allowance for subsistence, expenses, and mileage as provided in Part I for Circuit Court Judges.

4 (I) No expense shall be allowed an employee either at his place of residence or at the official headquarters of the agency by 5 which he is employed except as provided in paragraph E, of this section. When an employee is assigned to work a particular territory 6 or district, and such territory or district and his official headquarters are in different localities or sections of the State, expenses may 7 be allowed for the necessary travel to his official headquarters. The members of the Workers' Compensation Commission may be 8 reimbursed at the regular mileage rate of one round trip each week from their respective homes to Columbia. No subsistence reimbursement shall be allowed to a member of the Workers' Compensation Commission while traveling in the county of his official 9 residence. When traveling on official business of the commission outside the county of his official residence, a member of the 10 Workers' Compensation Commission shall be allowed subsistence expenses in the amount of \$35 per day. When traveling on official 11 business of the commission fifty or more miles outside the county of his official residence, each member shall be allowed a 12 subsistence allowance in the amount as provided in this act for members of the General Assembly. When out-of-state, members of 13 the Workers' Compensation Commission and the members of the Appellate Panel of the Department of Employment and Workforce 14 may claim the established amount of per diem, as stated in the General Appropriation Act, or actual expenses as deemed reasonable 15 by the Comptroller General. The members of the Appellate Panel of the Department of Employment and Workforce may be 16 reimbursed at the regular mileage rate when the member is on official business fifty miles or more outside of Columbia. The members 17 of the Appellate Panel of the Department of Employment and Workforce shall be allowed subsistence allowance in the amount as 18 provided in this act for members of the General Assembly when the member is on official business fifty miles or more outside of 19 Columbia. 20

(J) When an employee of the State shall use his or her personal automobile in traveling on necessary official business, a charge 21 to equal the standard business mileage rate as established by the Internal Revenue Service will be allowed for the use of such 22 23 automobile and the employee shall bear the expense of supplies and upkeep thereof. The standard business mileage rate used in this 24 calculation shall be the current rate established by the Internal Revenue Service. Whenever state provided motor pool vehicles are 25 reasonably available and their use is practical and an employee of the State shall request for his own benefit to use his or her personal vehicle in traveling on necessary official business, a charge of four cents per mile less than the standard business mileage rate as 26 established by the Internal Revenue Service will be allocated for the use of such vehicle and the employee shall bear the expense of 27 28 supplies and upkeep thereof. The standard business mileage rate used in this calculation shall be the current rate established by the Internal Revenue Service. When such travel is by a state-owned automobile, the State shall bear the expense of supplies and upkeep 29 thereof but no mileage will be allowed. Agencies and employees are directed to use state fueling facilities to the maximum extent 30 possible, when such use is cost beneficial to the State. When using commercial fueling facilities, operators of State-owned vehicles 31 are directed to use self-service pumps. In traveling on the business of the State, employees are required to use the most economical 32 mode of transportation, due consideration being given to urgency, schedules and like factors. 33

Mileage between an employee's home and his/her place of employment is not subject to reimbursement. However, when an employee leaves on a business trip directly from his/her home, and does not go by the employee's headquarters, the employee shall be eligible for reimbursement for actual mileage beginning at his/her residence.

1 (K) That a state agency may advance travel and subsistence expense monies to employees of that agency for the financing of 2 ordinary and necessary travel required in the conducting of the business of the agency. The Office of Comptroller General is directed 3 to develop and publish rules and regulations pertaining to the advancing of travel expenses and no state agency shall make such 4 advances except under the rules and regulations as published. All advances for travel and subsistence monies shall be repaid to the 5 agency within thirty days after the end of the trip or by July fifteenth, whichever comes first.

6 (L) That the state institutions of higher learning are authorized to reimburse reasonable relocation expenses for new employees 7 when such reimbursements are considered by the agency head to be essential to successful recruitment of professionally competent 8 staff members.

9 (M) The Office of Comptroller General is authorized to promulgate and publish rules and regulations governing travel and 10 subsistence payments.

11 (N) No state funds may be used to purchase first class airline tickets.

117.21. (GP: Organizations Receiving State Appropriations Report) Each organization receiving a contribution in this act shall 12 render to the state agency making the contribution by November first of the fiscal year in which funds are received, an accounting 13 of how the state funds will be spent, a copy of the adopted budget for the current year, and also a copy of the organization's most 14 recent operating financial statement. The funds appropriated in this act for contributions shall not be expended until the required 15 financial statements are filed with the appropriate state agency. No funds in this act shall be disbursed to organizations or purposes 16 which practice discrimination against persons by virtue of race, creed, color or national origin. The State Auditor shall review and 17 audit, if necessary, the financial structure and activities of each organization receiving contributions in this act and make a report to 18 the General Assembly of such review and/or audit, when requested to do so by the State Fiscal Accountability Authority. 19

117.22. (GP: State-Owned Aircraft - Flight Logs) Each agency having in its custody one or more aircraft shall maintain a 20 continuing log on all flights, which in order to promote accountability and transparency shall be open for public inspection and shall 21 also be posted online. Any and all aircraft owned or operated by agencies of the State Government shall be used only for official 22 23 business. The Division of Aeronautics and other agencies owning and operating aircraft may furnish transportation to the Governor, 24 Constitutional Officers, members of the General Assembly, members of state boards, commissions, and agencies and their invitees 25 for official business only; no member of the General Assembly, no member of a state board, commission, or committee, and no state 26 official shall use any state-owned or operated aircraft unless the member or official files within twenty-four hours after the completion of the flight with the agency that provided the flight a sworn statement certifying and describing the official nature of his trip; and 27 no member of the General Assembly, no member of a state board, commission or committee, and no state official shall be furnished 28 air transportation by a state agency unless such agency prepares and maintains in its files a sworn statement from the highest ranking 29 official of the agency or its designee certifying that the member's or state official's trip was in conjunction with the official business 30 of the agency. Official business shall not include routine transportation to and from meetings of the General Assembly or committee 31 meetings for which mileage is authorized. Official business also does not include attending a press conference, bill signing, or 32 political function. 33

All logs shall be signed by the parties using the flight and the signatures shall be maintained as part of the permanent record of any agency. All passengers shall be listed on the flight log by their legal name; passengers flying with an appropriate official of SLED or the Department of Commerce whose confidentiality must, in the opinion of SLED or the department, be protected shall be

listed in writing on the flight log as "Confidential Passenger SLED or the Department of Commerce (strike one)" and the appropriate 1

2 official of SLED or the department shall certify to the agency operating the aircraft the necessity for such confidentiality. The

Division of Aeronautics shall post its flight logs on its website within one working day of completion of trips. 3

4 Violation of the above provisions of this section is prima facie evidence of a violation of Section 8-13-700(A) of the 1976 Code 5 and shall subject a violating member of the General Assembly to the ethics procedure of his appropriate house and shall subject a 6 violating member of a state board, commission or committee, or a state official to the applicable ethics procedure relating to them as 7 provided by law. The above provisions do not apply to state-owned or operated aircraft when used by the Medical University of 8 South Carolina, nor to aircraft of the athletic department or the educational foundations of any state-supported institution of higher education, nor to law enforcement officers when flying on state-owned aircraft in pursuit of fugitives, missing persons, or felons or 9 for investigation of gang, drug, or other violent crimes. 10

Aircraft owned by agencies of state government shall not be leased to individuals for their personal use. 11

117.23. (GP: Carry Forward) Each agency is authorized to carry forward unspent general fund appropriations from the prior 12 fiscal year into the current fiscal year, up to a maximum of ten percent of its original general fund appropriations less any 13 appropriation reductions for the current fiscal year. Agencies shall not withhold services in order to carry forward general funds. 14

15 This provision shall be suspended if necessary to avoid a fiscal year-end general fund deficit. For purposes of this proviso, the amount of the general fund deficit shall be determined after first applying the Capital Reserve Fund provisions in Section 11-11-16 320(D) of the 1976 Code, and before any transfers from the General Reserve. The amount of general funds needed to avoid a year-17

end deficit shall be reduced proportionately from each agency's carry forward amount. 18

Agencies which have separate general fund carry forward authority must exclude the amount carried forward by such separate 19 authority from their base for purposes of calculating the ten percent carry forward authorized herein. Any funds that are carried 20 forward as a result of this provision are not considered part of the base of appropriations for any succeeding years. 21

22 117.24. (GP: TEFRA-Tax Equity and Fiscal Responsibility Act) It is the intent of the General Assembly that the State Medicaid 23 Plan be amended to provide benefits for disabled children as allowed by the Tax Equity and Fiscal Responsibility Act (TEFRA) option. State agencies, including but not limited to, the Department of Social Services - the Continuum of Care, the Department of 24 25 Health and Environmental Control, the Department of Mental Health, the Department of Disabilities and Special Needs, and the 26 Department of Health and Human Services shall collectively review and identify existing state appropriations within their respective budgets that can be used as state match to serve these children. Such funds shall be used effective January 1, 1995 to implement 27 TEFRA option benefits. Agencies providing services under the provisions of this paragraph must not spend less in the current fiscal 28 29 year than expended in the previous fiscal year.

117.25. (GP: Prison Industries) All agencies funded in this act, when procuring goods and services, shall first consider 30 contracting for services or purchasing goods and services through the Department of Corrections' Prison Industries Program. The 31 Department of Corrections shall furnish, upon request, to all agencies a catalogue of goods and services provided by Prison Industries. 32

The department is hereby directed to develop and market a catalogue of Prison Industries products for nationwide circulation. 33

34 117.26. (GP: Travel Report) Annually on November first, the Comptroller General shall issue a report on travel expenditures for the prior fiscal year which shall be distributed to the Senate Finance Committee, the House Ways and Means Committee, and the 35 36

Statehouse Press Room. The Comptroller General may use up to \$500 of general fund appropriations for the purpose of providing

copies to the media or the public upon request. The report must contain a listing for every agency receiving an appropriation in the 1 2 annual General Appropriations Act. The listing must show at a minimum the top ten percent of employees for whom travel expenses and registration fees were paid within each agency, not to exceed twenty-five employees per agency. Agencies should include 3 4 position titles for each of the top twenty-five travelers for each agency. Expenditures must include state, federal and other sources 5 of funds. Expenditures for in-state and out-of-state registration fees (fees to attend conferences, teleconferences, workshops, or 6 seminars for training on a per person basis) must be shown as a separate subtotal within the grand total for the individual employees 7 and the agency as a whole. The list for each agency must be in rank order with the largest expenditure first and the name of the employee must be shown with each amount. Agencies should include a brief summary of the type of travel the agency incurs. The 8 Comptroller General may provide additional information as deemed appropriate. The Comptroller General shall provide no 9 exceptions to this report in that the information contained is not considered confidential or restricted for economic development 10 purposes. However, further disclosure of detailed information shall be restricted as provided for by law. 11 12 **117.27.** (GP: School Technology Initiative) From the funds appropriated/authorized for the K-12 technology initiative, the

Department of Education, in consultation with the Department of Administration, the State Library, the Educational Television 13 Commission, and a representative from the Education Oversight Committee, shall administer the K-12 technology initiative funds. 14 These funds are intended to provide technology, encourage effective use of technology in K-12 public schools throughout the state, 15 conduct cost/benefit analyses of the various technologies, and should, to the maximum extent possible, involve public-private sector 16 collaborative efforts. Funds may also be used to establish pilot projects for new technologies with selected school districts as part of 17 the evaluation process. K-12 technology initiative funds shall be retained and carried forward to be used for the same purpose. 18 117.28. (GP: State-Operated Day Care Facilities Fees) Any state agency receiving funding in this act and any higher education 19 institution, including four-year institutions, two-year institutions, and technical colleges, that operates an early childhood 20 development center or day care facility shall charge, at a minimum, fees that are comparable to those charged by private day care 21

facilities in the local community. The institution or agency shall not restrict enrollment in the center solely to the children of faculty, staff, and students of the institution; nor shall fees be set at a lower level for faculty, staff, or students of the institution or agency.

24 **117.29.** (GP: Base Budget Analysis) Agencies' annual accountability reports for the prior fiscal year, as required in Section 1-1-25 810, must be accessible to the Governor, Senate Finance Committee, House Ways and Means Committee, and to the public on or 26 before September fifteenth, for the purpose of a zero-base budget analysis and in order to ensure that the Agency Head Salary Commission has the accountability reports for use in a timely manner. Accountability Report guidelines shall require agencies to 27 28 identify key program area descriptions and expenditures and link these to key financial and performance results measures. The Executive Budget Office is directed to develop a process for training agency leaders on the annual agency accountability report and 29 its use in financial, organizational, and accountability improvement. Until performance-based funding is fully implemented and 30 31 reported annually, the state supported colleges, universities and technical schools shall report in accordance with Section 59-101-32 350.

117.30. (GP: Collection on Dishonored Payments) In lieu of any other provision of law, any state agency may collect a service charge as provided in Section 34-11-70 to cover the costs associated with the processing and collection of dishonored instruments or electronic payments where any amount is not paid by the drawee due to insufficient funds on deposit with the bank or the person upon which it was drawn when presented, or the instrument has an incorrect or insufficient signature on it. Such funds shall be

retained and expended by the agency in accordance with this purpose and any unused amount shall carry forward to the following
 fiscal year.

117.31. (GP: State DNA Database) Funds collected by the South Carolina Department of Corrections, the Department of Probation, Parole and Pardon, and Department of Juvenile Justice to process DNA samples must be remitted to the State Law Enforcement Division to offset the expenses incurred to operate the State DNA Database program. SLED may retain, expend, and carry forward these funds. Any carry forward funds resulting from the DNA Database program must be used solely to operate the DNA Database program.

117.32. (GP: Voluntary Separation Incentive Program) State agencies may implement, in consultation with the Department of 8 Administration, a program to realign resources to include provisions for a separation incentive payment for employees which may 9 include the employer portion of health and dental benefits not to exceed one year. Employees participating in such program shall 10 not be eligible to participate in the Teacher and Employee Retention Incentive (TERI) program. Employees participating in such 11 program shall be considered to have voluntarily quit their employment without good cause and be subject to the provisions of Section 12 41-35-120(1) of the South Carolina Employment Security Law. Any program developed under this provision will involve voluntary 13 participation from employees and will be funded within existing appropriations. The program must be approved by the agency head 14 and the Director of the Human Resources Division based on ability to demonstrate recurring cost savings for realignment and/or 15 permanent downsizing. State agencies shall report the prior year's results to the Department of Administration by August fifteenth, 16 of the current fiscal year. The Department of Administration, upon request, shall report to the Senate Finance Committee and the 17 House Ways and Means Committee on these results. 18

19 **117.33.** (GP: Alternative Commitment to Truancy) As part of its plan for an alternative school, a school district receiving funds 20 from the Department of Education for an alternative school shall identify available alternatives to commitment for children whose 21 truancy is approaching the level of being referred to family court. When proceeding under S.C. Code Section 59-65-50 to bring an 22 individual case before the family court, the school district must present this plan as well as the district's efforts with respect to the 23 individual child to the court. Each school district's plan under this proviso shall include possible assignment to alternative school 24 for a non-attending child before petitioning the court.

117.34. (GP: Debt Collection Reports) Each state agency shall provide to the Chairmen of the Senate Finance and House of Representatives Ways and Means Committees and the Inspector General a report detailing the amount of its outstanding debt and all methods it has used to collect that debt. This report is due by the last day of February for the previous calendar year. For purposes of this provision, outstanding debt means a sum remaining due and owed to a state agency by a nongovernmental entity for more than sixty calendar days.

117.35. (GP: State-Funded Libraries - Web Filters) (A) A library receiving state funds, directly, indirectly, by grant, or otherwise, other than a library at an institution of higher learning, that has computers available for use by the public or students, or both, must equip these computers with software incorporating web-filtering technology designed to eliminate or reduce the ability of the computer to access sites displaying pornographic pictures or text. However, up to ten percent, and at least one, of the library's computers must be unfiltered. Each library's governing officials shall determine the physical location of any unfiltered computer(s). The library also must have a written policy providing sanctions against a person who instructs or demonstrates to another person

36 how to bypass this web-filtering technology.

(B) State funds intended for a library not in compliance with subsection (A) must be reduced by fifty percent. Funds resulting 1 2 from this reduction must be distributed among other libraries that are in compliance with subsection (A). 117.36. (GP: Tobacco Settlement Funds Carry Forward) State agencies are hereby authorized to retain and carry forward any 3 4 unexpended Tobacco Settlement Agreement funds from the prior fiscal year into the current fiscal year and to expend such funds for 5 the same purpose. 6 **117.37.** (GP: Use Tax Exemption) For the current fiscal year there is exempt from the use tax imposed pursuant to Chapter 36, 7 Title 12 of the 1976 Code the sales price of tangible personal property purchased for use in private primary and secondary schools. including kindergartens and early childhood education programs, which are exempt from income taxes pursuant to Section 501(c)(3)8 of the Internal Revenue Code. For the purposes of this item, the Internal Revenue Code means Internal Revenue Code as described 9 in Section 12-6-40 of the 1976 Code. This exemption applies for sales occurring after 1995. No refund is due any taxpayer of use 10 tax paid on sales exempted by this paragraph. 11 117.38. (GP: Personal Property Tax Relief Fund) For the current fiscal year, Section 12-37-2735 of the 1976 Code is suspended. 12 If the Personal Property Tax Exemption Sales Tax is imposed in a county and a sales tax rate of two percent of gross proceeds of 13 sales is insufficient to offset the property tax not collected, sufficient amounts must be credited to the Trust Fund for Tax Relief 14 established pursuant to Section 11-11-150 of the 1976 Code to provide the reimbursement to offset such a shortfall in the manner 15 provided in Section 4-10-540(A) of the 1976 Code. 16 117.39. (GP: COG Annual Report) Each Council of Government shall submit a report to the Senate Finance Committee and the 17 House Ways and Means Committee by December first each year describing how the funds which they received from the State in the 18 prior fiscal year were expended. 19 117.40. (GP: Department of Administration, OEPP, Veterans Affairs) Of the funds appropriated for the Department of 20 Administration, Office of Executive Policy and Programs, Division of Veterans Affairs, the Director of the Division shall appoint an 21 additional claims representative within the Division of Veterans Affairs, who, in addition to being charged with the duty of assisting 22 23 all ex-servicemen, regardless of the wars in which their service may have been rendered, in filing, presenting, and prosecuting to final determination all claims which they have for money compensation, hospitalization, training, and insurance benefits under the 24 25 terms of federal legislation, shall also specialize in the specific needs and diseases associated with veterans of the Vietnam era. The person appointed as a claims representative under this section must be versed in federal legislation relating to these matters and the 26 rules, regulations, and practice of the Veterans Administration as created by Congress and his appointment must be approved by the 27 28 Governor. 29 Subject to the direction of the director, and in addition to other duties prescribed in this section, the claims representative appointed pursuant to this section may represent the Division of Veterans Affairs on the South Carolina Agent Orange Advisory Council and 30 31 on the Hepatitis C Coalition established by the South Carolina Department of Health and Environmental Control, assist the Division of Veterans Affairs in carrying out its duties in connection with the Agent Orange Information and Assistance program, represent 32 the director in connection with functions relating to Vietnam veterans, and perform other duties as may be assigned by the director. 33 34 117.41. (GP: South Carolina Recycling Initiative) To protect the public health and safety, protect and preserve the environment of this State, and to recover resources which have the potential for usefulness in the most environmentally safe, economically feasible 35

1 and cost effective manner, state agencies shall purchase recycled steel unless the item cannot be acquired competitively at a 2 reasonable price.

3 117.42. (GP: Life and Palmetto Fellows Scholarships Waiver Exemption) Any provision in permanent law or in Part IB,

4 Section 117 of this act, except that which is specified for LIFE and Palmetto Fellows Scholarships, that would require general fund

5 appropriations other than what is specified in Part IA of this act is waived for the current fiscal year.

6 117.43. (GP: Sole Source Procurements) The State Fiscal Accountability Authority shall evaluate and determine whether the
 7 written determinations, explanations, and basis for sole source procurements, pursuant to South Carolina Code Section 11-35-1560,
 8 and emergency procurements, pursuant to South Carolina Code Section 11-35-1570, are legitimate and valid reasons for awarding
 9 noncompetitive contracts.

- 10 **117.44.** (GP: DMV Data) The Department of Motor Vehicles shall provide access, in compliance with all state and federal 11 privacy protection statues, to the following data and reports without charge to the South Carolina Department of Transportation:
 - (1) all collision data and collision reports;

12

- (2) registration information used for toll enforcement; and
- (3) driver records of employees or prospective employees.

15 **117.45.** (GP: Parking Fees) State agencies shall not impose additional parking fees or increases in current fees for state 16 employees during the current fiscal year. This provision does not apply to any college or university.

17 **117.46.** (GP: Facility Rental Fee) The Governor's School for the Arts and Humanities, Governor's School for Science and
 Mathematics, Wil Lou Gray Opportunity School, and John de la Howe School are authorized to charge, collect, expend and carry
 forward fees charged for facility and equipment rental and registration.

117.47. (GP: Insurance Claims) Any insurance reimbursement to an agency may be used to offset expenses related to the claim.
 These funds may be retained, expended, and carried forward.

117.48. (GP: Organizational Charts) All agencies, departments and institutions of state government shall furnish to the Human Resources Division (1) a current personnel organizational chart annually no later than September first of the current fiscal year, or upon the request of the division and (2) notification of any change to the agency's organizational structure which impacts an employee's grievance rights within thirty days of such change. The organizational chart shall be in a form prescribed by the Human Resources Division showing all authorized positions, class title, class code, position number and indications as to whether such positions are filled or vacant. In addition, the organizational chart shall clearly identify those employees who are exempt from the State Employee Grievance Procedure Act.

117.49. (GP: Agencies Affected by Restructuring) Upon restructuring of state agencies by the General Assembly the Department of Administration is directed to work with affected State agencies in order to phase-in operations of restructured organizations during the current fiscal year. Restructured organizations should be operating entirely under the revised structure no later than December thirty-first, of the current fiscal year, unless otherwise directed by law. The department is further directed to work with the affected agencies in order to identify and facilitate the transfer of any portion of their operations, including transfer of funds during the current fiscal year, which is affected by the restructured organization adopted by the General Assembly, but which has not already been accomplished herein. Until sufficient changes can be made to the State's accounting system and the appointment of appropriate

36 agency heads, the Comptroller General and the State Treasurer shall allow those agencies affected by restructuring to continue

processing documents within the account structure existing on June thirtieth, of the prior fiscal year. Restructured agencies shall make all the necessary accounting adjustments to complete the transition to the new account structure as soon as possible, but no later than December thirty-first, of the current fiscal year, unless otherwise directed by law. The Executive Budget Office is directed to prepare the subsequent detail budget to conform Part IA and corresponding provisos in this act to any restructuring changes that are ratified.

6 **117.50.** (GP: Agency Administrative Support Collaboration) It is the intent of the General Assembly that state agencies continue 7 to actively pursue cost savings measures through collaborative efforts and where feasible may combine administrative support 8 functions with other agencies in order to maximize efficiency and effectiveness.

9 **117.51.** (GP: Assessment Audit / Crime Victim Funds) If the State Auditor finds that any county treasurer, municipal treasurer, county clerk of court, magistrate, or municipal court has not properly allocated revenue generated from court fines, fines, and 10 assessments to the crime victim funds or has not properly expended crime victim funds, pursuant to Sections 14-1-206(B)(D), 14-1-11 12 207(B)(D), 14-1-208(B)(D), and 14-1-211(B) of the 1976 Code, the State Auditor shall notify the State Office of Victim Assistance. The State Office of Victim Assistance is authorized to conduct an audit which shall include both a programmatic review and financial 13 audit of any entity or nonprofit organization receiving victim assistance funding based on the referrals from the State Auditor or 14 complaints of a specific nature received by the State Office of Victim Assistance to ensure that crime victim funds are expended in 15 accordance with the law. Guidelines for the expenditure of these funds shall be developed by the Victim Services Coordinating 16 Council. The Victim Services Coordinating Council shall develop these guidelines to ensure any expenditure which meets the 17 parameters of Article 15, Chapter 3, Title 16 is an allowable expenditure. Any local entity or nonprofit organization that receives 18 funding from revenue generated from crime victim funds is required to submit their budget for the expenditure of these funds to the 19 State Office of Victim Assistance within thirty days of the budget's approval by the governing body of the entity or nonprofit 20 organization. Failure to comply with this provision shall cause the State Office of Victim Assistance to initiate a programmatic 21 review and a financial audit of the entity's or nonprofit organization's expenditures of victim assistance funds. Additionally, the 22 23 State Office of Victim Assistance will place the name of the noncompliant entity or nonprofit organization on their website where it shall remain until such time as they are in compliance with the terms of this proviso. Any entity or nonprofit organization receiving 24 25 victim assistance funding must cooperate and provide expenditure/program data requested by the State Office of Victim Assistance. 26 If the State Office of Victim Assistance finds an error, the entity or nonprofit organization has ninety days to rectify the error. An 27 error constitutes an entity or nonprofit organization spending victim assistance funding on unauthorized items as determined by the 28 State Office of Victims Assistance. If the entity or nonprofit organization fails to cooperate with the programmatic review and 29 financial audit or to rectify the error within ninety days, the State Office of Victim Assistance shall assess and collect a penalty in the amount of the unauthorized expenditure plus \$1,500 against the entity or nonprofit organization for improper expenditures. 30 31 This penalty plus \$1,500 must be paid within thirty days of the notification by the State Office of Victim Assistance to the entity or nonprofit organization that they are in noncompliance with the provisions of this proviso. All penalties received by the State 32 Office of Victim Assistance shall be credited to the General Fund of the State. If the penalty is not received by the State Office of 33 34 Victim Assistance within thirty days of the notification, the political subdivision will deduct the amount of the penalty from the entity 35 or nonprofit organization's subsequent fiscal year appropriation.

1 117.52. (GP: H.L. Hunley Museum Location) The General Assembly approves the City of North Charleston as the permanent 2 site of the H.L. Hunley Museum. This approval is contingent upon the negotiation and execution of necessary contracts between the 3 State of South Carolina and the City of North Charleston. The Hunley Commission is directed to expend funds from its account to 4 negotiate and execute contracts on behalf of the State of South Carolina.

5 117.53. (GP: Secure Juvenile Confinement) The Attorney General shall review the interpretation of the current policies of the 6 Department of Public Safety and the Department of Corrections regarding secure juvenile confinement that the departments indicate 7 may jeopardize federal grant funds. The departments may not implement any changes to the current policies regarding secure juvenile 8 confinement until the Attorney General considers the departments' interpretation of the federal Juvenile Justice and Delinquency 9 Prevention Act in regard to the secure holding of juveniles for more than six hours in adult detention facilities that also serve as fortyeight-hour juvenile holdover facilities. The Attorney General will determine if the departments' interpretation is fair and equitable 10 and how the local governments and the Department of Juvenile Justice would be impacted, to include any financial considerations. 11 12 117.54. (GP: ISCEDC Funding Transfer) The departments of Mental Health, Disabilities and Special Needs, and Juvenile Justice are directed to transfer a total of \$1,199,456 in funds to the Department of Social Services for the support of the Interagency System 13 for Caring for Emotionally Disturbed Children. Funding transfers shall be in the following amounts: Department of Mental Health 14 - \$595,000, Department of Disabilities and Special Needs - \$379,456, and Department of Juvenile Justice - \$225,000. The transfer 15

16 of funds shall be accomplished by September thirtieth of the current fiscal year.

117.55. (GP: Employee Bonuses) State agencies and institutions are allowed to spend state, federal, and other sources of revenue 17 to provide selected employees lump sum bonuses, not to exceed three thousand dollars per year, based on objective guidelines 18 established by the Department of Administration. Payment of these bonuses is not a part of the employee's base salary and is not 19 earnable compensation for purposes of employee and employer contributions to respective retirement systems. Employees earning 20 \$100,000 or more shall not be eligible to receive bonuses under this provision. The employing agency must report this information 21 on or before August thirty-first of each year and must include the total amount and source of the bonus received by the employee 22 23 during the preceding fiscal year (July first through June thirtieth). The Human Resources Division of the Department of Administration shall formulate policies and procedures to ensure compliance with the reporting provisions of this proviso. Copies 24 of the reports shall be made available to the Chairman of the Senate Finance Committee and the Chairman of the House Ways and 25 26 Means Committee, upon request.

117.56. (GP: FEMA Flexibility) Any appropriation designated as the state share for a federally declared disaster may be carried forward and used for the same purpose by the Emergency Management Division of the Adjutant General's Office in the event of additional federally declared disasters. Unallocated funds from established state accounts may be used as the state share in any federally declared disaster. These funds may also be used during a Governor's state of emergency to augment existing state appropriations of the South Carolina Emergency Management Division (SCEMD). When these funds are used during a Governor's state of emergency, the allocation of those funds following the event will be determined by the Governor based on the recommendation of the Adjutant General and the Director of the South Carolina Emergency Management Division.

In the event there is a federally declared disaster and state match funds are unavailable, the State Fiscal Accountability Authority may borrow from any internal account or accounts necessary to maximize federal matching funds through the Emergency

Management Division. Any such borrowing must be reported to the General Assembly within five days. Funds borrowed from 1 2 accounts shall be replenished by the General Assembly as soon as practicable. 117.57. (GP: Respiratory Syncytial Virus Prescription Sales and Use Tax Exemption) The effective date of the exemption from 3 4 sales and use tax of prescription medicines used to prevent respiratory syncytial virus shall be January 1, 1999. No refund of sales 5 and use taxes may be claimed as a result of this provision. 6 117.58. (GP: Year-End Financial Statements - Penalties) Agencies, *institutions*, and other reporting entities required to submit annual audited financial statements for inclusion in the State's Comprehensive Annual Financial Report must comply with the 7 8 submission dates stipulated in the State Auditor's Office audit contract submit final audited financial statements to the Comptroller General not later than October 1st for those with fiscal year-end June 30th. For institutions and reporting entities with fiscal year-9 ends other than June 30th, final audited financial statements must be submitted to the Comptroller General within 120 days of that 10 fiscal year-end. If the audit was not contracted by the State Auditor's Office, the final audited financial statements are due not later 11 than October tenth for the prior fiscal year. Each agency that does not comply with the provisions of this proviso shall appear before 12 the Comptroller General, providing an explanation for the delay. The Comptroller General shall provide a written report of each 13 agency, institution, or other reporting entity not in compliance with this provision to the State Fiscal Accountability Authority by 14 15 November 30th. 117.59. (GP: Purchase Card Incentive Rebates) In addition to the Purchase Card Rebate deposited in the general fund, any 16 incentive rebate premium received by an agency from the Purchase Card Program may be retained and used by the agency to support 17 its operations. 18 117.60. (GP: Sex Offender Monitoring and Supervision) The funds appropriated to the Department of Probation, Parole and 19 Pardon Services in Part IA, Section 66, Program II.A.2. for the Sex Offender Monitoring Program and to the Department of Juvenile 20 Justice in Part IA, Section 67, Program III.A. Special Item: Sex Offender Monitoring are to be used and expended only for GPS 21 monitoring programs of the departments. In cases of limited funds, monitoring of "Jessie's Law" offenders shall take precedence 22 23 over all other GPS programs of the departments. Funds appropriated for this program may not be used for any other purpose or 24 transferred to any other program. Unexpended funds appropriated for Sex Offender Monitoring may be carried forward and used 25 for the same purpose. The departments are directed to submit a report to the General Assembly by January fifteenth each year accounting for the expenditure of the funds including any carry-forward funding; the total costs and per-day costs for equipment, 26 supervision, and monitoring; the total number of staff assigned to the activity and the average agent caseloads; the amount of funds 27 28 collected from sex offenders for both intensive supervision and electronic monitoring; and the anticipated fiscal needs for the upcoming fiscal year. The report shall also include, but not be limited to, data regarding the number of offenders sentenced to 29 electronic monitoring, including the number sentenced for life; the number of alert notifications received, investigated, and 30 31 prosecuted; and the number of offenders returned to prison as a result of electronic monitoring violations. 117.61. (GP: Viscosupplementation Therapies Sales and Use Tax Exemption) For the current fiscal year only, sales and use 32

32 117.61. (GP: Viscosupplementation Therapies Sales and Use Tax Exemption) For the current fiscal year only, sales and use 33 taxes on viscosupplementation therapies shall be suspended. No refund or forgiveness of tax may be claimed as a result of this 34 provision.

117.62. (GP: CID & PCC Agency Head Salaries) All hiring salaries and salary increases for the agency heads of the Commission 1 2 on Indigent Defense and the Prosecution Coordination Commission shall be subject to all provisions related to agency heads covered by the Agency Head Salary Commission. 3 117.63. (GP: Prosecutors and Defenders Public Service Incentive Program) The Office of Attorney General, the Prosecution 4 5 Coordination Commission, and the Commission on Indigent Defense, in consultation with the South Carolina Student Loan 6 Corporation and the Commission on Higher Education, shall develop and implement a Prosecutors and Defenders Public Service Incentive Program for attorneys employed by the Office of Attorney General, the Prosecution Coordination Commission, the 7 8 Commission on Indigent Defense, a Circuit Solicitor's Office or a county Public Defender's Office. After more than three years of continuous service as a full-time attorney with any of these entities, qualifying attorneys may be 9 reimbursed up to \$1,000 for payments made in the prior calendar year on outstanding law school loans. Reimbursements for law 10 school loan payments may be increased by up to \$1,000 for each additional year of continuous service; however, such reimbursements 11 shall not exceed \$5,000 in any year. The amount of law school loan payment reimbursement in any calendar year shall not exceed 12 the amount of principal and interest paid on the loan in the prior calendar year. Reimbursements under the program may continue 13 until all outstanding law school loans are satisfied; however, such reimbursements shall not exceed \$40,000 per qualifying attorney. 14 15 Reimbursements shall be adjusted if necessary so as not to exceed appropriations for the program. The Prosecutors and Defenders Public Service Incentive Program must be administered by the South Carolina Student Loan 16 Corporation, which shall pay for the cost of administration within the funds appropriated. 17 The Office of Attorney General, the Prosecution Coordination Commission, and the Commission on Indigent Defense shall each 18 compile a report that includes, but is not limited to, the number of applicants and the impact of the program on attracting and retaining 19 attorneys. The Student Loan Corporation shall compile a report that includes, but is not limited to, the cost of administering the 20 21 program as well as the amount of reimbursements per agency or entity. Such reports shall be submitted to the Senate Finance 22 Committee and the House Ways and Means Committee by September first each fiscal year. 23 Unexpended program funds from the prior fiscal year may be carried forward into the current fiscal year to be used for the same 24 purpose. 25 117.64. (GP: Attorney Dues) Agencies and offices of the State of South Carolina that employ attorneys are authorized, if they 26 so decide, to use other appropriated funds, including General Fund carry forward funds, to pay the costs of mandatory dues owed to 27 the South Carolina Bar Association. 28 **117.65.** (GP: Healthcare Employee Recruitment and Retention) The Department of Corrections, Department of Disabilities and Special Needs, Department of Health and Environmental Control, Department of Health and Human Services, Department of 29 Juvenile Justice, Department of Mental Health, and Department of Vocational Rehabilitation, and Wil Lou Gray Opportunity School 30 are allowed to spend state, federal, and other sources of revenue to provide lump sum bonuses to aid in recruiting and retaining 31 healthcare workers in critical needs healthcare jobs based on objective guidelines established by the Department of Administration. 32 The employee bonus amount shall be approved by the State Human Resources Director and shall not exceed \$10,000 per year. 33

Payment of these bonuses is not a part of the employee's base salary and is not earnable compensation for purposes of employee and

35 employer contributions to respective retirement systems.

These agencies may also provide paid educational leave for any employees in an FTE position to attend class while enrolled in 1 2 healthcare degree programs that are related to the agency's mission. All such leave is at the agency head's discretion.

These agencies may enter into an agreement with Psychiatrists, Psychologists, and Nurses employed in those positions to repay 3 4 them for their outstanding student loans associated with completion of a healthcare degree. The employee must be employed in a 5 critical needs area, which would be identified at the agency head's discretion. Critical needs areas could include rural areas, areas 6 with high turnover, or where the agency has experienced recruiting difficulties. Agencies may pay these employees up to twenty 7 percent or \$7,500, whichever is less, of their outstanding student loan each year over a five-year period. Payments will be made directly to the employee at the end of each year of employment. The agency will be responsible for verifying the principle balance 8 of the employee's student loan prior to issuing payments. 9

Employees of these agencies working on a practicum or required clinical experience towards completion of a healthcare degree 10 may be allowed to complete these requirements at their state agency or another state agency at the discretion of the agency head. 11 This field placement at another state agency may be considered work time for participating employees. 12

These agencies are also authorized to allow tuition reimbursement from a maximum of ten credit hours per semester; allow 13 probationary employees to participate in tuition programs; and provide tuition prepayment instead of tuition reimbursement for 14 employees willing to pursue a degree in a healthcare program. An agency may pay up to fifty percent of an employee's tuition 15 through tuition prepayment. The remaining tuition could be reimbursed to the employee after successful completion of the class. 16

117.66. (GP: Governor's Budget Certification) The annual Executive Budget proposed by the Governor must be certified by the 17 Director of the Revenue and Fiscal Affairs Office or his designee in the same manner as the House Ways and Means and Senate 18 Finance Committee versions of the budget bill are certified. 19

117.67. (GP: Sexually Violent Predator Program) After the Department of Mental Health obtains all necessary project approvals. 20 the Department of Corrections may utilize inmate labor to perform any portion of the construction of an addition to the Edisto Unit 21 at the Broad River Correctional Institution, which houses the Department of Mental Health's Sexually Violent Predator Treatment 22 23 Program, such addition to be used for additional treatment space and staff offices. For purposes of this project, the Department of 24 Corrections may exceed the \$350,000 limit on projects for which it may use inmate labor.

25 **117.68.** (GP: Voluntary Furlough) Agency heads may institute a voluntary employee furlough program of not more than ninety 26 days per fiscal year. During this voluntary furlough, the state employees shall be entitled to participate in the same state benefits as otherwise available to them except for receiving their salaries. As to those benefits which require employer and employee 27 28 contributions, the state agencies, institutions and departments will be responsible for making both employee and employee contributions if coverage would otherwise be interrupted; and as to those benefits which require only employee contributions, the 29 employee remains solely responsible for making those contributions. In the event an agency's reduction is due solely to the General 30 31 Assembly transferring or deleting a program, this provision does not apply.

117.69. (GP: Governor's Security Detail) The State Law Enforcement Division, the Department of Public Safety, and the 32 Department of Natural Resources shall provide a security detail to the Governor in a manner agreed to by the State Law Enforcement 33 34 Division, the Department of Public Safety, the Department of Natural Resources, and the Office of Governor. Reimbursement to the State Law Enforcement Division, the Department of Public Safety, and the Department of Natural Resources to offset the cost of the 35

security detail for the Governor shall be made in an amount agreed to by the State Law Enforcement Division, the Department of 36

Public Safety, the Department of Natural Resources, and the Office of Governor from funds appropriated to the Office of Governor 1 2 for this purpose. Law enforcement officers assigned to security detail for the Governor shall only perform services related to security and shall not provide any unrelated service during the assignment. 3 4 **117.70.** (GP: Reduction in Force Antidiscrimination) In the event of a reduction in force implemented by a state agency or institution, the state agency or institution must comply with Title VII of the Civil Rights Act of 1964 or any other applicable federal 5 6 or state antidiscrimination laws. 7 117.71. (GP: Reduction in Force/Agency Head Furlough) In the event a reduction in force is implemented by a state agency or 8 institution of higher learning, the agency head shall be required to take five days furlough in the current fiscal year. If more than one reduction in force plan is implemented in a fiscal year, the mandatory agency head furlough is only required for the initial plan. The 9 agency head will retain all responsibilities and authority during the furlough. All monies saved from this furlough may be retained 10 by that agency and expended at the discretion of the agency head. During this furlough, the agency head shall be entitled to participate 11 in the same state benefits as otherwise available to them except for receiving their salaries. As to those benefits which require 12 employer and employee contributions, the state agency will be responsible for making both employer and employee contributions if 13 coverage would otherwise be interrupted; and as to those benefits which require only employee contributions, the agency head 14 15 remains solely responsible for making those contributions. Placement of an agency head on furlough under this provision does not constitute a grievance or appeal under the State Employee 16 Grievance Procedure Act. In the event the reduction for the state agency or institution of higher learning is due solely to the General 17 Assembly transferring or deleting a program, this provision does not apply. Agencies may allocate the agency head's reduction in 18 pay over the balance of the fiscal year for payroll purposes regardless of the pay period within which the furlough occurs. The 19 Department of Administration shall promulgate guidelines and policies, as necessary, to implement the provisions of this proviso. 20 State agencies shall report information regarding furloughs to the Department of Administration. 21 For purposes of this provision, agency head includes the president of a technical college as defined by Section 59-103-5 of the 22 23 1976 Code. 24 The agency head of the State Board for Technical and Comprehensive Education shall not be required to take this mandatory 25 furlough based solely on the implementation of a reduction in force plan by a technical college. 26 An agency head shall not be required to take this mandatory furlough based solely on reductions in force implemented as a result of federal budget cuts or reorganization to accomplish organizational efficiencies. 27 117.72. (GP: Printed Report Requirements) (A) For Fiscal Year 2015-16 2016-17, state supported institutions of higher learning 28 29 shall not be required to submit printed reports mandated by Sections 2-47-40, 2-47-50, and 59-103-110 of the 1976 Code, and shall

- 30 instead only submit the documents electronically.
- Submission of the plans or reports required by Sections 59-101-350, 59-103-30, 59-103-45(4), and 59-103-160(D) shall be waived for the current fiscal year, except institutions of higher learning must continue to report student pass rates on professional

examinations, and data elements otherwise required for the Commission on Higher Education Management Information System.

34 The commission, in consultation with institutions, shall take further action to reduce data reporting burdens as possible.

(B) For Fiscal Year 2015-16 2016-17, the Department of Agriculture shall not be required to submit printed reports mandated by
 Section 46-49-10 of the 1976 Code. The department shall provide these reports electronically and shall use any monetary savings
 for K5-12 agricultural education programs.

4 (C) For Fiscal Year 2015-16 2016-17, the Department of Health and Human Services shall not be required to provide printed 5 copies of the Medicaid Annual Report required pursuant to Section 44-6-80 of the 1976 Code and shall instead only submit the 6 documents electronically.

7 (D) For Fiscal Year 2015-16 2016-17, the Department of Transportation shall not be required to submit printed reports or 8 publications mandated by Sections 1-11-58, 2-47-55, and 58-17-1450 of the 1976 Code.

9 The Department of Transportation may combine their Annual Report and Mass Transit Report into their Annual Accountability 10 Report.

117.73. (GP: IMD Operations) All funds received by the Department of Education, the Department of Juvenile Justice, the 11 12 Department of Disabilities and Special Needs, the Department of Mental Health, the Department of Social Services, and the Department of Administration, Office of Executive Policy and Programs-Continuum of Care as State child placing agencies for the 13 Institution for Mental Diseases Transition Plan (IMD) of the discontinued behavioral health services in group homes and child caring 14 institutions, as described in the Children's Behavioral Health Services Manual Section 2, dated 7/01/06, shall be applied only for out 15 of home placement in providers which operate Department of Social Services or Department of Health and Environmental Control 16 licensed institutional, residential, or treatment programs. An annual report by each state child placing agency shall be made on the 17 expenditures of all IMD transition funds and shall be provided to the Chairman of the Senate Finance Committee, Chairman of the 18 House Ways and Means Committee, and the Governor no later than November first each year. The Department of Health and Human 19 Services shall review the numbers of out of home placements by type and by agency each year and make recommendations to the 20 General Assembly. 21

117.74. (GP: Fines and Fees Report) In order to promote accountability and transparency, each state agency must provide and 22 23 release to the public via the agency's website, a report of all aggregate amounts of fines and fees that were charged and collected by 24 that state agency in the prior fiscal year. The report shall include, but not be limited to: (1) the code section, regulation, or proviso 25 that authorized the fines and fees to be charged, collected, or received; (2) the amount of the fine or fee; (3) the amount received by source; (4) the purpose for which the funds were expended by the agency; (5) the amount of funds transferred to the general fund, if 26 applicable, and the authority by which the transfer took place; and (6) the amount of funds transferred to another entity, if applicable, 27 28 and the authority by which the transfer took place, as well as the name of the entity to which the funds were transferred. The report 29 must be posted online by September first. Additionally, the report must be delivered to the Chairman of the Senate Finance Committee and the Chairman of the House Ways and Means Committee by September first. Funds appropriated to and/or authorized 30 31 for use by each state agency shall be used to accomplish this directive.

32 117.75. (GP: Mandatory Furlough) In a fiscal year in which the general funds appropriated for a state agency are less than the 33 general funds appropriated for that agency in the prior fiscal year, or whenever the General Assembly or the Executive Budget Office 34 implements a midyear across-the-board budget reduction, and agency heads institute a mandatory employee furlough program, in 35 determining which employees must participate in the program, agency heads should give consideration to furloughs for contract 36 employees, post-TERI employees, and TERI employees before other employees. During this mandatory furlough, the state

employees shall be entitled to participate in the same state benefits as otherwise available to them except for receiving their salaries. 1 2 As to those benefits which require employer and employee contributions, the state agencies, institutions, and departments will be responsible for making both employer and employee contributions if coverage would otherwise be interrupted; and as to those 3 4 benefits which require only employee contributions, the employee remains solely responsible for making those contributions. In the 5 event an agency's reduction is due solely to the General Assembly transferring or deleting a program, this provision does not apply. 6 **117.76.** (GP: Reduction In Force) In a fiscal year in which the general funds appropriated for a state agency are less than the 7 general funds appropriated for that agency in the prior fiscal year, or whenever the General Assembly or the Executive Budget Office 8 implements a midyear across-the-board budget reduction, and agency heads must make reductions in force, agency heads should give consideration to reductions of contract employees, post-TERI employees, and TERI employees before other employees. In the 9 event an agency's reduction is due solely to the General Assembly transferring or deleting a program, this provision does not apply. 10 117.77. (GP: Cost Savings When Filling Vacancies Created by Retirements) During the current fiscal year, whenever classified 11 12 FTEs become vacant because of employee retirements, it is the intent of the General Assembly that state agencies should realize personnel costs savings of at least twenty-five percent in the aggregate when managing these vacant positions. Prior to filling a 13 classified FTE which has become vacant because of a retirement, an agency must review and determine the appropriate salary for 14 the position as well as determine whether the agency can manage without filling the position or by delay in filling the position. Prior 15 to filling the vacant FTE, agencies must follow all laws and regulations concerning posting and competitive solicitation and 16 consideration of applicants. No agency shall enter into any agreement with any employee that violates the terms of this proviso. 17 117.78. (GP: Information Technology for Health Care) From the funds appropriated and awarded to the South Carolina 18 Department of Health and Human Services for the Health Information Technology for Economic and Clinical Health Act of 2009, 19 the department shall advance the use of health information technology and health information exchange to improve quality and 20 efficiency of health care and to decrease the costs of health care. In order to facilitate the qualification of Medicare and/or Medicaid 21 22 eligible providers and hospitals for incentive payments for meaningful health information technology (HIT) use, a health care 23 organization participating in the South Carolina Health Information Exchange (SCHIEx) or a Regional Health Information 24 Organization (RHIO) or a hospital system health information exchange (HIE) that participates in SCHIEx may release patient records 25 and medical information, including the results of any laboratory or other tests ordered or requested by an authorized health care 26 provider within the scope of his or her license or practice act, to another health information organization that requests the information 27 via a HIE for treatment purposes with or without express written consent or authorization from the patient. A health information

organization that receives or views this information from a patient's electronic health record or incorporates this information into the health information organization's electronic medical record for the patient in providing treatment is considered an authorized person for purposes of 42 C.F.R. 493.2 and the Clinical Laboratory Improvement Amendments.

117.79. (GP: Broadband Spectrum Lease) The General Assembly must approve any exercise of the Middle Band Segment Channel recapture provisions contained in the Educational Broadband Service Spectrum Lease Agreements if the exercise of the recapture provisions would result in a decrease in payments received by the State. The Educational Television Commission assumes management and administration of the lease and receives lease payments directly. The Educational Television Commission shall retain and expend funds received pursuant to the lease for agency operations. The commission shall be authorized to carry forward unexpended funds from the prior fiscal year into the current fiscal year. In the event of a default by the current lease holder, the

1 Educational Television Commission is authorized to use contingent funds up until such time as a new lease can be negotiated by the

2 State and the Educational Television Commission.

3 **117.80.** (GP: Reduction in Compensation) For the current fiscal year, no state agency or political subdivision of this state may 4 decrease the compensation of an employee, including dismissal, suspension, or demotion, solely because the employee gave sworn 5 testimony regarding alleged wrongdoing to a standing committee, subcommittee of a standing committee, or study committee of the

6 Senate or the House of Representatives. This proviso shall apply regardless of when the alleged wrongdoing occurred.

117.81. (GP: Deficit Monitoring) It is the responsibility of each state agency, department, and institution to operate within the
 limits of its authorized appropriations. All agencies, departments, and institutions are to budget, allocate and manage its authorized
 appropriations in a way to avoid an operating deficit for the fiscal year.

If at the end of each quarterly deficit monitoring review by the Executive Budget Office, it is determined by either the Executive Budget Office or a state agency, department, or institution that the likelihood of a deficit for the current fiscal year exists, the state agency shall notify the General Assembly within fifteen days of this determination and shall further request the Executive Budget Office to work with it to develop a plan to avoid the deficit. Within fifteen days of the deficit avoidance plan being completed, the Executive Budget Office shall either request the General Assembly to recognize the deficit if it determines the deficit avoidance plan will not be sufficient to avoid a deficit or notify the General Assembly of how the deficit will be avoided based on the deficit avoidance plan if the Executive Budget Office determines the plan will be sufficient to avoid a deficit.

Upon notification from the Executive Budget Office that an agency will run a deficit and requesting that it be recognized, the General Assembly, by joint resolution, may make a finding that the cause of, or likelihood of, a deficit is unavoidable due to factors which are outside the control of the state agency, department, or institution, and recognize the deficit. Any legislation to recognize a deficit must be in a separate joint resolution enacted for the sole purpose of recognizing the deficit of a particular state agency, department, or institution. A deficit may only be recognized by an affirmative vote of each branch of the General Assembly.

If the General Assembly recognizes the deficit, then the actual deficit at the close of the fiscal year must be reduced as necessary from surplus revenues or surplus funds available at the close of the fiscal year in which the deficit occurs and from funds available in the General Reserve Fund and the Capital Reserve Fund, as required by the Constitution of this State.

Once a deficit has been recognized by the General Assembly, the state agency, department, or institution shall limit travel and conference attendance to that which is deemed essential by the director of the agency, department, or institution. In addition, the General Assembly, when recognizing a deficit may direct that any pay increases and purchases of equipment and vehicles must be approved by the Executive Budget Office.

117.82. (GP: Commuting Costs) State government employees who use a permanently assigned agency or state-owned vehicle to commute from their permanently assigned work location to and from the employee's home must reimburse the agency in which they are employed for commuting use in accordance with IRS regulations based on guidance from the Office of Comptroller General which must use the Cents per mile Rule, unless they are exempted from such reimbursement by applicable IRS regulations. These permanently assigned vehicles must be clearly marked as a state or agency vehicle through the use of permanent state-government license plates and either state or agency seal decals unless the vehicle is used primarily in undercover operations. This requirement

does not apply to a vehicle used by an employee for the purpose of a special travel assignment, for active certified law enforcement

1 officers authorized to carry firearms, execute warrants, and make arrests, for Constitutional Officers, or for Department of 2 Transportation employees on call for emergency maintenance.

117.83. (GP: Bank Account Transparency and Accountability) Each state agency, except state institutions of higher learning, 3 4 which has composite reservoir bank accounts or any other accounts containing public funds which are not included in the Comptroller 5 General's South Carolina Enterprise Information System shall prepare a report for each account disclosing every transaction of the 6 account in the prior fiscal year. The report shall be submitted to the State Fiscal Accountability Authority by October first of each 7 fiscal year. The report shall include the name(s) and title(s) of each person authorized to sign checks or make withdrawals from each 8 account, the name and title of each person responsible for reconciling each account, the beginning and year-end balance of funds in each account, and data related to both deposits and expenditures of each account. The report shall include, but not be limited to, the 9 date, amount, and source of each deposit transaction and the date, name of the payee, the transaction amount, and a description of 10 the goods or services purchased for each expenditure transaction. To facilitate review, the State Fiscal Accountability Authority 11 shall prescribe a common format for the report which agencies must use. In order to promote accountability and transparency, a link 12 to the report shall be posted on the Comptroller General's website as well as the agency's homepage. 13 When the State Auditor conducts or contracts for an audit of a state agency, accounts of the agency subject to this proviso must be 14 15 included as part of the review. If an agency determines that the release of the information required in this provision would be detrimental to the state or the 16 agency, the agency may petition the State Fiscal Accountability Authority to grant the agency an exemption from the reporting 17 requirements for the detrimental portion. The meeting to determine whether an exemption should be granted shall be closed. 18 However, the exemption may only be granted upon a majority vote of the State Fiscal Accountability Authority in a public meeting. 19

117.84. (GP: Websites) All agencies, departments, and institutions of state government shall be responsible for providing on its 20 Internet website a link to the Internet website of any agency, other than the individual agency, department, or institution, that posts 21 on its Internet website that agency, department, or institution's monthly state procurement card statements or monthly reports 22 23 containing all or substantially all the same information contained in the monthly state procurement card statements. The link must 24 be to the specific webpage or section on the website of the agency where the state procurement card information for the state agency, 25 department, or institution can be found. The information posted may not contain the state procurement card number. Any 26 information that is expressly prohibited from public disclosure by federal or state law or regulation must be redacted from any posting 27 required by this section.

117.85. (GP: Regulations) For the current fiscal year, if a state agency proposes a regulation that levies or increases a fee, fine, or that otherwise generates revenues, the title to the Joint Resolution which proposes the regulation must indicate that a fee, fine, or revenue source is being proposed.

117.86. (GP: Joint Children's Committee) For the current fiscal year, the Department of Revenue is directed to reduce the rate of interest paid on eligible refunds by one percentage point. Of the revenue resulting from this reduction, \$300,000 shall be transferred to the Senate for the Joint Citizens and Legislative Committee on Children to provide the report, research, and other operating expenses as directed in Section 63-1-50 of the 1976 Code. Funds transferred to the University of South Carolina for the Joint Citizens and Legislative Committee on Children shall be maintained in a separate and distinct account. A detailed report of all expenditures shall be made to the Executive Budget Office within thirty days of the close each fiscal quarter, and the Executive

1 Budget Office shall distribute this information to the Chairman of the Senate Finance Committee and the Chairman of the House

2 Ways and Means Committee. The remaining revenue resulting from this reduction shall be transferred to the Department of Juvenile

3 Justice to be used for mentoring or alternatives to incarceration programs. Unexpended funds authorized by this provision may be

4 retained and carried forward by the Senate or the Department of Juvenile Justice, respectively, and used for the same purposes. The

5 rate of reduction authorized in this provision shall be in addition to the reduction authorized in Proviso 93.7.

6 **117.87.** (GP: Civil Conspiracy Defense Costs) For the current fiscal year, for any claim that has not reached a judgment, if a

7 state or local government employee or former state or local government employee ("government employee") is personally sued for

8 civil conspiracy based in part upon a personnel or employment action or decision regarding an employee, the court must, prior to 9 trial, make a final determination whether the action or decision giving rise to the suit was made by the government employee within

10 the scope of their official duty. If the court finds that the government employee was acting outside the scope of the employee's

official duties, the government shall not thereafter expend any funds to pay or defend the claim. If the court finds the government

12 employee was acting within the scope of their official duties, the employee is immune from suit, liability, and damages with respect

13 to the civil conspiracy claim. The government may only expend funds to defend the claim if the determination is that the employee 14 was acting within the scope of their official duties. Nothing in this proviso prevents an insurance provider from defending and

15 paying, respectively, any claims that the provider has contractually agreed to defend and pay.

16 **117.88.** (GP: Recovery Audits) The State Fiscal Accountability Authority shall contract with one or more firms to conduct 17 recovery audits of payments made by all state agencies to vendors for goods and services. The audits must be designed to detect,

18 document, and recover overpayments and erroneous payments to the vendors and to recommend improved financial and operational

19 practices and procedures. A state agency shall pay, from recovered monies received, the recovery audit firm responsible for obtaining

for the agency a reimbursement or payment from a vendor a negotiated fee not to exceed twenty percent of the funds recovered by that firm.

Unless otherwise restricted by law, funds recovered, less the cost of recovery, shall be remitted to a special fund subject to appropriation by the General Assembly. Agencies may recover costs that are documented to be directly related to implementation

24 of this provision.

Recovery audits apply only to payments made more than one hundred eighty days prior to the date the audit is initiated and shall cover at least three complete fiscal years.

All information provided under a contract must be treated as confidential by the recovery audit firm. A violation of this provision shall result in the forfeiture by the firm of all compensation under the contract and to the same sanctions and penalties that would

apply to that disclosure.

30 Each state agency shall participate in this recovery audit program and shall cooperate and provide the recovery audit firm with all

31 information necessary for the audit in a timely manner. All vendors that provide goods or services to a state agency shall cooperate

32 with the recovery audit firm in its audit.

33 A state agency shall expend or return to the federal government any federal money that is recovered through a recovery audit

34 conducted under this provision. Payments to the recovery audit firm from the federal share of recovered funds shall be solely from

35 the federal portion as allowed by the federal agency.

In addition to performing the recovery audits, the recovery audit firm may conduct an analysis of contracts and pricing structures, 1 2 as determined and directed by the Executive Director of the State Fiscal Accountability Authority or her or his designee, to identify and recommend future cost-savings and improved state agency financial operations going forward. A state agency shall pay the 3 4 recovery audit firm responsible for obtaining the agency actual cost-savings a fee as authorized by the contract with the recovery 5 audit firm. 6 The recovery audit firm shall provide reports to the State Fiscal Accountability Authority detailing its findings, the causes for the 7 overpayments and erroneous payments, future cost-savings opportunities and its recommendations for strengthening state operations 8 and/or state contracts to prevent improper payments in the future. For purposes of this proviso, the term "vendor" or "vendors" includes, but is not limited to, sellers, suppliers, service providers, 9 other providers, contractors and third party administrators; the term "overpayments and erroneous payments" includes, but is not 10 limited to, overpayments, duplicate payments, erroneous payments, and rebates, discounts and credits not received; and the term 11 "state agency" or "state agencies" includes all state agencies, boards, commissions, institutions and institutions of higher education. 12 The State Fiscal Accountability Authority shall provide copies, including electronic form copies, of final reports received from a 13 firm under contract to: the Governor; the Chairman of the Senate Finance Committee; the Chairman of the House Ways and Means 14 Committee; and the state auditor's office. Not later than January first of each year, the board shall issue a report to the General 15 Assembly summarizing the contents of all reports received under this provision during the prior fiscal year. 16 117.89. (GP: Funds Transfer to ETV) In the current fiscal year funds appropriated in Part IA to the Department of Administration 17 Section 93 for Legislative and Public Affairs Coverage and Emergency Communications Backbone and to the Law Enforcement 18 Training Council in Section 64 for State and Local Training of Law Enforcement, City and County municipal training services must 19 be transferred to the Educational Television Commission (ETV) during July 2015 2016 for the continuation of services as provided 20 21 in the prior fiscal year. 117.90. (GP: Opt Out of Federal Patient Protection and Affordable Care Act) If federal law permits, the State of South Carolina 22 23 opts out of the following provisions in the federal Patient Protection and Affordable Care Act (Public Law 111-148): 24 (1) Subtitles A through C of Title I (and the amendments made by such subtitles), except for Sections 1253 and 1254; 25 (2) Parts I, II, III, and V of subtitle D of Title I (and the amendments made by such parts); (3) Part I of subtitle E of Title I (and the amendments made by such part); 26 (4) Subtitle F of Title I (and the amendments made by such subtitle); 27 28 (5) Sections 2001 through 2006 (and the amendments made by such sections); and (6) Sections 10101 through 10107 (and the amendments made by such sections). 29 117.91. (GP: Means Test) All agencies providing Healthcare Services are directed to identify standards and criteria for means 30 testing on all programs provided, where allowed by Federal guidelines. Once a consistent criteria has been established within an 31 agency, they shall implement their respective plans. Each agency shall report all criteria and fiscal data to the Chairman of the Senate 32 Finance Committee and to the Chairman of the House Ways and Means Committee no later than January 1st, 2014. 33 34 117.92. (GP: Agency Reduction Management) The General Assembly encourages state agencies, in the event agencies are

35 assessed a base reduction, to endeavor to realize savings through: (1) payroll management, including, but not limited to, furloughs,

reductions in employee compensation, and instituting a hiring freeze; (2) eliminate administrative overhead cost that does not directly 1 2 impact the agency's mission; and as a final option (3) reductions to programmatic funding. 117.93. (GP: WIA Service Advertising) For Fiscal Year 2014-15 2016-17, the Workforce Investment Boards may promote 3 4 outreach for their services via billboard, bus placard, newspapers, or radio in all workforce investment areas. This outreach may not 5 be limited to e-mail, online, or other internet-based outreach, publicity, or other promotions. Workforce investment boards must adhere to all state procurement policies and procedures when utilizing outreach for the services provided by the Workforce 6 7 Investment Act. 8 **117.94.** (GP: WIA Training Marketability Evaluation) (A) For Fiscal Year 2014-15 2016-17, the Department of Employment and Workforce shall submit a report that demonstrates how funds were expended in the prior fiscal year to provide marketable work 9 skills training. The report shall include, but not be limited to the total number of local training recipients, a description of the training 10 area in which each recipient participated, and the number and percentage of participants in each training area that, upon completion 11 of training, have become employed in the field in which they were trained. The report shall be submitted to the Chairman of the 12 Senate Finance Committee, the Chairman of the Senate Labor, Commerce and Industry Committee, the Chairman of the House Ways 13 and Means Committee, and the Chairman of the House Labor, Commerce and Industry Committee on or before November sixteenth. 14 15 (B) Also, the report must specifically describe any restructuring or realignment of agency functions, and any changes in staffing levels or service. The report must detail information on employees terminated, hired, re-hired, reassigned, or reclassified by program 16 area and location. Further, the report must describe efforts made by the agency to reassign or retrain employees who were terminated 17 for positions for which the department hired new employees. 18 117.95. (GP: Victims Assistance Transfer) The Department of Corrections shall transfer \$20,500 each month to the Department 19

of Public Safety for distribution through the State Victims Assistance Program. 20 117.96. (GP: DOC & PPP Potential Consolidation Plan) From the funds appropriated to the Department of Corrections and the 21

Department of Probation, Parole and Pardon Services, the directors of the departments may collaborate and develop a plan to 22 23 consolidate the functions of the departments.

24 117.97. (GP: USC Greenville Medical School) It is the intent of the General Assembly that during Fiscal Year 2014-15 the current fiscal year, no general funds shall be appropriated for the new medical school at the University of South Carolina in 25 Greenville. In addition, no state funds may be transferred from state earmarked or restricted funds held by the University of South 26 Carolina to the medical school except for grants, contributions, contractual payments, and tuition and required fees for students 27 28 attending the new medical school at the University of South Carolina in Greenville that are specifically designated for the medical 29 school at the University of South Carolina in Greenville.

117.98. (GP: First Steps - BabyNet) In addition to the statutory duties assigned to South Carolina First Steps to School Readiness 30

Board of Trustees; the board shall ensure the state's compliance with the Individuals with Disabilities Act, Part C and the First Steps' 31

full implementation of recommendations contained in the 2011 audit report of the LAC regarding the BabyNet Program. First Steps 32

shall submit any necessary statutory changes to the Chairman of the House Education and Public Works Committee and the Chairman 33

34 of the Senate Education Committee and any budget recommendations in the agency's budget request as submitted to the Governor. Until completion, First Steps shall post on its' website a quarterly report on the timelines of its progress in implementing the 35

recommendations of the LAC. The Board of Trustees will be kept informed monthly of all activities related to this requirement and 36

those progress reports must be recorded in the minutes for each meeting of the Board of Trustees. When First Steps has implemented 1 2 all of the recommendations enumerated above, a final report shall be submitted to the Board of Trustees for its' adoption. Upon approval by the Board of Trustees, the final report shall be published on First Steps' homepage. First Steps to School Readiness, the 3 4 School for the Deaf and Blind, the Department of Disabilities and Special Needs, the Department of Health and Human Services, the 5 Department of Mental Health and the Department of Social Services shall each provide on a common template developed by the agencies, a quarterly report to the Chairman of the House Ways and Means Committee and the Chairman of Senate Finance outlining 6 all programs provided by them for BabyNet; all federal funds received and expended on BabyNet and all state funds expended on 7 8 BabyNet. Each entity and agency shall report on its share of the state's ongoing maintenance of effort as defined by the US 9 Department of Education under IDEA Part C. **117.99.** (GP: Single Audit Schedule of Federal Expenditures) To ensure timely completion of the of the Statewide Single Audit, 10 state agencies which do not receive a separate audit of federal expenditures, must submit to the Office of the State Auditor a schedule 11 of federal program expenditures in a format prescribed by the Office of the State Auditor, no later than August fifteenth of each year. 12 117.100. (GP: Prohibits Local Government Fund Public Funded Lobbyists) All local governmental entities including, but not 13 limited to, counties, municipalities, and associations are prohibited from using taxpayer funds received from the Local Government 14 Fund to compensate employees for lobbying activities engaged in on behalf of such governmental entity. 15 117.101. (GP: School Construction Development Impact Fee Assessment Prohibition) Governmental entities are prohibited from 16 assessing South Carolina Development Impact Fees on the construction of new elementary, middle, or secondary schools. If a 17 governmental entity violates this prohibition it shall have its Aid to Subdivisions Allocation reduced by the amount of the impact 18 19 fee. 117.102. (GP: Sexually Violent Predator Treatment RFP) The Director of the Department of Mental Health and the Director of 20 the Department of Corrections shall cooperate with the State Fiscal Accountability Authority, Division of Procurement Services 21 which shall develop and cause to be issued a Request for Proposals (RFP) seeking long term solutions for securely housing and 22 23 treating the growing population of individuals adjudicated as Sexually Violent Predators and civilly committed to the Department of 24 Mental Health pursuant to the Sexually Violent Predators Act. 25 The purpose of the RFP shall be to seek proposals from qualified private providers to provide secure housing and treatment services to all individuals civilly committed pursuant to the Sexually Violent Predators Act. 26 As part of the process, the Department of Mental Health, the Department of Corrections, and the State Fiscal Accountability 27 Authority shall provide up-to-date information concerning the current operation of the program and shall provide information about 28 suitable state owned real property. The RFP shall be issued on or before October 31, 2013. 29 The RFP shall be worded broadly to allow respondents to propose creative and cost-effective long-term solutions for the operation 30 of this program in order to address the issues raised in Proviso 23.15 of the 2012-13 State Appropriations Act and the resulting 31 January 3, 2013, Report on the SVP Program issued by the Department of Mental Health and the Department of Corrections. 32 In addition to treatment services, respondents shall be allowed, but not required, to propose a single source solution with 33 34 responsibility for all aspects of the program including but not limited to housing, security, food, clothing, health care, transport, and treatment services. The RFP shall allow for, but not require, respondents to include in their responses the use of other private or 35 public partners (subcontractors) and/or the lease or use or purchase of state owned real property. 36

The selected contractor may be authorized to sponsor the issuance of tax exempt certificates of participation or other finance 1 2 solutions to fund the project and the state is authorized to enter into a lease/purchase agreement for the necessary replacement facilities. 3 4 117.103. (GP: Prohibit Use of State Aircraft for Athletic Recruitment) Institutions of higher learning may use the state aircraft 5 operated by the Division of Aeronautics for the purpose of athletic recruiting, provided that they reimburse the Division of Aeronautics for all flight hours on an at cost basis, using non-general funds. 6 7 To ensure availability of the aircraft for purposes of economic development, the Department of Commerce shall have first right of refusal in the event of scheduling conflicts with athletic recruiting flights. 8 117.104. (GP: Recreational Activities) Two counties that receive an allocation from the Local Government Fund may enter into 9 a Memorandum of Understanding in order to provide recreational activities and projects that benefit the citizens of both counties. 10 117.105. (GP: Technology and Remediation) The funds appropriated to the Department of Administration for the Division of 11 Information Security shall be used to develop and implement a statewide information security program. A portion of the nonrecurring 12 funds may be used for enterprise technology and remediation, and distributed to state agencies to address the State's most serious 13 information security vulnerabilities as determined by the Division of Information Security and the Division of Technology 14 15 Operations. Funds appropriated for Enterprise Technology and Remediation shall be excluded from the Department of Administration's base budget calculation of any across-the-board agency base reduction mandated by the Executive Budget Office 16 or the General Assembly. Unexpended Enterprise Technology and Remediation funds may be carried forward from the prior fiscal 17 vear and used for the same purpose. 18 117.106. (GP: Donation of Alcoholic Liquors) In the current fiscal year, a wholesaler may donate beer, wine, and alcoholic liquors 19 to a nonprofit organization that has a license, including a temporary license, to serve the applicable beverage. This provision only 20 21 applies if the event hosted by the nonprofit organization creates an economic impact on State revenues. 117.107. (GP: Data Breach Notification) (A) An agency of this State owning or licensing computerized data or other data that 22 23 includes personal identifying information shall disclose any breach of the security of the system following discovery or notification of the breach in the security of the data to any resident of this State whose personal identifying information was, or is reasonably 24 25 believed to have been, acquired by an unauthorized person. In determining whether information has been acquired, or is reasonably believed to have been acquired, by an unauthorized person or a person without valid authorization, the agency may consider the 26 following factors, among others: 27 28 (1) indications that the information is in the physical possession and control of an unauthorized person, such as a lost or 29 stolen computer or other device containing information; 30 (2) indications that the information has been viewed, downloaded, or copied; or (3) indications that the information was used by an unauthorized person, such as fraudulent accounts opened or instances of 31 reported identity theft. 32 (B) An agency maintaining computerized data or other data that includes personal identifying information that the agency does 33 34 not own shall notify the owner or licensee of the information of a breach of the security of the data immediately following discovery, if the personal identifying information was, or is reasonably believed to have been, acquired by an unauthorized person. 35

(C) The disclosure requirements of subsections (A) and (B) must be made in the most expedient time possible and without 1 2 unreasonable delay; however, the notification required by this section may be delayed if a law enforcement agency determines that the notification impedes a criminal investigation and must be made after the law enforcement agency determines that it no longer 3 4 compromises the investigation. A delay in notification shall not exceed seventy-two hours after discovery, unless the agency requests 5 and the attorney general grants, in writing, additional delays of up to seventy-two hours each upon a determination that such notification impedes a criminal investigation. 6

(D) For purposes of this section:

8 (1) "Agency" means any agency, department, board, commission, committee, or institution of higher learning of the State or a political subdivision of it. 9

(2) "Breach of the security of the system" means unauthorized access to and acquisition of computerized data that was not 10 rendered unusable through encryption, redaction, or other methods that compromise the security, confidentiality, or integrity of 11 personal identifying information maintained by the agency, when illegal use of the information has occurred or is reasonably likely 12 to occur or use of the information creates a material risk of harm to the consumer. Good faith acquisition of personal identifying 13 information by an employee or agent of the agency for the purposes of the agency is not a breach of the security of the system if the 14 15 personal identifying information is not used or subject to further unauthorized disclosure.

(3) "Consumer reporting agency" means any person which, for monetary fees, dues, or on a cooperative nonprofit basis, 16 regularly engages in whole or in part in the practice of assembling or evaluating consumer credit information or other information 17 on consumers for the purpose of furnishing consumer reports to third parties, and which uses any means or facility of interstate 18 commerce for the purpose of preparing or furnishing consumer reports. A list of consumer reporting agencies shall be compiled by 19 the Department of Consumer Affairs and furnished upon request to the agency required to make a notification under this section. 20

21 (4) "Personal identifying information" means the first name or first initial and last name in combination with and linked to 22 any one or more of the following data elements that relate to a resident of this State, when the data elements are neither encrypted 23 nor redacted or when the data elements are encrypted with an encryption key and the encryption key that has also been acquired:

(b) driver's license number or state identification card number issued instead of a driver's license; (c) financial account number, or credit card or debit card number in combination with any required security code, access

34 (2) electronic notice, if the agency's primary method of communication with the individual is by electronic means, the 35 person to whom notice is required has expressly consented to receiving said notice in electronic form, or is consistent with the

provisions regarding electronic records and signatures set forth in Section 7001 of Title 15 USC and Chapter 6, Title 26 of the 1976 1 2 Code: 3

(3) telephonic notice; or

(4) substitute notice, if the agency demonstrates that the cost of providing notice exceeds two hundred fifty thousand dollars 4 5 or that the affected class of subject persons to be notified exceeds five hundred thousand or the agency has insufficient contact 6 information. Substitute notice consists of:

- (a) e-mail notice when the agency has an e-mail address for the subject persons;
- (b) conspicuous posting of the notice on the agency's website page, if the agency maintains one; or

Regardless of the method by which notice is provided, such notice shall include contact information for the agency making the 10 notification and a description of the categories of information that were, or are reasonably believed to have been, acquired by a person 11 without valid authorization, including specification of which of the elements of personal information and private information were, 12 or are reasonably believed to have been, so acquired. 13

(F) A resident of this State who is injured by a violation of this section, in addition to and cumulative of all other rights and 14 15 remedies available at law, may:

- (1) institute a civil action to recover damages;
 - (2) seek an injunction to enforce compliance; and
 - (3) recover attorney's fees and court costs, if successful.

(G) An agency that knowingly and willfully violates this section is subject to an administrative fine up to one thousand dollars 19 for each resident whose information was accessible by reason of the breach, the amount to be decided by the Department of Consumer 20 Affairs. 21

(H) If the agency provides notice to more than one thousand persons at one time pursuant to this section, the agency shall notify, 22 without unreasonable delay, the Consumer Protection Division of the Department of Consumer Affairs and all consumer reporting 23 24 agencies that compile and maintain files on a nationwide basis, as defined in 15 USC Section 1681a(p), of the timing, distribution, 25 and content of the notice.

117.108. (GP: State Ports Authority Property) The State Ports Authority shall transfer fifty acres of its real property on Daniel 26 Island to the Department of Parks, Recreation and Tourism, which shall ensure, in the manner it deems appropriate, that the property 27

28 is used for public recreation activities. If the State Ports Authority has not completed the sale of its remaining real property on Daniel

Island and Thomas (St. Thomas) Island, except for the dredge disposal cells that are needed in connection with the construction of 29

the North Charleston terminal on the Charleston Naval Complex and for harbor deepening and for channel and berth maintenance, 30

by June 30, 2016 2017, the authority must transfer the property to the Department of Administration. The authority shall sell the 31

real property under terms and conditions it considers most advantageous to the authority and the State of South Carolina. 32

117.109 (GP: Remittance of Court Fee and Fine Money) County and city treasurers are required to remit to the State Treasurer 33 34 set percentages of revenues generated by assessments imposed by 14-1-206(A), 14-1-207(A), 14-1-208(A). This remittance is required on a monthly basis by the 15th day of each month. 35

Should a county and/or city treasurer fail to make the required remittance, the SC Criminal Justice Academy shall cease providing 1 2 services to all law enforcement officers of all law enforcement agencies encompassed within the political subdivision if they have failed to make remittance for two consecutive months in a fiscal year. The finance director shall certify by July first, under oath, that 3 4 the county and/or city has remitted all funds or the SC Criminal Justice Academy shall withhold services until such time as remittance 5 is made. 6 117.110. (GP: Detailed Expenditure/Revenue Reports PCC/CID) The Prosecution Coordination Commission and the Commission 7 on Indigent Defense shall provide detailed expenditure reports and associated revenue streams for each individual circuit, revenue streams shall include, but not be limited to, state funds, local funds, Federal funds, and also nongovernmental sources of funds, by 8 no later than September first, on the prior fiscal year, to the appropriate commission. The commissions shall than provide the 9 Chairman of the House Ways and Means Committee and Chairman of the Senate Finance Committee with a combined report by 10 September fifteenth of the current fiscal year. 11 117.111. (GP: South Carolina Welcome Centers) The Department of Parks, Recreation and Tourism and the Department of 12 Transportation shall maintain a Memorandum of Understanding (MOU) that provides that the Department of Parks, Recreation and 13 Tourism shall control operations of all South Carolina Welcome Centers. The MOU shall include replacement, renovation and 14 15 maintenance of the facilities, daily operations, and grounds maintenance and upkeep and shall clearly define responsibility for additional portions of Welcome Centers to include paving and sidewalks. The Department of Transportation shall transfer to the 16 Department of Parks, Recreation and Tourism the amount of \$3,313,560 \$3,713,160 less any state funds appropriated by the General 17 Assembly for the same purpose. Grantees failing to submit reports with thirty days of the end of each quarter shall have their grant terminated. 12 Unexpended funds for Continuation of Teen Pregnancy Prevention projects under the Department of Social Services or under the 13 Department of Health and Environmental Control shall be carried forward for the purpose of fulfilling the department's contractual 14 15 agreement. 117.113. (GP: Charleston & Dorchester County Sound Barriers) From the funds authorized to the Department of Transportation, 16 the department shall take the appropriate measures to allow the counties of Charleston and Dorchester to construct sound barriers in 17 the department's easements along Interstate 26 within the borders of Charleston County and along Dorchester Road within Dorchester 18 County, provided, no funds appropriated or authorized in Part IA to the Department of Transportation, any other section of this act, 19 any Federal Funds, unless otherwise agreed to by the local Metropolitan Planning Organization or Council or Governments for use 20 of a portion of their annual federal allocation, or any Other Funds, shall be used in the construction of the sound barriers, and only 21 22 local dollars shall be used in the construction of sound barriers. The sound barriers must meet the state and federal noise abatement 23 guidelines and must be constructed to meet any and all state and federal regulations. Consistent with the requirements of Section 24 57-25-190 (E) of the 1976 Code, or regulations adopted pursuant thereto, including construction by a local government in a state 25 right of way, the owner of a legally erected and maintained billboard shall have the option to relocate such billboard sign to another 26 location as close as practicable to the sign being relocated or adjust the height or angle of the billboard sign to a height or angle that restores the visibility of the billboard sign to the same or comparable visibility as before construction of a sound barrier. Costs for 27 28 re-location or alteration of a billboard due to sound barrier installation by a local government in a state right of way shall be paid by the local government. The provisions of Section 39-14-10 et seq. of the 1976 Code will apply regarding any compensation to be 29 paid by local governments for billboard signs which cannot be relocated or altered. 30 31 117.114. (GP: Information Technology and Information Security Plans) (A) By October 1, 2015 2016, all state agencies must submit an information technology plan and an information security plan for Fiscal Year 2015-16 2016-17 to the Department of 32 Administration. State agencies must submit updates to their plans if there are changes following initial submission. Changes that 33 34 would necessitate an updated plan include, but are not limited to, changes in response to technological advancements, changes in legislation, regulation or compliance requirements, newly identified funding sources, or new issues relating to information 35
- 36 technology management or business requirements.

The information technology plans required by this section shall be in the form and level of detail required by the department 1 2 and shall include at least: (1) the information technology objectives of the state agency; (2) an inventory of the state agency's information technology; (3) any performance measures used by the state agency for implementing its information technology 3 4 objectives; (4) how the state agency's development of information technology coordinates with other governmental entities; (5) the 5 state agency's budget plans for information technology for the coming fiscal year which must include: (a) all fixed, recurring information technology costs, regardless of funding sources; (b) new information technology expenditures for services, hardware 6 7 upgrades/replacements and software purchases, regardless of funding sources; (c) new information technology projects, regardless of funding sources; and (d) FTE counts, temporary personnel counts, and salary information and position descriptions for all 8 information technology personnel, regardless of funding sources; and (6) the state agency's need for appropriations for information 9 10 technology.

The information security plans required by this section shall be in the form and level of detail required by the division and 11 shall include at least: (1) the information security objectives of the state agency; (2) an inventory of the state agency's information 12 security technology; (3) a profile of the state agency's compliance with security policies established by the division; (4) a profile of 13 the state agency's sensitive data and a description of applicable state and federal privacy requirements; (5) a profile of risk 14 management and other measures taken by the state agency to protect its data from unauthorized access and disclosure; (6) the state 15 agency's budget plans for information security for the coming fiscal year which must include: (a) all fixed, recurring information 16 security technology costs, regardless of funding sources; (b) new information security expenditures for services hardware 17 upgrades/replacements and software purchases, regardless of funding sources; (c) new information security projects, regardless of 18 funding sources; and (d) FTE counts, temporary personnel counts, and salary information and position descriptions for all information 19 security personnel, regardless of funding sources; and (7) the state agency's need for appropriations for information security. 20

117.115. (GP: SCOIS Transfer) For Fiscal Year 2015-16 2016-17, the South Carolina Occupational Information System, its

117.116. (GP: PEBA Fiduciary Audit) For the current fiscal year, the provisions of Section 9-4-40 requiring the Inspector General

117.117. (GP: ABLE Savings Expense Fund) For the current fiscal year, the South Carolina ABLE Saving Expense Fund is established in the Office of the State Treasurer to allow for tax-exempt savings accounts for disability-related expenses for <u>'eligible</u> individuals<u>' as</u> defined <u>in Section 529A(e)(1) of the federal Internal Revenue Code of 1986, as amended</u> as being entitled to benefits based on blindness or disability under Title II or XVI of the Social Security Act, or individuals with a disability certification, which

36 must state that "the individual has a medically determinable physical or mental impairment, which results in marked and severe

functional limitations, and which can be expected to result in death or which has lasted or can be expected to last for a continuous 1 2 period of not less than 12 months." or is blind. The certification must include the diagnosis and be signed by a physician. As the administrator of the ABLE Fund, the State Treasurer may develop, implement and administer the ABLE Fund in a manner 3 4 consistent with Section 529A of the federal Internal Revenue Code of 1986, as amended and the authorizing legislation. The Treasurer will establish the methods by which the funds held in accounts will be collected, invested and disbursed. The Treasurer 5 may charge and collect administrative fees and service charges in connection with any agreement or transaction relating to the 6 program, including an annual account maintenance fee. All expenses incurred by the State Treasurer in developing and 7 administering the ABLE Savings Program must be payable from the South Carolina ABLE Savings Expense Fund. Additionally, the 8 Treasurer may engage financial institutions or other qualified entities to serve as program manager for the ABLE Fund. 9 An ABLE account within the ABLE Fund must be opened by the eligible individual or an authorized agent, trustee or guardian for 10 the beneficiary. Account opening will require the Treasurer to collect information about the eligible individual and may require the 11 Treasurer to share information with the Social Security Administration in the future. Account opening details, such as maximum 12 contributions annually and over time, will be established by the ABLE Fund and will be in compliance with Section 529A of the 13 Internal Revenue Code. 14 15 Funds in an account will be exempt from attachment, garnishments and other creditor claims against the contributor and the beneficiary. These funds will also be disregarded for purposes of determining eligibility for any State public assistance, including 16 Medicaid. However, upon the death of a beneficiary, funds remaining in an account maybe be recovered by the South Carolina 17 Department of Health and Human Services in an amount equal to Medicaid benefits previously paid on behalf of the beneficiary. 18 None of the accounts established by and for an eligible individual create an obligation by the State, the State Treasurer or any 19 agency or instrumentality of South Carolina. There are no guarantees with regard to return of principal, a rate of return on 20 investments or any payment of interest or other earnings. 21 Contributions to a trust account within the Fund or a qualified account under Section 529A located in another state by a South 22 23 Carolina taxpayer will be entitled to a state income tax deduction, subject to any limits on contributions imposed by the Internal 24 Revenue Code. Income earned on investments in a trust account will be deferred from federal and South Carolina taxation while they remain in the account, and will be exempt from federal and South Carolina taxation as long as the funds are used for Qualified 25 26 Withdrawals. The earnings portion of withdrawals that are used for nonqualified purposes will be subject to federal and South Carolina taxation and any South Carolina income tax deductions taken previously will be recaptured. 27 117.118. (GP: Employee Compensation) The amounts appropriated to the Department of Administration F300-Statewide 28 29 Employee Benefits for Employee Pay Increases must be allocated by the department Department of Administration, Executive Budget *Office* to the various state agencies to provide for employee pay increases in accordance with the following plan: 30 (1) With respect to classified and non-judge judicial classified employees, effective on the first pay date that occurs on or after 31 July first of the current fiscal year, the compensation of all classified employees shall be increased by zero four percent. 32 (2) With respect to unclassified and non-judge judicial unclassified employees or unclassified executive compensation system 33 34 employees not elsewhere covered in this act, effective on the first pay date that occurs on or after July first of the current fiscal year the compensation of all unclassified employees shall be increased by zero four percent. Any employee subject to the provisions of 35 this paragraph shall not be eligible for compensation increases provided in paragraphs 1, 3, 4, 5, or 6. 36

(3) Effective on the first pay date that occurs on or after July first of the current fiscal year, agency heads not covered by the 1 2 Agency Head Salary Commission, shall receive an annualized base pay increase of zero four percent. (4) With respect to local health care providers compensation increases shall be zero four percent effective on the first pay date 3 4 that occurs on or after July first of the current fiscal year. With respect to Area Agencies on Aging funded by the Lieutenant Governor's Office on Aging, compensation shall be increased by zero four percent effective on the first pay date that occurs on or 5 after July first of the current fiscal year. With respect to local councils on aging or local providers of services funded by the Lieutenant 6 7 Governor's Office on Aging through Area Agencies on Aging, no pay increases will be allowed. School Bus Driver salary and fringe 8 funding to school districts shall be increased by zero four percent. The committee is to examine existing 26 services and resources available to children with the disease as well as adults with the disease. Additionally, the committee is to 27 establish partnerships with institutions, and communities, a statewide network of service providers for adults with the disease; a 28 29 comprehensive education and treatment program for adults, as well as establish standardized treatment and emergency room 30 protocols. 117.121. (GP: Child Fatality Review) The agencies specified shall implement the following recommendations contained in the

16	Subdivisions - State Treasurer for the Local Government Fund, and funds designated in X500, Section 115, Tax Relief Trust Fund
17	shall be excluded from the calculation of any across-the-board base reduction mandated by the Department of Administration,
18	Executive Budget Office or the General Assembly and shall not be subject to any such reduction.

22	118.1. (SR: Year End Cutoff) Unless specifically authorized herein, the appropriations provided in Part IA of this act as ordinary
23	expenses of the State Government shall lapse on July 31, 2016 2017. State agencies are required to submit all current fiscal year
24	input documents and all electronic workflow for accounts payable transactions to the Office of Comptroller General by July 14, 2016
25	2017. Appropriations for Permanent Improvements, now outstanding or hereafter provided, shall lapse at the end of the second fiscal
26	year in which such appropriations were provided, unless definite commitments shall have been made, with the approval of the State
27	Fiscal Accountability Authority and Joint Bond Review Committee, toward the accomplishment of the purposes for which the
28	appropriations were provided. Appropriations for other specific purposes aside from ordinary operating expenses, now outstanding
29	or hereafter provided, shall lapse at the end of the second fiscal year in which such appropriations were provided, unless definite
30	commitments shall have been made, with the approval of the State Fiscal Accountability Authority, toward the accomplishment of
31	the purposes for which the appropriations were provided.
32	118.2. (SR: Titling of Real Property) It is the intent of the General Assembly to establish a comprehensive central property and
33	office facility management process to plan for the needs of state government agencies and to achieve maximum efficiency and
34	economy in the use of state owned or state leased real properties. The Department of Administration is directed to identify all state

35 owned properties whether titled in the name of the state or an agency or department, and all agencies and departments of state

36 government are upon request to provide the department all documents related to the title and acquisition of the real properties that

are occupied or used by the agency or titled in the name of the agency. Except for any properties where the department determines 1 2 title should not be in the name of the State because the properties are subject to reverter clauses or other restraints on the property, or where the department determines the state would be best served by not receiving title, and with the exception of properties, 3 4 highways and roadways owned by the Department of Transportation, title of any property held by or acquired by a state agency or department shall be titled in the name of the state under the control of the Department of Administration. Titling in the name of the 5 6 state shall not affect the operation or use of real property by an agency. 7 This provision applies to all state agencies and departments except: institutions of higher learning; the Public Service Authority; the Ports Authority; the South Carolina Division of Public Railways; the MUSC Hospital Authority; the Myrtle Beach Air Force 8 Redevelopment Authority; the Department of Transportation; the Midlands Technical College Enterprise Campus Authority, the 9 Trident Technical College Enterprise Campus Authority; the Area Commission of Tri-County Technical College; and the Charleston 10 Naval Complex Redevelopment Authority. 11 This provision is comprehensive and supersedes any conflicting provisions concerning title and acquisition and disposition of state 12 owned real property whether in permanent law, temporary law or by provision elsewhere in this act. 13 The Department of Administration is directed to provide to the Department of Education, funds equal to the amount realized from 14 the sale of the Greenville Halton Road Bus Shop property for school bus maintenance shop relocations, construction, and shop 15 16 equipment. 118.3. (SR: Contingency Reserve Fund) (A) There is created in the State Treasury a fund separate and distinct from the general 17 fund of the State, the Capital Reserve Fund, and all other funds entitled the Contingency Reserve Fund. All general fund revenues 18 accumulated in a fiscal year in excess of general appropriations and supplemental appropriations must be credited to this fund. 19 Revenues credited to this fund in a fiscal year may be appropriated by the General Assembly. Upon determination by the Comptroller 20 General as to the amount to be deposited in the Contingency Reserve Fund, the Comptroller General shall notify the Board of 21 22 Economic Advisors and the board shall recognize that amount as surplus funds. Revenues in this fund may be appropriated only for 23 the purposes provided in subsection (B). 24 (B) (1) If the balance in the general reserve fund established pursuant to Section 36, Article III of the Constitution of this State 25 and Section 11-11-310 of the 1976 Code is less than the required balance, there must be appropriated to it all amounts in the 26 Contingency Reserve Fund up to the total necessary to replenish the general reserve fund. This amount does not replace or supplant the minimum replenishment amount otherwise required to be made to the general reserve fund. 27 (2) After the appropriation of amounts required pursuant to item (1) of this subsection, any remaining balance may be 28

29 appropriated by the General Assembly as it deems appropriate.

30 118.4. (SR: Increased Enforced Collections Carry Forward) Unexpended funds appropriated pursuant to Proviso 90.16 in Part IB 31 of Act 291 of 2010 may be carried forward from the prior fiscal year into the current fiscal year and shall be expended for the same 32 purposes.

33 **118.5.** (SR: Health Care Maintenance of Effort Funding) The revenue collected from the fifty cent cigarette surcharge and 34 deposited into the South Carolina Medicaid Reserve Fund and shall be utilized by the Department of Health and Human Services for 35 the Medicaid program. By this provision these funds are deemed to have been received and are available for appropriation.

1 Unexpended funds appropriated pursuant to this provision may be carried forward to succeeding fiscal years and expended for the 2 same purposes.

118.6. (SR: Prohibits Public Funded Lobbyists) All state agencies and institutions are prohibited from using general fund appropriations to compensate employees who engage in lobbying on behalf of the state agency or institution. The State Ethics Commission shall require state agencies and institutions that report lobbying activities to the commission to certify that the lobbying activities were not funded by general fund appropriations.

All state agencies and institutions are prohibited from entering into contracts using general fund appropriations to provide lobbying
 services to the agency or institution.

9 118.7. (SR: Admissions Tax) For the current fiscal year, up to one hundred fourteen thousand dollars in admissions tax revenue 10 collected annually from all events held at a NASCAR sanctioned motor speedway or racetrack that hosts at least one race each year 11 featuring the preeminent NASCAR cup series must be rebated to the motorsports entertainment complex facility in the current fiscal 12 year to keep a NASCAR race at the motorsports entertainment complex facility. In addition, any sports facility that hosts at least 13 one preeminent Women's Tennis Association-sanctioned tournament or any sports facility that operates as the home venue for a 14 professional soccer team that participates in the United Soccer Leagues, second division or higher, must be rebated to the facility 15 half of its admissions tax revenue for the fiscal year and used by that facility for marketing the events held at the facility.

16 **118.8.** (SR: Agency Deficit Notice) The Comptroller General or the Executive Budget Office shall (1) provide written notice to 17 each member of the General Assembly when it makes a report concerning an agency, department, or institution that is expending 18 authorized appropriations at a rate which predicts or projects a general fund deficit for the agency, department, or institution, and (2) 19 make monthly progress reports concerning an agency's, department's, or institution's plan to reduce or eliminate the deficit.

118.9. (SR: Tax Relief Reserve Fund) There is created the Tax Relief Reserve Fund, which shall be separate and distinct from the General Fund. Interest accrued by the fund must remain in the fund. Notwithstanding any other provision of law, on December 31, 2015 2016, the State Treasurer shall transfer funds identified in this act from the General Fund to the Tax Relief Reserve Fund. These funds may only be used to provide tax relief to businesses and individuals as provided by law. Funds within the Tax Relief Reserve Fund shall be retained and carried forward to be used for the same purpose.

25 **118.10.** (SR: Tax Deduction for Consumer Protection Services) (A) In addition to the deductions allowed in Section 12-6-1140 of the 1976 Code, there is allowed a deduction in computing South Carolina taxable income of an individual the actual costs, but not 26 exceeding three hundred dollars for an individual taxpayer, and not exceeding one thousand dollars for a joint return or a return 27 28 claiming dependents, incurred by a taxpayer in the taxable year to purchase a monthly or annual contract or subscription for identity theft protection and identity theft resolution services. The deduction allowed by this item may not be claimed by an individual if the 29 individual deducted the same actual costs as a business expense or if the taxpayer is enrolled in the identity theft protection and 30 31 identity theft resolution services offered free of charge by the State of South Carolina. For purposes of this item, 'identity theft protection' means products and services designed to prevent an incident of identify fraud or identity theft or other protect the private 32 of a person' personal identifying information, as defined in Section 16-13-510(D), by precluding a third party from gaining 33 34 unauthorized acquisition of another's personal identifying information to obtain financial resources or other products, benefits or services; and identity theft resolution services means products and services designed to assist persons whose personal identifying 35

information, as defined by Section 16-13-510(D), was obtained by a third party, whereby minimizing the effects of the identity fraud 1 2 or identity theft incident and restoring the person's identity to pretheft status. (B) The deduction provided in (A) is only allowed for taxpayers that filed a return with the Department of Revenue for any taxable 3 4 year after 1997 and before 2013, whether by paper or electronic transmission, or any person whose personally identifiable information 5 was contained on the return of another eligible person, including minor dependents. (C) By March fifteenth of each year, the department shall issue a report to the Governor and the General Assembly detailing the 6 7 number of taxpayers claiming the deduction allowed by this item in the most recent tax year for which there is an accurate figure. and the total monetary value of the deductions claimed pursuant to this item in that same year. 8 (D) The department shall prescribe the necessary forms to claim the deduction allowed by this section. The department may 9 require the taxpayer to provide proof of the actual costs and the taxpayer's eligibility. 10 **118.11.** (SR: Tobacco Settlement) (A) To the extent funds are available from payments received on behalf of the State by the 11 Tobacco Settlement Revenue Management Authority from the Tobacco Master Settlement Agreement ("MSA") during Fiscal Year 12 2015-16 the current fiscal year, the State Treasurer is authorized and directed, after transferring funds sufficient to cover the operating 13 expenses of the Authority, to transfer the remaining funds as follows: 14 15 (1) \$1,253,000 to the Attorney General's Office for Diligent Enforcement and Arbitration Litigation; \$450,000 to the State Law Enforcement Division for Diligent Enforcement; and \$325,000 to the Department of Revenue for Diligent Enforcement, all to 16 enforce Chapter 47 of Title 11, the Tobacco Escrow Fund Act; and 17 (2) The remaining balance shall be transferred to the Department of Health and Human Services for the Medicaid program. 18 (B) The requirements of Section 11-11-170 of the 1976 Code shall be suspended for Fiscal Year 2015-16 2016-17. 19 118.12. (SR: Nonrecurring Revenue) (A) The source of revenue appropriated in subsection (B) is nonrecurring revenue 20 21 generated from the following sources: (1) \$19,740,576 from Fiscal Year 2013-14 Contingency Reserve Fund; 22 (2) \$19,280,467 from Fiscal Year 2014-15 unobligated general fund revenue as certified by the Board of Economic 23 24 Advisors: (3) \$27,802,168 from the Litigation Recovery Account; and 25 26 (4) \$49,500,000 from Fiscal Year 2015-16 non-recurring contribution from the Unclaimed Property Fund. Any restrictions concerning specific utilization of these funds are lifted for the specified fiscal year. The above agency transfers 27 28 shall occur no later than thirty days after the close of the books on Fiscal Year 2014-15 and shall be available for use in Fiscal Year 29 2015 - 1630 This revenue is deemed to have occurred and is available for use in Fiscal Year 2015-16 after September 1, 2015, following the Comptroller General's close of the state's books on Fiscal Year 2014-15. 31 (B) The appropriations in this provision are listed in priority order. However, a person who shares an ownership interest with another person or entity may not be refused a grant solely 16 17 because the other person or related person has otherwise received the maximum grant amount, but in this case, the person's grant amount is limited by the person's ownership interest. If the total amount of grants allowed pursuant to this paragraph exceeds the 18 monies in the fund, then each person's grant must be reduced proportionately. 19 20 *To determine loss, the department:* (1) must measure the person's cumulative total loss of all affected agricultural commodities for 2015 against the person's 21 22 expected production of all agricultural commodities affected by the flood in 2015: 23 (2) shall use the person's applicable actual production history vield, as determined by the Federal Crop Insurance 24 Corporation, to determine loss for insured agricultural commodities. In determining loss for uninsured agricultural commodities, the department shall use the most recent year's county price and county yield, as applicable, as determined by the National 25 26 Agriculture Statistics Service, United States Department of Agriculture: and 27 (3) may require any documentation or proof it considers necessary to efficiently administer the grant program, including the ownership structure of each entity and the social security numbers of each owner. Minimally, in order to verify loss, the Department 28 29 of Agriculture shall require the submission of dated, signed, and continuous records. These records may include, but are not limited to, commercial receipts, settlement sheets, warehouse ledger sheets, pick records, load summaries, contemporaneous measurements, 30 31 truck scale tickets, contemporaneous diaries, appraisals, ledgers of income, income statements of deposit slips, cash register tape. 32 invoices for custom harvesting, u-pick records, and insurance documents. Grant awards must be used for agricultural production expenses and losses due to the flood which demonstrate an intent to 33 34 continue the agricultural operation; however, awards may not be used to purchase new equipment. The Department of Agriculture 35 shall develop guidelines and procedures to ensure that funds are expended in the manner outlined in grant applications, and may 36 require any documentation it determines necessary to verify the appropriate use of grant awards including receipts.

1	If the Department of Agriculture determines that a person who received a grant provided inaccurate information, then the person
2	shall refund the entire amount of the grant. If the department determines that a person who received a grant used the funds for
3	ineligible expenses, then the person must refund the amount of the ineligible expenses. If the person does not refund the appropriate
4	amount, the Department of Revenue shall utilize the provisions of the Setoff Debt Collection Act to collect the money from the person.
5	For purposes of this provision:
6	(1) 'Agricultural commodities' means wheat, cotton, flax, corn, dry beans, oats, barley, rye, tobacco, rice, peanuts, soybeans,
7	sugar beets, sugar cane, tomatoes, grain sorghum, sunflowers, raisins, oranges, sweet corn, dry peas, freezing and canning peas,
8	forage, apples, grapes, potatoes, timber and forests, nursery crops, citrus, and other fruits and vegetables, nuts, tame hay, native
9	grass, aquacultural species including, but not limited to, any species of finfish, mollusk, crustacean, or other aquatic invertebrate,
10	amphibian, reptile, or aquatic plant propagated or reared in a controlled or selected environment, excluding stored grain.
11	(2) 'Person' means any individual, trust, estate, partnership, receiver, association, company, limited liability company,
12	corporation, or other entity or group.
13	(3) 'Related person' means any person, joint venture, or entity that has a direct or indirect ownership interest of a person or
14	<u>legal entity.</u>
15	If the General Assembly enacts a grant program in the permanent laws of this state substantially similar to the program established
16	in this proviso, codified in the 1976 Code, then the provisions contained in the 1976 Code shall govern the operations of the program
17	and this proviso shall have no force and effect.
18	(E) Unexpended funds appropriated pursuant to this provision may be carried forward to succeeding fiscal years and expended
19	for the same purposes.
20	118.17. (SR: One Dollar Appropriations) Funds appropriated in the amount of one dollar by this act shall not be disbursed.
21	The Comptroller General shall adjust the affected agency's chart of accounts accordingly, if necessary.

25	All acts or parts of acts inconsistent with any of the provisions of Part IA or Part IB of this act are suspended for Fiscal Year 2016-

27	If any part, section, subsection, paragraph, subparagraph, sentence, clause, phrase, or word of this act is for any reason held to
28	be unconstitutional or invalid, such holding shall not affect the constitutionality or validity of the remaining portions of this act, the
29	General Assembly hereby declaring that it would have passed this act, and each and every part, section, subsection, paragraph,
30	subparagraph, sentence, clause, phrase, and word thereof, irrespective of the fact that any one or more other parts, sections,
31	subsections, paragraphs, subparagraphs, sentences, clauses, phrases, or words hereof may be declared to be unconstitutional, invalid,
32	or otherwise ineffective.
33	Except as otherwise specifically provided, this act takes effect July 1, 2016.
