### **Fiscal Impact Summary**

This bill amends Sections 25-11-50 and 25-11-60 to specifically allow the Secretary of the Department of Veterans Affairs (Secretary) to require monthly reports from county veterans' affairs officers (CVAOs) to analyze metrics of veterans' care across the state. These reports must be provided within five days of the initial request. This bill further stipulates that CVAOs provide a copy of their semiannual report to the Secretary as well.

This bill will have no expenditure impact to the Department of Veterans Affairs (department) as the department can fulfill the requirements of this bill using current appropriations and staff.

This bill will have no expenditure impact to local county veterans' affairs offices, as the department purchased claims management software for use by local offices in FY 2020-21 to generate the county-level data that would be requested in these reports.

The expenditure impact of this bill has been updated following responses from counties.

### Updated for Additional Agency Responses on March 23, 2022 **Introduced on February 1, 2022 State Expenditure**
